COMMITTEE SUBSTITUTE

An Act relating to appropriations; making an
appropriation to the Department of Mental Health and
Substance Abuse Services; stating purpose; and
declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. There is hereby appropriated to the Department of
Mental Health and Substance Abuse Services from any monies not
otherwise appropriated from the General Revenue Fund of the State
Treasury for the fiscal year ending June 30, 2017, the sum of
Twenty-four Million Nine Hundred Forty Thousand Dollars
(\$24,940,000.00) or so much thereof as may be necessary to perform
the duties imposed upon the Department of Mental Health and
Substance Abuse Services by law.

1 SECTION 2. It being immediately necessary for the preservation
2 of the public peace, health or safety, an emergency is hereby
3 declared to exist, by reason whereof this act shall take effect and
4 be in full force from and after its passage and approval.
