11 An Act relating to appropriations; making an
12 appropriation to the Department of Human Services;
13 stating purpose; and declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. There is hereby appropriated to the Department of
17 Human Services from any monies not otherwise appropriated from the
18 General Revenue Fund of the State Treasury for the fiscal year
19 ending June 30, 2017, the sum of Twenty-nine Million Seventy
20 Thousand Dollars (\$29,070,000.00) or so much thereof as may be
21 necessary to perform the duties imposed upon the Department of Human
22 Services by law.

23 SECTION 2. It being immediately necessary for the preservation
24 of the public peace, health or safety, an emergency is hereby

1 declared to exist, by reason whereof this act shall take effect and
2 be in full force from and after its passage and approval.
