HB 1445 provides that the fine and court costs for speeding one to ten mph over the limit and speeding eleven to fifteen mph over the limit is to be no more than \$100.

**Fiscal Analysis**

HB 1445, as introduced, which limits the fine for certain speeding tickets, would have a significant fiscal impact on several law enforcement and judicial agency revenue streams and budgets. The Administrator of the Courts has provided the chart below with estimates of FY-18 revenue losses (based on FY-16 citation data):
