12	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
13	SECTION 1. AMENDATORY 28 O.S. 2011, Section 152.1, as
14	amended by Section 4, Chapter 362, O.S.L. 2016 (28 O.S. Supp. 2016,
15	Section 152.1), is amended to read as follows:
16	Section 152.1 A. In civil cases, the court clerk shall collect
17	and deposit in the court fund the following charges in addition to
18	the flat fee:
19	1. For posting notices and filing
20	certificates required by statute\$30.00
21	2. For the filing of any counterclaim or
22	setoff pursuant to Section 1758 of
23	Title 12 of the Oklahoma Statutes\$20.00

1	3.	For mailing by any type of mail writs,
2		warrants, orders, process, command, or
3		notice for each person\$10.00
4	4.	For the actual cost of all postage in
5		each case in excess of\$10.00
6	5.	For serving or endeavoring to serve each
7		writ, warrant, order, process,
8		command, or notice for each person in
9		one or more counties\$50.00
10		provided that if more than one person is
11		served at the same address, one flat fee
12		of Fifty Dollars (\$50.00) may be charged
13	6.	For sheriff's fees on court-ordered
14		sales of real or personal property\$75.00
15	7.	When a jury is requested\$349.00
16	8.	For issuing each summons for each person\$10.00
17	9.	For issuing each subpoena for each
18		person\$25.00
19	10.	For filing a Motion to Enter\$25.00
20	<u>11.</u>	For services of a court reporter at
21		each trial held in the case\$20.00
22	<u>12.</u>	For filing a motion for summary
23		judgment or summary disposition of
24		issue(s)\$50.00

1	The fees prescribed in paragraphs 5 and 6 of this subsection
2	shall be paid by the court clerk into the Sheriff's Service Fee
3	Account, created pursuant to the provisions of Section 514.1 of
4	Title 19 of the Oklahoma Statutes, of the sheriff in the county
5	where service is made or attempted or where the sheriff's sale
6	occurs. All other fees shall be deposited into the local court fund
7	in the county where collected.
8	B. The fee prescribed in paragraph 7 of subsection A of this
9	section shall be paid at the time of the pretrial conference by the
10	party requesting a jury.
