15	SECTION 1. NEW LAW A new section of law to be codified	
16	in the Oklahoma Statutes as Section 6-6 of Title 2, unless there is	
17	created a duplication in numbering, reads as follows:	
18	A. It shall be unlawful and be a misdemeanor in Oklahoma to	
19	import or possess exotic swine of the family Suidae. Provided,	
20	however, exotic swine species shall not include pot-bellied pigs,	
21	teacup pigs and other swine or pigs commonly owned as domestic pets.	
22	B. The State Veterinarian may grant exceptions for importation	
23	and possession by a zoo accredited by the Association of Zoos and	
24	Aquariums.
