The measure amends sales tax apportionment [68 O.S. § 1353] by deducting \$92,000,000 from revenues apportioned to the General Revenue Fund for allocation to the State Highway Construction and Maintenance Fund in the amount of \$80,000,000 and the Oklahoma Railroad Maintenance Revolving Fund in the amount of \$12,000,000.

The measure amends sales tax apportionment [68 O.S. § 1353] by deducting \$92,000,000 from revenues apportioned to the General Revenue Fund for allocation to the State Highway Construction and Maintenance Fund in the amount of \$80,000,000 and the Oklahoma Railroad Maintenance Revolving Fund in the amount of \$12,000,000. The change in apportionment is to be accomplished in the following manner.

August 2018

\$25,000,000 allocated to the State Highway Construction and Maintenance Fund. \$4,000,000 allocated to the Oklahoma Railroad Maintenance Revolving Fund.

September 2018

\$25,000,000 allocated to the State Highway Construction and Maintenance Fund. \$4,000,000 allocated to the Oklahoma Railroad Maintenance Revolving Fund.

October 2018

\$30,000,000 allocated to the State Highway Construction and Maintenance Fund. \$4,000,000 allocated to the Oklahoma Railroad Maintenance Revolving Fund.

For FY 19 the measure results in a \$92,000,000 decrease in sales tax revenues apportioned to the General Revenue Fund with an increase in sales tax revenues apportioned to the State Highway Construction and Maintenance Fund and Oklahoma Railroad Maintenance Revolving Fund of \$80,000,000 and \$12,000,000, respectively.
