Section 1 creates the Owasso Rams Supporter, Collinsville Cardinals Supporter, Sperry Pirates Supporter, Skiatook Bulldogs Supporter, Rejoice Christian Eagles Supporter, and East Central Cardinals Supporter special license plates.

Section 2 proposes to amend 62 O.S. § 34.89 to include deposit of revenues apportioned to the Education Reform Revolving Fund pursuant to Section 1135.5 of Title 47.

ATTACHMENT TO FISCAL IMPACT-SB 408 [Introduced] Prepared February 6, 2017.

Section 1 proposes to amend 47 O.S. § 1135.5 by creating the following special license plates:

- Owasso Rams Supporter special license plate which may be issued to any person wishing to demonstrate support for the Owasso Rams and designed in consultation with representatives of Owasso Schools.
- Collinsville Cardinals Supporter special license plate which may be issued to any person wishing to demonstrate support for the Collinsville Cardinals and designed in consultation with representatives of Collinsville Schools.
- Sperry Pirates Supporter special license plate which may be issued to any person wishing to demonstrate support for the Sperry Pirates and designed in consultation with representatives of Sperry Schools
- Skiatook Bulldogs Support special license plate which may be issued to any person wishing to demonstrate support for the Skiatook Bulldogs and designed in consultation with representatives of Skiatook Schools.
- Rejoice Christian Eagles Support special license plate which may be issued to any person wishing to demonstrate support for the Rejoice Christian Eagles Bulldogs and designed in consultation with representatives of Rejoice Christian Schools.
- East Central Cardinals Supporter special license plate which may be issued to any person
 wishing to demonstrate support for the East Central Cardinals and designed in consultation
 with representative of East Central Schools.

The annual fee for special license plates issued pursuant to the amended section is \$35 and is in addition to all other annual vehicle registration fees. For the proposed plates, \$20 of the \$35 fee shall be deposited to the Education Reform Revolving Fund. Eight Dollars (\$8.00) shall be deposited in the OTC Reimbursement Fund to be used for administrative purposes associated with issuance of the special license plates and any remaining amounts of the \$35 fee are to be apportioned as motor vehicle collections pursuant to the provisions of 47 O.S. § 1104.

Section 2 proposes to amend 62 O.S. § 34.89 to include deposit of revenues apportioned to the Education Reform Revolving Fund pursuant to Section 1135.5 of Title 47.

The estimated revenue impact is minimal/positive. There is no estimated administrative impact associated with the proposed amendments.
