BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. AMENDATORY 59 O.S. 2011, Section 1354, as
2 amended by Section 1, Chapter 345, O.S.L. 2013 (59 O.S. Supp. 2018,
3 Section 1354), is amended to read as follows:

4 Section 1354. There is hereby re-created, to continue until
5 July 1, ~~2019~~ 2020, pursuant to the provisions of the Oklahoma Sunset
6 Law, the State Board of Examiners of Psychologists. The Board shall
7 administer the provisions of the Psychologists Licensing Act. The
8 Board shall consist of seven (7) members appointed by the Governor.
9 Five members shall be psychologists from various areas in psychology
10 and two members shall be lay persons. At the expiration of the term
11 of each Board member who is a psychologist, the Governor shall
12 appoint a successor from a list of ten licensed psychologists which
13 is provided by the Oklahoma State Psychological Association.
14 Members shall serve for a term of four (4) years and until a
15 successor is appointed and qualified. Before entering upon the
16 duties of office, each member of the Board shall take the
17 constitutional oath of office and file it with the Secretary of
18 State.

19 SECTION 2. This act shall become effective July 1, 2019.

20 SECTION 3. It being immediately necessary for the preservation
21 of the public peace, health or safety, an emergency is hereby
22 declared to exist, by reason whereof this act shall take effect and
23 be in full force from and after its passage and approval."

17 amended by Section 1, Chapter 345, O.S.L. 2013 (59 O.S. Supp. 2018,
18 Section 1354), is amended to read as follows:

19 Section 1354. There is hereby re-created, to continue until
20 July 1, ~~2019~~ 2023, pursuant to the provisions of the Oklahoma Sunset
21 Law, the State Board of Examiners of Psychologists. The Board shall
22 administer the provisions of the Psychologists Licensing Act. The
23 Board shall consist of seven (7) members appointed by the Governor.
24 Five members shall be psychologists from various areas in psychology
and two members shall be lay persons. At the expiration of the term
of each Board member who is a psychologist, the Governor shall

1 appoint a successor from a list of ten licensed psychologists which
2 is provided by the Oklahoma State Psychological Association.
3 Members shall serve for a term of four (4) years and until a
4 successor is appointed and qualified. Before entering upon the
5 duties of office, each member of the Board shall take the
6 constitutional oath of office and file it with the Secretary of
7 State.

8 SECTION 5. This act shall become effective July 1, 2019.
