Supp. 2018, Sections 250.4 and 251), which relate to
the Administrative Procedures Act; exempting military
publications from certain provisions of the act;
directing the Secretary of State to publish military
publications; determining certain numberings;
modifying contents of Oklahoma Register; providing
for codification of military publications in the
Oklahoma Administrative Code; establishing deadline
for certain publications; repealing 44 O.S. 2011,
Sections 3200, 3201, 3202, 3203, 3204, 3205, 3206,
3207, 3211, 3212, 3213, 3214, 3215, 3216, 3217, 3218,
3221, 3231, 3232, 3233, 3234, 3235, 3236, 3241, 3242,
3243, 3244, 3245, 3246, 3247, 3248, 3249, 3251, 3252,
3253, 3254, 3255, 3256, 3261, 3262, 3263, 3264, 3265,

relate to the Uniform State Code of Military Justice;
providing for codification; providing for
recodification; and providing an effective date.

1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 SECTION 1. NEW LAW A new section of law to be codified
3 in the Oklahoma Statutes as Section 26.2 of Title 44, unless there
4 is created a duplication in numbering, reads as follows:

5 The Adjutant General or the Adjutant General's designee may
6 request from a district attorney or law enforcement agency
7 confidential criminal justice information relating to the member of
8 the National Guard for use in an administrative or court-martial
9 action. Unless the district attorney or law enforcement agency
10 determines that dissemination of the requested confidential criminal
11 justice information would jeopardize a pending investigation or
12 other pending criminal proceeding, the district attorney or the
13 investigating law enforcement agency shall disseminate the requested
14 information to the Adjutant General or the Adjutant General's
15 designee.

16 SECTION 2. AMENDATORY 44 O.S. 2011, Section 21, is
17 amended to read as follows:

18 Section 21. The Military Department of the State of Oklahoma is
19 hereby established and shall be ~~administered and controlled by~~ under
20 the command and control of the Governor as Commander in Chief, with
21 the Adjutant General as the executive and administrative head
22 thereof. The Military Department shall be constituted of the state
23 military forces, as defined by Section 801 of this title, and is
24 hereby organized into a joint headquarters ~~with separate branches~~

1 ~~for the~~ which shall be identified as the joint forces headquarters.
2 The joint forces headquarters shall be jointly staffed by Army
3 National Guard and the Air National Guard, and there personnel who,
4 under the authority and direction of the Adjutant General, shall
5 support and assist the Adjutant General in the exercise of command
6 and control over state military forces when not activated for
7 federal duty under Title 10 of the United States Code. There shall
8 be assigned to each the joint force headquarters, officers, enlisted
9 ~~men~~ personnel and civilian employees as may be considered necessary
10 by the Governor as Commander in Chief and as may be authorized by
11 law and Army National Guard regulations and Air National Guard
12 regulations.

13 SECTION 3. AMENDATORY 44 O.S. 2011, Section 212, is
14 amended to read as follows:

15 Section 212. A. If a suit or proceeding shall be commenced in
16 any court by any person against any ~~officer or enlisted person~~
17 member of the military forces for any act done by ~~such officer or~~
18 ~~enlisted person~~ the member in his or her official capacity in the
19 discharge of any duty under Sections 1 through 117, 208 through
20 ~~235.2~~ 237, ~~or~~ 241 through 250, or 800 through 946 of this title, or
21 against any ~~soldier~~ member of the state military forces as defined
22 in Section 801 of this title acting under the authority or order of
23 any such officer, or by virtue of any warrant issued by him or her

24

1 pursuant to law, it shall be the duty of the Attorney General or
2 Judge Advocate to defend such person.

3 The actual court costs of such a defense shall be a legal charge
4 against the state and shall be submitted to the Legislature for
5 payment. Before any suit or proceeding shall be filed or maintained
6 against any ~~officer or soldier~~ member of state military forces as
7 herein provided, the plaintiff shall be required to give security,
8 to be approved by the court in a sum not less than One Hundred
9 Dollars (\$100.00), to secure the costs. If the plaintiff fails to
10 recover judgment such costs shall be taxed and judgment rendered
11 therefor against him or her and his or her sureties.

12 B. Any officer or enlisted person of the state military forces
13 acting in his or her official capacity in the discharge of any duty
14 under Sections 1 through 117, 208 through 235.3, or 241 through 250
15 of this title, or any member of state military forces acting under
16 the authority or order of any such officer, or by virtue of any
17 warrant issued by him or her pursuant to law, shall be immune from
18 personal liability for any acts that include the use of deadly force
19 in self-defense or in defense of another person from what the member
20 reasonably believes is the imminent use of unlawful deadly force.

21 PART I.

22 GENERAL PROVISIONS

1 SECTION 4. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 800 of Title 44, unless there is
3 created a duplication in numbering, reads as follows:

4 Sections 800 through 946 of this title shall be known and may be
5 cited as the "Oklahoma Uniform Code of Military Justice". With the
6 Oklahoma Uniform Code of Military Justice, good order and discipline
7 shall be established and safeguarded within state military forces
8 pursuant to Section 40 of Article V of the Oklahoma Constitution.

9 SECTION 5. NEW LAW A new section of law to be codified
10 in the Oklahoma Statutes as Section 801 of Title 44, unless there is
11 created a duplication in numbering, reads as follows:

12 ARTICLE 1. Definitions.

13 A. As used in the Oklahoma Uniform Code of Military Justice,
14 unless the context otherwise requires:

15 1. "Accuser" means a person who signs and swears to charges,
16 any person who directs that charges nominally be signed and sworn to
17 by another, and any other person who has an interest other than an
18 official interest in the prosecution of the accused;

19 2. "Adjutant General" means the commander and most senior
20 military officer of the Oklahoma National Guard appointed by the
21 Governor with the advice and consent of the Senate. The Adjutant
22 General exercises command and control over the Oklahoma National
23 Guard when it is not activated for federal duty under Title 10 of
24 the United States Code. The Adjutant General serves as the

1 executive and administrative head of the Military Department of the
2 State of Oklahoma as provided for in Section 21 of this title;

3 3. "Administrative control (ADCON)" means the control or
4 exercise of authority over subordinate units and other organizations
5 or units with respect to administration and support, including
6 control of resources and equipment, personnel management, unit
7 logistics, individual and unit training, readiness, mobilization,
8 demobilization and other matters not included in the operational
9 missions of the subordinate units or other organizations or units.
10 Lawfully issued orders implementing administrative control may
11 incorporate references to the Oklahoma Uniform Code of Military
12 Justice (OUCMJ) for disciplinary purposes;

13 4. "Allowance" means an amount of money provided to members of
14 the state military forces when adequate services or facilities are
15 not provided by the military. Allowances are usually provided tax-
16 free for basic housing, basic subsistence, cost of living, clothing
17 expenses and separation from family members;

18 5. "Arrest in quarters" means moral restraint, as opposed to
19 physical restraint, limiting the liberty of an officer. The limits
20 of arrest in quarters are set by the authority imposing nonjudicial
21 punishment and may extend beyond the physical quarters of an
22 officer;

23 6. "Assistant Adjutant General" means an officer appointed by
24 the Adjutant General to assist the Adjutant General in the discharge

1 and performance of his or her duties. An Assistant Adjutant General
2 shall meet the qualifications prescribed by law for the Adjutant
3 General. At least one Assistant Adjutant General for the Army
4 National Guard and one Assistant Adjutant General for the Air
5 National Guard are customarily appointed to establish lines of
6 command and administration into each component of the state military
7 forces. Additional assistant adjutants general may be appointed
8 pursuant to law, custom or National Guard regulations;

9 7. "Cadet" or "officer candidate" means a person who is
10 enrolled in or attending a state military academy, a regional
11 training institute, or any other formal education program for the
12 purpose of becoming a commissioned officer in the state military
13 forces;

14 8. "Classified information" means:

- 15 a. any information or material that has been determined
16 pursuant to federal law, by an Executive Order issued
17 by the President in execution of federal law, or a
18 lawfully promulgated federal regulation, to require
19 protection against unauthorized disclosure for reasons
20 of national security and that is so designated, and
21 b. any restricted data, as defined in Section 11(y) of
22 the Atomic Energy Act of 1954 (42 U.S.C., Section
23 2014(y));

1 9. "Code" means the Oklahoma Uniform Code of Military Justice
2 (OUCMJ);

3 10. "Command authority" means the authority that a commander
4 lawfully exercises over subordinates by virtue of rank or
5 assignment. Disciplinary authority under the OUCMJ is inherent to
6 command authority;

7 11. "Commander" means a designated commissioned officer vested
8 with command authority pursuant to law, regulation, assignment,
9 lawful order or custom;

10 12. "Commanding officer" includes only commissioned officers of
11 the state military forces and shall include officers in charge only
12 when administering nonjudicial punishment under Section 815 (Article
13 15) of this title. "Commander" has the same meaning as "commanding
14 officer" unless the context otherwise requires;

15 13. "Component" means one of two constituent parts that make up
16 the state military forces, namely the army force responsible for
17 land-based operations and the air force responsible for aerial
18 operations and related support activities;

19 14. "Confidential information" means any information or
20 material that shall be designated as confidential pursuant to
21 Section 24A.27 of Title 51 of the Oklahoma Statutes and any
22 information or material that may be kept confidential pursuant to
23 Section 24A.28 of Title 51 of the Oklahoma Statutes that has not
24 previously been released by an appropriate authority;

1 15. "Convening authority" includes, in addition to the person
2 who convened the court, a commissioned officer commanding for the
3 time being or a successor in command to the convening authority;

4 16. "Day" means calendar day and is not synonymous with the
5 term "unit training assembly". Any punishment authorized by this
6 act which is measured in terms of days shall, when served in a
7 status other than annual field training, be construed to mean
8 succeeding duty days;

9 17. "Court of Criminal Appeals" means the Oklahoma Court of
10 Criminal Appeals, the highest court in the State of Oklahoma with
11 appellate jurisdiction in criminal cases. It is the court of last
12 resort for courts-martial conducted under the Code;

13 18. "Duty status" means duty in the state military forces under
14 an order issued by authority of law, and includes travel to and from
15 such duty;

16 19. "Enlisted member" means a person in an enlisted grade;

17 20. "Fatigue duty" means general labor performed by members of
18 the state military forces when unarmed, including but not limited to
19 cleaning, digging, loading, organizing, etc.;

20 21. "Fine" means a type of punishment that makes a member
21 pecuniarily liable to the State of Oklahoma for the amounts
22 specified by nonjudicial punishment or adjudged by a court-martial.
23 A fine may be paid in cash by a member, collected by deduction from
24

1 the current pay of a member or collected by deduction on settlement
2 of the pay account of a member upon discharge;

3 22. "Forfeiture" means a loss of monetary compensation provided
4 to members of the Oklahoma National Guard or Oklahoma State Guard
5 for performance of military duties as a result of nonjudicial
6 punishment or as adjudged by a court-martial. A forfeiture is
7 applicable to basic pay and allowances if total forfeitures of pay
8 and allowances are specifically adjudged by a general court-martial;
9 provided, that forfeitures other than total forfeitures shall not
10 apply to special pay, other than hardship duty pay, or proficiency
11 or incentive pay;

12 23. "Grade" means a step or degree in a graduated scale of
13 office or military rank which is established and designated as a
14 grade by law or regulation;

15 24. "Installation commander" means a commissioned officer
16 responsible for the protection of assigned forces and assets,
17 lodging, dining and administrative reporting, regardless of the
18 command relations of the various types of forces present on the
19 installation. For purposes of this definition, an installation is
20 an Armed Forces Reserve Center, air base, armory, camp, post,
21 readiness center, office building, the joint forces headquarters or
22 other facility, location, structure or property so designated as an
23 "installation" by the Adjutant General;

1 25. "Joint forces headquarters" means the joint headquarters
2 provided for and established in Section 21 of this title;

3 26. "Judge advocate" means a commissioned officer of the
4 organized state military forces who is a member in good standing of
5 the bar of the highest court of a state, and is certified or
6 designated as a judge advocate in the Judge Advocate General's Corps
7 of the Army or the Air Force, or a reserve component of the same;

8 27. "May" is used in a permissive sense. The phrase "no person
9 may" means that no person is required, authorized, or permitted to
10 do the act prescribed;

11 28. "Military court" means a court-martial or a court of
12 inquiry;

13 29. "Military Court of Appeals" means the intermediate
14 appellate court of record established in Section 866 of this title
15 (Article 66) and charged with conducting an appellate review of
16 questions of law arising from general and special courts-martial
17 proceedings conducted by the state military forces and, when
18 necessary in furtherance of its jurisdiction, reviewing all
19 petitions for extraordinary relief properly brought before it;

20 30. "Military department" means the administrative agency
21 established in Section 21 of this title charged with coordinating
22 and supervising state military forces. The military department
23 consists of a joint forces headquarters, an army component and an
24 air force component under the command and control of the Adjutant

1 General when not activated for federal duty under Title 10 of the
2 United States Code;

3 31. "Military judge" means a judicial officer who presides over
4 a general or special court-martial and is detailed in accordance
5 with Section 826 of this title (Article 26);

6 32. "Military offenses" means those offenses designated as
7 punitive articles under Sections 877 (Article 77, Principals), 878
8 (Article 78, Accessory after the fact), 879 (Article 79, Conviction
9 of offense charged, lesser included offenses, and attempts), 880
10 (Article 80, Attempts), 881 (Article 81, Conspiracy), 882 (Article
11 82, Soliciting commission of offenses), 883 (Article 83,
12 Malingering), 884 (Article 84, Breach of medical quarantine), 885
13 (Article 85, Desertion), 886 (Article 86, Absence without leave),
14 887 (Article 87, Missing movement; jumping from vessel), 887A
15 (Article 87A, Resistance, flight, breach of arrest, and escape), 888
16 (Article 88, Contempt toward officials), 889 (Article 89, Disrespect
17 toward superior commissioned officer; assault of superior
18 commissioned officer), 890 (Article 90, Willfully disobeying
19 superior commissioned officer), 891 (Article 91, Insubordinate
20 conduct toward warrant officer, or noncommissioned officer), 892
21 (Article 92, Failure to obey order or regulation), 893 (Article 93,
22 Cruelty and maltreatment), 893A (Article 93A, Prohibited activities
23 with military recruit or trainee by person in position of special
24 trust), 894, (Article 94, Mutiny or sedition), 895 (Article 95,

1 Offenses by sentinel or lookout), 895A (Article 95A, Disrespect
2 toward sentinel or lookout), 896 (Article 96, Release of prisoner
3 without authority; drinking with prisoner), 897 (Article 97,
4 Unlawful detention), 898 (Article 98, Misconduct as prisoner), 899
5 (Article 99, Misbehavior before the enemy), 900 (Article 100,
6 Subordinate compelling surrender), 901 (Article 101, Improper use of
7 countersign), 902 (Article 102, Forcing a safeguard), 903B (Article
8 103B, Aiding the enemy), 903C (Article 103C, Unlawful disclosure of
9 confidential information), 904 (Article 104, Public records
10 offenses), 904A (Article 104A, Fraudulent enlistment, appointment,
11 or separation), 904B (Article 104B, Unlawful enlistment,
12 appointment, or separation), 905A (Article 105A, False or
13 unauthorized pass offenses), 906A (Article 106A, Wearing
14 unauthorized insignia, decoration, badge, ribbon, device, or lapel
15 button), 907 (Article 107, False official statements; false
16 swearing), 908 (Article 108, Military property-loss, damage,
17 destruction, or wrongful disposition), 908A (Article 108A, Captured
18 or abandoned property), 909 (Article 109, Property other than
19 military property-waste, spoilage, or destruction), 910 (Article
20 110, Improper hazarding of vessel or aircraft), 912 (Article 112,
21 Drunkenness and other incapacitation offenses), 912A (Article 112A,
22 Wrongful use, possession, etc., of controlled substances), 914
23 (Article 114, Endangerment offenses), 916 (Article 116, Riot or
24 breach of peace), 917 (Article 117, Provoking speeches or gestures),

1 917A (Article 117A, Wrongful broadcast or distribution of intimate
2 visual images), 920 (Article 120, Sexual assault generally), 920C
3 (Article 120C, Other sexual misconduct), 920D (Article 120D,
4 Fraternization), 921 (Article 121, Larceny and wrongful
5 appropriation), 924 (Article 124, Frauds against the government),
6 928 (Article 128, Assault), 930 (Article 130, Stalking), 931
7 (Article 131, Perjury), 931A (Article 131A, Subornation of perjury),
8 931B (Article 131B, Obstructing justice), 931C (Article 131C,
9 Misprision of serious offense), 931D (Article 131D, Wrongful refusal
10 to testify), 931F (Article 131F, Noncompliance with procedural
11 rules), 931G (Article 131G, Wrongful interference with adverse
12 administrative proceeding), 932 (Article 132, Retaliation), 933
13 (Article 133, Conduct unbecoming an officer and a gentleman), 934
14 (Article 134, General article) of this title;

15 33. "Military publication" means a written publication of an
16 administrative nature such as a regulation, instruction, pamphlet,
17 circular, permanent or general order, numbered adjutant general
18 policy memorandum or blank form promulgated or published by or under
19 the authority of the Adjutant General. An order or directive issued
20 by the Adjutant General that is operational in nature or issued in
21 execution of a military mission shall not be included within the
22 meaning of military publication. Rules of procedure published by
23 the State Judge Advocate for the Military Court of Appeals are
24 included in the meaning of military publication;

1 34. "Month's pay" means the amount of basic pay that would be
2 paid to a member if that member were serving on active duty;

3 35. "National security" means the national defense and foreign
4 relations of the United States;

5 36. "Nexus" means the appearance of a connection between a
6 nonmilitary offense and the state military forces which brings
7 discredit or dishonor to the state military forces due to
8 representations of membership in the state military forces by a
9 member. Such representations may be made directly or indirectly,
10 including but not limited to publication on social media or other
11 electronic communication platforms;

12 37. "Noncommissioned officer" means an enlisted member above
13 the pay grade of E-4 or an enlisted member in the army component of
14 state military forces holding the rank of corporal;

15 38. "Nonjudicial punishment" means punishment imposed
16 administratively by a commander or officer in charge for minor
17 offenses in lieu of a court-martial;

18 39. "Officer" means a commissioned or warrant officer;

19 40. "Officer in charge" means a commissioned or warrant officer
20 designated as such by appropriate authority;

21 41. "Pay" means monetary compensation provided to members of
22 the state military forces in exchange for performance of military
23 duties carried out pursuant to a lawful order or otherwise under the
24 authority of law, including basic pay, special pay, proficiency pay

1 and incentive pay. "Pay" shall not mean allowances as defined in
2 this section;

3 42. "Rank" means the order of precedence among members of the
4 state military forces;

5 43. "Record", when used in connection with the proceedings of a
6 court-martial, means:

7 a. an official written transcript, written summary, or
8 other writing relating to the proceedings, or

9 b. an official audiotape, videotape, digital image or
10 file, or similar material from which sound, or sound
11 and visual images, depicting the proceedings may be
12 reproduced;

13 44. "Regulation" means a written, administrative expression of
14 executive authority issued by an executive branch officer which
15 carries with it the force and effect of law due to inherent command
16 authority or express delegation of authority by the legislative
17 branch; regulations provided for in the Code are published and
18 indexed in the Oklahoma Administrative Code;

19 45. "Rehearing" means a new trial on the findings, on the
20 sentence, or on both;

21 46. "Restriction" means moral restraint, as opposed to physical
22 restraint, limiting access to physical places or participation in
23 certain activities. In comparison to arrest in quarters,
24 "restriction" is a lesser punishment;

1 47. "Senior Assistant Adjutant General" means an Assistant
2 Adjutant General who either possesses the most time in grade or has
3 been designated in writing by the Adjutant General as the Senior
4 Assistant Adjutant General for his or her force component
5 irrespective of time in grade;

6 48. "Senior force component judge advocate" means the judge
7 advocate assigned as chief legal advisor to the Senior Assistant
8 Adjutant General of the same component of the state military forces
9 as the accused. Unless there is a conflict of interest, a senior
10 force component judge advocate may also serve as legal counsel to
11 the Adjutant General and may be designated as the State Judge
12 Advocate. The customary duty station of a senior force component
13 judge advocate is joint forces headquarters;

14 49. "Shall" is used in an imperative sense;

15 50. "State" means one of the several states, the District of
16 Columbia, the Commonwealth of Puerto Rico, Guam and the U.S. Virgin
17 Islands;

18 51. "State active duty" means full-time duty in the state
19 military forces under an order of the Governor or otherwise issued
20 by authority of law, and paid by state funds, and includes travel to
21 and from such duty;

22 52. "State Judge Advocate" means a member of the Oklahoma
23 National Guard qualified as a judge advocate, as defined in this
24

1 section, and who is designated in writing by the Adjutant General as
2 the State Judge Advocate;

3 53. "State military forces" means the National Guard of the
4 State of Oklahoma, which includes an army component and an air force
5 component, as defined in Title 32, United States Code, and Section
6 41 of this title; the Oklahoma State Guard, organized pursuant to
7 Section 109 of Title 32, United States Code, and established
8 pursuant to the Oklahoma State Guard Act; and any other military
9 force organized under the Constitution and laws of the State of
10 Oklahoma when not in a status placing them under exclusive federal
11 jurisdiction pursuant to Chapter 47 of Title 10, United States Code.
12 Unless otherwise established by Oklahoma law, the unorganized
13 militia, as provided for in Section 41 of this title, or any other
14 state military force that does not meet this definition shall not be
15 considered part of the "state military forces" under the Code;

16 54. "Superior commissioned officer" means a commissioned
17 officer superior in rank or command;

18 55. "Supplies" means materiel, equipment and stores of all
19 types possessed or lawfully controlled by state military forces; and

20 56. "Title 32 active duty" means training or other duty, other
21 than inactive duty, performed by a member of the Army National Guard
22 of the United States or the Air National Guard of the United States
23 in the member's status as a member of the Oklahoma National Guard
24 pursuant to Section 316, 502, 503, 504 or 505 of Title 32 of the

1 United States Code for which the member is entitled to pay from the
2 United States or for which the member has waived pay from the United
3 States.

4 B. Other terms not specifically defined herein shall be defined
5 by military rules or regulations and customs and usage of the
6 National Guard and the Armed Forces of the United States.

7 C. If a term is not defined in either subsection A of this
8 section nor defined as provided in subsection B of this section, it
9 shall receive the construction and usage customarily accorded by
10 reference to dictionaries of the English language in existence at
11 the time of adoption of this act.

12 SECTION 6. NEW LAW A new section of law to be codified
13 in the Oklahoma Statutes as Section 802 of Title 44, unless there is
14 created a duplication in numbering, reads as follows:

15 ARTICLE 2. Persons subject to the Oklahoma Uniform Code of
16 Military Justice.

17 A. The Oklahoma Uniform Code of Military Justice applies to all
18 members of the state military forces at all times who are not in
19 active federal service, as defined by Title 10 of the United States
20 Code.

21 B. Subject matter jurisdiction is established if more likely
22 than not a nexus exists between an offense, either military or
23 nonmilitary, and the state military forces. Courts-martial shall
24

1 have primary jurisdiction over military offenses as defined in the
2 Code.

3 C. The civilian courts shall have primary jurisdiction over
4 nonmilitary offenses when an act or omission violates both the Code
5 and local criminal law. In such a case, a court-martial may be
6 initiated only after the civilian authority has declined to
7 prosecute or has dismissed the charge, provided jeopardy has not
8 attached. When a member is not in a duty status under Title 32 of
9 the United States Code or on state active duty orders, there shall
10 be a rebuttable presumption that subject matter jurisdiction does
11 not exist under the Code. The Governor or Adjutant General may
12 promulgate additional regulations prescribing how a convening
13 authority shall determine the existence of a nexus between a
14 nonmilitary offense and state military forces.

15 D. Jurisdiction over attempted crimes, conspiracy crimes,
16 solicitation and accessory crimes shall be determined by the
17 underlying offense.

18 E. If a commander or officer in charge determines that a nexus
19 exists between a nonmilitary offense and the state military forces,
20 for purposes of administrative action, the commander or officer in
21 charge may impose nonjudicial punishment regardless of whether
22 courts-martial jurisdiction is then possessed or later acquired by
23 the state military forces.

1 SECTION 7. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 803 of Title 44, unless there is
3 created a duplication in numbering, reads as follows:

4 ARTICLE 3. Jurisdiction to try certain personnel.

5 A. Each person discharged from the state military forces who is
6 later charged with having fraudulently obtained a discharge is,
7 subject to Section 904A of this title, subject to trial by court-
8 martial on that charge and is, after apprehension, subject to the
9 Oklahoma Uniform Code of Military Justice while in custody under the
10 direction of the state military forces for that trial. Upon
11 conviction of the charge, the person shall be subject to trial by
12 court-martial for all offenses under the Oklahoma Uniform Code of
13 Military Justice committed before the fraudulent discharge.

14 B. No person who has deserted from the state military forces
15 shall be relieved from amenability to the jurisdiction of the
16 Oklahoma Uniform Code of Military Justice by virtue of a separation
17 from any later period of service.

18 SECTION 8. NEW LAW A new section of law to be codified
19 in the Oklahoma Statutes as Section 804 of Title 44, unless there is
20 created a duplication in numbering, reads as follows:

21 RESERVED.

22 SECTION 9. NEW LAW A new section of law to be codified
23 in the Oklahoma Statutes as Section 805 of Title 44, unless there is
24 created a duplication in numbering, reads as follows:

1 ARTICLE 5. Territorial applicability of Oklahoma Uniform Code
2 of Military Justice.

3 The Oklahoma Uniform Code of Military Justice applies at all
4 times and in all places. Courts-martial and courts of inquiry may
5 be convened while state military forces are deployed outside the
6 state with the same jurisdiction and powers as if the proceedings
7 were held inside the state, and offenses committed outside the state
8 may be tried and punished either inside or outside of the state.

9 SECTION 10. NEW LAW A new section of law to be codified
10 in the Oklahoma Statutes as Section 806 of Title 44, unless there is
11 created a duplication in numbering, reads as follows:

12 ARTICLE 6. Judge advocates.

13 A. The senior force component judge advocates in each of the
14 state's military force components or those judge advocates'
15 delegates shall make frequent inspections in the field in
16 supervision of the administration of military justice in that force
17 component.

18 B. Convening authorities shall at all times communicate
19 directly with their judge advocates in matters relating to the
20 administration of military justice. The judge advocate of any
21 command is entitled to communicate directly with the judge advocate
22 of a superior or subordinate command, or with the State Judge
23 Advocate.

24

1 C. No person who, with respect to a case, serves in a capacity
2 specified in subsection D of this section may later serve as a judge
3 advocate to any reviewing or convening authority upon the same case.

4 D. The capacities referred to in subsection C of this section
5 are, with respect to the case involved, any of the following:

6 1. Preliminary hearing officer, court member, military judge,
7 military magistrate, or appellate judge; or

8 2. Counsel who have acted in the same case or appeared in any
9 proceeding before a military judge, preliminary hearing officer, or
10 appellate court.

11 SECTION 11. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 806A of Title 44, unless there
13 is created a duplication in numbering, reads as follows:

14 ARTICLE 6A. Investigation and disposition of matters pertaining
15 to the fitness of military judges.

16 The Adjutant General shall promulgate regulations prescribing
17 procedures for the investigation and disposition of charges,
18 allegations, or information pertaining to the fitness of a military
19 judge to perform the duties of the judge's position. To the extent
20 practicable, the procedures shall be uniform for both force
21 components.

22 SECTION 12. NEW LAW A new section of law to be codified
23 in the Oklahoma Statutes as Section 806B of Title 44, unless there
24 is created a duplication in numbering, reads as follows:

1 ARTICLE 6B. Rights of the victim of an offense under the
2 Oklahoma Uniform Code of Military Justice.

3 A. A victim of an offense under the Oklahoma Uniform Code of
4 Military Justice has the following rights:

5 1. The right to be reasonably protected from the accused;

6 2. The right to reasonable, accurate and timely notice of any
7 of the following:

8 a. a public hearing concerning the continuation of
9 confinement prior to trial of the accused,

10 b. a preliminary hearing under Section 832 of this title
11 (Article 32) relating to the offense,

12 c. a court-martial relating to the offense,

13 d. a public proceeding of the parole board relating to
14 the offense, and

15 e. the release or escape of the accused, unless such
16 notice may endanger the safety of any person;

17 3. The right not to be excluded from any public hearing or
18 proceeding described in paragraph 2 of this subsection unless the
19 military judge or preliminary hearing officer, as applicable, after
20 receiving clear and convincing evidence, determines that testimony
21 by the victim of an offense under the Code would be materially
22 altered if the victim heard other testimony at that hearing or
23 proceeding;

24 4. The right to be reasonably heard at any of the following:

- a. a public hearing concerning the continuation of confinement prior to trial of the accused,
- b. a sentencing hearing relating to the offense, and
- c. a public proceeding of the parole board relating to the offense;

5. The reasonable right to confer with the counsel representing the government at any proceeding described in paragraph 2 of this subsection;

6. The right to receive restitution as provided in law;

7. The right to proceedings free from unreasonable delay; and

8. The right to be treated with fairness and with respect for the dignity and privacy of the victim of an offense under the Code.

B. In this section, the term "victim of an offense under the Code" means an individual who has suffered direct physical, emotional, or pecuniary harm as a result of the commission of an offense under the Oklahoma Uniform Code of Military Justice.

C. Nothing in this section shall be construed:

1. To authorize a cause of action for damages; or

2. To create, to enlarge, or to imply any duty or obligation to any victim of an offense under the Code or other person for the breach of which the State of Oklahoma or any of its officers or employees could be held liable in damages.

D. Enforcement by Military Court of Appeals.

1 1. If the victim of an offense under the Code believes that a
2 preliminary hearing ruling under Section 832 of this title (Article
3 32) or a court-martial ruling violates the rights of the victim
4 afforded by paragraph 4 of subsection A of this section the victim
5 may petition the Military Court of Appeals for a writ of mandamus to
6 require the preliminary hearing officer or the court-martial to
7 comply with the provisions of paragraph 4 of subsection A of this
8 section.

9 2. If the victim of an offense under the Code is subject to an
10 order to submit to a deposition, notwithstanding the availability of
11 the victim to testify at the court-martial trying the accused for
12 the offense, the victim may petition the Military Court of Appeals
13 for a writ of mandamus to quash such order.

14 3. A petition for a writ of mandamus described in this
15 subsection shall be forwarded directly to the Military Court of
16 Appeals, by such means as may be prescribed by regulations
17 promulgated by the Adjutant General, and, to the extent practicable,
18 shall have priority over all other proceedings before the court.

19 4. Paragraph 1 of this subsection applies with respect to the
20 protections afforded by the following:

- 21 a. this section,
 - 22 b. Section 832 (Article 32) of the Code,
- 23
24

- c. Military Rule of Evidence 412, relating to the admission of evidence regarding a victim's sexual background,
- d. Military Rule of Evidence 513, relating to the psychotherapist-patient privilege,
- e. Military Rule of Evidence 514, relating to the victim advocate-victim privilege,
- f. Military Rule of Evidence 615, relating to the exclusion of witnesses.

PART II.

APPREHENSION AND RESTRAINT

SECTION 13. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 807 of Title 44, unless there is created a duplication in numbering, reads as follows:

ARTICLE 7. Apprehension.

A. Apprehension is the taking of a person into custody.

B. Any person authorized by the Oklahoma Uniform Code of Military Justice or by Chapter 47 of Title 10 of the United States Code, or by regulations issued under either, to apprehend persons subject to the Oklahoma Uniform Code of Military Justice, any marshal of a court-martial appointed pursuant to the provisions of the Code, and any civil officer or peace officer having authority to apprehend offenders under the laws of the United States or of a

1 state, may do so upon reasonable belief that an offense has been
2 committed and that the person apprehended committed it.

3 C. Commissioned officers, warrant officers and noncommissioned
4 officers have authority to quell quarrels, frays, and disorders
5 among persons subject to the Code and to apprehend persons subject
6 to the Code who take part therein.

7 SECTION 14. NEW LAW A new section of law to be codified
8 in the Oklahoma Statutes as Section 808 of Title 44, unless there is
9 created a duplication in numbering, reads as follows:

10 ARTICLE 8. Warrant of arrest, issuance, contents, service.

11 A. A warrant of arrest for the purposes of securing the
12 presence of an accused at any court-martial proceedings or in
13 execution of a sentence of confinement may be issued by a general or
14 special court-martial convening authority.

15 B. The warrant issued under this section shall:

16 1. Be in writing and in the name of the State of Oklahoma;

17 2. State the date when issued and the municipality or county
18 where issued;

19 3. State the name and rank of the person to be arrested;

20 4. State the offense charged against the person to be arrested;

21 5. Command that the person against whom the complaint was made
22 be arrested, conducted to a designated civil or military facility
23 under the control of the state or federal government, placed in
24 custody as directed, and booked;

1 6. Be signed by an authorized officer of the armed forces of
2 this state; and

3 7. Specify the amount of bail.

4 C. The warrant shall be directed to all peace officers in the
5 state or federal government and the provost marshal of the Oklahoma
6 National Guard. Such officers shall have the power and authority to
7 conduct the arrested person to the designated facility without
8 regard to territorial jurisdiction.

9 SECTION 15. NEW LAW A new section of law to be codified
10 in the Oklahoma Statutes as Section 809 of Title 44, unless there is
11 created a duplication in numbering, reads as follows:

12 ARTICLE 9. Imposition of restraint.

13 A. Arrest is the restraint of a person by an order, not imposed
14 as a punishment for an offense, directing that person to remain
15 within certain specified limits. Confinement is the physical
16 restraint of a person.

17 B. An enlisted member may be ordered into arrest or confinement
18 by any commissioned officer by an order, oral or written, delivered
19 in person or through other persons subject to the Oklahoma Uniform
20 Code of Military Justice. A commanding officer may authorize
21 warrant officers or noncommissioned officers to order enlisted
22 members of his or her command or subject to his or her authority
23 into arrest or confinement.

1 C. A commissioned officer or a warrant officer may be ordered
2 into arrest or confinement only by a commanding officer to whose
3 authority he or she is subject, by an order, oral or written,
4 delivered in person, or by another commissioned officer. The
5 authority to order such persons into arrest or confinement shall not
6 be delegated.

7 D. No person may be ordered into arrest or confinement except
8 for probable cause.

9 E. Nothing in this section limits the authority of persons
10 authorized to apprehend offenders to secure the custody of an
11 alleged offender until proper authority may be notified.

12 SECTION 16. NEW LAW A new section of law to be codified
13 in the Oklahoma Statutes as Section 810 of Title 44, unless there is
14 created a duplication in numbering, reads as follows:

15 ARTICLE 10. Restraint of persons charged.

16 A. 1. Unless otherwise provided in paragraph 2 of this
17 subsection, any person subject to the Oklahoma Uniform Code of
18 Military Justice who is charged with an offense under the Code may
19 be ordered into arrest or confinement, as the circumstances require.

20 2. When a person subject to the Code is charged only with an
21 offense that is normally tried by summary court-martial, the person
22 ordinarily shall not be ordered into confinement.

23 B. 1. When a person subject to the Code is ordered into arrest
24 or confinement before trial, immediate steps shall be taken:

- a. to inform the person of the specific offense of which the person is accused, and
- b. to try the person or to dismiss the charges and release the person.

2. To facilitate compliance with paragraph 1 of this subsection, the Adjutant General shall promulgate regulations setting forth procedures relating to referral for trial, including procedures for prompt forwarding of the charges and specifications and, if applicable, the preliminary hearing report submitted under Section 832 of this title (Article 32).

SECTION 17. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 811 of Title 44, unless there is created a duplication in numbering, reads as follows:

ARTICLE 11. Place of confinement, reports and receiving of prisoners.

A. Persons confined before or during trial by court-martial shall be confined in any place of confinement under the control of any of the armed forces, in any county jail or in any penal or correctional facility under the control of the Oklahoma Department of Corrections.

B. No provost marshal, commander of a guard, master at arms, warden, keeper, or officer of a place of confinement designated in subsection A of this section shall refuse to receive or keep any prisoner committed to his or her charge, when the committing person

1 furnishes a statement, signed by him or her, of the offense charged
2 against the prisoner.

3 C. Every commander of a guard, master at arms, warden, keeper,
4 or officer of a place of confinement designated in subsection A of
5 this section, to whose charge a prisoner is committed shall, within
6 twenty-four (24) hours after that commitment or as soon as he or she
7 is relieved from guard, report to the commanding officer of the
8 prisoner the name of the prisoner, the offense charged against him
9 or her, and the name of the person who ordered or authorized the
10 commitment.

11 SECTION 18. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 812 of Title 44, unless there is
13 created a duplication in numbering, reads as follows:

14 ARTICLE 12. Prohibition of confinement of members of the state
15 military forces with enemy prisoners and certain others.

16 No member of the state military forces shall be placed in
17 confinement in immediate association with:

18 1. Enemy prisoners; or

19 2. Other individuals:

20 a. who are detained under the law of war and are foreign
21 nationals, and

22 b. who are not members of the armed forces.

23

24

1 SECTION 19. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 813 of Title 44, unless there is
3 created a duplication in numbering, reads as follows:

4 ARTICLE 13. Punishment prohibited before trial.

5 No person, while being held for trial, shall be subjected to
6 punishment or penalty other than arrest or confinement upon the
7 charges pending against him or her, nor shall the arrest or
8 confinement imposed upon him or her be any more rigorous than the
9 circumstances required to insure his or her presence, but he or she
10 may be subjected to minor punishment during that period for
11 infractions of discipline.

12 SECTION 20. NEW LAW A new section of law to be codified
13 in the Oklahoma Statutes as Section 814 of Title 44, unless there is
14 created a duplication in numbering, reads as follows:

15 ARTICLE 14. Delivery of offenders to civil authorities.

16 A. Under such regulations as the Adjutant General may
17 prescribe, a person subject to the Oklahoma Uniform Code of Military
18 Justice who is in a duty status and who is accused of an offense
19 against civil authority may be delivered, upon request, to the civil
20 authority for trial.

21 B. When delivery under this section is made to any civil
22 authority of a person undergoing sentence of a court-martial, the
23 delivery, if followed by conviction in a civil tribunal, interrupts
24 the execution of the sentence of the court-martial, and the

1 offender, after having answered to the civil authorities of his or
2 her offense shall, upon the request of competent military authority,
3 be returned to the place of original custody for the completion of
4 his or her sentence.

5 PART III.

6 NONJUDICIAL PUNISHMENT

7 SECTION 21. NEW LAW A new section of law to be codified
8 in the Oklahoma Statutes as Section 815 of Title 44, unless there is
9 created a duplication in numbering, reads as follows:

10 ARTICLE 15. Commanding officer's nonjudicial punishment.

11 A. Except as provided in subsection B of this section, any
12 commanding officer and, for purposes of this section, any officer in
13 charge, may impose disciplinary punishments for minor offenses
14 arising under the punitive articles of the Oklahoma Uniform Code of
15 Military Justice without the intervention of a court-martial.

16 B. Any superior commander may limit or withhold the exercise of
17 nonjudicial punishment authority by subordinate commanders,
18 including limiting authority over certain categories of military
19 personnel or offenses. Likewise, individual cases may be reserved
20 by a superior commander. A superior authority may limit or withhold
21 any power that a subordinate might otherwise exercise under this
22 article.

23 C. Except as provided in subsection K of this section, the
24 Governor, the Adjutant General, or a general officer in command may

1 delegate the powers established under this section to a principal
2 assistant who is a member of the state military forces and is also a
3 member of the same force component as the accused.

4 D. Any commanding officer may impose upon enlisted members of
5 the officer's command:

- 6 1. An admonition;
- 7 2. A reprimand;
- 8 3. The withholding of privileges for not more than six (6)
9 months which need not be consecutive;
- 10 4. The forfeiture of pay of not more than seven (7) days' pay;
- 11 5. A fine of not more than seven (7) days' pay;
- 12 6. A reduction to the next inferior pay grade, if the grade
13 from which demoted is within the promotion authority of the officer
14 imposing the reduction or any officer subordinate to the one who
15 imposes the reduction;
- 16 7. Extra duties, including fatigue or other duties, for not
17 more than fourteen (14) days, which need not be consecutive; and
- 18 8. Restriction to certain specified limits, with or without
19 suspension from duty, for not more than fourteen (14) days, which
20 need not be consecutive.

21 E. Any commanding officer of the grade of major or above may
22 impose upon enlisted members of the officer's command:

- 23 1. An admonition;
- 24 2. A reprimand;

1 3. The withholding of privileges for not more than six (6)
2 months which need not be consecutive;

3 4. The forfeiture of not more than one-half (1/2) of one (1)
4 month's pay per month for two (2) months;

5 5. A fine of not more than one (1) month's pay;

6 6. A reduction to the lowest or any intermediate pay grade, if
7 the grade from which demoted is within the promotion authority of
8 the officer imposing the reduction or any officer subordinate to the
9 one who imposes the reduction, but an enlisted member in a pay grade
10 above E-4 shall not be reduced more than two pay grades;

11 7. Extra duties, including fatigue or other duties, for not
12 more than forty-five (45) days which need not be consecutive; and

13 8. Restriction to certain specified limits, with or without
14 suspension from duty, for not more than sixty (60) days which need
15 not be consecutive.

16 F. The Governor, the Adjutant General, an officer exercising
17 general or special court-martial convening authority, or a general
18 officer in command may impose:

19 1. Upon officers of the officer's command:

20 a. any punishment authorized in subsection E of this
21 section, except for the punishments provided in
22 paragraphs 6 and 7 of subsection E of this section,
23 and
24

b. arrest in quarters for not more than thirty (30) days
which need not be consecutive; and

2. Upon enlisted members of the officer's command, any
punishment authorized in subsection E of this section.

Admonitions or reprimands given as nonjudicial punishment to
commissioned officers and warrant officers shall be administered in
writing. In all other cases, unless otherwise prescribed by
regulations promulgated by the Adjutant General, such punishments
may be administered either orally or in writing.

G. Whenever any punishments are combined to run consecutively,
the total length of the combined punishment shall not exceed the
authorized duration of the longest punishment included in the
combination, and there shall be an apportionment of punishments so
that no single punishment in the combination exceeds its authorized
length under this section.

H. The right to demand trial by court-martial in lieu of
nonjudicial punishment shall arise only when arrest in quarters or
restriction will be considered as punishments. If the commanding
officer determines that arrest in quarters or restriction will be
considered as punishments, prior to the offer of nonjudicial
punishment, the accused shall be notified in writing of the right to
demand trial by court-martial. Should the commanding officer
determine that the punishment options will not include arrest in
quarters or restriction, the accused shall be notified that there is

1 no right to trial by court-martial in lieu of nonjudicial
2 punishment. Upon notification by the commander or officer in charge
3 of his or her intent to impose nonjudicial punishment, the accused
4 shall be afforded a reasonable amount of time to confer with legal
5 counsel and to prepare a response.

6 I. The officer who imposes the punishment, or the successor in
7 command, may, at any time, suspend, set aside, mitigate, or remit
8 any part or amount of the punishment and restore all rights,
9 privileges, and property affected. The officer also may:

- 10 1. Mitigate reduction in grade to forfeiture of pay;
- 11 2. Mitigate arrest in quarters to restriction; or
- 12 3. Mitigate extra duties to restriction.

13 The mitigated punishment shall not be for a greater period than the
14 punishment mitigated. When mitigating reduction in grade to
15 forfeiture of pay, the amount of the forfeiture shall not be greater
16 than the amount that could have been imposed initially under this
17 section by the officer who imposed the punishment mitigated.

18 J. A person punished under this section who considers the
19 punishment unjust or disproportionate to the offense may, through
20 his or her chain of command, appeal to the Senior Assistant Adjutant
21 General of the same component of the state military forces as the
22 accused within fifteen (15) days after the punishment is announced
23 to the accused. The officer exercising appellate authority may, at
24 his or her discretion, extend the deadline for an appeal. The

1 appeal shall be promptly forwarded and decided, and the member shall
2 not be punished until the appeal is decided. The Senior Assistant
3 Adjutant General exercising appellate authority may exercise the
4 same powers with respect to the punishment imposed as may be
5 exercised under subsection I of this section by the officer who
6 imposed the punishment. Before acting on an appeal from a
7 punishment, the Senior Assistant Adjutant General shall refer the
8 case to a judge advocate for consideration and advice.

9 K. Except for nonjudicial punishment imposed by the Governor or
10 the Adjutant General, the final appellate authority for nonjudicial
11 punishment imposed within state military forces is the Adjutant
12 General. A person punished under this article whose appeal was
13 previously denied by a Senior Assistant Adjutant General may lodge
14 an additional appeal with the Adjutant General within five (5) days
15 after the appeal is denied. In the event the officer imposing
16 nonjudicial punishment is the Senior Assistant Adjutant General, an
17 appeal thereof shall be addressed directly to the Adjutant General.
18 In the event the officer imposing nonjudicial punishment is the
19 Adjutant General, an appeal thereof shall be addressed directly to
20 the Governor. An appeal offered pursuant to this subsection shall
21 be made only in writing. Neither the Governor nor the Adjutant
22 General shall delegate their duties as an appellate authority under
23 this subsection.

1 L. Whenever nonjudicial punishment is imposed under this
2 article:

3 1. After adjudication and while the punishment is being carried
4 out or while the adjudged punishment is pending before the appellate
5 authority, the commander or officer in charge who imposed the
6 nonjudicial punishment, upon the request of the accused, may:

7 a. excuse the accused from attendance at scheduled unit
8 training assemblies, or

9 b. arrange for the accused to drill on alternate dates
10 and in alternate locations; or

11 2. If necessary to maintain good order and discipline within
12 the unit, the commander or officer in charge who imposed the
13 nonjudicial punishment may order the accused to drill on alternate
14 dates and in alternate locations. The order shall be reduced to
15 writing and shall become part of the record of nonjudicial
16 punishment.

17 M. The imposition and enforcement of disciplinary punishment
18 under this section for any act or omission shall not be a bar to
19 trial by court-martial or a civilian court of competent jurisdiction
20 for a crime or offense arising out of the same act or omission; but
21 the fact that a disciplinary punishment has been enforced may be
22 demonstrated by the accused upon trial and, when so demonstrated, it
23 shall be considered in determining the measure of punishment to be
24 adjudged in the event of a finding or verdict of guilty.

1 Nonjudicial punishment shall not be imposed for an offense
2 previously tried by a civilian court unless so authorized by
3 regulations promulgated by the Adjutant General.

4 N. When nonjudicial punishment has been imposed for an offense,
5 punishment shall not again be imposed for the same offense under
6 this section. Once nonjudicial punishment has been imposed, it may
7 not be increased, upon appeal or otherwise. When a commander or
8 officer in charge determines that nonjudicial punishment is
9 appropriate for a particular member, all known offenses determined
10 to be appropriate for disposition by nonjudicial punishment and
11 ready to be considered at that time, including all offenses arising
12 from a single incident or course of conduct, shall be considered
13 together and shall not be made the basis for multiple punishments.
14 This subsection shall in no way restrict the right of a commander to
15 prefer court-martial charges for an offense previously punished
16 under the provisions of this article.

17 O. In accordance with subsection B of Section 843 of this title
18 (Article 43, subsection B), a person accused of an offense is not
19 liable to be punished under this section if the offense was
20 committed more than two (2) years before the imposition of
21 punishment. Periods in which the accused is absent without
22 authority shall be excluded in computing the period of limitation
23 prescribed in this section.

24

1 P. Whenever a punishment of forfeiture of pay is imposed under
2 this section, the forfeiture shall not apply to pay accruing before
3 the date that punishment is imposed, but only pay accruing on or
4 after the date that punishment is imposed.

5 Q. The Adjutant General may promulgate regulations prescribing
6 the type and form of records to be kept of proceedings conducted
7 pursuant to this section. The Adjutant General may promulgate any
8 other regulations necessary to carry out the provisions of this
9 section.

10 PART IV.

11 COURTS-MARTIAL JURISDICTION

12 SECTION 22. NEW LAW A new section of law to be codified
13 in the Oklahoma Statutes as Section 816 of Title 44, unless there is
14 created a duplication in numbering, reads as follows:

15 ARTICLE 16. Courts-martial classified.

16 A. The three kinds of courts-martial in the state military
17 forces are the following:

18 1. General courts-martial, as described in subsection B of this
19 section;

20 2. Special courts-martial, as described in subsection C of this
21 section; and

22 3. Summary courts-martial, as described in subsection D of this
23 section.

1 B. General courts-martial. General courts-martial are of the
2 following two types:

3 1. A general court-martial consisting of a military judge and
4 eight members, subject to paragraph 3 of subsection E of Section 825
5 and Section 829 of this title (Article 25, subsection E, paragraph
6 3, and Article 29); and

7 2. A general court-martial consisting of a military judge
8 alone, if, before the court is assembled, the accused, knowing the
9 identity of the military judge and after consultation with defense
10 counsel, requests, orally on the record or in writing, a court
11 composed of a military judge alone and the military judge approves
12 the request.

13 C. Special courts-martial. Special courts-martial are of the
14 following two types:

15 1. A special court-martial consisting of a military judge and
16 four members, subject to paragraph 3 of subsection E of Section 825
17 and Section 829 of this title (Article 25, subsection E, paragraph
18 3, and Article 29); and

19 2. A special court-martial consisting of a military judge
20 alone:

21 a. if the case is so referred by the convening authority,
22 subject to Section 819 of this title (Article 19) and
23 such limitations as may be prescribed by regulations
24 promulgated by the Adjutant General, or

1 b. if the case is referred under paragraph 1 of this
2 subsection and, before the court is assembled, the
3 accused, knowing the identity of the military judge
4 and after consultation with defense counsel, requests,
5 orally on the record or in writing, a court composed
6 of a military judge alone and the military judge
7 approves the request.

8 D. Summary court-martial. A summary court-martial consists of
9 one commissioned officer.

10 SECTION 23. NEW LAW A new section of law to be codified
11 in the Oklahoma Statutes as Section 817 of Title 44, unless there is
12 created a duplication in numbering, reads as follows:

13 ARTICLE 17. Jurisdiction of courts-martial in general.

14 A. Each force component shall have court-martial jurisdiction
15 over all persons subject to the Oklahoma Uniform Code of Military
16 Justice. The exercise of jurisdiction by one force component over
17 personnel of the other force component shall be in accordance with
18 regulations promulgated by the Adjutant General.

19 B. In all cases, the force component review after that by the
20 officer with authority to convene a general court-martial for the
21 command which held the trial, where that review is required under
22 the Code, shall be carried out by the same force component of which
23 the accused is a member.

1 SECTION 24. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 818 of Title 44, unless there is
3 created a duplication in numbering, reads as follows:

4 ARTICLE 18. General courts-martial.

5 Subject to Section 817 of this title (Article 17), general
6 courts-martial shall have jurisdiction to try persons subject to the
7 Oklahoma Uniform Code of Military Justice for any offense made
8 punishable by the Code and may, under such limitations as the
9 Governor or Adjutant General may prescribe by regulation, adjudge
10 any punishment not forbidden by the Code.

11 SECTION 25. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 819 of Title 44, unless there is
13 created a duplication in numbering, reads as follows:

14 ARTICLE 19. Jurisdiction of special courts-martial.

15 A. Subject to Section 817 of this title (Article 17), special
16 courts-martial have jurisdiction to try persons subject to the
17 Oklahoma Uniform Code of Military Justice for any offense made
18 punishable by the Code and may, under such limitations prescribed by
19 regulation promulgated by the Governor or Adjutant General, adjudge
20 any punishment not forbidden by the Code except dishonorable
21 discharge, dismissal, confinement for more than one (1) year,
22 forfeiture of pay exceeding two-thirds (2/3) pay per month, or
23 forfeiture of pay for more than one (1) year.

1 B. Neither confinement for more than six (6) months, nor
2 forfeiture of pay for more than six (6) months may be adjudged if
3 charges and specifications are referred to a special court-martial
4 consisting of a military judge alone under subparagraph a of
5 paragraph 2 of subsection C of Section 816 of this title (Article
6 16, subsection C, paragraph 2, subparagraph a).

7 SECTION 26. NEW LAW A new section of law to be codified
8 in the Oklahoma Statutes as Section 820 of Title 44, unless there is
9 created a duplication in numbering, reads as follows:

10 ARTICLE 20. Jurisdiction and appeals of summary courts-martial.

11 A. Subject to Section 817 of this title (Article 17), summary
12 courts-martial have jurisdiction to try persons subject to the
13 Oklahoma Uniform Code of Military Justice, except officers, cadets
14 and officer candidates for any offense made punishable by the Code
15 under such limitations as may be prescribed by regulation
16 promulgated by the Governor or Adjutant General. No person with
17 respect to whom summary courts-martial have jurisdiction shall be
18 brought to trial before a summary court-martial if he or she objects
19 thereto. If objection to trial by summary court-martial is made by
20 an accused, trial may be ordered by special or general court-martial
21 as may be appropriate. Summary courts-martial may, under such
22 limitations as may be prescribed by regulation promulgated by the
23 Governor or Adjutant General, adjudge any punishment not forbidden
24 by the Code except dismissal, dishonorable or bad-conduct discharge,

1 confinement for more than one (1) month, hard labor without
2 confinement for more than forty-five (45) days, restriction to
3 specified limits for more than two (2) months, or forfeiture of more
4 than two-thirds (2/3) of one (1) month's pay.

5 B. A summary court-martial is a noncriminal forum. A finding
6 of guilty at a summary court-martial does not constitute a criminal
7 conviction.

8 C. Regular appeals. A person found guilty at a summary court-
9 martial who considers the punishment unjust or disproportionate to
10 the offense may appeal to the Senior Assistant Adjutant General of
11 the same component of the state military forces as the accused
12 within thirty (30) calendar days after the date the accused receives
13 written notice from the convening authority that the convening
14 authority has complied with the requirements of subsection B of
15 Section 860C of this title (Article 860C, subsection B). Before
16 acting on an appeal submitted pursuant to this subsection, the
17 Senior Assistant Adjutant General shall refer the case to a judge
18 advocate for consideration and advice.

19 D. Appeals in certain instances. Except for summary courts-
20 martial convened by the Governor or the Adjutant General, the final
21 appellate authority for summary courts-martial convened pursuant to
22 this Code shall be the Adjutant General. A person found guilty at a
23 summary court-martial whose appeal was previously denied by the
24 Senior Assistant Adjutant General may lodge an additional appeal

1 with the Adjutant General within fifteen (15) calendar days after
2 the appeal is denied. In the event the officer who convened the
3 summary court-martial is the Senior Assistant Adjutant General, an
4 appeal thereof shall be addressed directly to the Adjutant General.
5 In the event the officer who convened the summary court-martial is
6 the Adjutant General, an appeal thereof shall be addressed directly
7 to the Governor. An appeal offered pursuant to this subsection
8 shall be made only in writing. Neither the Governor nor the
9 Adjutant General shall delegate their duties as an appellate
10 authority under this subsection.

11 E. The Adjutant General may promulgate regulations prescribing
12 the type and form of records to be kept of appellate proceedings
13 undertaken pursuant to subsections C and D of this section.

14 SECTION 27. NEW LAW A new section of law to be codified
15 in the Oklahoma Statutes as Section 821 of Title 44, unless there is
16 created a duplication in numbering, reads as follows:

17 RESERVED.

18 PART V.

19 COMPOSITION OF COURTS-MARTIAL

20 SECTION 28. NEW LAW A new section of law to be codified
21 in the Oklahoma Statutes as Section 822 of Title 44, unless there is
22 created a duplication in numbering, reads as follows:

23 ARTICLE 22. Who may convene general courts-martial.

24 A. General courts-martial may be convened by:

1 1. The Governor;

2 2. The Adjutant General;

3 3. Any other commanding officer in the state military forces
4 designated by the Adjutant General; or

5 4. Any other commanding officer in the state military forces
6 designated by the Governor.

7 B. If any such officer is an accuser, the court shall be
8 convened by superior competent authority, and may in any case be
9 convened by such authority if considered desirable by that superior
10 authority.

11 SECTION 29. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 823 of Title 44, unless there is
13 created a duplication in numbering, reads as follows:

14 ARTICLE 23. Who may convene special courts-martial.

15 A. Special courts-martial may be convened by:

16 1. Any person who may convene a general court-martial;

17 2. The Senior Assistant Adjutant General of the same component
18 of the state military forces as the accused;

19 3. The officer designated as the army land component commander
20 when the accused is a member of the army component of state military
21 forces;

22 4. The officer designated as the air component commander when
23 the accused is a member of the air component of state military
24 forces;

1 5. The commanding officer of a brigade in the army component of
2 state military forces;

3 6. The commanding officer of a wing in the air component of
4 state military forces; or

5 7. Any other commanding officer designated by the Adjutant
6 General.

7 B. If any such officer is an accuser, the court shall be
8 convened by superior competent authority, and may in any case be
9 convened by such authority if considered desirable by that superior
10 authority.

11 SECTION 30. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 824 of Title 44, unless there is
13 created a duplication in numbering, reads as follows:

14 ARTICLE 24. Who may convene summary courts-martial.

15 A. Summary courts-martial may be convened by:

16 1. Any person who may convene a general or special court-
17 martial;

18 2. The commanding officer of a battalion in the army component
19 of state military forces;

20 3. The commanding officer of a group in the air component of
21 state military forces; or

22 4. Any other commanding officer designated by the Adjutant
23 General.

1 B. If any such officer is an accuser, the court shall be
2 convened by superior competent authority, and may in any case be
3 convened by such authority if considered desirable by that superior
4 authority.

5 SECTION 31. NEW LAW A new section of law to be codified
6 in the Oklahoma Statutes as Section 825 of Title 44, unless there is
7 created a duplication in numbering, reads as follows:

8 ARTICLE 25. Who may serve on courts-martial.

9 A. Any commissioned officer who is a member of the same force
10 component as the accused is eligible to serve on all courts-martial
11 for the trial of any person who may lawfully be brought before such
12 courts for trial.

13 B. Any warrant officer who is a member of the same force
14 component as the accused is eligible to serve on general and special
15 courts-martial for the trial of any person, other than a
16 commissioned officer, who may lawfully be brought before such courts
17 for trial.

18 C. 1. Any enlisted member from the same force component as the
19 accused is eligible to serve on a general or special court-martial
20 for the trial of an enlisted member.

21 2. Before a court-martial with a military judge and members is
22 assembled for trial, an enlisted member who is an accused may
23 personally request, orally on the record or in writing, that:
24

1 a. the membership of the court-martial be comprised
2 entirely of officers, or

3 b. enlisted members comprise at least one-third of the
4 membership of the court-martial, regardless of whether
5 enlisted members have been detailed to the court-
6 martial.

7 3. After such a request, the accused may not be tried by a
8 general or special court-martial if the membership of the court-
9 martial is inconsistent with the request.

10 D. The accused in a court-martial with a military judge and
11 members may, after the findings are announced and before any matter
12 is presented in the sentencing phase, request, orally on the record
13 or in writing, sentencing by members.

14 E. 1. No person subject to the Oklahoma Uniform Code of
15 Military Justice may be tried by a court-martial any member of which
16 is junior to him or her in rank or grade.

17 2. When convening a court-martial, the convening authority
18 shall detail as members thereof such members of the same force
19 component as the accused as, in his or her opinion, are best
20 qualified for the duty by reason of age, education, training,
21 experience, length of service, and judicial temperament. No member
22 of the state military force is eligible to serve as a member of a
23 general or special court-martial when he or she is the accuser or a
24

1 witness or has acted as preliminary hearing officer or as counsel in
2 the same case.

3 3. The convening authority shall detail not less than the
4 number of members necessary to impanel the court-martial under
5 Section 829 of this title (Article 29).

6 F. Before a court-martial is assembled for the trial of a case,
7 the convening authority may excuse a member of the court from
8 participating in the case. Under regulations promulgated by the
9 Adjutant General, the convening authority may delegate his or her
10 authority under this subsection to his or her staff judge advocate,
11 to an assistant staff judge advocate or to any other principal
12 assistant.

13 SECTION 32. NEW LAW A new section of law to be codified
14 in the Oklahoma Statutes as Section 826 of Title 44, unless there is
15 created a duplication in numbering, reads as follows:

16 ARTICLE 26. Military judge of a general or special court-
17 martial.

18 A. A military judge shall be detailed to each general and
19 special court-martial. The Adjutant General shall promulgate
20 regulations prescribing the manner of selection, certification and
21 detailing of military judges for such general and special courts-
22 martial. The military judge shall preside over each open session of
23 the court-martial to which he or she has been detailed.

1 B. A military judge shall be a member of the bar of the highest
2 court of a state, or a member of the bar of a federal court.

3 C. A military judge shall be qualified, by reason of education,
4 training, experience, and judicial temperament, for duty as a
5 military judge and shall be one of the following:

6 1. A commissioned officer of the state military forces who is a
7 member of the bar of the highest court of a state, or a member of
8 the bar of a federal court, and who is certified to be qualified for
9 such duty by the State Judge Advocate;

10 2. A retired commissioned officer of the state military forces
11 who is a member of the bar of the highest court of a state, or a
12 member of the bar of a federal court, and who is certified to be
13 qualified for such duty by the State Judge Advocate;

14 3. A judge advocate in any department of the Armed Forces of
15 the United States serving on active duty within the meaning of Title
16 10 of the United States Code who is certified to be qualified for
17 duty as a military judge by the Judge Advocate General of the armed
18 force of which such military judge is a member;

19 4. A judge presently serving in any judicial district within
20 the State of Oklahoma who possesses at least one (1) year of trial
21 experience and who currently serves or previously served as a judge
22 advocate in any department of the Armed Forces of the United States,
23 to include reserve components of the same;

1 5. A retired judge or justice who served in any judicial
2 capacity within the judicial department of the State of Oklahoma and
3 who previously served as a judge advocate in any department of the
4 Armed Forces of the United States, to include reserve components of
5 the same;

6 6. A federal district court judge presently serving in any
7 federal judicial district within the State of Oklahoma who possesses
8 at least one (1) year of trial experience and who previously served
9 as a judge advocate in any department of the Armed Forces of the
10 United States, to include reserve components of the same; or

11 7. A retired federal district court judge or retired federal
12 appellate court judge who previously served as a judge advocate in
13 any department of the Armed Forces of the United States, to include
14 reserve components of the same.

15 D. 1. In accordance with regulations prescribed under
16 subsection A of this section, a military judge of a general or
17 special court-martial shall be designated for detail by the senior
18 force component judge advocate of the same force component as the
19 accused.

20 2. Neither the convening authority nor any member of the staff
21 of the convening authority shall prepare or review any report
22 concerning the effectiveness, fitness, or efficiency of the military
23 judge so detailed, which relates to the military judge's performance
24 of duty as a military judge.

1 3. A commissioned officer of the state military forces who is
2 certified to be qualified for duty as a military judge of a general
3 court-martial:

4 a. may perform such duties only when the officer is
5 assigned and directly responsible to the senior force
6 component judge advocate of the force component of
7 which the military judge is a member, and

8 b. may perform duties of a judicial or nonjudicial nature
9 other than those relating to the officer's primary
10 duty as a military judge of a general court-martial
11 only when such duties are assigned to the officer by
12 or with the approval of that senior force component
13 judge advocate.

14 4. A commissioned officer of any department of the Armed Forces
15 of the United States serving on active duty within the meaning of
16 Title 10 of the United States Code who, pursuant to the Oklahoma
17 Uniform Code of Military Justice and the regulations promulgated
18 pursuant to subsection A of this section, is certified to be
19 qualified for duty as a military judge of a general court-martial
20 shall not be assigned other duties of a judicial or nonjudicial
21 nature other than those relating to the officer's primary duty as a
22 military judge of a general court-martial, except when such duties
23 are assigned to the officer by or with the approval of the Judge
24

1 Advocate General of the armed force of which the military judge is a
2 member.

3 5. In accordance with regulations promulgated by the Adjutant
4 General, assignments of military judges under this Article who are
5 members of the state military forces shall be for appropriate
6 minimum periods, subject to such exceptions as may be authorized in
7 the regulations.

8 E. No person is eligible to act as military judge in a case if
9 he or she is the accuser, a witness or has acted as preliminary
10 hearing officer or a counsel in the same case.

11 F. The military judge of a court-martial may not consult with
12 the members of the court except in the presence of the accused,
13 trial counsel, and defense counsel, nor may he or she vote with the
14 members of the court.

15 G. A military judge who is a commissioned officer in the state
16 military forces may be detailed under subsection A of this section
17 to a court-martial or a proceeding under subsection A of Section 830
18 of this title (Article 30, subsection A) that is convened in a
19 different force component of the state military forces, when so
20 permitted by the senior force component judge advocate of the force
21 component of which the military judge is a member.

22 SECTION 33. NEW LAW A new section of law to be codified
23 in the Oklahoma Statutes as Section 826 of Title 44, unless there is
24 created a duplication in numbering, reads as follows:

1 RESERVED.

2 SECTION 34. NEW LAW A new section of law to be codified
3 in the Oklahoma Statutes as Section 827 of Title 44, unless there is
4 created a duplication in numbering, reads as follows:

5 ARTICLE 27. Detail of trial counsel and defense counsel.

6 A. 1. Trial counsel and defense counsel shall be detailed for
7 each general and special court-martial. Assistant trial counsel and
8 assistant and associate defense counsel may be detailed for each
9 general and special court-martial. The Adjutant General shall
10 promulgate regulations providing for the manner in which counsel are
11 detailed for such courts-martial and for the persons who are
12 authorized to detail counsel for such courts-martial.

13 2. No person who, with respect to a case, has served as a
14 preliminary hearing officer, court member, military judge, military
15 magistrate, or appellate judge, may later serve as trial counsel,
16 assistant trial counsel, or, unless expressly requested by the
17 accused, as defense counsel or assistant or associate defense
18 counsel in the same case. No person who has acted for the
19 prosecution may act later in the same case for the defense, nor may
20 any person who has acted for the defense act later in the same case
21 for the prosecution.

22 B. Trial counsel, defense counsel, or assistant defense counsel
23 detailed for a general or a special court-martial:
24

1 1. Shall be a judge advocate who is a graduate of an accredited
2 law school or is a member of the bar of a federal court or of the
3 highest court of a state; and

4 2. Shall be certified as competent to perform such duties by
5 the senior force component judge advocate of the same force
6 component of the state military forces of which he or she is a
7 member.

8 SECTION 35. NEW LAW A new section of law to be codified
9 in the Oklahoma Statutes as Section 828 of Title 44, unless there is
10 created a duplication in numbering, reads as follows:

11 ARTICLE 28. Detail or employment of reporters and interpreters.

12 Under such regulations as the Adjutant General may prescribe,
13 the convening authority of a court-martial or court of inquiry shall
14 detail or employ qualified court reporters, who shall record the
15 proceedings of and testimony taken before that court. Under like
16 regulations the convening authority of a court-martial or court of
17 inquiry may detail or employ interpreters who shall interpret for
18 the court.

19 SECTION 36. NEW LAW A new section of law to be codified
20 in the Oklahoma Statutes as Section 829 of Title 44, unless there is
21 created a duplication in numbering, reads as follows:

22 ARTICLE 29. Assembly and impaneling of members; detail of new
23 members and military judges.

1 A. The military judge shall announce the assembly of a general
2 or special court-martial with members. After such a court-martial
3 is assembled, no member may be absent, unless the member is excused:

4 1. As a result of a challenge;

5 2. Under subparagraph b of paragraph 1 of subsection B of this
6 section; or

7 3. By order of the military judge or the convening authority
8 for disability or other good cause.

9 B. 1. Under rules promulgated by the Adjutant General, the
10 military judge of a general or special court-martial with members
11 shall:

12 a. after determination of challenges, impanel the court-
13 martial, and

14 b. excuse the members who, having been assembled, are not
15 impaneled.

16 2. In a general court-martial, the military judge shall impanel
17 eight members.

18 3. In a special court-martial, the military judge shall impanel
19 four members.

20 C. In addition to members specified in subsection B of this
21 section, the military judge shall impanel alternate members, if the
22 convening authority authorizes alternate members.

23 D. 1. If, after members are impaneled, the membership of the
24 court-martial is reduced to:

1 a. fewer than six members with respect to a general
2 court-martial, or

3 b. fewer than four members with respect to a special
4 court-martial,

5 the trial may not proceed unless the convening authority details new
6 members and, from among the members so detailed, the military judge
7 impanels new members sufficient in number to provide the membership
8 specified in paragraph 2 of this subsection.

9 2. The membership referred to in paragraph 1 of this subsection
10 is as follows:

11 a. at least six but not more than eight members with
12 respect to a general court-martial, and

13 b. four members with respect to a special court-martial.

14 E. If the military judge is unable to proceed with the trial
15 because of disability or otherwise, a new military judge shall be
16 detailed to the court-martial.

17 F. 1. In the case of new members detailed under subsection D
18 of this section, the trial may proceed with the new members present
19 after the evidence previously introduced is read or, in the case of
20 audiotape, videotape, or similar recording, is played, in the
21 presence of the new members, the military judge, the accused, and
22 counsel for both sides.

23 2. In the case of a new military judge under subsection E of
24 this section, the trial shall proceed as if no evidence had been

1 introduced, unless the evidence previously introduced is read or, in
2 the case of audiotape, videotape, or similar recording, is played,
3 in the presence of the new military judge, the accused, and counsel
4 for both sides.

5 PART VI.

6 PRETRIAL PROCEDURE

7 SECTION 37. NEW LAW A new section of law to be codified
8 in the Oklahoma Statutes as Section 830 of Title 44, unless there is
9 created a duplication in numbering, reads as follows:

10 ARTICLE 30. Charges and specifications.

11 A. Charges and specifications:

12 1. May be preferred only by a person subject to the Oklahoma
13 Uniform Code of Military Justice; and

14 2. Shall be preferred by presentment in writing, signed under
15 oath before a commissioned officer of the armed forces who is
16 authorized to administer oaths.

17 B. The writing specified in paragraph 2 of subsection A of this
18 section shall state that the signer:

19 1. Has personal knowledge of, or has investigated, the matters
20 set forth in the charges and specifications; and

21 2. The matters set forth in the charges and specifications are
22 true, to the best of the knowledge and belief of the signer.
23
24

1 C. When charges and specifications are preferred under
2 subsection A of this section, the proper authority shall, as soon as
3 practicable:

4 1. Inform the person accused of the charges and specifications;
5 and

6 2. Determine what disposition should be made of the charges and
7 specifications in the interest of justice and discipline.

8 SECTION 38. NEW LAW A new section of law to be codified
9 in the Oklahoma Statutes as Section 831 of Title 44, unless there is
10 created a duplication in numbering, reads as follows:

11 ARTICLE 31. Compulsory self-incrimination prohibited.

12 A. No person subject to the Oklahoma Uniform Code of Military
13 Justice shall compel any person to incriminate himself or herself or
14 to answer any question the answer to which may tend to incriminate
15 him or her.

16 B. No person subject to the Code shall interrogate or request
17 any statement from an accused or a person suspected of an offense
18 without first informing that person of the nature of the accusation
19 and advising that person that the person does not have to make any
20 statement regarding the offense of which the person is accused or
21 suspected and that any statement made by the person may be used as
22 evidence against the person in an administrative board proceeding,
23 in nonjudicial punishment, or in a trial by court-martial.

1 C. No person subject to the Code shall compel any person to
2 make a statement or produce evidence in the course of an
3 administrative board proceeding, nonjudicial punishment or before
4 any military court if the statement or evidence is not material to
5 the issue and may tend to degrade the person.

6 D. No statement obtained from any person in violation of this
7 section or through the use of coercion, unlawful influence, or
8 unlawful inducement may be received in evidence against the person
9 in an administrative board proceeding, in nonjudicial punishment or
10 in a trial by court-martial.

11 SECTION 39. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 832 of Title 44, unless there is
13 created a duplication in numbering, reads as follows:

14 ARTICLE 32. Preliminary hearing required before referral to
15 general court-martial.

16 A. In general.

17 1. a. Except as provided in subparagraph b of this
18 paragraph, a preliminary hearing shall be held before
19 referral of charges and specifications for trial by
20 general court-martial. The preliminary hearing shall
21 be conducted by an impartial hearing officer, detailed
22 by the convening authority in accordance with
23 subsection B of this section.
24

1 b. Under regulations promulgated by the Adjutant General,
2 a preliminary hearing need not be held if the accused
3 submits a written waiver to the convening authority
4 and the convening authority determines that a hearing
5 is not required.

6 2. The purpose of the preliminary hearing shall be limited to
7 determining the following:

8 a. whether or not the specification alleges an offense
9 under the Oklahoma Uniform Code of Military Justice,

10 b. whether or not there is probable cause to believe that
11 the accused committed the offense charged,

12 c. whether or not the convening authority has court-
13 martial jurisdiction over the accused and over the
14 offense, and

15 d. a recommendation as to the disposition that should be
16 made of the case.

17 B. Hearing officer.

18 1. A preliminary hearing under this section shall be conducted
19 by an impartial hearing officer, who shall be a judge advocate who
20 is certified under paragraph 2 of subsection B of Section 827 of
21 this title (Article 27, subsection B, paragraph 2).

22 2. Whenever practicable, the hearing officer shall be equal in
23 grade or senior in grade to military counsel who are detailed to
24 represent the accused or the Government at the preliminary hearing.

1 C. Report to convening authority. After a preliminary hearing
2 under this section, the hearing officer shall submit to the
3 convening authority a written report, accompanied by a recording of
4 the preliminary hearing as required under subsection E of this
5 section, that includes the following:

6 1. For each specification, a statement of the reasoning and
7 conclusions of the hearing officer with respect to determinations
8 under paragraph 2 of subsection A of this section, including a
9 summary of relevant witness testimony and documentary evidence
10 presented at the hearing and any observations of the hearing officer
11 concerning the testimony of witnesses and the availability and
12 admissibility of evidence at trial;

13 2. Recommendations for any necessary modifications to the form
14 of the charges or specifications;

15 3. An analysis of any additional information submitted after
16 the hearing by the parties or by a victim of an offense that, under
17 such rules as the Adjutant General may promulgate, is relevant to
18 disposition under Sections 830 and 834 of this title (Articles 30
19 and 34); and

20 4. A statement of action taken on evidence adduced with respect
21 to uncharged offenses, as described in subsection F of this section.

22 D. Rights of accused and victim.

23 1. The accused shall be advised of the charges against the
24 accused and of the accused's right to be represented by counsel at

1 the preliminary hearing under this section. The accused has the
2 right to be represented at the preliminary hearing as provided in
3 Section 838 of this title (Article 38) and in regulations prescribed
4 under that article.

5 2. The accused may cross-examine witnesses who testify at the
6 preliminary hearing and present additional evidence that is relevant
7 to the issues for determination under paragraph 2 of subsection A of
8 this section.

9 3. The presentation of evidence and examination, including
10 cross-examination, of witnesses at a preliminary hearing shall be
11 limited to the matters relevant to determinations under paragraph 2
12 of subsection A of this section.

13 E. Effect of evidence of uncharged offense. If evidence
14 adduced in a preliminary hearing conducted under subsection A of
15 this section indicates that the accused committed an uncharged
16 offense, the hearing officer may consider the subject matter of that
17 offense without the accused having first been charged with the
18 offense if the accused:

19 1. Is present at the preliminary hearing;

20 2. Is informed of the nature of each uncharged offense
21 considered; and

22 3. Is afforded the opportunities for representation, cross-
23 examination, and presentation consistent with subsection D of this
24 section.

1 F. Effect of violation. The requirements of this section are
2 binding on all persons administering the Code, but failure to follow
3 the requirements does not constitute jurisdictional error. A defect
4 in a report under subsection C of this section is not a basis for
5 relief if the report is in substantial compliance with subsection C
6 of this section.

7 G. Victim defined. In this article, the term "victim" means a
8 person who:

9 1. Is alleged to have suffered a direct physical, emotional, or
10 pecuniary harm as a result of the matters set forth in a charge or
11 specification being considered; and

12 2. Is named in one of the specifications.

13 SECTION 40. NEW LAW A new section of law to be codified
14 in the Oklahoma Statutes as Section 833 of Title 44, unless there is
15 created a duplication in numbering, reads as follows:

16 ARTICLE 33. Disposition guidance.

17 The Adjutant General shall issue nonbinding guidance regarding
18 factors that commanders, convening authorities, staff judge
19 advocates, and judge advocates should take into account when
20 exercising their duties with respect to disposition of charges and
21 specifications in the interest of justice and discipline under
22 Sections 830 and 834 of this title (Articles 30 and 34). Such
23 guidance shall take into account, with appropriate consideration of
24 military requirements, the principles contained in official guidance

1 of the United States Attorney General to attorneys for the
2 government with respect to disposition of federal criminal cases in
3 accordance with the principle of fair and evenhanded administration
4 of federal criminal law.

5 SECTION 41. NEW LAW A new section of law to be codified
6 in the Oklahoma Statutes as Section 834 of Title 44, unless there is
7 created a duplication in numbering, reads as follows:

8 ARTICLE 34. Advice to convening authority before referral for
9 trial.

10 A. General court-martial.

11 1. Staff judge advocate advice required before referral.

12 Before referral of charges and specifications to a general court-
13 martial for trial, the convening authority shall submit the matter
14 to the staff judge advocate for advice, which the staff judge
15 advocate shall provide to the convening authority in writing. The
16 convening authority may not refer a specification under a charge to
17 a general court-martial unless the staff judge advocate advises the
18 convening authority in writing that:

- 19 a. the specification alleges an offense under the
20 Oklahoma Uniform Code of Military Justice,
21 b. there is probable cause to believe that the accused
22 committed the offense charged, and
23 c. a court-martial would have jurisdiction over the
24 accused and the offense.

1 2. Staff judge advocate recommendation as to disposition.

2 Together with the written advice provided under paragraph 1 of this
3 subsection, the staff judge advocate shall provide a written
4 recommendation to the convening authority as to the disposition that
5 should be made of the specification in the interest of justice and
6 discipline.

7 3. Staff judge advocate advice and recommendation to accompany
8 referral. When a convening authority makes a referral for trial by
9 general court-martial, the written advice of the staff judge
10 advocate under paragraph 1 of this subsection and the written
11 recommendation of the staff judge advocate under paragraph 2 of this
12 subsection with respect to each specification shall accompany the
13 referral.

14 B. Special court-martial; convening authority consultation with
15 judge advocate. Before referral of charges and specifications to a
16 special court-martial for trial, the convening authority shall
17 consult a judge advocate on relevant legal issues.

18 C. General and special courts-martial; correction of charges
19 and specifications before referral. Before referral for trial by
20 general court-martial or special court-martial, changes may be made
21 to charges and specifications:

22 1. To correct errors in form; and
23
24

1 2. When applicable, to conform to the substance of the evidence
2 contained in a report under subsection C of Section 832 of this
3 title (Article 32, subsection C).

4 D. Referral defined. In this section, the term "referral"
5 means the order of a convening authority that charges and
6 specifications against an accused be tried by a specified court-
7 martial.

8 SECTION 42. NEW LAW A new section of law to be codified
9 in the Oklahoma Statutes as Section 835 of Title 44, unless there is
10 created a duplication in numbering, reads as follows:

11 ARTICLE 35. Service of charges; commencement of trial.

12 A. In general. Trial counsel detailed for a court-martial
13 under Section 827 of this title (Article 27) shall cause to be
14 served upon the accused a copy of the charges and specifications
15 referred for trial.

16 B. Commencement of trial.

17 1. Subject to paragraph 2 of this subsection, no trial or other
18 proceeding of a general court-martial or a special court-martial,
19 including any session under subsection A of Section 839 of this
20 title (Article 39, subsection A) may be held over the objection of
21 the accused:

22 a. with respect to a general court-martial, from the time
23 of service through the fifth day after the date of
24 service, or

1 b. with respect to a special court-martial, from the time
2 of service through the third day after the date of
3 service.

4 2. An objection under paragraph 1 of this subsection may be
5 raised only at the first session of the trial or other proceeding
6 and only if the first session occurs before the end of the
7 applicable periods under subparagraph a or b of paragraph 1 of this
8 subsection. If the first session occurs before the end of the
9 applicable period, the military judge shall, at that session,
10 inquire as to whether the defense objects under this subsection.

11 C. Continuances. Upon a showing of good cause, the military
12 judge in a general or special court-martial may grant a continuance
13 of any hearing in which the presence of the accused is required.

14 PART VII.

15 TRIAL PROCEDURE

16 SECTION 43. NEW LAW A new section of law to be codified
17 in the Oklahoma Statutes as Section 836 of Title 44, unless there is
18 created a duplication in numbering, reads as follows:

19 ARTICLE 36. Procedure for courts-martial.

20 A. The procedure, in all cases tried by courts-martial under
21 the Oklahoma Uniform Code of Military Justice, shall be the federal
22 Rules for Courts-Martial, as prescribed in the most recent edition
23 of the Manual for Courts-Martial, United States, including all
24

1 amendments thereto adopted from time to time, except when such rules
2 are contrary to or inconsistent with the Code.

3 B. The federal Military Rules of Evidence shall govern the
4 modes of proof in all cases tried by courts-martial under the Code,
5 as prescribed in the most recent edition of the Manual for Courts-
6 Martial, United States, including all amendments thereto adopted
7 from time to time, except when such rules are contrary to or
8 inconsistent with the Code.

9 C. The Governor or Adjutant General may promulgate additional
10 regulations applicable to courts-martial procedure. All regulations
11 made under this article shall be uniform insofar as practicable.

12 SECTION 44. NEW LAW A new section of law to be codified
13 in the Oklahoma Statutes as Section 837 of Title 44, unless there is
14 created a duplication in numbering, reads as follows:

15 ARTICLE 37. Unlawfully influencing action of court.

16 A. No authority convening a general, special, or summary court-
17 martial nor any other commanding officer, or officer serving on the
18 staff thereof, shall censure, reprimand, or admonish the court or
19 any member, military judge, or counsel thereof, with respect to the
20 findings or sentence adjudged by the court, or with respect to any
21 other exercise of its or his or her functions in the conduct of the
22 proceeding. No person subject to the Oklahoma Uniform Code of
23 Military Justice shall attempt to coerce or, by an unauthorized
24 means, influence the action of the court-martial or any other

1 military tribunal or any member thereof, in reaching the findings or
2 sentence in any case, or the action of any convening, approving, or
3 reviewing authority with respect to his or her judicial acts. The
4 foregoing provisions of this subsection shall not apply with respect
5 to:

6 1. General instructional or informational courses in military
7 justice if such courses are designed solely for the purpose of
8 instructing members of a command in the substantive and procedural
9 aspects of courts-martial; or

10 2. To statements and instructions given in open court by the
11 military judge or counsel.

12 B. In the preparation of an effectiveness, fitness, or
13 efficiency report or any other report or document used in whole or
14 in part for the purpose of determining whether a member of the state
15 military forces is qualified to be advanced in grade, or in
16 determining the assignment or transfer of a member of the state
17 military force, or in determining whether a member of the state
18 military forces should be retained, no person subject to the Code
19 may, in preparing any such report:

20 1. Consider or evaluate the performance of duty of any such
21 member as a member of a court-martial; or

22 2. Give a less favorable rating or evaluation of any member of
23 the state military forces because of the zeal with which such
24 member, as counsel, represented any accused before a court-martial.

1 SECTION 45. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 838 of Title 44, unless there is
3 created a duplication in numbering, reads as follows:

4 ARTICLE 38. Duties of trial counsel and defense counsel.

5 A. The trial counsel of a general or special court-martial
6 shall prosecute in the name of the State of Oklahoma, and shall,
7 under the direction of the court, prepare the record of the
8 proceedings.

9 B. 1. The accused has the right to be represented in his or
10 her defense before a general or special court-martial or at a
11 preliminary hearing under Section 832 of this title (Article 32) as
12 provided in this subsection.

13 2. The accused may be represented by civilian counsel if
14 provided by the accused.

15 3. The accused may be represented:

16 a. by military counsel detailed under Section 827 of this
17 title (Article 27), or

18 b. by military counsel of his or her own selection if
19 that counsel is reasonably available as determined
20 under regulations prescribed under paragraph 7 of this
21 subsection.

22 4. If the accused is represented by civilian counsel, military
23 counsel detailed or selected under paragraph 3 of this subsection
24

1 shall act as associate counsel unless excused at the request of the
2 accused.

3 5. Except as provided under paragraph 6 of this subsection, if
4 the accused is represented by military counsel of his or her own
5 selection under subparagraph b of paragraph 3 of this subsection,
6 any military counsel detailed under subparagraph a of paragraph 3 of
7 this subsection shall be excused.

8 6. The accused is not entitled to be represented by more than
9 one military counsel. However, the person authorized under
10 regulations prescribed under Section 827 of this title (Article 27)
11 to detail counsel, in his or her sole discretion:

12 a. may detail additional military counsel as assistant
13 defense counsel, and

14 b. if the accused is represented by military counsel of
15 his or her own selection under subparagraph b of
16 paragraph 3 of this subsection, may approve a request
17 from the accused that military counsel detailed under
18 subparagraph a of paragraph 3 of this subsection, act
19 as associate defense counsel.

20 7. The Adjutant General shall, by regulation, define
21 "reasonably available" for the purpose of subparagraph b of
22 paragraph 3 of this subsection, and establish procedures for
23 determining whether the military counsel selected by an accused
24 under that paragraph is reasonably available. Such regulations may

1 not prescribe any limitation based on the reasonable availability of
2 counsel solely on the grounds that the counsel selected by the
3 accused is from a force component other than the one of which the
4 accused is a member. To the maximum extent practicable, such
5 regulations shall establish uniform policies between the force
6 components of the state military forces while recognizing the
7 differences in the circumstances and needs of both force components.

8 C. In any court-martial proceeding resulting in a conviction,
9 the defense counsel:

10 1. May forward for attachment to the record of proceedings a
11 brief of such matters as he or she determines should be considered
12 in behalf of the accused on review (including any objection to the
13 contents of the record which he or she considers appropriate);

14 2. May assist the accused in the submission of any matter under
15 Section 860, 860A or 860B of this title (Article 60, 60A or 60B);
16 and

17 3. May take other action authorized by the Oklahoma Uniform
18 Code of Military Justice.

19 D. An assistant trial counsel of a general court-martial may,
20 under the direction of the trial counsel or when he or she is
21 qualified to be a trial counsel as required by Section 827 of this
22 title (Article 27), perform any duty imposed by law, regulation, or
23 the custom of the service upon the trial counsel of the court. An
24

1 assistant trial counsel of a special court-martial may perform any
2 duty of the trial counsel.

3 E. An assistant defense counsel of a general or special court-
4 martial may perform any duty imposed by law, regulation, or the
5 custom of the service upon counsel for the accused.

6 SECTION 46. NEW LAW A new section of law to be codified
7 in the Oklahoma Statutes as Section 839 of Title 44, unless there is
8 created a duplication in numbering, reads as follows:

9 ARTICLE 39. Sessions.

10 A. At any time after the service of charges which have been
11 referred for trial to a court-martial composed of a military judge
12 and members, the military judge may, subject to Section 835 of this
13 title (Article 35), call the court into session without the presence
14 of the members for the purpose of:

15 1. Hearing and determining motions raising defenses or
16 objections which are capable of determination without trial of the
17 issues raised by a plea of not guilty;

18 2. Hearing and ruling upon any matter which may be ruled upon
19 by the military judge under the Oklahoma Uniform Code of Military
20 Justice, whether or not the matter is appropriate for later
21 consideration or decision by the members of the court;

22 3. Holding the arraignment and receiving the pleas of the
23 accused;

24

1 4. Conducting a sentencing proceeding and sentencing the
2 accused under paragraph 1 of subsection B of Section 853 of this
3 title (Article 53, subsection B, paragraph 1); and

4 5. Performing any other procedural function which may be
5 performed by the military judge under the Code or under rules
6 prescribed pursuant to Section 836 of this title (Article 36) and
7 which does not require the presence of the members of the court.

8 B. Proceedings under subsection A of this section shall be
9 conducted in the presence of the accused, the defense counsel, and
10 the trial counsel and shall be made a part of the record. These
11 proceedings may be conducted notwithstanding the number of members
12 of the court and without regard to Section 829 of this title
13 (Article 29). If authorized by regulations promulgated by the
14 Adjutant General, and if at least one defense counsel is physically
15 in the presence of the accused, the presence required by this
16 subsection may otherwise be established by audiovisual technology,
17 such as videoteleconferencing technology.

18 C. When the members of a court-martial deliberate or vote, only
19 the members may be present. All other proceedings, including any
20 other consultation of the members of the court with counsel or the
21 military judge, shall be made a part of the record and shall be in
22 the presence of the accused, the defense counsel, the trial counsel,
23 and the military judge.

1 D. The findings, holdings, interpretations, and other
2 precedents of military commissions under Chapter 47A of Title 10 of
3 the United States Code:

4 1. May not be introduced or considered in any hearing, trial,
5 or other proceeding of a court-martial under the Code; and

6 2. May not form the basis of any holding, decision, or other
7 determination of a court-martial.

8 SECTION 47. NEW LAW A new section of law to be codified
9 in the Oklahoma Statutes as Section 840 of Title 44, unless there is
10 created a duplication in numbering, reads as follows:

11 ARTICLE 40. Continuances.

12 The military judge or a summary court-martial may, for
13 reasonable cause, grant a continuance to any party for such time,
14 and as often, as may appear to be just.

15 SECTION 48. NEW LAW A new section of law to be codified
16 in the Oklahoma Statutes as Section 841 of Title 44, unless there is
17 created a duplication in numbering, reads as follows:

18 ARTICLE 41. Challenges.

19 A. 1. The military judge and members of a general or special
20 court-martial may be challenged by the accused or the trial counsel
21 for cause stated to the court. The military judge shall determine
22 the relevancy and validity of challenges for cause, and may not
23 receive a challenge to more than one person at a time. Challenges
24

1 by the trial counsel shall ordinarily be presented and decided
2 before those by the accused are offered.

3 2. If exercise of a challenge for cause reduces the court below
4 the number of members required by Section 816 of this title (Article
5 16), all parties shall, notwithstanding Section 829 of this title
6 (Article 29), either exercise or waive any challenge for cause then
7 apparent against the remaining members of the court before
8 additional members are detailed to the court. However, peremptory
9 challenges shall not be exercised at that time.

10 B. 1. Each accused and the trial counsel are entitled
11 initially to one peremptory challenge of the members of the court.
12 The military judge may not be challenged except for cause.

13 2. If exercise of a peremptory challenge reduces the court
14 below the number of members required by Section 816 of this title
15 (Article 16), the parties shall, notwithstanding Section 829 of this
16 title (Article 29), either exercise or waive any remaining
17 peremptory challenge (not previously waived) against the remaining
18 members of the court before additional members are detailed to the
19 court.

20 C. Whenever additional members are detailed to the court, and
21 after any challenges for cause against such additional members are
22 presented and decided, each accused and the trial counsel are
23 entitled to one peremptory challenge against members not previously
24 subject to peremptory challenge.

1 SECTION 49. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 842 of Title 44, unless there is
3 created a duplication in numbering, reads as follows:

4 ARTICLE 42. Oaths.

5 A. Before performing their respective duties, military judges,
6 members of general and special courts-martial, trial counsel,
7 assistant trial counsel, defense counsel, assistant or associate
8 defense counsel, reporters, and interpreters shall take an oath to
9 perform their duties faithfully. The form of the oath, the time and
10 place of the taking thereof, the manner of recording the same, and
11 whether the oath shall be taken for all cases in which these duties
12 are to be performed or for a particular case, shall be as prescribed
13 in regulations promulgated by the Adjutant General. These
14 regulations may provide that an oath to perform faithfully duties as
15 a military judge, trial counsel, assistant trial counsel, defense
16 counsel, or assistant or associate defense counsel may be taken at
17 any time by any judge advocate or other person certified to be
18 qualified or competent for the duty, and if such an oath is taken it
19 need not again be taken at the time the judge advocate, or other
20 person is detailed to that duty.

21 B. Each witness before a court-martial shall be examined on
22 oath.
23
24

1 SECTION 50. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 843 of Title 44, unless there is
3 created a duplication in numbering, reads as follows:

4 ARTICLE 43. Statute of limitations.

5 A. Except as otherwise provided in this section, a person
6 charged with a military offense is not liable to be tried by court-
7 martial if the offense was committed more than three (3) years
8 before the receipt of sworn charges and specifications by an officer
9 exercising summary court-martial jurisdiction over the command.

10 B. A person accused of an offense is not liable to be punished
11 under Section 815 of this title (Article 15) if the offense was
12 committed more than two (2) years before the imposition of
13 punishment.

14 C. Periods in which the accused is absent without authority or
15 fleeing from justice shall be excluded in computing the period of
16 limitation prescribed in this article.

17 D. Periods in which the accused was absent from territory in
18 which the State of Oklahoma has the authority to apprehend him or
19 her, or in the custody of civil authorities, or on active duty
20 within the meaning of Title 10 of the United States Code, or in the
21 hands of the enemy, shall be excluded in computing the periods of
22 limitation prescribed in this article.

1 E. When the United States is at war, the running of any statute
2 of limitations applicable to any offense under the Oklahoma Uniform
3 Code of Military Justice:

4 1. Involving fraud or attempted fraud against the United
5 States, the State of Oklahoma, or any agency of the foregoing in any
6 manner, whether by conspiracy or not;

7 2. Committed in connection with the acquisition, care,
8 handling, custody, control, or disposition of any real or personal
9 property of the United States, or the State of Oklahoma; or

10 3. Committed in connection with the negotiation, procurement,
11 award, performance, payment, interim financing, cancellation, or
12 other termination or settlement, of any contract, subcontract, or
13 purchase order which is connected with or related to the prosecution
14 of the war, or with any disposition of termination inventory by any
15 war contractor or government agency,
16 is suspended until three (3) years after the termination of
17 hostilities as proclaimed by the President of the United States or
18 by a joint resolution of Congress.

19 F. Defective or insufficient charges.

20 1. If charges or specifications are dismissed as defective or
21 insufficient for any cause and the period prescribed by the
22 applicable statute of limitations:

23 a. has expired, or
24

1 b. will expire within one hundred eighty (180) days after
2 the date of dismissal of the charges and
3 specifications,

4 trial and punishment under new charges and specifications are not
5 barred by the statute of limitations if the conditions specified in
6 paragraph 2 of this subsection are met.

7 2. The conditions referred to in paragraph 1 of this subsection
8 are that the new charges and specifications shall:

9 a. be received by an officer exercising summary court-
10 martial jurisdiction over the command within one
11 hundred eighty (180) days after the dismissal of the
12 charges or specifications, and

13 b. allege the same acts or omissions that were alleged in
14 the dismissed charges or specifications (or allege
15 acts or omissions that were included in the dismissed
16 charges or specifications).

17 G. A person charged with fraudulent enlistment or fraudulent
18 appointment under Section 904A of this title (Article 104A) may be
19 tried by court-martial if the sworn charges and specifications are
20 received by an officer exercising summary court-martial jurisdiction
21 with respect to that person, as follows:

22 1. In the case of an enlisted member, during the period of the
23 enlistment or five (5) years, whichever provides a longer period;
24 and

1 2. In the case of an officer, during the period of the
2 appointment or five (5) years, whichever provides a longer period.

3 H. If deoxyribonucleic acid (DNA) testing implicates an
4 identified person in the commission of an offense punishable by
5 confinement for more than one (1) year, no statute of limitations
6 that would otherwise preclude prosecution of the offense shall
7 preclude such prosecution until a period of time following the
8 implication of the person by DNA testing has elapsed that is equal
9 to the otherwise applicable limitation period.

10 SECTION 51. NEW LAW A new section of law to be codified
11 in the Oklahoma Statutes as Section 844 of Title 44, unless there is
12 created a duplication in numbering, reads as follows:

13 ARTICLE 44. Former jeopardy.

14 A. No person may, without his or her consent, be tried a second
15 time for the same offense.

16 B. No proceeding in which an accused has been found guilty by
17 court-martial upon any charge or specification is a trial in the
18 sense of this article until the finding of guilty has become final
19 after review of the case has been fully completed.

20 C. 1. A court-martial with a military judge alone is a trial
21 for the purposes of this section if, without fault of the accused:

22 a. after introduction of evidence, and

23 b. before announcement of findings under Section 853 of
24 this title (Article 53),

1 the case is dismissed or terminated by the convening authority or on
2 motion of the prosecution for failure of available evidence or
3 witnesses.

4 2. A court-martial with a military judge and members is a trial
5 in the sense of this section if, without fault of the accused:

6 a. after the members, having taken an oath as members
7 under Section 842 of this title (Article 42) and after
8 completion of challenges under Section 841 of this
9 title (Article 41), are impaneled, and

10 b. before announcement of findings under Section 853 of
11 this title (Article 53),

12 the case is dismissed or terminated by the convening authority or on
13 motion of the prosecution for failure of available evidence or
14 witnesses.

15 SECTION 52. NEW LAW A new section of law to be codified
16 in the Oklahoma Statutes as Section 845 of Title 44, unless there is
17 created a duplication in numbering, reads as follows:

18 ARTICLE 45. Pleas of the accused.

19 A. Irregular and similar pleas. If an accused after
20 arraignment makes an irregular pleading, or after a plea of guilty
21 sets up matter inconsistent with the plea, or if it appears that he
22 or she has entered the plea of guilty improvidently or through lack
23 of understanding of its meaning and effect, or if he or she fails or
24 refuses to plead, a plea of not guilty shall be entered in the

1 record, and the court shall proceed as though he or she had pleaded
2 not guilty.

3 B. Pleas of guilty. With respect to any charge or
4 specification to which a plea of guilty has been made by the accused
5 and accepted by the military judge, a finding of guilty of the
6 charge or specification may be entered immediately without vote.
7 This finding shall constitute the finding of the court unless the
8 plea of guilty is withdrawn prior to announcement of the sentence,
9 in which event the proceedings shall continue as though the accused
10 had pleaded not guilty.

11 C. Harmless error. A variance from the requirements of this
12 article is harmless error if the variance does not materially
13 prejudice the substantial rights of the accused.

14 SECTION 53. NEW LAW A new section of law to be codified
15 in the Oklahoma Statutes as Section 846 of Title 44, unless there is
16 created a duplication in numbering, reads as follows:

17 ARTICLE 46. Opportunity to obtain witnesses and other evidence
18 in trials by court-martial.

19 A. Opportunity to obtain witnesses and other evidence. In a
20 case referred for trial by court-martial, the trial counsel, the
21 defense counsel, and the court-martial shall have equal opportunity
22 to obtain witnesses and other evidence in accordance with such
23 regulations as may be promulgated by the Adjutant General.

24

1 B. Subpoena and other process generally. Any subpoena or other
2 process issued under this section:

3 1. Shall be similar to that which courts of the State of
4 Oklahoma having criminal jurisdiction may issue pursuant to Title 22
5 of the Oklahoma Statutes;

6 2. Shall be executed in accordance with regulations promulgated
7 by the Adjutant General; and

8 3. Shall run to any part of the State of Oklahoma.

9 C. Subpoena and other process for witnesses. A subpoena or
10 other process may be issued to compel a witness to appear and
11 testify:

12 1. Before a court-martial or court of inquiry;

13 2. At a deposition under Section 849 of this title (Article
14 49); or

15 3. As otherwise authorized under the Oklahoma Uniform Code Of
16 Military Justice.

17 D. Subpoena and other process for evidence.

18 1. In general. A subpoena or other process may be issued to
19 compel the production of evidence:

20 a. for a court-martial or court of inquiry,

21 b. for a deposition under Section 849 of this title
22 (Article 49),

23 c. for an investigation of an offense under the Code, or

24 d. as otherwise authorized under the Code.

1 2. Investigative subpoena. An investigative subpoena under
2 subparagraph c of paragraph 1 of this subsection may be issued
3 before referral of charges to a court-martial only if a general
4 court-martial convening authority has authorized counsel for the
5 government to issue such a subpoena or a military judge issues such
6 a subpoena pursuant to subsection A of Section 830 of this title
7 (Article 30, subsection A).

8 3. Warrant or order for wire or electronic communications.
9 With respect to an investigation of an offense under the Code, a
10 military judge detailed in accordance with Section 826 or subsection
11 A of Section 830 of this title (Article 26 or Article 30, subsection
12 A) may issue warrants or court orders for the contents of, and
13 records concerning, wire or electronic communications in the same
14 manner as such warrants and orders may be issued by a district court
15 of the State of Oklahoma under the provisions of Title 22 of the
16 Oklahoma Statutes, subject to such limitations as may be prescribed
17 by regulations promulgated by the Adjutant General.

18 E. Request for relief from subpoena or other process. If a
19 person requests relief from a subpoena or other process under this
20 section (article) on grounds that compliance is unreasonable or
21 oppressive or is prohibited by law, a military judge detailed in
22 accordance with Section 826 or subsection A of Section 830 of this
23 title (Article 26 or Article 30, subsection A) shall review the
24 request and shall:

1 1. Order that the subpoena or other process be modified or
2 withdrawn, as appropriate; or

3 2. Order the person to comply with the subpoena or other
4 process.

5 SECTION 54. NEW LAW A new section of law to be codified
6 in the Oklahoma Statutes as Section 847 of Title 44, unless there is
7 created a duplication in numbering, reads as follows:

8 ARTICLE 47. Refusal to appear or testify.

9 A. In general.

10 1. Any person described in paragraph 2 of this subsection who:
11 a. willfully neglects or refuses to appear, or
12 b. willfully refuses to qualify as a witness or to
13 testify or to produce any evidence which that person
14 is required to produce,
15 shall be guilty of indirect contempt of the court-martial or court
16 of inquiry from which the subpoena issued.

17 2. The persons referred to in paragraph 1 of this subsection
18 are the following:

19 a. any person not subject to the Oklahoma Uniform Code of
20 Military Justice who:

21 (1) is issued a subpoena or other process described
22 in subsection C of Section 846 of this title
23 (Article 46, subsection C), and
24

1 (2) is provided a means for payment of fees and
2 mileage pursuant to subsection D of this section,
3 and

4 b. any person not subject to the Code who is issued a
5 subpoena or other process described in subsection D of
6 Section 846 of this title (Article 46, subsection D).

7 B. Any person who commits indirect contempt shall be punished
8 in accordance with Sections 566, 567 and 568 of Title 21 of the
9 Oklahoma Statutes.

10 C. The district attorney exercising jurisdiction in the county
11 where the court-martial or court of inquiry is convened, shall, upon
12 the certification of the facts to him or her by the military court,
13 court of inquiry or convening authority, file an information against
14 and prosecute any person violating this article. Upon conviction,
15 such a person shall be punished by the imposition of a fine in a sum
16 not exceeding Five Hundred Dollars (\$500.00) or by imprisonment in
17 the county jail not exceeding six (6) months, or by both, at the
18 discretion of the district court.

19 D. The fees and mileage of witnesses shall be paid as follows:

20 1. Any civilian witness, who is not a federal employee,
21 appearing in obedience to an order, subpoena, or other lawful
22 compulsion at any stage of a general or special court-martial or
23 court of inquiry where the party seeking the attendance of the
24 witness is the trial counsel, the defense counsel or the defendant

1 appearing pro se, shall be paid from any monies available in the
2 Military Justice Fund established in Section 941 of Title 44 of the
3 Oklahoma Statutes, the fees and mileage at the rate prescribed by
4 Section 81 of Title 28 of the Oklahoma Statutes;

5 2. Any witness appearing in obedience to an order, subpoena, or
6 other lawful compulsion at any stage of a court-martial for which no
7 provision in this subsection is applicable, shall be paid at the
8 discretion of the military judge presiding over a general or special
9 court-martial proceeding from any monies available in the Military
10 Justice Fund established in Section 941 of Title 44 of the Oklahoma
11 Statutes, the fees and mileage at the rate prescribed by Section 81
12 of Title 28 of the Oklahoma Statutes;

13 3. The comptroller of the military department, or any other
14 person designated by the Adjutant General, shall, upon proof of
15 claim, issue to witnesses, summoned pursuant to this subsection,
16 certificates showing the names of witnesses, number of days'
17 attendance, distance traveled and the amount of such fees and
18 mileage; and

19 4. The Adjutant General may promulgate additional regulations
20 governing the method and process for payment of fees and mileage to
21 a civilian witness, who is not a federal employee, appearing in
22 obedience to an order, subpoena, or other lawful compulsion at any
23 stage of a general, special or summary court-martial or court of
24 inquiry.

1 SECTION 55. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 848 of Title 44, unless there is
3 created a duplication in numbering, reads as follows:

4 ARTICLE 48. Contempt.

5 A. Authority to punish.

6 1. With respect to any proceeding under the Oklahoma Uniform
7 Code of Military Justice, a judicial officer specified in paragraph
8 2 of this subsection may punish for contempt any person who:

- 9 a. uses any menacing word, sign, or gesture in the
10 presence of the judicial officer during the
11 proceeding,
12 b. disturbs the proceeding by any riot or disorder, or
13 c. willfully disobeys a lawful writ, process, order,
14 rule, decree, or command issued with respect to the
15 proceeding.

16 2. A judicial officer referred to in paragraph 1 of this
17 subsection is either of the following:

- 18 a. any military judge detailed to a court-martial,
19 b. the chief judge of the Military Court of Appeals, or
20 c. the president of a court of inquiry.

21 B. Opportunity to be heard and warning. A judicial officer, as
22 specified in paragraph 2 of subsection A of this section, may punish
23 a person cited for contempt after an opportunity to be heard has
24

1 been given. Censure shall be imposed by the judicial officer only
2 if:

3 1. It is clear from the identity of the offender and the
4 character of his or her acts that disruptive conduct is willfully
5 contemptuous; or

6 2. The conduct warranting the sanction is preceded by a clear
7 warning that the conduct is impermissible and that specified
8 sanctions may be imposed for its repetition.

9 C. Notification of contempt proceedings. The judicial officer,
10 as specified in paragraph 2 of subsection A of this section, as soon
11 as practicable after he or she is satisfied that courtroom
12 misconduct requires contempt proceedings, should inform the alleged
13 offender of his or her intention to institute said proceedings.

14 D. Notice and opportunity to provide evidence or testimony.
15 Before imposing any punishment for contempt, the judicial officer
16 shall give the offender notice of the charges and an opportunity to
17 adduce evidence or argument relevant to guilt or punishment.

18 E. Imposition of sanctions. The judicial officer before whom
19 the misconduct occurs may impose appropriate sanctions including
20 punishment for contempt.

21 F. Punishment. The punishment for contempt under subsection A
22 of this section may not exceed a fine of Five Hundred Dollars
23 (\$500.00) or imprisonment in the county jail for more than six (6)
24 months, or by both, at the discretion of the judicial officer.

1 G. Review. A punishment under this section:

2 1. If imposed by a military judge, may be reviewed by the
3 Military Court of Appeals in accordance with the uniform rules of
4 procedure for the Military Court of Appeals under subsection M of
5 Section 866 of this title (Article 66, subsection M);

6 2. If imposed by the chief judge of the Military Court of
7 Appeals, shall constitute a judgment of the court, subject to review
8 under the applicable provisions of Section 867 of this title
9 (Article 67); and

10 3. If imposed by a court of inquiry, shall be subject to review
11 by the convening authority in accordance with regulations
12 promulgated by the Adjutant General.

13 SECTION 56. NEW LAW A new section of law to be codified
14 in the Oklahoma Statutes as Section 849 of Title 44, unless there is
15 created a duplication in numbering, reads as follows:

16 ARTICLE 49. Depositions.

17 A. In general.

18 1. Subject to paragraph 2 of this subsection, a convening
19 authority or a military judge may order depositions at the request
20 of any party.

21 2. A deposition may be ordered under paragraph 1 of this
22 subsection only if the requesting party demonstrates that, due to
23 exceptional circumstances, it is in the interest of justice that the
24

1 testimony of a prospective witness be preserved for use at a court-
2 martial or court of inquiry.

3 3. A party who requests a deposition under this section shall
4 give to every other party reasonable written notice of the time and
5 place for the deposition.

6 4. A deposition under this section shall be taken before, and
7 authenticated by, an impartial officer, as follows:

8 a. whenever practicable, by an impartial judge advocate
9 certified under subsection B of Section 827 of this
10 title (Article 27, subsection B), and

11 b. in exceptional circumstances, by an impartial military
12 or civil officer authorized to administer oaths by:

13 (1) the laws of the United States, or

14 (2) the laws of the place where the deposition is
15 taken.

16 B. Representation by counsel. Representation of the parties
17 with respect to a deposition shall be by counsel detailed in the
18 same manner as trial counsel and defense counsel are detailed under
19 Section 827 of this title (Article 27). In addition, the accused
20 shall have the right to be represented by civilian or military
21 counsel in the same manner as such counsel is provided for in
22 subsection B of Section 838 of this title (Article 38, subsection
23 B).

1 C. Admissibility and use as evidence. A deposition order under
2 subsection A of this section does not control the admissibility of
3 the deposition in a court-martial or other proceeding under the
4 Oklahoma Uniform Code of Military Justice. A party may use all or
5 part of a deposition as provided by the federal Military Rules of
6 Evidence.

7 SECTION 57. NEW LAW A new section of law to be codified
8 in the Oklahoma Statutes as Section 850 of Title 44, unless there is
9 created a duplication in numbering, reads as follows:

10 ARTICLE 50. Admissibility of sworn testimony from records of
11 courts of inquiry.

12 A. Use as evidence by any party. In any case not extending to
13 the dismissal of a commissioned officer, the sworn testimony,
14 contained in the duly authenticated record of proceedings of a court
15 of inquiry, of a person whose oral testimony cannot be obtained,
16 may, if otherwise admissible under the rules of evidence, be read in
17 evidence by any party before a court-martial if the accused was a
18 party before the court of inquiry and if the same issue was involved
19 or if the accused consents to the introduction of such evidence.

20 B. Use as evidence by defense. Such testimony may be read in
21 evidence only by the defense in cases extending to the dismissal of
22 a commissioned officer.
23
24

1 C. Use in courts of inquiry and military boards. Such
2 testimony may also be read in evidence before a court of inquiry or
3 an administrative board.

4 D. Audiotape or videotape. Sworn testimony that:

5 1. Is recorded by audiotape, videotape, or similar method; and

6 2. Is contained in the duly authenticated record of proceedings
7 of a court of inquiry,

8 shall be admissible before a court-martial, court of inquiry, or
9 military board, to the same extent as sworn testimony may be read in
10 evidence before any such body under this section.

11 SECTION 58. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 850A of Title 44, unless there
13 is created a duplication in numbering, reads as follows:

14 ARTICLE 50A. Defense of lack of mental responsibility.

15 A. It is an affirmative defense in a trial by court-martial
16 that, at the time of the commission of the acts constituting the
17 offense, the accused, as a result of a severe mental disease or
18 defect, was unable to appreciate the nature and quality or the
19 wrongfulness of the acts. Mental disease or defect does not
20 otherwise constitute a defense.

21 B. The accused has the burden of proving the defense of lack of
22 mental responsibility by clear and convincing evidence.

23 C. Whenever lack of mental responsibility of the accused with
24 respect to an offense is properly at issue, the military judge shall

1 instruct the members of the court as to the defense of lack of
2 mental responsibility under this article and shall charge them to
3 find the accused:

4 1. Guilty;

5 2. Not guilty; or

6 3. Not guilty only by reason of lack of mental responsibility.

7 D. Subsection C of this section does not apply to a court-
8 martial composed of a military judge only. In the case of a court-
9 martial composed of a military judge only, whenever lack of mental
10 responsibility of the accused with respect to an offense is properly
11 at issue, the military judge shall find the accused:

12 1. Guilty;

13 2. Not guilty; or

14 3. Not guilty only by reason of lack of mental responsibility.

15 E. Notwithstanding the provisions of Section 852 of this title
16 (Article 52), the accused shall be found not guilty only by reason
17 of lack of mental responsibility if:

18 1. A majority of the members of the court-martial present at
19 the time the vote is taken determines that the defense of lack of
20 mental responsibility has been established; or

21 2. In the case of a court-martial composed of a military judge
22 only, the military judge determines that the defense of lack of
23 mental responsibility has been established.

1 SECTION 59. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 851 of Title 44, unless there is
3 created a duplication in numbering, reads as follows:

4 ARTICLE 51. Voting and rulings.

5 A. Voting by members of a general or special court-martial on
6 the findings and on the sentence shall be by secret written ballot.
7 The junior member of the court shall count the votes. The count
8 shall be checked by the president, who shall forthwith announce the
9 result of the ballot to the members of the court.

10 B. The military judge shall rule upon all questions of law and
11 all interlocutory questions arising during the proceedings. Any
12 such ruling made by the military judge upon any question of law or
13 any interlocutory question other than the factual issue of mental
14 responsibility of the accused is final and constitutes the ruling of
15 the court, except that the military judge may change a ruling at any
16 time during trial.

17 C. Before a vote is taken on the findings, the military judge
18 shall, in the presence of the accused and counsel, instruct the
19 members of the court as to the elements of the offense and charge
20 them:

21 1. That the accused shall be presumed to be innocent until his
22 or her guilt is established by legal and competent evidence beyond
23 reasonable doubt;

1 2. That in the case being considered, if there is a reasonable
2 doubt as to the guilt of the accused, the doubt shall be resolved in
3 favor of the accused and he or she shall be acquitted;

4 3. That, if there is reasonable doubt as to the degree of
5 guilt, the finding shall be in a lower degree as to which there is
6 no reasonable doubt; and

7 4. That the burden of proof to establish the guilt of the
8 accused beyond reasonable doubt is upon the government.

9 D. This section does not apply to a court-martial composed of a
10 military judge only. The military judge of such a court-martial
11 shall determine all questions of law and fact arising during the
12 proceedings and, if the accused is convicted, adjudge an appropriate
13 sentence. The military judge of such a court-martial shall make a
14 general finding and shall in addition on request find the facts
15 specially. If an opinion or memorandum of decision is filed, it
16 will be sufficient if the findings of fact appear therein.

17 SECTION 60. NEW LAW A new section of law to be codified
18 in the Oklahoma Statutes as Section 852 of Title 44, unless there is
19 created a duplication in numbering, reads as follows:

20 ARTICLE 52. Votes required for conviction, sentencing and other
21 matters.

22 A. In general. No person may be convicted of an offense in a
23 general or special court-martial, other than:
24

1 1. After a plea of guilty under subsection B of Section 845 of
2 this title (Article 45, subsection B);

3 2. By a military judge in a court-martial with a military judge
4 alone, under Section 816 of this title (Article 16); or

5 3. In a court-martial with members under Section 816 of this
6 title (Article 16), by the concurrence of at least three-fourths of
7 the members present when the vote is taken.

8 B. Level of concurrence required.

9 1. In general. Except as provided in paragraph 2 of subsection
10 A of this section, all matters to be decided by members of a general
11 or special court-martial shall be determined by a majority vote, but
12 a reconsideration of a finding of guilty or reconsideration of a
13 sentence, with a view toward decreasing the sentence, may be made by
14 any lesser vote which indicates that the reconsideration is not
15 opposed by the number of votes required for that finding or
16 sentence.

17 2. Sentencing. All sentences imposed by members under the
18 Oklahoma Uniform Code of Military Justice shall be determined by the
19 concurrence of at least three-fourths of the members present when
20 the vote is taken.

21 SECTION 61. NEW LAW A new section of law to be codified
22 in the Oklahoma Statutes as Section 853 of Title 44, unless there is
23 created a duplication in numbering, reads as follows:

24 ARTICLE 53. Findings and sentencing.

1 A. A court-martial shall announce its findings and sentence to
2 the parties as soon as determined.

3 B. Sentencing generally.

4 1. General and special courts-martial.

5 a. Sentencing by military judge. Except as provided in
6 subparagraph b of this paragraph, if the accused is
7 convicted of an offense in a trial by general or
8 special court-martial, the military judge shall
9 sentence the accused.

10 b. Sentencing by members. If the accused is convicted of
11 an offense by general or special court-martial
12 consisting of a military judge and members and the
13 accused elects sentencing by members under Section 825
14 of this title (Article 25), the members shall sentence
15 the accused.

16 c. Sentence of the accused. The sentence determined
17 pursuant to this paragraph constitutes the sentence of
18 the accused.

19 2. Summary courts-martial. If the accused is convicted of an
20 offense in a trial by summary court-martial, the court-martial shall
21 sentence the accused.

22 SECTION 62. NEW LAW A new section of law to be codified
23 in the Oklahoma Statutes as Section 853A of Title 44, unless there
24 is created a duplication in numbering, reads as follows:

1 ARTICLE 53A. Plea agreements.

2 A. In general.

3 1. At any time before the announcement of findings under
4 Section 853 of this title (Article 53), the convening authority and
5 the accused may enter into a plea agreement with respect to such
6 matters as:

- 7 a. the manner in which the convening authority will
8 dispose of one or more charges and specifications, and
9 b. limitations on the sentence that may be adjudged for
10 one or more charges and specifications.

11 2. The military judge of a general or special court-martial may
12 not participate in discussions between the parties concerning
13 prospective terms and conditions of a plea agreement.

14 B. Limitation on acceptance of plea agreements. The military
15 judge of a general or special court-martial shall reject a plea
16 agreement that:

- 17 1. Contains a provision that has not been accepted by both
18 parties; or
19 2. Contains a provision that is not understood by the accused.

20 C. Binding effect of plea agreement. Upon acceptance by the
21 military judge of a general or special court-martial, a plea
22 agreement shall bind the parties and the court-martial.
23
24

1 SECTION 63. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 854 of Title 44, unless there is
3 created a duplication in numbering, reads as follows:

4 ARTICLE 54. Record of trial.

5 A. General and special courts-martial. Each general or special
6 court-martial shall keep a separate record of the proceedings in
7 each case brought before it. The record shall be certified by a
8 court-reporter, except that in the case of death, disability, or
9 absence of a court reporter, the record shall be certified by an
10 official selected as the Adjutant General may prescribe by
11 regulation.

12 B. Summary courts-martial. Each summary court-martial shall
13 keep a separate record of the proceedings in each case, and the
14 record shall be certified in the manner required by such regulations
15 as the Adjutant General may prescribe.

16 C. Contents of record.

17 1. Except as provided in paragraph 2 of this subsection, the
18 record shall contain such matters as the Adjutant General may
19 prescribe by regulation.

20 2. In accordance with regulations prescribed by the Adjutant
21 General, a complete record of proceedings and testimony shall be
22 prepared in any case of a sentence of dismissal, discharge,
23 confinement for more than six months, or forfeiture of pay for more
24 than six (6) months.

1 D. A copy to the accused. A copy of the record of the
2 proceedings of each general and special court-martial shall be given
3 to the accused as soon as it is certified.

4 E. Copy to victim. In the case of a general or special court-
5 martial upon request, a copy of all prepared records of the
6 proceedings of the court-martial shall be given to the victim of the
7 offense if the victim testified during the proceedings. The record
8 of the proceedings shall be provided without charge and as soon as
9 the records are certified. The victim shall be notified of the
10 opportunity to receive the records of the proceedings.

11 PART VIII.

12 SENTENCES

13 SECTION 64. NEW LAW A new section of law to be codified
14 in the Oklahoma Statutes as Section 855 of Title 44, unless there is
15 created a duplication in numbering, reads as follows:

16 ARTICLE 55. Cruel and unusual punishments prohibited.

17 Punishment by flogging, or by branding, marking, or tattooing on
18 the body, or any other cruel or unusual punishment, may not be
19 adjudged by any court-martial or inflicted upon any person subject
20 to the Oklahoma Uniform Code of Military Justice. The use of irons,
21 single or double, except for the purpose of safe custody, is
22 prohibited.

SECTION 65. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 856 of Title 44, unless there is created a duplication in numbering, reads as follows:

ARTICLE 56. Sentencing.

A. Sentence maximums. The punishment which a court-martial may direct for an offense may not exceed such limits as the Governor or Adjutant General may prescribe for that offense.

B. Imposition of sentence.

1. In general. In sentencing an accused under Section 853 of this title (Article 53), a court-martial shall impose punishment that is sufficient, but not greater than necessary, to promote justice and to maintain good order and discipline in the state military forces, taking into consideration:

a. the nature and circumstances of the offense and the history and characteristics of the accused,

b. the impact of the offense on:

(1) the financial, social, psychological, or medical well-being of any victim of the offense, and

(2) the mission, discipline, or efficiency of the command of the accused and any victim of the offense,

c. the need for the sentence:

(1) to reflect the seriousness of the offense,

(2) to promote respect for the law,

- (3) to provide just punishment for the offense,
- (4) to promote adequate deterrence of misconduct,
- (5) to protect others from further crimes by the accused,
- (6) to rehabilitate the accused, and
- (7) to provide, in appropriate cases, the opportunity for retraining and return to duty to meet the needs of the service, and

d. the sentences available under this chapter.

2. Sentencing by military judge. In announcing the sentence in a general or special court-martial in which the accused is sentenced by a military judge alone under Section 853 of this title (Article 53), the military judge shall, with respect to each offense of which the accused is found guilty, specify the term of confinement, if any, and the amount of the fine, if any. If the accused is sentenced to confinement for more than one offense, the military judge shall specify whether the terms of confinement are to run consecutively or concurrently.

3. Sentencing by members. In a general or special court-martial in which the accused has elected sentencing by members, the court-martial shall announce a single sentence for all of the offenses of which the accused was found guilty.

C. Appeal of sentence by the State of Oklahoma.

1 1. With the approval of the State Judge Advocate and consistent
2 with standards and procedures set forth in regulations prescribed by
3 the Governor or the Adjutant General, the government may appeal a
4 sentence to the Military Court of Appeals, on the grounds that:

5 a. the sentence violates the law, or

6 b. the sentence is plainly unreasonable, as determined in
7 accordance with standards and procedures prescribed by
8 the Governor or the Adjutant General.

9 2. An appeal under this subsection shall be filed within sixty
10 (60) days after the date on which the judgment of a court-martial is
11 entered into the record under Section 860C of this title (Article
12 60C).

13 SECTION 66. NEW LAW A new section of law to be codified
14 in the Oklahoma Statutes as Section 857 of Title 44, unless there is
15 created a duplication in numbering, reads as follows:

16 ARTICLE 57. Effective date of sentences.

17 A. Execution of sentences. A court-martial sentence shall be
18 executed and take effect as follows:

19 1. Forfeiture and reduction. A forfeiture of pay or allowances
20 shall be applicable to pay and allowances accruing on and after the
21 date on which the sentence takes effect. Any forfeiture of pay or
22 allowances or reduction in grade that is included in a sentence of a
23 court-martial takes effect on the earlier of:

- a. the date that is fourteen (14) days after the date on which the sentence is adjudged, or
- b. in the case of a summary court-martial, the date on which the sentence is approved by the convening authority;

2. Confinement. Any period of confinement included in a sentence of a court-martial begins to run from the date the sentence is adjudged by the court-martial, but periods during which the sentence to confinement is suspended or deferred shall be excluded in computing the service of the term of confinement;

3. Approval of dismissal. If in the case of a commissioned officer, or cadet, the sentence of a court-martial extends to dismissal, that part of the sentence providing for dismissal may not be executed until approved by the Adjutant General or by the Senior Assistant Adjutant General of the same component as the accused if such authority is so delegated by the Adjutant General. In such a case, the Adjutant General, or Senior Assistant Adjutant General, as the case may be, may commute, remit, or suspend the sentence, or any part of the sentence, as the Adjutant General or Senior Assistant Adjutant General sees fit. In time of war or national emergency he or she may commute a sentence of dismissal to reduction to any enlisted grade. A person so reduced may be required to serve for the duration of the war or emergency and six (6) months thereafter;

4. Completion of appellate review. If a sentence extends to

1 dismissal, or a dishonorable or bad-conduct discharge, that part of
2 the sentence extending to dismissal or a dishonorable or bad-conduct
3 discharge may be executed, in accordance with applicable
4 regulations, after completion of appellate review and, with respect
5 to dismissal, approval under paragraph 3 of this subsection, as
6 appropriate; and

7 5. Other sentences. Except as otherwise provided in this
8 subsection, a general or special court-martial sentence is effective
9 upon entry of judgment and a summary court-martial sentence is
10 effective when the convening authority acts on the sentence.

11 B. Deferral of sentences.

12 1. In general. On application by an accused, the convening
13 authority or, if the accused is no longer under his or her
14 jurisdiction, the officer exercising general court-martial
15 jurisdiction over the command to which the accused is currently
16 assigned, may, in his or her sole discretion, defer the effective
17 date of a sentence of confinement, reduction, or forfeiture. The
18 deferment shall terminate upon entry of judgment or, in the case of
19 a summary court-martial, when the convening authority acts on the
20 sentence. The deferment may be rescinded at any time by the officer
21 who granted it or, if the accused is no longer under his or her
22 jurisdiction, by the officer exercising general court-martial
23 jurisdiction over the command to which the accused is currently
24 assigned.

1 2. Deferral of certain persons sentenced to confinement. In
2 any case in which a court-martial sentences a person referred to in
3 paragraph 3 of this subsection to confinement, the convening
4 authority may defer the service of the sentence to confinement,
5 without the consent of that person, until after the person has been
6 permanently released to the state military forces by a state or
7 foreign country referred to in that paragraph.

8 3. Covered persons. Paragraph 2 of this subsection applies to
9 a person subject to this chapter who:

10 a. while in the custody of a state or foreign country is
11 temporarily returned by that state or foreign country
12 to the state military forces for trial by court-
13 martial, and

14 b. after the court-martial, is returned to that state or
15 foreign country under the authority of a mutual
16 agreement or treaty, as the case may be.

17 4. State defined. In this subsection, the term "state"
18 includes the District of Columbia and any commonwealth, territory,
19 or possession of the United States.

20 5. Deferral while review pending. In any case in which a
21 court-martial sentences a person to confinement, but in which review
22 of the case under subsection A of Section 867 of this title (Article
23 67, subsection A) is pending, the Adjutant General may defer further
24 service of the sentence to confinement while that review is pending.

1 C. Appellate review.

2 1. Completion of appellate review. Appellate review is
3 complete under this section when:

4 a. a review under Section 865 of this title (Article 65)
5 is completed, or

6 b. a review under Section 866 of this title (Article 66)
7 is completed by the Military Court of Appeals and:

8 (1) the time for the accused to file a Petition for
9 Review by the Court of Criminal Appeals has
10 expired and the accused has not filed a timely
11 petition for such review and the case is not
12 otherwise under review by that Court,

13 (2) such a petition is rejected by the Court of
14 Criminal Appeals, or

15 (3) review is completed in accordance with the
16 judgment of the Court of Criminal Appeals.

17 2. Completion as final judgment of legality of proceedings.

18 The completion of appellate review shall constitute a final judgment
19 as to the legality of the proceedings.

20 SECTION 67. NEW LAW A new section of law to be codified
21 in the Oklahoma Statutes as Section 858 of Title 44, unless there is
22 created a duplication in numbering, reads as follows:

23 ARTICLE 58. Execution of confinement.
24

1 A. Under such regulations as the Governor or Adjutant General
2 may prescribe, a sentence of confinement adjudged by a court-
3 martial, whether or not the sentence includes discharge or
4 dismissal, and whether or not the discharge or dismissal has been
5 executed, may be carried into execution by confinement in any place
6 of confinement under the control of the state military forces or in
7 any penal or correctional institution used or under the control of
8 the Oklahoma Department of Corrections. Persons so confined in a
9 penal or correctional institution not under the control of the state
10 military forces are subject to the same discipline and treatment as
11 persons confined or committed by the courts of this state.

12 B. No confinement ordered by a court-martial shall include hard
13 labor.

14 SECTION 68. NEW LAW A new section of law to be codified
15 in the Oklahoma Statutes as Section 858A of Title 44, unless there
16 is created a duplication in numbering, reads as follows:

17 ARTICLE 58A. Sentences: reduction in enlisted grade.

18 A. A court-martial sentence of an enlisted member in a pay
19 grade above E-1, as set forth in the judgment of the court-martial
20 entered into the record under Section 860C of this title (Article
21 60C), that includes:

- 22 1. A dishonorable or bad-conduct discharge; or
- 23 2. Confinement,

1 reduces that member to pay grade E-1, if such a reduction is
2 authorized by regulation prescribed by the Governor or Adjutant
3 General. The reduction in pay grade shall take effect on the date
4 on which the judgment is so entered.

5 B. If the sentence of a member who is reduced in pay grade
6 under subsection A of this section is set aside or reduced, or, as
7 finally affirmed, does not include any punishment named in
8 paragraphs 1 or 2 of subsection A of this section, the rights and
9 privileges of which he or she was deprived because of that reduction
10 shall be restored to him or her and he or she is entitled to the pay
11 and allowances to which he or she would have been entitled, for the
12 period the reduction was in effect, had he or she not been so
13 reduced.

14 SECTION 69. NEW LAW A new section of law to be codified
15 in the Oklahoma Statutes as Section 858B of Title 44, unless there
16 is created a duplication in numbering, reads as follows:

17 ARTICLE 58B. Sentences: forfeiture of pay and allowances during
18 confinement.

19 A. 1. A court-martial sentence described in paragraph 2 of
20 this subsection shall result in the forfeiture of pay, or of pay and
21 allowances, due that member during any period of confinement or
22 parole. The forfeiture pursuant to this article shall take effect
23 on the date determined under Section 857 of this title (Article 57)
24 and may be deferred as provided in that article. The pay and

1 allowances forfeited, in the case of a general court-martial, shall
2 be all pay and allowances due that member during such period and, in
3 the case of a special court-martial, shall be two-thirds of all pay
4 due that member during such period.

5 2. A sentence covered by this section is any sentence that
6 includes:

- 7 a. confinement for more than six (6) months; or
- 8 b. confinement for six (6) months or less and a
9 dishonorable or bad-conduct discharge or dismissal.

10 B. In a case involving an accused who has dependents, the
11 convening authority or other person acting under Section 860A or
12 860B of this title (Article 60A or 60B) may waive any or all of the
13 forfeitures of pay and allowances required by subsection A of this
14 section for a period not to exceed six (6) months. Any amount of
15 pay or allowances that, except for a waiver under this subsection,
16 would be forfeited shall be paid, as the convening authority or
17 other person taking action directs, to the dependents of the
18 accused.

19 C. If the sentence of a member who forfeits pay and allowances
20 under subsection A of this section is set aside or disapproved or,
21 as finally approved, does not provide for a punishment referred to
22 in paragraph 2 of subsection A of this section, the member shall be
23 paid the pay and allowances which the member would have been paid,
24

1 except for the forfeiture, for the period which the forfeiture was
2 in effect.

3 SECTION 70. NEW LAW A new section of law to be codified
4 in the Oklahoma Statutes as Section 858C of Title 44, unless there
5 is created a duplication in numbering, reads as follows:

6 ARTICLE 58C. Enforcement of fines or adjudication of pecuniary
7 liability.

8 When a sentence, including a fine, or a finally approved
9 adjudication of pecuniary liability under a report of survey or
10 financial liability investigation of property loss (FLIPL) has been
11 ordered executed pursuant to regulations promulgated by the Adjutant
12 General, the collection of the fine or the adjudication of pecuniary
13 liability may be made executory and enforced by the Oklahoma
14 Attorney General, or his or her designee, in the judicial district
15 as described in Section 22 of Title 20 of the Oklahoma Statutes in
16 which the court martial was held or in the district court judicial
17 district, where nonjudicial punishment was decided or district court
18 judicial district of residence of the accused or person against whom
19 the pecuniary charge was raised in the same manner as a money
20 judgment in a civil case or by the withholding of any funds due the
21 accused from the state or any of its agencies in accordance with
22 regulations prescribed by the Adjutant General. To the extent not
23 prohibited by federal law or regulation, a fine may be enforced by
24 withholding federal funds due the accused.

PART IX.

POSTTRIAL PROCEDURE AND REVIEW OF COURTS-MARTIAL

SECTION 71. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 859 of Title 44, unless there is created a duplication in numbering, reads as follows:

ARTICLE 59. Error of law; lesser included offense.

A. A finding or sentence of court-martial may not be held incorrect on the ground of an error of law unless the error materially prejudices the substantial rights of the accused.

B. Any reviewing authority with the power to approve or affirm a finding of guilty may approve or affirm, instead, so much of the finding as includes a lesser included offense.

SECTION 72. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 860 of Title 44, unless there is created a duplication in numbering, reads as follows:

ARTICLE 60. Posttrial processing in general and special courts-martial

A. Statement of trial results.

1. The military judge of a general or special court-martial shall enter into the record of trial a document entitled "Statement of Trial Results", which shall set forth:

a. each plea and finding,

b. the sentence, if any, and

1 c. such other information as the Adjutant General may
2 prescribe by regulation.

3 2. Copies of the Statement of Trial Results shall be provided
4 promptly to the convening authority, the accused, and any victim of
5 the offense.

6 B. Posttrial motions. In accordance with regulations
7 prescribed by the Adjutant General, the military judge in a general
8 or special court-martial shall address all posttrial motions and
9 other posttrial matters that:

10 1. May affect a plea, a finding, the sentence, the Statement of
11 Trial Results, the record of trial, or any posttrial action by the
12 convening authority; and

13 2. Are subject to resolution by the military judge before entry
14 of judgment.

15 SECTION 73. NEW LAW A new section of law to be codified in
16 the Oklahoma Statutes as Section 860A of Title 44, unless there is
17 created a duplication in numbering, reads as follows:

18 ARTICLE 60A. Limited authority to act on sentence in specified
19 posttrial circumstances

20 A. In general.

21 1. The convening authority of a general or special court-
22 martial described in paragraph 2 of this subsection:

23 a. may act on the sentence of the court-martial only as
24 provided in subsection B, C or D of this section, and

1 b. may not act on the findings of the court-martial.

2 2. The courts-martial referred to in paragraph 1 of this
3 subsection are the following:

4 a. a general or special court-martial in which the
5 maximum sentence of confinement established under
6 subsection A of Section 856 of this title (Article 56,
7 subsection A) for any offense of which the accused is
8 found guilty is more than two (2) years,

9 b. a general or special court-martial in which the total
10 of the sentences of confinement imposed, running
11 consecutively, is more than six (6) months, and

12 c. a general or special court-martial in which the
13 sentence imposed includes a dismissal, dishonorable
14 discharge, or bad-conduct discharge.

15 3. Except as provided in subsection D of this section, the
16 convening authority may act under this section only before entry of
17 judgment.

18 4. Under regulations prescribed by the Adjutant General, a
19 commissioned officer commanding for the time being, a successor in
20 command, or any person exercising general court-martial jurisdiction
21 may act under this section in place of the convening authority.

22 B. Reduction, commutation, and suspension of sentences
23 generally.
24

1 1. Except as provided in subsection C or D of this section, the
2 convening authority may not reduce, commute, or suspend any of the
3 following sentences:

- 4 a. a sentence of confinement, if the total period of
5 confinement imposed for all offenses involved, running
6 consecutively, is greater than six (6) months, and
- 7 b. a sentence of dismissal, dishonorable discharge, or
8 bad-conduct discharge.

9 2. The convening authority may reduce, commute, or suspend any
10 sentence not specified in paragraph 1 of this subsection.

11 C. Suspension of certain sentences upon recommendation of
12 military judge.

13 1. Upon recommendation of the military judge, as included in
14 the Statement of Trial Results, together with an explanation of the
15 facts supporting the recommendation, the convening authority may
16 suspend:

- 17 a. a sentence of confinement, in whole or in part, or
- 18 b. a sentence of dismissal, dishonorable discharge, or
19 bad-conduct discharge.

20 2. The convening authority may not, under paragraph 1 of this
21 subsection:

- 22 a. suspend a mandatory minimum sentence, or
- 23 b. suspend a sentence to an extent in excess of the
24 suspension recommended by the military judge.

1 D. Reduction of sentence for substantial assistance by accused.

2 1. Upon a recommendation by the trial counsel, if the accused,
3 after sentencing and before entry of judgment, provides substantial
4 assistance in the investigation or prosecution of another person,
5 the convening authority may reduce, commute, or suspend a sentence,
6 in whole or in part, including any mandatory minimum sentence.

7 2. Upon a recommendation by a trial counsel, designated in
8 accordance with regulations prescribed by the Adjutant General, if
9 the accused, after entry of judgment, provides substantial
10 assistance in the investigation or prosecution of another person, a
11 convening authority, designated under such regulations, may reduce,
12 commute, or suspend a sentence, in whole or in part, including any
13 mandatory minimum sentence.

14 3. In evaluating whether the accused has provided substantial
15 assistance under this subsection, the convening authority may
16 consider the presentence assistance of the accused.

17 E. Submissions by accused and victim.

18 1. In accordance with regulations prescribed by the Adjutant
19 General, in determining whether to act under this section, the
20 convening authority shall consider matters submitted in writing by
21 the accused or any victim of an offense. Such rules shall include:

- 22 a. procedures for notice of the opportunity to make such
23 submissions,
24 b. the deadlines for such submissions, and

1 c. procedures for providing the accused and any victim of
2 an offense with a copy of the recording of any open
3 sessions of the court-martial and copies of, or access
4 to, any admitted, unsealed exhibits.

5 2. The convening authority shall not consider under this
6 section any submitted matters that relate to the character of a
7 victim unless such matters were presented as evidence at trial and
8 not excluded at trial.

9 F. Decision of convening authority.

10 1. The decision of the convening authority under this section
11 shall be forwarded to the military judge, with copies provided to
12 the accused and to any victim of the offense.

13 2. If, under this section, the convening authority reduces,
14 commutes, or suspends the sentence, the decision of the convening
15 authority shall include a written explanation of the reasons for
16 such action.

17 3. If, under paragraph 2 of subsection D of this section, the
18 convening authority reduces, commutes, or suspends the sentence, the
19 decision of the convening authority shall be forwarded to the
20 military judge for appropriate modification of the entry of
21 judgment, which shall be transmitted to the State Judge Advocate for
22 appropriate action.

SECTION 74. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 860B of Title 44, unless there is created a duplication in numbering, reads as follows:

ARTICLE 60B. Posttrial actions in summary courts-martial and certain general and special courts-martial.

A. In general.

1. In a court-martial not specified in paragraph 2 of subsection A of Section 860A of this title (Article 60A, subsection A, paragraph 2), the convening authority may:

- a. dismiss any charge or specification by setting aside the finding of guilty,
- b. change a finding of guilty to a charge or specification to a finding of guilty to a lesser included offense,
- c. disapprove the findings and the sentence and dismiss the charges and specifications,
- d. disapprove the findings and the sentence and order a rehearing as to the findings and the sentence,
- e. disapprove, commute, or suspend the sentence, in whole or in part, or
- f. disapprove the sentence and order a rehearing as to the sentence.

1 2. In a summary court-martial, the convening authority shall
2 approve the sentence or take other action on the sentence under
3 paragraph 1 of this subsection.

4 3. Except as provided in paragraph 4 of this subsection, the
5 convening authority may act under this section only before entry of
6 judgment.

7 4. The convening authority may act under this section after
8 entry of judgment in a general or special court-martial in the same
9 manner as the convening authority may act under paragraph 2 of
10 subsection D of Section 860A of this title ((Article 60A, subsection
11 D, paragraph 2)). Such action shall be forwarded to the military
12 judge, who shall ensure appropriate modification to the entry of
13 judgment and shall transmit the entry of judgment to the State Judge
14 Advocate for appropriate action.

15 5. Under regulations prescribed by the Adjutant General, a
16 commissioned officer commanding for the time being, a successor in
17 command, or any person exercising general court-martial jurisdiction
18 may act under this section in place of the convening authority.

19 B. Limitations on rehearings. The convening authority may not
20 order a rehearing under this section:

21 1. As to the findings, if there is insufficient evidence in the
22 record to support the findings;

23 2. To reconsider a finding of not guilty of any specification
24 or a ruling which amounts to a finding of not guilty; or

1 3. To reconsider a finding of not guilty of any charge, unless
2 there has been a finding of guilty under a specification laid under
3 that charge, which sufficiently alleges a violation of some section
4 of the Oklahoma Uniform Code of Military Justice.

5 C. Submissions by accused and victim. In accordance with
6 regulations prescribed by the Adjutant General, in determining
7 whether to act under this section, the convening authority shall
8 consider matters submitted in writing by the accused or any victim
9 of the offense. Such rules shall include the matter required by
10 subsection E of Section 860A of this title (Article 60A, subsection
11 E).

12 D. Decision of convening authority.

13 1. In a general or special court-martial, the decision of the
14 convening authority under this section shall be forwarded to the
15 military judge, with copies provided to the accused and to any
16 victim of the offense.

17 2. If the convening authority acts on the findings or the
18 sentence under paragraph 1 of subsection A of this section, the
19 decision of the convening authority shall include a written
20 explanation of the reasons for such action.

21 SECTION 75. NEW LAW A new section of law to be codified
22 in the Oklahoma Statutes as Section 860C of Title 44, unless there
23 is created a duplication in numbering, reads as follows:

24 ARTICLE 60C. Entry of judgment.

1 A. Entry of judgment of general or special court-martial.

2 1. In accordance with regulations prescribed by the Adjutant
3 General, in a general or special court-martial, the military judge
4 shall enter into the record of trial the judgment of the court. The
5 judgment of the court shall consist of the following:

6 a. the Statement of Trial Results under Section 860 of
7 this title (Article 60),

8 b. any modifications of, or supplements to, the Statement
9 of Trial Results by reason of:

10 (1) any posttrial action by the convening authority,
11 or

12 (2) any ruling, order, or other determination of the
13 military judge that affects a plea, a finding, or
14 the sentence.

15 2. Under regulations prescribed by the Adjutant General, the
16 judgment under paragraph 1 of this subsection shall be:

17 a. provided to the accused and to any victim of the
18 offense, and

19 b. made available to the public.

20 B. Summary court-martial judgment. The findings and sentence
21 of a summary court-martial, as modified by any posttrial action by
22 the convening authority under Section 860B of this title (Article
23 60B), constitutes the judgment of the court-martial and shall be
24

1 recorded and distributed under regulations prescribed by the
2 Adjutant General.

3 SECTION 76. NEW LAW A new section of law to be codified
4 in the Oklahoma Statutes as Section 861 of Title 44, unless there is
5 created a duplication in numbering, reads as follows:

6 ARTICLE 61. Waiver of right to appeal; withdrawal of appeal.

7 A. Waiver of right to appeal. After entry of judgment in a
8 general or special court-martial, under regulations promulgated by
9 the Adjutant General, the accused may waive the right to appellate
10 review in each case subject to such review under Section 866 of this
11 title (Article 66). Such a waiver shall be:

12 1. Signed by the accused and by defense counsel; and

13 2. Attached to the record of trial.

14 B. Withdrawal of appeal. In a general or special court-
15 martial, the accused may withdraw an appeal at any time.

16 C. Waiver or withdrawal as bar. A waiver or withdrawal under
17 this section bars review under Section 866 of this title (Article
18 66).

19 SECTION 77. NEW LAW A new section of law to be codified
20 in the Oklahoma Statutes as Section 862 of Title 44, unless there is
21 created a duplication in numbering, reads as follows:

22 ARTICLE 62. Appeal by the State of Oklahoma.
23
24

1 A. 1. In a trial by general or special court-martial, or in a
2 pretrial proceeding under Section 830A of this title (Article 30A),
3 the State of Oklahoma may appeal the following:

- 4 a. an order or ruling of the military judge which
5 terminates the proceedings with respect to a charge or
6 specification,
- 7 b. an order or ruling which excludes evidence that is
8 substantial proof of a fact material in the
9 proceeding,
- 10 c. an order or ruling which directs the disclosure of
11 classified or confidential information,
- 12 d. an order or ruling which imposes sanctions for
13 nondisclosure of classified or confidential
14 information,
- 15 e. a refusal of the military judge to issue a protective
16 order sought by the State of Oklahoma to prevent the
17 disclosure of classified or confidential information,
- 18 f. a refusal by the military judge to enforce an order
19 described in subparagraph e of this paragraph that has
20 previously been issued by appropriate authority, and
- 21 g. an order or ruling of the military judge entering a
22 finding of not guilty with respect to a charge or
23 specification following the return of a finding of
24 guilty by the members.

1 2. a. An appeal of an order or ruling may not be taken
2 unless the trial counsel provides the military judge
3 with written notice of appeal from the order or ruling
4 within seventy-two (72) hours of the order or ruling.
5 Such notice shall include a certification by the trial
6 counsel that the appeal is not taken for the purpose
7 of delay and (if the order or ruling appealed is one
8 which excludes evidence) that the evidence excluded is
9 substantial proof of a fact material in the
10 proceeding.

11 b. An appeal of an order or ruling may not be taken when
12 prohibited by Section 844 of this title (Article 44).

13 3. An appeal under this section shall be diligently prosecuted
14 by appellate government counsel.

15 B. An appeal under this section shall be forwarded by a means
16 prescribed under regulations of the Adjutant General directly to the
17 Military Court of Appeals and shall, whenever practicable, have
18 priority over all other proceedings before that court. In ruling on
19 an appeal under this section, the Military Court of Appeals may act
20 only with respect to matters of law.

21 C. Any period of delay resulting from an appeal under this
22 section shall be excluded in deciding any issue regarding denial of
23 a speedy trial unless an appropriate authority determines that the
24

1 appeal was filed solely for the purpose of delay with the knowledge
2 that it was totally frivolous and without merit.

3 D. The provisions of this section shall be liberally construed
4 to effect its purposes.

5 SECTION 78. NEW LAW A new section of law to be codified
6 in the Oklahoma Statutes as Section 863 of Title 44, unless there is
7 created a duplication in numbering, reads as follows:

8 Article 63. Rehearings.

9 A. Each rehearing under the Oklahoma Uniform Code of Military
10 Justice shall take place before a court-martial composed of members
11 who were not members of the court-martial which first heard the
12 case. Upon a rehearing the accused may not be tried for any offense
13 of which he or she was found not guilty by the first court-martial,
14 and no sentence in excess of or more severe than the original
15 sentence may be adjudged, unless the sentence is based upon a
16 finding of guilty of an offense not considered upon the merits in
17 the original proceedings, or unless the sentence prescribed for the
18 offense is mandatory.

19 B. If the sentence adjudged by the first court-martial was in
20 accordance with a plea agreement under Section 853A of this title
21 (Article 53A) and the accused at the rehearing does not comply with
22 the agreement, or if a plea of guilty was entered for an offense at
23 the first court-martial and a plea of not guilty was entered at the
24 rehearing, the sentence as to those charges or specifications may

1 include any punishment not in excess of that which could have been
2 adjudged at the first court-martial, subject to such limitations as
3 the Adjutant General may prescribe by regulation.

4 C. If, after appeal by the government under subsection C of
5 Section 856 of this title (Article 56, subsection C), the sentence
6 adjudged is set aside and a rehearing on sentence is ordered by the
7 Military Court of Appeals or Court of Criminal Appeals, the court-
8 martial may impose any sentence that is in accordance with the order
9 or ruling setting aside the adjudged sentence, subject to such
10 limitations as the Adjutant General may prescribe by regulation.

11 SECTION 79. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 864 of Title 44, unless there is
13 created a duplication in numbering, reads as follows:

14 ARTICLE 64. Judge advocate review of finding of guilty in
15 summary court-martial.

16 A. In general. Under regulations prescribed by the Adjutant
17 General, each summary court-martial in which there is a finding of
18 guilty shall be reviewed by a judge advocate. A judge advocate may
19 not review a case under this subsection if the judge advocate has
20 acted in the same case as an accuser, preliminary hearing officer,
21 member of the court, military judge, or counsel or has otherwise
22 acted on behalf of the prosecution or defense. The judge advocate's
23 review shall be in writing and shall contain the following:

24 1. Conclusions as to whether:

- a. the court had jurisdiction over the accused and the offense,
- b. the charge and specification stated an offense, and
- c. the sentence was within the limits prescribed as a matter of law;

2. A response to each allegation of error made in writing by the accused; and

3. If the case is sent for action under subsection B of this section, a recommendation as to the appropriate action to be taken and an opinion as to whether corrective action is required as a matter of law.

B. Record. The record of trial and related documents in each case reviewed under subsection A of this section shall be sent for action to the person exercising general court-martial jurisdiction over the accused at the time the court was convened (or to that person's successor in command) if:

1. The judge advocate who reviewed the case recommends corrective action; or

2. Such action is otherwise required by regulations of the Adjutant General.

C. 1. The person to whom the record of trial and related documents are sent under subsection B of this section may:

- a. disapprove or approve the findings or sentence, in whole or in part,

- 1 b. remit, commute, or suspend the sentence in whole or in
2 part,
3 c. except where the evidence was insufficient at the
4 trial to support the findings, order a rehearing on
5 the findings, on the sentence, or on both, or
6 d. dismiss the charges.

7 2. If a rehearing is ordered but the convening authority finds
8 a rehearing impracticable, he or she shall dismiss the charges.

9 3. If the opinion of the judge advocate in the judge advocate's
10 review under subsection A of this section is that corrective action
11 is required as a matter of law and if the person required to take
12 action under subsection B does not take action that is at least as
13 favorable to the accused as that recommended by the judge advocate,
14 the record of trial and action thereon shall be sent to the State
15 Judge Advocate for review under Section 869 of this title (Article
16 69).

17 SECTION 80. NEW LAW A new section of law to be codified
18 in the Oklahoma Statutes as Section 865 of Title 44, unless there is
19 created a duplication in numbering, reads as follows:

20 ARTICLE 65. Transmittal and review of records.

21 A. Transmittal of records.

22 1. Finding of guilty in general or special court-martial. If
23 the judgment of a general or special court-martial entered under
24

1 Section 860C of this title (Article 60C) includes a finding of
2 guilty, the record shall be transmitted to the State Judge Advocate.

3 2. Other cases. In all other cases, records of trial by court-
4 martial and related documents shall be transmitted and disposed of
5 as the Adjutant General may prescribe by regulation.

6 B. Cases for direct appeal.

7 1. Automatic review. If the judgment includes a sentence of
8 dismissal of a commissioned officer, or cadet, dishonorable
9 discharge or bad-conduct discharge, or confinement for two (2) years
10 or more, the State Judge Advocate shall forward the record of trial
11 to the Military Court of Appeals for review under paragraph 3 of
12 subsection F of Section 866 of this title (Article 66, subsection F,
13 paragraph 3).

14 2. Cases eligible for direct appeal review.

15 a. In general. If the case is eligible for direct review
16 under paragraph 1 of subsection F of Section 866 of
17 this title (Article 66, subsection F, paragraph 1),
18 the State Judge Advocate shall:

- 19 (1) forward a copy of the record of trial to an
20 appellate defense counsel who shall be detailed
21 to review the case and, upon request of the
22 accused, to represent the accused before the
23 Military Court of Appeals, and
24

1 (2) upon written request of the accused, forward a
2 copy of the record of trial to civilian counsel
3 provided by the accused.

4 b. Inapplicability. Subparagraph a of this paragraph
5 shall not apply if the accused:

6 (1) waives the right to appeal under Section 861 of
7 this title (Article 61), or

8 (2) declines in writing the detailing of appellate
9 defense counsel under division (1) of
10 subparagraph a of this paragraph.

11 C. Notice of right to appeal.

12 1. In general. The State Judge Advocate shall provide notice
13 to the accused of the right to file an appeal under paragraph 1 of
14 subsection F of Section 866 of this title (Article 66, subsection F,
15 paragraph 1) by means of depositing in the United States mails for
16 delivery by first class certified mail to the accused at an address
17 provided by the accused or, if no such address has been provided by
18 the accused, at the latest address listed for the accused in the
19 official service record of the accused.

20 2. Inapplicability upon waiver of appeal. Paragraph 1 of this
21 subsection shall not apply if the accused waives the right to appeal
22 under Section 861 of this title (Article 61).

23 D. Review by State Judge Advocate.
24

1 1. By whom. A review conducted under this subsection may be
2 conducted by an attorney within the Office of the State Judge
3 Advocate or another attorney designated under regulations prescribed
4 by the Adjutant General.

5 2. Review of cases not eligible for direct appeal.

6 a. In general. A review under subparagraph b of this
7 paragraph shall be completed in each general and
8 special court-martial that is not eligible for direct
9 appeal under paragraph 1 or 3 of subsection F of
10 Section 866 of this title (Article 66, subsection F,
11 paragraph 1 or 3).

12 b. Scope of review. A review referred to in subparagraph
13 a of this paragraph shall include a written decision
14 providing each of the following:

- 15 (1) a conclusion as to whether the court had
16 jurisdiction over the accused and the offense,
17 (2) a conclusion as to whether the charge and
18 specification stated an offense,
19 (3) a conclusion as to whether the sentence was
20 within the limits prescribed as a matter of law,
21 and
22 (4) a response to each allegation of error made in
23 writing by the accused.
24

1 3. Review when direct appeal is waived, withdrawn, or not
2 filed.

3 a. In general. A review under subparagraph b of this
4 paragraph shall be completed in each general and
5 special court-martial if:

6 (1) the accused waives the right to appeal or
7 withdraws appeal under Section 861 of this title
8 (Article 61), or

9 (2) the accused does not file a timely appeal in a
10 case eligible for direct appeal under
11 subparagraph a, b or c of paragraph 1 of
12 subsection F of Section 866 of this title
13 (Article 66, subsection F, paragraph 1,
14 subparagraph a, b or c).

15 b. Scope of review. A review referred to in subparagraph
16 a of this paragraph shall include a written decision
17 limited to providing conclusions on the matters
18 specified in divisions (1), (2) and (3) of
19 subparagraph b of paragraph 2 of this subsection.

20 E. Remedy.

21 1. In general. If, after a review of a record under subsection
22 D of this section, the attorney conducting the review believes
23 corrective action may be required, the record shall be forwarded to
24

1 the State Judge Advocate, who may set aside the findings or
2 sentence, in whole or in part.

3 2. Rehearing. In setting aside findings or sentence, the State
4 Judge Advocate may order a rehearing, except that a rehearing may
5 not be ordered in violation of Section 844 of this title (Article
6 44).

7 3. Remedy without rehearing.

8 a. Dismissal when no rehearing ordered. If the State
9 Judge Advocate sets aside findings and sentence and
10 does not order a rehearing, the State Judge Advocate
11 shall dismiss the charges.

12 b. Dismissal when rehearing impractical. If the State
13 Judge Advocate sets aside findings and orders a
14 rehearing and the convening authority determines that
15 a rehearing would be impractical, the convening
16 authority shall dismiss the charges.

17 SECTION 81. NEW LAW A new section of law to be codified
18 in the Oklahoma Statutes as Section 866 of Title 44, unless there is
19 created a duplication in numbering, reads as follows:

20 ARTICLE 66. Military Court of Appeals for state military
21 forces.

22 A. Military Court of Appeals. There is hereby established a
23 Military Court of Appeals for the state military forces of the State
24 of Oklahoma. The Military Court of Appeals shall be a court of

1 record and except as provided in Section 867 of this title (Article
2 67), the appellate jurisdiction of the Military Court of Appeals
3 shall be exclusive in all courts-martial cases convened by state
4 military forces regardless of whether a court-martial was conducted
5 within or without the physical boundaries of the State of Oklahoma.

6 B. Composition and method of appointment. The Military Court
7 of Appeals shall be composed of one panel of not less than three
8 appellate military judges. At the time the Military Court of
9 Appeals is initially constituted and each time thereafter when a
10 vacancy shall occur or is certain to occur on the Court, the State
11 Judge Advocate shall choose and submit to the Governor at least one
12 nominee for a vacant seat, certified by the State Judge Advocate as
13 qualified, by reason of education, training, experience, and
14 judicial temperament, for duty as an appellate military judge.
15 Prior to submission of a nominee to the Governor, the nominee shall
16 have previously notified the State Judge Advocate in writing that he
17 or she will serve as an appellate military judge if appointed. The
18 Governor shall appoint one nominee to fill the vacancy, but if the
19 Governor fails to do so within sixty (60) days after the State Judge
20 Advocate submits the nominee to the Governor or the Governor does
21 not affirmatively reject in writing the nominee so submitted, the
22 State Judge Advocate shall appoint one nominee, the appointment to
23 be certified by the Secretary of State. No person so nominated and
24 appointed by the Governor or by the State Judge Advocate shall take

1 his or her seat on the Military Court of Appeals without first
2 receiving the approbation of the Senate through advice and consent.

3 C. Qualifications. An appellate military judge who is
4 appointed to the Military Court of Appeals shall be a licensed
5 practicing attorney or judge of a court of record, or both, in
6 Oklahoma for one year preceding his or her appointment and shall
7 continue to be a duly licensed attorney while in office to be
8 eligible to hold the office. No appellate military judge shall be
9 appointed to the Military Court of Appeals who did not previously
10 serve as a judge advocate in any department of the Armed Forces of
11 the United States, to include reserve components of the same. The
12 Military Court of Appeals shall include at least one appellate
13 military judge who previously served in the United States Army or a
14 reserve component of the same. The Military Court of Appeals shall
15 include at least one appellate military judge who previously served
16 in the United States Air Force or a reserve component of the same.

17 D. Term of office and causes for removal or retirement. Each
18 appellate military judge appointed pursuant to this section shall,
19 unless removed for cause, serve out the term for which he or she is
20 appointed. Appellate military judges appointed pursuant to this
21 section shall serve for fixed terms of office of appropriate minimum
22 periods which shall be prescribed by regulations promulgated by the
23 Adjutant General. The appellate military judges of the Military
24 Court of Appeals, exercising judicial power under the provisions of

1 the Oklahoma Uniform Code of Military Justice, shall be subject to
2 removal from office, or to compulsory retirement from office, by
3 proceedings in the Court on the Judiciary, for:

4 1. Gross neglect of duty, corruption in office, habitual
5 drunkenness, commission while in office of any offense involving
6 moral turpitude, gross partiality in office, oppression in office,
7 mental or physical disability preventing the proper performance of
8 official duty or incompetence to perform the duties of the office;
9 or

10 2. Other reasons arising from military customs and practices
11 defined in regulations promulgated by the Adjutant General.

12 E. Compensation. Appellate military judges shall receive
13 compensation calculated on the basis of the current basic pay
14 received by a member in active federal service at the grade of O-6
15 with twenty (20) years of time in service. The Adjutant General
16 shall promulgate regulations establishing the method of calculating
17 compensation for less than full-time service by members of the
18 Military Court of Appeals. Appellate military judges may be paid
19 such actual and necessary expenses as may be provided for in
20 regulations promulgated by the Adjutant General.

21 F. Review.

22 1. Appeals by accused. The Military Court of Appeals shall
23 have jurisdiction over a timely appeal from the judgment of a court-

1 martial, entered into the record under Section 860C of this title
2 (Article 60C), as follows:

- 3 a. on appeal by the accused in a case in which the
4 sentence extends to confinement for more than six (6)
5 months and the case is not subject to automatic review
6 under paragraph 3 of this subsection,
- 7 b. on appeal by the accused in a case in which the
8 government previously filed an appeal under Section
9 862 of this title (Article 62),
- 10 c. on appeal by the accused in a case that the State
11 Judge Advocate has sent to the Military Court of
12 Appeals for review of the sentence under subsection C
13 of Section 856 of this title (Article 56, subsection
14 C),
- 15 d. in a case in which the accused filed an application
16 for review with the Court under subparagraph b of
17 paragraph 1 of subsection D of Section 869 of this
18 title (Article 69, subsection D, paragraph 1,
19 subparagraph b) and the application has been granted
20 by the Court.

21 2. Review of certain sentences. The Military Court of Appeals
22 shall have jurisdiction over all cases that the State Judge Advocate
23 orders sent to the Court for review under subsection C of Section
24 856 of this title (Article 56, subsection C).

1 3. Automatic review. The Military Court of Appeals shall have
2 jurisdiction over a court-martial in which the judgment entered into
3 the record under Section 860C of this title (Article 60C) includes a
4 sentence of dismissal of a commissioned officer, cadet, dishonorable
5 discharge or bad-conduct discharge, or confinement for two (2) years
6 or more.

7 G. Timeliness. An appeal under paragraph 1 of subsection F of
8 this section is timely if it is filed as follows:

9 1. In the case of an appeal by the accused under subparagraph a
10 or b of paragraph 1 of subsection F of this section, if filed before
11 the later of:

12 a. the end of the ninety-day period beginning on the date
13 the accused is provided notice of appellate rights
14 under subsection C of Section 865 of this title
15 (Article 65, subsection C), or

16 b. the date set by the Military Court of Appeals by rule
17 or order; and

18 2. In the case of an appeal by the accused under paragraph 1 of
19 subsection C of Section 865 of this title (Article 65, subsection C,
20 paragraph 1), if filed before the later of:

21 a. the end of the ninety-day period beginning on the date
22 the accused is notified that the application for
23 review has been granted by letter placed in the United
24 States mails for delivery by first class certified

1 mail to the accused at an address provided by the
2 accused or, if no such address has been provided by
3 the accused, at the latest address listed for the
4 accused in his or her official service record, or
5 b. the date set by the Military Court of Appeals by rule
6 or order.

7 H. Duties.

8 1. Cases appealed by accused. In any case before the Military
9 Court of Appeals under subsection F of this section, the Court may
10 act only with respect to the findings and sentence as entered into
11 the record under Section 860C of this title (Article 60C). The
12 Court may affirm only such findings of guilty, and the sentence or
13 such part or amount of the sentence, as the Court finds correct on
14 the basis of applicable law.

15 2. Error or excessive delay. In any case before the Military
16 Court of Appeals under subsection F of this section, the Court may
17 provide appropriate relief if the accused demonstrates error or
18 excessive delay in the processing of the court-martial after the
19 judgment was entered into the record under Section 860C of this
20 title (Article 60C).

21 I. Consideration of appeal of sentence by the State of
22 Oklahoma.
23
24

1 1. In general. In considering a sentence on appeal or review
2 as provided in subsection C of Section 856 of this title (Article
3 56, subsection C), the Military Court of Appeals may consider:

4 a. whether the sentence violates the law, and

5 b. whether the sentence is plainly unreasonable.

6 2. Record on appeal or review. In an appeal or review under
7 this subsection or subsection C of Section 856 of this title
8 (Article 56, subsection C), the record on appeal or review shall
9 consist of:

10 a. any portion of the record in the case that is
11 designated as pertinent by either of the parties,

12 b. the information submitted during the sentencing
13 proceeding, and

14 c. any information required by regulations promulgated by
15 the Adjutant General or by rule or order of the
16 Military Court of Appeals.

17 J. Limits of authority.

18 1. Set aside of findings.

19 a. In general. If the Military Court of Appeals sets
20 aside the findings, the Court:

21 (1) may affirm any lesser included offense, and

22 (2) may, except when prohibited by Section 844 of
23 this title (Article 44), order a rehearing.

1 b. Dismissal when no rehearing ordered. If the Military
2 Court of Appeals sets aside the findings and does not
3 order a rehearing, the Court shall order that the
4 charges be dismissed.

5 c. Dismissal when rehearing impracticable. If the
6 Military Court of Appeals orders a rehearing on a
7 charge and the convening authority finds a rehearing
8 impracticable, the convening authority may dismiss the
9 charge.

10 2. Set aside of sentence. If the Military Court of Appeals
11 sets aside the sentence, the Court may:

12 a. modify the sentence to a lesser sentence, or

13 b. order a rehearing.

14 3. Additional proceedings. If the Military Court of Appeals
15 determines that additional proceedings are warranted, the Court may
16 order a hearing as may be necessary to address a substantial issue,
17 subject to such limitations as the Court may direct and under such
18 regulations as the Adjutant General may prescribe.

19 K. Action in accordance with decisions of courts. The State
20 Judge Advocate shall, unless there is to be further action by the
21 Governor, the Adjutant General, or the Oklahoma Court of Criminal
22 Appeals, instruct the appropriate authority to take action in
23 accordance with the decision of the Military Court of Appeals.

1 L. Rules of procedure and designation of chief judge. The
2 State Judge Advocate shall prescribe uniform rules of procedure for
3 the Military Court of Appeals which shall be published as a military
4 publication and shall meet periodically to formulate policies and
5 procedure in regard to review of court-martial cases in the office
6 of the State Judge Advocate and by the Military Court of Appeals.
7 The State Judge Advocate shall designate as chief judge one of the
8 appellate military judges of the Military Court of Appeals.

9 M. Prohibition on evaluation of other members of courts. No
10 member of the Military Court of Appeals shall be required, or on his
11 or her own initiative be permitted, to prepare, approve, disapprove,
12 review, or submit, with respect to any other member of the Military
13 Court of Appeals, an effectiveness, fitness, or efficiency report,
14 or any other report or document used in whole or in part for the
15 purpose of determining whether a member of the state military forces
16 is qualified to be advanced in grade, or in determining the
17 assignment or transfer of a member of the state military forces, or
18 in determining whether a member of the state military forces should
19 be retained as a member of the state military forces.

20 N. Ineligibility of members of courts to review records of
21 cases involving certain prior member service. No member of the
22 Military Court of Appeals shall be eligible to review the record of
23 any trial if such member served as investigating officer in the case
24 or served as a member of the court-martial before which such trial

1 was conducted, or served as military judge, trial or defense
2 counsel, or reviewing officer of such trial.

3 SECTION 82. NEW LAW A new section of law to be codified
4 in the Oklahoma Statutes as Section 867 of Title 44, unless there is
5 created a duplication in numbering, reads as follows:

6 ARTICLE 67. Review by the Oklahoma Court of Criminal Appeals.

7 A. Powers as court of last resort. The Oklahoma Court of
8 Criminal Appeals shall be the court of last resort for all general
9 and special courts-martial convened by the state military forces.
10 In reviewing petitions or appeals granted pursuant to this section,
11 the Oklahoma Court of Criminal Appeals shall have and shall exercise
12 all powers granted to the Court under the Oklahoma Statutes and the
13 Oklahoma Constitution.

14 B. Petition for Review. Except as provided in subsection C of
15 this section for appeals arising from a guilty plea, a decision of
16 the Military Court of Appeals may be reviewed by the Oklahoma Court
17 of Criminal Appeals upon the filing of an appeal in the form of a
18 Petition for Review if a majority of judges on the Oklahoma Court of
19 Criminal Appeals directs that such Petition for Review shall be
20 granted. Decisions of the Military Court of Appeals shall be final
21 unless a Petition for Review is granted by the Oklahoma Court of
22 Criminal Appeals or a writ of certiorari is granted pursuant to
23 subsection C of this section.

1 C. Appeals arising from guilty plea. All appeals taken from
2 any conviction on a plea of guilty shall first be decided by the
3 Military Court of Appeals. In the event the conviction arising from
4 a plea of guilty is upheld by the Court of Military Appeals, an
5 appeal may be taken by petition for writ of certiorari to the
6 Oklahoma Court of Criminal Appeals, as provided in subsection D of
7 this section; provided, such petition must be filed within ninety
8 (90) days from the date of said conviction. The Oklahoma Court of
9 Criminal Appeals may take jurisdiction of any case for the purpose
10 of correcting the appeal records when the same do not disclose
11 judgment and sentence; such jurisdiction shall be for the sole
12 purpose of correcting such defect or defects.

13 D. Procedures established by court rules. The procedures for
14 filing a Petition for Review or appeal made pursuant to subsection B
15 or C of this section shall be as provided in the Rules of the Court
16 of Criminal Appeals; and the Oklahoma Court of Criminal Appeals
17 shall provide by court rules, which shall have the force of statute:

18 1. The procedure to be followed by the courts-martial in the
19 preparation and authentication of transcripts and records in cases
20 appealed under the Oklahoma Uniform Code of Military Justice;

21 2. The procedure to be followed by the Court of Military
22 Appeals in the preparation of the record in cases brought up on
23 appeal to the Oklahoma Court of Criminal Appeals under the Code;

1 3. The procedure to be followed for the completion and
2 submission of the Petition for Review or such other appeals lodged
3 pursuant to the Code; and

4 4. The procedure to be followed for filing a petition for and
5 the issuance of a writ of certiorari.

6 E. Scope of review on certiorari. The scope of review to be
7 afforded on certiorari shall be prescribed by the Oklahoma Court of
8 Criminal Appeals.

9 F. Additional proceedings. If the Oklahoma Court of Criminal
10 Appeals determines that additional proceedings are warranted, the
11 Oklahoma Court of Criminal Appeals may order a hearing, rehearing or
12 other proceedings in accordance with the Rules of the Court of
13 Criminal Appeals.

14 G. Action in accordance with decisions of the Oklahoma Court of
15 Criminal Appeals. The State Judge Advocate shall instruct the
16 appropriate authority to take action in accordance with the decision
17 of the Oklahoma Court of Criminal Appeals.

18 SECTION 83. NEW LAW A new section of law to be codified
19 in the Oklahoma Statutes as Section 867A of Title 44, unless there
20 is created a duplication in numbering, reads as follows:

21 RESERVED.

22 SECTION 84. NEW LAW A new section of law to be codified
23 in the Oklahoma Statutes as Section 868 of Title 44, unless there is
24 created a duplication in numbering, reads as follows:

1 RESERVED

2 SECTION 85. NEW LAW A new section of law to be codified
3 in the Oklahoma Statutes as Section 869 of Title 44, unless there is
4 created a duplication in numbering, reads as follows:

5 ARTICLE 69. Review by State Judge Advocate.

6 A. In general. Upon application by the accused and subject to
7 subsections B, C and D of this section, the State Judge Advocate may
8 modify or set aside, in whole or in part, the findings and sentence
9 in a court-martial that is not reviewed under Section 866 of this
10 title (Article 66).

11 B. Timing. To qualify for consideration, an application under
12 subsection A of this section shall be submitted to the State Judge
13 Advocate not later than one (1) year after the date of completion of
14 review under Section 864 or 865 of this title (Article 64 or 65), as
15 the case may be. The State Judge Advocate may, for good cause
16 shown, extend the period for submission of an application, but may
17 not consider an application submitted more than three (3) years
18 after such completion date.

19 C. Scope.

20 1. a. In a case reviewed under Section 864 or subsection B
21 of Section 865 of this title (Article 64 or Article
22 65, subsection B), the State Judge Advocate may set
23 aside the findings or sentence, in whole or in part,
24 on the grounds of newly discovered evidence, fraud on

1 the court, lack of jurisdiction over the accused or
2 the offense, error prejudicial to the substantial
3 rights of the accused, or the appropriateness of the
4 sentence.

5 b. In setting aside findings or sentence, the State Judge
6 Advocate may order a rehearing, except that a
7 rehearing may not be ordered in violation of Section
8 844 of this title (Article 44).

9 c. If the State Judge Advocate sets aside findings and
10 sentence and does not order a rehearing, the State
11 Judge Advocate shall dismiss the charges.

12 d. If the State Judge Advocate sets aside findings and
13 orders a rehearing and the convening authority
14 determines that a rehearing would be impractical, the
15 convening authority shall dismiss the charges.

16 2. In a case reviewed under subsection B of Section 865 of this
17 title (Article 65, subsection B), review under this section is
18 limited to the issue of whether the waiver or withdrawal of an
19 appeal was invalid under the law. If the State Judge Advocate
20 determines that the waiver or withdrawal of an appeal was invalid,
21 the State Judge Advocate shall order appropriate corrective action
22 under regulations promulgated by the Adjutant General.

23 D. Military Court of Appeals.
24

1 1. The Military Court of Appeals may review the action taken by
2 the State Judge Advocate under subsection C of this section:

3 a. in a case sent to the Military Court of Appeals by
4 order of the State Judge Advocate, or

5 b. in a case submitted to the Military Court of Appeals
6 by the accused in an application for review.

7 2. The Military Court of Appeals may grant an application under
8 subparagraph b of paragraph 1 of this subsection only if:

9 a. the application demonstrates a substantial basis for
10 concluding that the action on review under subsection
11 C of this section constituted prejudicial error, and

12 b. the application is filed not later than the earlier
13 of:

14 (1) sixty (60) days after the date on which the
15 accused is notified of the decision of the State
16 Judge Advocate, or

17 (2) sixty (60) days after the date on which a copy of
18 the decision of the State Judge Advocate is
19 deposited in the United States mails for delivery
20 by first-class certified mail to the accused at
21 an address provided by the accused or, if no such
22 address has been provided by the accused, at the
23 latest address listed for the accused in his or
24 her official service record.

1 3. The submission of an application for review under this
2 subsection does not constitute a proceeding before the Military
3 Court of Appeals for purposes of paragraph 1 of subsection C of
4 Section 870 of this title (Article 70, subsection C, paragraph 1).

5 E. Action only on matters of law. Notwithstanding Section 866
6 of this title (Article 66), in any case reviewed by the Military
7 Court of Appeals under subsection D of this section, the Court may
8 take action only with respect to matters of law.

9 SECTION 86. NEW LAW A new section of law to be codified
10 in the Oklahoma Statutes as Section 870 of Title 44, unless there is
11 created a duplication in numbering, reads as follows:

12 ARTICLE 70. Appellate counsel.

13 A. The State Judge Advocate shall detail in his or her office
14 one or more commissioned officers as appellate government counsel,
15 and one or more commissioned officers as appellate defense counsel,
16 who are qualified under paragraph 1 of subsection B of Section 827
17 of this title (Article 27, subsection B, paragraph 1).

18 B. Appellate government counsel shall represent the State of
19 Oklahoma before the Military Court of Appeals or the Court of
20 Criminal Appeals when directed to do so by the State Judge Advocate.

21 C. Appellate defense counsel shall represent the accused before
22 the Military Court of Appeals, or the Court of Criminal Appeals:

23 1. When requested by the accused;

24 2. When the State of Oklahoma is represented by counsel; or

1 3. When the State Judge Advocate has sent the case to the
2 Military Court of Appeals.

3 D. The accused has the right to be represented before the
4 Military Court of Appeals, or the Court of Criminal Appeals by
5 civilian counsel if provided by him or her.

6 E. Military appellate counsel shall also perform such other
7 functions in connection with the review of court-martial cases as
8 the State Judge Advocate directs.

9 F. As provided in regulations promulgated by the Adjutant
10 General, if needed, the State Judge Advocate may employ civilian
11 appellate counsel for the government and for the defense.

12 SECTION 87. NEW LAW A new section of law to be codified
13 in the Oklahoma Statutes as Section 871 of Title 44, unless there is
14 created a duplication in numbering, reads as follows:

15 RESERVED.

16 SECTION 88. NEW LAW A new section of law to be codified
17 in the Oklahoma Statutes as Section 872 of Title 44, unless there is
18 created a duplication in numbering, reads as follows:

19 ARTICLE 72. Vacation of suspension.

20 A. Before the vacation of the suspension of a special court-
21 martial sentence which as approved includes a bad-conduct discharge,
22 or of any general court-martial sentence, the officer having special
23 court-martial jurisdiction over the probationer shall hold a hearing
24 on the alleged violation of probation. The State Judge Advocate

1 shall detail a judge advocate, who is certified under subsection B
2 of Section 827 of this title (Article 27, subsection B), to conduct
3 the hearing. The probationer shall be represented at the hearing by
4 counsel if the probationer so desires.

5 B. The record of the hearing and the recommendation of the
6 officer having special court-martial jurisdiction shall be sent for
7 action to the Adjutant General. If the Adjutant General vacates the
8 suspension, any unexecuted part of the sentence shall be executed,
9 subject to applicable restrictions in Section 857 of this title
10 (Article 57).

11 C. The suspension of any other sentence may be vacated by any
12 authority competent to convene, for the command in which the accused
13 is serving or assigned, a court of the kind that imposed the
14 sentence.

15 SECTION 89. NEW LAW A new section of law to be codified
16 in the Oklahoma Statutes as Section 873 of Title 44, unless there is
17 created a duplication in numbering, reads as follows:

18 ARTICLE 73. Petition for a new trial.

19 At any time within three (3) years after the date of the entry
20 of judgment under Section 860C of this title (Article 60C), the
21 accused may petition the State Judge Advocate for a new trial on the
22 grounds of newly discovered evidence or fraud on the court. If the
23 accused's case is pending before the Military Court of Appeals or
24 before the Court of Criminal Appeals, the State Judge Advocate shall

1 refer the petition to the appropriate court for action. Otherwise,
2 the State Judge Advocate shall act upon the petition.

3 SECTION 90. NEW LAW A new section of law to be codified
4 in the Oklahoma Statutes as Section 874 of Title 44, unless there is
5 created a duplication in numbering, reads as follows:

6 ARTICLE 74. Remission and suspension.

7 A. The Adjutant General and, when designated by him or her, a
8 Senior Assistant Adjutant General, the State Judge Advocate, or
9 commanding officer may remit or suspend any part or amount of the
10 unexecuted part of any sentence, including all uncollected
11 forfeitures other than a sentence approved by the Governor.

12 B. The Adjutant General may, for good cause, substitute an
13 administrative form of discharge for a discharge or dismissal
14 executed in accordance with the sentence of a court-martial.

15 SECTION 91. NEW LAW A new section of law to be codified
16 in the Oklahoma Statutes as Section 875 of Title 44, unless there is
17 created a duplication in numbering, reads as follows:

18 ARTICLE 75. Restoration.

19 A. Under such regulations as the Adjutant General may
20 promulgate, all rights, privileges, and property affected by an
21 executed part of a court-martial sentence which has been set aside
22 or disapproved, except an executed dismissal or discharge, shall be
23 restored unless a new trial or rehearing is ordered and such
24

1 executed part is included in a sentence imposed upon the new trial
2 or rehearing.

3 B. If a previously executed sentence of dishonorable or bad-
4 conduct discharge is not imposed on a new trial, the Adjutant
5 General shall substitute therefor a form of discharge authorized for
6 administrative issuance unless the accused is to serve out the
7 remainder of his or her enlistment.

8 C. If a previously executed sentence of dismissal is not
9 imposed on a new trial, the Adjutant General shall substitute
10 therefor a form of discharge authorized for administrative issue,
11 and the commissioned officer dismissed by that sentence may be
12 reappointed pursuant to Sections 875 and 12203 of Title 10 of the
13 United States Code and any applicable regulations prescribed
14 thereunder by the President of the United States or the Secretary
15 concerned.

16 SECTION 92. NEW LAW A new section of law to be codified
17 in the Oklahoma Statutes as Section 876 of Title 44, unless there is
18 created a duplication in numbering, reads as follows:

19 ARTICLE 76. Finality of proceedings, findings, and sentences.

20 The appellate review of records of trial provided by the
21 Oklahoma Uniform Code of Military Justice, the proceedings,
22 findings, and sentences of courts-martial as approved, reviewed, or
23 affirmed as required by the Code, and all dismissals and discharges
24 carried into execution under sentences by courts-martial following

1 approval, review, or affirmation as required by the Code, are final
2 and conclusive. Orders publishing the proceedings of courts-martial
3 and all action taken pursuant to those proceedings are binding upon
4 all departments, courts, agencies, and officers of the State of
5 Oklahoma, subject only to action upon a petition for a new trial as
6 provided in Section 873 of this title (Article 73) and to action by
7 the Adjutant General as provided in Section 874 of this title
8 (Article 74) and the authority of the Governor.

9 SECTION 93. NEW LAW A new section of law to be codified
10 in the Oklahoma Statutes as Section 876A of Title 44, unless there
11 is created a duplication in numbering, reads as follows:

12 ARTICLE 76A. Leave required to be taken pending review of
13 certain court-martial convictions.

14 Under regulations promulgated by the Adjutant General, an
15 accused who has been sentenced by a court-martial may be required to
16 take leave pending completion of action under this part if the
17 sentence includes an unsuspended dismissal or an unsuspended
18 dishonorable or bad-conduct discharge. The accused may be required
19 to begin such leave on the date of the entry of judgment under
20 Section 860C of this title (Article 60C) or at any time after such
21 date, and such leave may be continued until the date on which action
22 under this part is completed or may be terminated at any earlier
23 time.

24

SECTION 94. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 876B of Title 44, unless there is created a duplication in numbering, reads as follows:

ARTICLE 76B. Lack of mental capacity or mental responsibility.

A. No person accused of violating a punitive section under the Oklahoma Uniform Code of Military Justice shall be brought to trial by a general or special court-martial if that person is presently suffering from a mental disease or defect rendering him or her mentally incompetent to the extent that he or she is unable to understand the nature of the proceedings against him or her or to conduct or cooperate intelligently in the defense of the case.

B. A person is presumed to have the capacity to stand trial unless the contrary is established.

C. The procedure for determining mental competence shall be established in regulations promulgated by the Adjutant General.

PART X.

PUNITIVE ARTICLES

SECTION 95. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 877 of Title 44, unless there is created a duplication in numbering, reads as follows:

ARTICLE 77. Principals.

Any person punishable under the Oklahoma Uniform Code of
Military Justice who:

1 1. Commits an offense punishable by the Oklahoma Uniform Code
2 of Military Justice, or aids, abets, counsels, commands, or procures
3 its commission; or

4 2. Causes an act to be done which if directly performed by him
5 or her would be punishable by this chapter,
6 shall be a principal.

7 SECTION 96. NEW LAW A new section of law to be codified
8 in the Oklahoma Statutes as Section 878 of Title 44, unless there is
9 created a duplication in numbering, reads as follows:

10 ARTICLE 78. Accessory after the fact.

11 Any person subject to the Oklahoma Uniform Code of Military
12 Justice who, knowing that an offense punishable by the Code has been
13 committed, receives, comforts, or assists the offender in order to
14 hinder or prevent his or her apprehension, trial, or punishment
15 shall be punished as a court-martial may direct.

16 SECTION 97. NEW LAW A new section of law to be codified
17 in the Oklahoma Statutes as Section 879 of Title 44, unless there is
18 created a duplication in numbering, reads as follows:

19 ARTICLE 79. Conviction of offense charged, lesser included
20 offenses.

21 A. In general. An accused may be found guilty of any of the
22 following:

23 1. The offense charged;

24 2. A lesser included offense;

1 3. An attempt to commit the offense charged; and

2 4. An attempt to commit a lesser included offense, if the
3 attempt is an offense in its own right.

4 B. Lesser included offense defined. In this section, the term
5 "lesser included offense" means:

6 1. An offense that is necessarily included in the offense
7 charged; and

8 2. Any lesser included offense so designated by regulation
9 prescribed by the Adjutant General.

10 C. Regulatory authority. Any designation of a lesser-included
11 offense in a regulation referred to in subsection B of this section
12 shall be reasonably included in the greater offense.

13 SECTION 98. NEW LAW A new section of law to be codified
14 in the Oklahoma Statutes as Section 880 of Title 44, unless there is
15 created a duplication in numbering, reads as follows:

16 ARTICLE 80. Attempts.

17 A. An act, done with specific intent to commit an offense under
18 the Oklahoma Uniform Code of Military Justice, amounting to more
19 than mere preparation and tending, even though failing, to effect
20 its commission, shall be an attempt to commit that offense.

21 B. Any person subject to the Code who attempts to commit any
22 offense punishable by the Code shall be punished as a court-martial
23 may direct, unless otherwise specifically prescribed.

1 C. Any person subject to the Code may be convicted of an
2 attempt to commit an offense although it appears on the trial that
3 the offense was consummated.

4 SECTION 99. NEW LAW A new section of law to be codified
5 in the Oklahoma Statutes as Section 881 of Title 44, unless there is
6 created a duplication in numbering, reads as follows:

7 ARTICLE 81. Conspiracy.

8 Any person subject to the Oklahoma Uniform Code of Military
9 Justice who conspires with any other person to commit an offense
10 under the Code shall, if one or more of the conspirators does an act
11 to effect the object of the conspiracy, be punished as a court-
12 martial may direct.

13 SECTION 100. NEW LAW A new section of law to be codified
14 in the Oklahoma Statutes as Section 882 of Title 44, unless there is
15 created a duplication in numbering, reads as follows:

16 ARTICLE 82. Soliciting commission of offenses.

17 A. Soliciting commission of offenses generally. Any person
18 subject to the Oklahoma Uniform Code of Military Justice who
19 solicits or advises another to commit an offense under the Code,
20 other than an offense specified in subsection B of this section,
21 shall be punished as a court-martial may direct.

22 B. Soliciting desertion, mutiny, sedition, or misbehavior
23 before the enemy. Any person subject to the Code who solicits or
24 advises another to violate Section 885 of this title (Article 85),

1 Section 894 of this title (Article 94), or Section 899 of this title
2 (Article 99):

3 1. If the offense solicited or advised is attempted or is
4 committed, shall be punished with the punishment provided for the
5 commission of the offense; and

6 2. If the offense solicited or advised is not attempted or
7 committed, shall be punished as a court-martial may direct.

8 SECTION 101. NEW LAW A new section of law to be codified
9 in the Oklahoma Statutes as Section 883 of Title 44, unless there is
10 created a duplication in numbering, reads as follows:

11 ARTICLE 83. Malingering.

12 Any person subject to the Oklahoma Uniform Code of Military
13 Justice who, with the intent to avoid work, duty, or service:

14 1. Feigns illness, physical disablement, mental lapse, or
15 mental derangement; or

16 2. Intentionally inflicts self-injury,
17 shall be punished as a court-martial may direct.

18 SECTION 102. NEW LAW A new section of law to be codified
19 in the Oklahoma Statutes as Section 884 of Title 44, unless there is
20 created a duplication in numbering, reads as follows:

21 ARTICLE 84. Breach of medical quarantine.

22 Any person subject to the Oklahoma Uniform Code of Military
23 Justice:

1 1. Who is ordered into medical quarantine by a person
2 authorized to issue such order; and

3 2. Who, with knowledge of the quarantine and the limits of the
4 quarantine, goes beyond those limits before being released from the
5 quarantine by proper authority,
6 shall be punished as a court-martial may direct.

7 SECTION 103. NEW LAW A new section of law to be codified
8 in the Oklahoma Statutes as Section 885 of Title 44, unless there is
9 created a duplication in numbering, reads as follows:

10 ARTICLE 85. Desertion.

11 A. Any member of the state military forces who:

12 1. Without authority goes or remains absent from his or her
13 unit, organization, or place of duty with intent to remain away
14 therefrom permanently;

15 2. Quits his or her unit, organization, or place of duty with
16 intent to avoid hazardous duty or to shirk important service; or

17 3. Without being regularly separated from one of the force
18 components of state military forces enlists or accepts an
19 appointment in the same or another one of the armed forces without
20 fully disclosing the fact that he or she has not been regularly
21 separated, or enters any foreign armed service except when
22 authorized by the United States,
23 is guilty of desertion.

24

1 B. Any commissioned officer of the state military forces who,
2 after tender of his or her resignation and before notice of its
3 acceptance, quits his or her post or proper duties without leave and
4 with intent to remain away therefrom permanently is guilty of
5 desertion.

6 C. Any person found guilty of desertion or attempt to desert
7 shall be punished, if the offense is committed in time of war, by
8 confinement of not more than ten (10) years or such other punishment
9 as a court-martial may direct, but if the desertion or attempt to
10 desert occurs at any other time, by such punishment as a court-
11 martial may direct.

12 SECTION 104. NEW LAW A new section of law to be codified
13 in the Oklahoma Statutes as Section 886 of Title 44, unless there is
14 created a duplication in numbering, reads as follows:

15 ARTICLE 86. Absence without leave.

16 Any member of the state military forces who, without authority:

17 1. Fails to go to his or her appointed place of duty at the
18 time prescribed;

19 2. Goes from that place; or

20 3. Absents himself or herself or remains absent from his or her
21 unit, organization, or place of duty at which he or she is required
22 to be at the time prescribed,
23 shall be punished as a court-martial may direct.
24

1 SECTION 105. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 887 of Title 44, unless there is
3 created a duplication in numbering, reads as follows:

4 ARTICLE 87. Missing movement; jumping from vessel.

5 A. Missing movement. Any person subject to the Oklahoma
6 Uniform Code of Military Justice who, through neglect or design,
7 misses the movement of a ship, aircraft, or unit with which the
8 person is required in the course of duty to move shall be punished
9 as a court-martial may direct.

10 B. Jumping from vessel into the water. Any person subject to
11 the Code who wrongfully and intentionally jumps into the water from
12 a vessel in use by the armed forces shall be punished as a court-
13 martial may direct.

14 SECTION 106. NEW LAW A new section of law to be codified
15 in the Oklahoma Statutes as Section 887A of Title 44, unless there
16 is created a duplication in numbering, reads as follows:

17 ARTICLE 87A. Resistance, flight, breach of arrest, and escape.

18 Any person subject to the Oklahoma Uniform Code of Military
19 Justice who:

- 20 1. Resists apprehension;
21 2. Flees from apprehension;
22 3. Breaks arrest; or
23 4. Escapes from custody or confinement,
24 shall be punished as a court-martial may direct.

1 SECTION 107. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 887B of Title 44, unless there
3 is created a duplication in numbering, reads as follows:

4 RESERVED.

5 SECTION 108. NEW LAW A new section of law to be codified
6 in the Oklahoma Statutes as Section 888 of Title 44, unless there is
7 created a duplication in numbering, reads as follows:

8 ARTICLE 88. Contempt toward officials.

9 Any commissioned officer who uses contemptuous words against the
10 President, the Vice President, Congress, the Secretary of Defense,
11 the Secretary of a military department, the Secretary of Homeland
12 Security, the Governor of the State of Oklahoma, or the Oklahoma
13 Legislature shall be punished as a court-martial may direct.

14 SECTION 109. NEW LAW A new section of law to be codified
15 in the Oklahoma Statutes as Section 889 of Title 44, unless there is
16 created a duplication in numbering, reads as follows:

17 ARTICLE 89. Disrespect toward superior commissioned officer;
18 assault of superior commissioned officer.

19 A. Disrespect. Any person subject to the Oklahoma Uniform Code
20 of Military Justice who behaves with disrespect toward that person's
21 superior commissioned officer shall be punished as a court-martial
22 may direct.

23 B. Assault. Any person subject to the Code who strikes that
24 person's superior commissioned officer or draws or lifts up any

1 weapon or offers any violence against that officer while the officer
2 is in the execution of the officer's office shall be punished, if
3 the offense is committed in time of declared war, by confinement of
4 not more than ten (10) years or such other punishment as a court-
5 martial may direct, and if the offense is committed at any other
6 time, by such punishment as a court-martial may direct.

7 SECTION 110. NEW LAW A new section of law to be codified
8 in the Oklahoma Statutes as Section 890 of Title 44, unless there is
9 created a duplication in numbering, reads as follows:

10 ARTICLE 90. Willfully disobeying superior commissioned officer.

11 Any person subject to the Oklahoma Uniform Code of Military
12 Justice who willfully disobeys a lawful command of that person's
13 superior commissioned officer shall be punished, if the offense is
14 committed in time of declared war, by confinement of not more than
15 ten (10) years or such other punishment as a court-martial may
16 direct, and if the offense is committed at any other time, by such
17 punishment as a court-martial may direct.

18 SECTION 111. NEW LAW A new section of law to be codified
19 in the Oklahoma Statutes as Section 891 of Title 44, unless there is
20 created a duplication in numbering, reads as follows:

21 ARTICLE 91. Insubordinate conduct toward warrant officer, or
22 noncommissioned officer.

23 Any warrant officer or enlisted member who:
24

1 1. Strikes or assaults a warrant officer, or noncommissioned
2 officer, while that officer is in the execution of his or her
3 office;

4 2. Willfully disobeys the lawful order of a warrant officer, or
5 noncommissioned officer; or

6 3. Treats with contempt or is disrespectful in language or
7 deportment toward a warrant officer, or noncommissioned officer,
8 while that officer is in the execution of his or her office,
9 shall be punished as a court-martial may direct.

10 SECTION 112. NEW LAW A new section of law to be codified
11 in the Oklahoma Statutes as Section 892 of Title 44, unless there is
12 created a duplication in numbering, reads as follows:

13 ARTICLE 92. Failure to obey order or regulation.

14 Any person subject to the Oklahoma Uniform Code of Military
15 Justice who:

16 1. Violates or fails to obey any lawful general order or
17 regulation;

18 2. Having knowledge of any other lawful order issued by a
19 member of the state military forces, which it is his or her duty to
20 obey, fails to obey the order; or

21 3. Is derelict in the performance of his or her duties,
22 shall be punished as a court-martial may direct.
23
24

1 SECTION 113. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 893 of Title 44, unless there is
3 created a duplication in numbering, reads as follows:

4 ARTICLE 93. Cruelty and maltreatment.

5 Any person subject to the Oklahoma Uniform Code of Military
6 Justice who is guilty of cruelty toward, or oppression or
7 maltreatment of, any person subject to his or her orders shall be
8 punished as a court-martial may direct.

9 SECTION 114. NEW LAW A new section of law to be codified
10 in the Oklahoma Statutes as Section 893A of Title 44, unless there
11 is created a duplication in numbering, reads as follows:

12 ARTICLE 93A. Prohibited activities with military recruit or
13 trainee by person in position of special trust.

14 A. Abuse of training leadership position. Any person subject
15 to the Oklahoma Uniform Code of Military Justice:

16 1. Who is an officer, or a noncommissioned officer;

17 2. Who is in a training leadership position with respect to a
18 specially protected junior member of the state military forces; and

19 3. Who engages in prohibited sexual activity with such
20 specially protected junior member of the state military forces,
21 shall be punished as a court-martial may direct.

22 B. Abuse of position as military recruiter. Any person subject
23 to the Code:

24

1 1. Who is a military recruiter and engages in prohibited sexual
2 activity with an applicant for military service; or

3 2. Who is a military recruiter and engages in prohibited sexual
4 activity with a specially protected junior member of the state
5 military forces who is enlisted under a delayed entry program,
6 shall be punished as a court-martial may direct.

7 C. Consent. Consent is not a defense for any conduct at issue
8 in a prosecution under this section (article).

9 D. Definitions. In this section (article):

10 1. Specially protected junior member of the state military
11 forces. The term "specially protected junior member of the state
12 military forces" means:

13 a. a member of the state military forces who is assigned
14 to, or is awaiting assignment to, basic training or
15 other initial active duty for training, including a
16 member who is enlisted under a delayed entry program,

17 b. a member of the state military forces who is a cadet,
18 an officer candidate, or a student in any other
19 officer qualification program, and

20 c. a member of the state military forces in any program
21 that, by regulation prescribed by the Secretary of the
22 Army or the Secretary of the Air Force or the Adjutant
23 General, is identified as a training program for
24 initial career qualification;

1 2. Training leadership position. The term "training leadership
2 position" means, with respect to a specially protected junior member
3 of the state military forces, any of the following:

4 a. any drill instructor position or other leadership
5 position in a basic training program, an officer
6 candidate school, a reserve officers' training corps
7 unit, a training program for entry into the state
8 military forces, or any program that, by regulation
9 prescribed by the Secretary of the Army or the
10 Secretary of the Air Force or the Adjutant General,
11 and

12 b. faculty and staff of any officer candidate school
13 organized under the authority of the Adjutant General;

14 3. Applicant for military service. The term "applicant for
15 military service" means a person who, under regulations prescribed
16 by the Secretary of the Army or the Secretary of the Air Force or
17 the Adjutant General, is an applicant for original enlistment or
18 appointment in the state military forces;

19 4. Military recruiter. The term "military recruiter" means a
20 person who, under regulations prescribed by the Secretary of the
21 Army or the Secretary of the Air Force or the Adjutant General, has
22 the primary duty to recruit persons for service in the state
23 military forces; and
24

1 5. Prohibited sexual activity. The term "prohibited sexual
2 activity" means, as specified in regulations prescribed by the
3 Secretary of the Army or the Secretary of the Air Force or the
4 Adjutant General, inappropriate physical intimacy under
5 circumstances described in such regulations.

6 SECTION 115. NEW LAW A new section of law to be codified
7 in the Oklahoma Statutes as Section 894 of Title 44, unless there is
8 created a duplication in numbering, reads as follows:

9 ARTICLE 94. Mutiny or sedition.

10 A. Any person subject to the Oklahoma Uniform Code of Military
11 Justice who:

12 1. With intent to usurp or override lawful military authority,
13 refuses, in concert with any other person, to obey orders or
14 otherwise do his or her duty or creates any violence or disturbance
15 is guilty of mutiny;

16 2. With intent to cause the overthrow or destruction of lawful
17 civil authority, creates, in concert with any other person, revolt,
18 violence, or other disturbance against that authority is guilty of
19 sedition;

20 3. Fails to do his or her utmost to prevent and suppress a
21 mutiny or sedition being committed in his or her presence, or fails
22 to take all reasonable means to inform his or her superior
23 commissioned officer or commanding officer of a mutiny or sedition
24

1 which he or she knows or has reason to believe is taking place, is
2 guilty of a failure to suppress or report a mutiny or sedition.

3 B. A person who is found guilty of attempted mutiny, mutiny,
4 sedition, or failure to suppress or report a mutiny or sedition
5 shall be punished as a court-martial may direct.

6 SECTION 116. NEW LAW A new section of law to be codified
7 in the Oklahoma Statutes as Section 895 of Title 44, unless there is
8 created a duplication in numbering, reads as follows:

9 ARTICLE 95. Offenses by sentinel or lookout.

10 A. Drunk or sleeping on post, or leaving post before being
11 relieved. Any sentinel or lookout who is drunk on post, who sleeps
12 on post, or who leaves post before being regularly relieved, shall
13 be punished, if the offense is committed in time of war, by
14 confinement of not more than ten (10) years or other punishment as a
15 court-martial may direct, but if the offense is committed at any
16 other time, by such punishment as a court-martial may direct.

17 B. Loitering or wrongfully sitting on post. Any sentinel or
18 lookout who loiters or wrongfully sits down on post shall be
19 punished as a court-martial may direct.

20 SECTION 117. NEW LAW A new section of law to be codified
21 in the Oklahoma Statutes as Section 895A of Title 44, unless there
22 is created a duplication in numbering, reads as follows:

23 ARTICLE 95A. Disrespect toward sentinel or lookout.

1 A. Disrespectful language toward sentinel or lookout. Any
2 person subject to the Oklahoma Uniform Code of Military Justice who,
3 knowing that another person is a sentinel or lookout, uses wrongful
4 and disrespectful language that is directed toward and within the
5 hearing of the sentinel or lookout, who is in the execution of
6 duties as a sentinel or lookout, shall be punished as a court-
7 martial may direct.

8 B. Disrespectful behavior toward sentinel or lookout. Any
9 person subject to the Code who, knowing that another person is a
10 sentinel or lookout, behaves in a wrongful and disrespectful manner
11 that is directed toward and within the sight of the sentinel or
12 lookout, who is in the execution of duties as a sentinel or lookout,
13 shall be punished as a court-martial may direct.

14 SECTION 118. NEW LAW A new section of law to be codified
15 in the Oklahoma Statutes as Section 896 of Title 44, unless there is
16 created a duplication in numbering, reads as follows:

17 ARTICLE 96. Release of prisoner without authority; drinking
18 with prisoner.

19 A. Release of prisoner without authority. Any person subject
20 to the Oklahoma Uniform Code of Military Justice:

21 1. Who, without authority to do so, releases a prisoner; or

22 2. Who, through neglect or design, allows a prisoner to escape,
23 shall be punished as a court-martial may direct, whether or not the
24 prisoner was committed in strict compliance with the law.

1 B. Drinking with prisoner. Any person subject to the Code who
2 unlawfully drinks any alcoholic beverage with a prisoner shall be
3 punished as a court-martial may direct.

4 SECTION 119. NEW LAW A new section of law to be codified
5 in the Oklahoma Statutes as Section 897 of Title 44, unless there is
6 created a duplication in numbering, reads as follows:

7 ARTICLE 97. Unlawful detention.

8 Any person subject to the Oklahoma Uniform Code of Military
9 Justice who, except as provided by law, apprehends, arrests, or
10 confines any person shall be punished as a court-martial may direct.

11 SECTION 120. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 898 of Title 44, unless there is
13 created a duplication in numbering, reads as follows:

14 ARTICLE 98. Misconduct as prisoner.

15 Any person subject to the Oklahoma Uniform Code of Military
16 Justice who, while in the hands of the enemy in time of war:

17 1. For the purpose of securing favorable treatment by his or
18 her captors acts without proper authority in a manner contrary to
19 law, custom, or regulation, to the detriment of others of whatever
20 nationality held by the enemy as civilian or military prisoners; or

21 2. While in a position of authority over such persons maltreats
22 them without justifiable cause,
23 shall be punished as a court-martial may direct.

1 SECTION 121. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 899 of Title 44, unless there is
3 created a duplication in numbering, reads as follows:

4 ARTICLE 99. Misbehavior before the enemy.

5 Any person subject to the Oklahoma Uniform Code of Military
6 Justice who before or in the presence of the enemy:

7 1. Runs away;

8 2. Shamefully abandons, surrenders, or delivers up any command,
9 unit, place, or military property which it is his or her duty to
10 defend;

11 3. Through disobedience, neglect, or intentional misconduct
12 endangers the safety of any such command, unit, place, or military
13 property;

14 4. Casts away his or her arms or ammunition;

15 5. Is guilty of cowardly conduct;

16 6. Quits his or her place of duty to plunder or pillage;

17 7. Causes false alarms in any command, unit, or place under
18 control of the armed forces of the United States or the state
19 military forces;

20 8. Willfully fails to do his or her utmost to encounter,
21 engage, capture, or destroy any enemy troops, combatants, vessels,
22 aircraft, or any other thing, which it is his or her duty so to
23 encounter, engage, capture, or destroy; or
24

1 9. Does not afford all practicable relief and assistance to any
2 troops, combatants, vessels, or aircraft of the armed forces
3 belonging to the United States or their allies, to the State of
4 Oklahoma, or to any other state, when engaged in battle,
5 shall be punished as a court-martial may direct.

6 SECTION 122. NEW LAW A new section of law to be codified
7 in the Oklahoma Statutes as Section 900 of Title 44, unless there is
8 created a duplication in numbering, reads as follows:

9 ARTICLE 100. Subordinate compelling surrender.

10 Any person subject to the Oklahoma Uniform Code of Military
11 Justice who compels or attempts to compel the commander of any
12 place, vessel, aircraft, or other military property, or of any body
13 of members of the state military forces, to give it up to an enemy
14 or to abandon it, or who strikes the colors or flag to an enemy
15 without proper authority, shall be punished as a court-martial may
16 direct.

17 SECTION 123. NEW LAW A new section of law to be codified
18 in the Oklahoma Statutes as Section 901 of Title 44, unless there is
19 created a duplication in numbering, reads as follows:

20 ARTICLE 101. Improper use of countersign.

21 Any person subject to the Oklahoma Uniform Code of Military
22 Justice who in time of war discloses the parole or countersign to
23 any person not entitled to receive it or who gives to another who is
24 entitled to receive and use the parole or countersign a different

1 parole or countersign from that which, to his or her knowledge, he
2 or she was authorized and required to give, shall be punished as a
3 court-martial may direct.

4 SECTION 124. NEW LAW A new section of law to be codified
5 in the Oklahoma Statutes as Section 902 of Title 44, unless there is
6 created a duplication in numbering, reads as follows:

7 ARTICLE 102. Forcing a safeguard.

8 Any person subject to the Oklahoma Uniform Code of Military
9 Justice who forces a safeguard shall be punished as a court-martial
10 may direct.

11 SECTION 125. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 903 of Title 44, unless there is
13 created a duplication in numbering, reads as follows:

14 RESERVED.

15 SECTION 126. NEW LAW A new section of law to be codified
16 in the Oklahoma Statutes as Section 903A of Title 44, unless there
17 is created a duplication in numbering, reads as follows:

18 RESERVED.

19 SECTION 127. NEW LAW A new section of law to be codified
20 in the Oklahoma Statutes as Section 903B of Title 44, unless there
21 is created a duplication in numbering, reads as follows:

22 ARTICLE 103B. Aiding the enemy.

23 Any person who:
24

1 1. Aids, or attempts to aid, the enemy with arms, ammunition,
2 supplies, money, or other things; or

3 2. Without proper authority, knowingly harbors or protects or
4 gives intelligence to, or communicates or corresponds with or holds
5 any intercourse with the enemy, either directly or indirectly,
6 shall be punished as a court-martial may direct.

7 SECTION 128. NEW LAW A new section of law to be codified
8 in the Oklahoma Statutes as Section 903C of Title 44, unless there
9 is created a duplication in numbering, reads as follows:

10 ARTICLE 103C. Unlawful disclosure of confidential information.

11 Any person subject to the Oklahoma Uniform Code of Military
12 Justice who, with intent or reason to believe that it is to be used
13 in the commission of a crime or act of terrorism under Oklahoma law,
14 communicates, delivers or transmits, or attempts to communicate,
15 deliver or transmit confidential information, directly or
16 indirectly, to any other person shall be punished as a court-martial
17 may direct.

18 SECTION 129. NEW LAW A new section of law to be codified
19 in the Oklahoma Statutes as Section 904 of Title 44, unless there is
20 created a duplication in numbering, reads as follows:

21 ARTICLE 104. Public records offenses.

22 Any person subject to the Oklahoma Uniform Code of Military
23 Justice who willfully and unlawfully alters, conceals, removes,
24 mutilates, obliterates, destroys, or takes with the intent to alter,

1 conceal, remove, mutilate, obliterate, or destroy, a certain public
2 record, and whose conduct, under the circumstances, was to the
3 prejudice of good order and discipline in the armed forces or was of
4 a nature to bring discredit upon the armed forces, shall be punished
5 as a court-martial may direct.

6 SECTION 130. NEW LAW A new section of law to be codified
7 in the Oklahoma Statutes as Section 904A of Title 44, unless there
8 is created a duplication in numbering, reads as follows:

9 ARTICLE 104A. Fraudulent enlistment, appointment, or
10 separation.

11 Any person who:

12 1. Procures his or her own enlistment or appointment in the
13 state military forces by knowingly false representation or
14 deliberate concealment as to his or her qualifications for that
15 enlistment or appointment and receives pay or allowances thereunder;
16 or

17 2. Procures his or her own separation from the state military
18 forces by knowingly false representation or deliberate concealment
19 as to his or her eligibility for that separation,
20 shall be punished as a court-martial may direct.

21 SECTION 131. NEW LAW A new section of law to be codified
22 in the Oklahoma Statutes as Section 904B of Title 44, unless there
23 is created a duplication in numbering, reads as follows:

24 ARTICLE 104B. Unlawful enlistment, appointment, or separation.

1 Any person subject to the Oklahoma Uniform Code of Military
2 Justice who effects an enlistment or appointment in or a separation
3 from the state military forces of any person who is known to him or
4 her to be ineligible for that enlistment, appointment, or separation
5 because it is prohibited by law, regulation, or order shall be
6 punished as a court-martial may direct.

21 if the statement is false and at the time of taking the oath, the
22 person does not believe the statement to be true,
23 shall be punished as a court-martial may direct.

10 sexually explicit conduct involving a person who:

11 a. is at least eighteen (18) years of age at the time the
12 intimate visual image or visual image of sexually
13 explicit conduct was created,

14 b. is identifiable from the intimate visual image or
15 visual image of sexually explicit conduct itself, or
16 from information displayed in connection with the
17 intimate visual image or visual image of sexually
18 explicit conduct, and

19 c. does not explicitly consent to the broadcast or
20 distribution of the intimate visual image or visual
21 image of sexually explicit conduct;

22 2. Who knows or reasonably should have known that the intimate
23 visual image or visual image of sexually explicit conduct was made
24 under circumstances in which the person depicted in the intimate

1 visual image or visual image of sexually explicit conduct retained a
2 reasonable expectation of privacy regarding any broadcast or
3 distribution of the intimate visual image or visual image of
4 sexually explicit conduct;

5 3. Who knows or reasonably should have known that the broadcast
6 or distribution of the intimate visual image or visual image of
7 sexually explicit conduct is likely:

8 a. to cause harm, harassment, intimidation, emotional
9 distress, or financial loss for the person depicted in
10 the intimate visual image or visual image of sexually
11 explicit conduct, or

12 b. to harm substantially the depicted person with respect
13 to that person's health, safety, business, calling,
14 career, financial condition, reputation, or personal
15 relationships; and

16 4. Whose conduct, under the circumstances, had a reasonably
17 direct and palpable connection to a military mission or military
18 environment,
19 is guilty of wrongful distribution of intimate visual images or
20 visual images of sexually explicit conduct and shall be punished as
21 a court-martial may direct.

22 B. Definitions. In this section:
23

1 1. Broadcast. The term "broadcast" means to electronically
2 transmit a visual image with the intent that it be viewed by a
3 person or persons;

4 2. Distribute. The term "distribute" means to deliver to the
5 actual or constructive possession of another person, including
6 transmission by mail or electronic means;

7 3. Intimate visual image. The term "intimate visual image"
8 means a visual image that depicts a private area of a person;

9 4. Private area. The term "private area" means the naked or
10 underwear-clad genitalia, anus, buttocks, or female areola or
11 nipple;

12 5. Reasonable expectation of privacy. The term "reasonable
13 expectation of privacy" means circumstances in which a reasonable
14 person would believe that a private area of the person, or sexually

18 conduct" means actual or simulated genital-genital contact, oral-
19 genital contact, anal-genital contact, or oral-anal contact, whether
20 between persons of the same or opposite sex, bestiality,
21 masturbation, or sadistic or masochistic abuse; and

22 7. Visual image. The term "visual image" means the following:

- 23 a. any developed or undeveloped photograph, picture,
24 film, or video,

- 1 b. any digital or computer image, picture, film, or video
2 made by any means, including those transmitted by any
3 means, including streaming media, even if not stored
4 in a permanent format,
5 c. any digital or electronic data capable of conversion
6 into a visual image.

5 A. Sexual assault. Any person subject to the Oklahoma Uniform
6 Code of Military Justice who:

7 1. Commits a sexual act upon another person by:

- 8 a. threatening or placing that other person in fear,
- 9 b. making a fraudulent representation that the sexual act
10 serves a professional purpose, or
- 11 c. inducing a belief by any artifice, pretense, or
12 concealment that the person is another person;

13 2. Commits a sexual act upon another person:

- 14 a. without the consent of the other person, or
- 15 b. when the person knows or reasonably should know that
16 the other person is asleep, unconscious, or otherwise
17 unaware that the sexual act is occurring; or

18 3. Commits a sexual act upon another person when the other
19 person is incapable of consenting to the sexual act due to:

- 20 a. impairment by any drug, intoxicant, or other similar
21 substance, and that condition is known or reasonably
22 should be known by the person, or

1 b. a mental disease or defect, or physical disability,
2 and that condition is known or reasonably should be
3 known by the person,
4 is guilty of sexual assault and shall be punished as a court-martial
5 may direct.

6 B. Aggravated sexual contact. Any person subject to the
7 Oklahoma Uniform Code of Military Justice who commits or causes
8 sexual contact upon or by another person, if to do so would violate
9 Section 1111 of Title 21 of the Oklahoma Statutes, had the sexual
10 contact been a sexual act as defined in subsection F of this
11 section, is guilty of aggravated sexual contact and shall be
12 punished as a court-martial may direct.

13 C. Abusive sexual contact. Any person subject to the Code who
14 commits or causes sexual contact upon or by another person, if to do
15 so would violate subsection A of this section had the sexual contact
16 been a sexual act, is guilty of abusive sexual contact and shall be
17 punished as a court-martial may direct.

18 D. Proof of threat. In a prosecution under this section, in
19 proving that a person made a threat, it need not be proven that the
20 person actually intended to carry out the threat or had the ability
21 to carry out the threat.

22 E. Defenses. An accused may raise any applicable defenses
23 available under the Code or the Rules for Court-Martial contained in
24 the most recent edition of the Manual for Courts-Martial, United

1 States, including all amendments thereto adopted from time to time,
2 except when such rules are contrary to or inconsistent with the
3 Code. Marriage is not a defense for any conduct in issue in any
4 prosecution under this section.

5 F. Definitions. In this section:

6 1. Sexual act. The term "sexual act" means:

- 7 a. the penetration, however slight, of the penis into the
8 vulva or anus or mouth,
- 9 b. contact between the mouth and the penis, vulva,
10 scrotum, or anus, or
- 11 c. the penetration, however slight, of the vulva or penis
12 or anus of another by any part of the body or any
13 object, with an intent to abuse, humiliate, harass, or
14 degrade any person or to arouse or gratify the sexual
15 desire of any person;

16 2. Sexual contact. The term "sexual contact" means touching,
17 or causing another person to touch, either directly or through the
18 clothing, the vulva, penis, scrotum, anus, groin, breast, inner
19 thigh, or buttocks of any person, with an intent to abuse,
20 humiliate, harass, or degrade any person or to arouse or gratify the
21 sexual desire of any person. Touching may be accomplished by any
22 part of the body or an object;

23 3. Grievous bodily harm. The term "grievous bodily harm" means
24 serious bodily injury. It includes fractured or dislocated bones,

1 deep cuts, torn members of the body, serious damage to internal
2 organs, and other severe bodily injuries. It does not include minor
3 injuries such as a black eye or a bloody nose;

4 4. Force. The term "force" means:

5 a. the use of a weapon,

6 b. the use of such physical strength or violence as is
7 sufficient to overcome, restrain, or injure a person,
8 or

9 c. inflicting physical harm sufficient to coerce or
10 compel submission by the victim;

11 5. Unlawful force. The term "unlawful force" means an act of
12 force done without legal justification or excuse;

13 6. Threatening or placing that other person in fear. The term
14 "threatening or placing that other person in fear" means a
15 communication or action that is of sufficient consequence to cause a
16 reasonable fear that noncompliance will result in the victim or
17 another person being subjected to the wrongful action contemplated
18 by the communication or action;

19 7. Consent.

20 a. the term "consent" means a freely given agreement to
21 the conduct at issue by a competent person. An
22 expression of lack of consent through words or conduct
23 means there is no consent. Lack of verbal or physical
24 resistance does not constitute consent. Submission

1 resulting from the use of force, threat of force, or
2 placing another person in fear also does not
3 constitute consent. A current or previous dating or
4 social or sexual relationship by itself or the manner
5 of dress of the person involved with the accused in
6 the conduct at issue does not constitute consent,

7 b. a sleeping, unconscious, or incompetent person cannot
8 consent. A person cannot consent to force causing or
9 likely to cause death or grievous bodily harm or to
10 being rendered unconscious. A person cannot consent
11 while under threat or in fear or under the
12 circumstances described in subparagraph b or c of
13 paragraph 1 of subsection A of this section,

14 c. all the surrounding circumstances are to be considered
15 in determining whether a person gave consent; and

16 8. Incapable of consenting. The term "incapable of consenting"
17 means the person is:

18 a. incapable of appraising the nature of the conduct at
19 issue, or

20 b. physically incapable of declining participation in, or
21 communicating unwillingness to engage in, the sexual
22 act at issue.

2. Knowingly photographs, videotapes, films, or records by any means the private area of another person, without that other person's consent and under circumstances in which that other person has a reasonable expectation of privacy; or

1 3. Knowingly broadcasts or distributes any such recording that
2 the person knew or reasonably should have known was made under the
3 circumstances proscribed in paragraphs 1 and 2 of this subsection,
4 is guilty of an offense under this section and shall be punished as
5 a court-martial may direct.

6 B. Forcible pandering. Any person subject to the Code who
7 compels another person to engage in an act of prostitution with any
8 person is guilty of forcible pandering and shall be punished as a
9 court-martial may direct.

10 C. Indecent exposure. Any person subject to the Code who
11 intentionally exposes, in an indecent manner, the genitalia, anus,
12 buttocks, or female areola or nipple is guilty of indecent exposure
13 and shall be punished as a court-martial may direct.

14 D. Definitions. In this section:

15 1. Act of prostitution. The term "act of prostitution" means a
16 sexual act or sexual contact, as defined in subsection F of Section
17 920 of this title (Article 120, subsection F), on account of which
18 anything of value is given to, or received by, any person;

19 2. Private area. The term "private area" means the naked or
20 underwear-clad genitalia, anus, buttocks, or female areola or
21 nipple;

22 3. Reasonable expectation of privacy. The term "under
23 circumstances in which that other person has a reasonable
24 expectation of privacy" means:

1 a. circumstances in which a reasonable person would
2 believe that he or she could disrobe in privacy,
3 without being concerned that an image of a private
4 area of the person was being captured, or

5 b. circumstances in which a reasonable person would
6 believe that a private area of the person would not be
7 visible to the public;

8 4. Broadcast. The term "broadcast" means to electronically
9 transmit a visual image with the intent that it be viewed by a
10 person or persons;

11 5. Distribute. The term "distribute" means delivering to the
12 actual or constructive possession of another, including transmission
13 by electronic means;

14 6. Indecent manner. The term "indecent manner" means conduct
15 that amounts to a form of immorality relating to sexual impurity
16 which is grossly vulgar, obscene, and repugnant to common propriety,
17 and tends to excite sexual desire or deprave morals with respect to
18 sexual relations.

19 SECTION 160. NEW LAW A new section of law to be codified

2 Justice who is a commissioned officer, warrant officer or
3 noncommissioned officer and:

4 1. Who fraternizes on terms of military equality with one or
5 more certain enlisted members in a certain manner;

6 2. Who then knows the person or persons to be an enlisted
7 person or persons;

8 3. Who, through such fraternization, knowingly violates the
9 customs of the United States Army, if a member of the army component
10 of the state military forces, or the customs of the United States
11 Air Force, if a member of the air force component of the state
12 military forces, that officers shall not fraternize with enlisted
13 members on terms of equality; and

14 4. Under the circumstances, the conduct of the accused was to
15 the prejudice of good order and discipline in the state military
16 forces or was of a nature to bring discredit upon the state military
17 forces,
18 shall be punished as a court-martial may direct.

19 SECTION 161. NEW LAW A new section of law to be codified
20 in the Oklahoma Statutes as Section 921 of Title 44, unless there is
21 created a duplication in numbering, reads as follows:

22 ARTICLE 121. Larceny and wrongful appropriation.

23 A. Any person subject to the Oklahoma Uniform Code of Military
24 Justice who wrongfully takes, obtains, or withholds, by any means,

1 from the possession of the owner or of any other person any money,
2 personal property, or article of value of any kind:

3 1. With intent permanently to deprive or defraud another person
4 of the use and benefit of property or to appropriate it to his or
5 her own use or the use of any person other than the owner, steals
6 that property and is guilty of larceny; or

7 2. With intent temporarily to deprive or defraud another person
8 of the use and benefit of property or to appropriate it to his or
9 her own use or the use of any person other than the owner, is guilty
10 of wrongful appropriation.

11 B. Any person found guilty of larceny or wrongful appropriation
12 shall be punished as a court-martial may direct.

13 SECTION 162. NEW LAW A new section of law to be codified

17 Any person subject to the Oklahoma Uniform Code of Military
18 Justice:

19 1. Who, knowing it to be false or fraudulent:

20 a. makes any claim against the United States, the State
21 of Oklahoma, or any officer thereof, or

22 b. presents to any person in the civil or military
23 service thereof, for approval or payment, any claim
24

1 against the United States, the State of Oklahoma, or
2 any officer thereof;

3 2. Who, for the purpose of obtaining the approval, allowance,
4 or payment of any claim against the United States, the State of
5 Oklahoma, or any officer thereof:

- 6 a. makes or uses any writing or other paper knowing it to
7 contain any false or fraudulent statements,
- 8 b. makes any oath, affirmation or certification to any
9 fact or to any writing or other paper knowing the
10 oath, affirmation or certification to be false, or
- 11 c. forges or counterfeits any signature upon any writing
12 or other paper, or uses any such signature knowing it
13 to be forged or counterfeited;

14 3. Who, having charge, possession, custody, or control of any
15 money, or other property of the United States or the State of
16 Oklahoma, furnished or intended for the armed forces of the United
17 States or the state military forces, knowingly delivers to any
18 person having authority to receive it, any amount thereof less than
19 that for which he or she receives a certificate or receipt; or

20 4. Who, being authorized to make or deliver any paper
21 certifying the receipt of any property of the United States or the
22 State of Oklahoma, furnished or intended for the armed forces of the
23 United States or the state military forces, makes or delivers to any
24 person such writing without having full knowledge of the truth of

1 the statements therein contained and with intent to defraud the
2 United States or the State of Oklahoma,
3 shall be punished as a court-martial may direct.

4 SECTION 169. NEW LAW A new section of law to be codified
5 in the Oklahoma Statutes as Section 924A of Title 44, unless there
6 is created a duplication in numbering, reads as follows:

7 RESERVED.

8 SECTION 170. NEW LAW A new section of law to be codified

5 A. Any person subject to the Oklahoma Uniform Code of Military
6 Justice who attempts or offers with unlawful force or violence to do
7 bodily harm to another person, whether or not the attempt or offer
8 is consummated, is guilty of assault and shall be punished as a
9 court-martial may direct.

10 B. Any person subject to the Code who:

11 1. Commits an assault with a dangerous weapon or other means or
12 force likely to produce death or grievous bodily harm; or

13 2. Commits an assault and intentionally inflicts grievous
14 bodily harm with or without a weapon,
15 is guilty of aggravated assault and shall be punished as a court-
16 martial may direct.

17 SECTION 175. NEW LAW A new section of law to be codified
18 in the Oklahoma Statutes as Section 928A of Title 44, unless there

17 or bodily harm, including sexual assault, to himself or herself, to
18 a member of his or her immediate family, or to his or her intimate
19 partner;

20 2. Who has knowledge, or should have knowledge, that the
21 specific person will be placed in reasonable fear of death or bodily
22 harm, including sexual assault, to himself or herself, to a member
23 of his or her immediate family, or to his or her intimate partner;
24 and

1 3. Whose conduct induces reasonable fear in the specific person
2 of death or bodily harm, including sexual assault, to himself or
3 herself, to a member of his or her immediate family, or to his or
4 her intimate partner,
5 is guilty of stalking and shall be punished as a court-martial may
6 direct.

7 B. Definitions. In this section:

8 1. The term "conduct" means conduct of any kind, including use
9 of surveillance, the mails, an interactive computer service, an
10 electronic communication service, or an electronic communication
11 system;

12 2. The term "course of conduct" means:

- 13 a. a repeated maintenance of visual or physical proximity
14 to a specific person,
- 15 b. a repeated conveyance of verbal threat, written
16 threats, or threats implied by conduct, or a
17 combination of such threats, directed at or toward a
18 specific person, or
- 19 c. a pattern of conduct composed of repeated acts
20 evidencing a continuity of purpose;

21 3. The term "repeated", with respect to conduct, means two or
22 more occasions of such conduct;

23 4. The term "immediate family", in the case of a specific
24 person, means:

1 a. that person's spouse, parent, brother or sister,
2 child, or other person to whom he or she stands in
3 loco parentis, or

4 b. any other person living in his or her household and
5 related to him or her by blood or marriage; and

6 5. The term "intimate partner", in the case of a specific
7 person, means:

8 a. a former spouse of the specific person, a person who
9 shares a child in common with the specific person, or
10 a person who cohabits with or has cohabited as a
11 spouse with the specific person, or

12 b. a person who has been in a social relationship of a
13 romantic or intimate nature with the specific person,
14 as determined by the length of the relationship, the
15 type of relationship, and the frequency of interaction
16 between the persons involved in the relationship.

17 SECTION 180. NEW LAW A new section of law to be codified
18 in the Oklahoma Statutes as Section 931 of Title 44, unless there is
19 created a duplication in numbering, reads as follows:

20 ARTICLE 131. Perjury.

21 Any person subject to the Oklahoma Uniform Code of Military
22 Justice who in a judicial proceeding or court of inquiry or in a
23 course of justice willfully and corruptly:
24

1 1. Upon a lawful oath or in any form allowed by law to be
2 substituted for an oath, gives any false testimony material to the
3 issue or matter of inquiry; or

4 2. In any declaration, certificate, verification, or statement
5 under penalty of perjury subscribes any false statement material to
6 the issue or matter of inquiry,
7 is guilty of perjury and shall be punished as a court-martial may
8 direct.

9 SECTION 181. NEW LAW A new section of law to be codified
10 in the Oklahoma Statutes as Section 931A of Title 44, unless there
11 is created a duplication in numbering, reads as follows:

12 ARTICLE 131A. Subornation of perjury.

13 A. In general. Any person subject to the Oklahoma Uniform Code
14 of Military Justice who induces and procures another person:

15 1. To take an oath; and

16 2. To falsely testify, depose, or state upon such oath,
17 shall, if the conditions specified in subsection B are satisfied, be
18 punished as a court-martial may direct.

19 B. Conditions. The conditions referred to in subsection A are
20 the following:

21 1. The oath is administered with respect to a matter for which
22 such oath is required or authorized by law;

23 2. The oath is administered by a person having authority to do
24 so;

1 3. Upon the oath, the other person willfully makes or
2 subscribes a statement;

3 4. The statement is material;

4 5. The statement is false; and

5 6. When the statement is made or subscribed, the person subject
6 to the Code and the other person do not believe that the statement
7 is true.

8 SECTION 182. NEW LAW A new section of law to be codified
9 in the Oklahoma Statutes as Section 931B of Title 44, unless there
10 is created a duplication in numbering, reads as follows:

11 ARTICLE 131B. Obstructing justice.

12 Any person subject to the Oklahoma Uniform Code of Military
13 Justice who engages in conduct in the case of a certain person
14 against whom the accused had reason to believe there were or would
15 be criminal or disciplinary proceedings pending, with intent to
16 influence, impede, or otherwise obstruct the due administration of
17 justice, shall be punished as a court-martial may direct.

18 SECTION 183. NEW LAW A new section of law to be codified
19 in the Oklahoma Statutes as Section 931C of Title 44, unless there
20 is created a duplication in numbering, reads as follows:

21 ARTICLE 131C. Misprision of serious offense.

22 Any person subject to the Oklahoma Uniform Code of Military
23 Justice:

1 1. Who knows that another person has committed a serious
2 offense; and

3 2. Wrongfully conceals the commission of the offense and fails
4 to make the commission of the offense known to civilian or military
5 authorities as soon as possible,
6 shall be punished as a court-martial may direct.

7 SECTION 184. NEW LAW A new section of law to be codified
8 in the Oklahoma Statutes as Section 931D of Title 44, unless there
9 is created a duplication in numbering, reads as follows:

10 ARTICLE 131D. Wrongful refusal to testify.

11 Any person subject to the Oklahoma Uniform Code of Military
12 Justice who, in the presence of a court-martial, a board of
13 officers, a court of inquiry, a preliminary hearing, or an officer
14 taking a deposition, of or for the State of Oklahoma, wrongfully
15 refuses to qualify as a witness or to answer a question after having
16 been directed to do so by the person presiding shall be punished as
17 a court-martial may direct.

18 SECTION 185. NEW LAW A new section of law to be codified
19 in the Oklahoma Statutes as Section 931E of Title 44, unless there
20 is created a duplication in numbering, reads as follows:

21 RESERVED.

22 SECTION 186. NEW LAW A new section of law to be codified
23 in the Oklahoma Statutes as Section 931F of Title 44, unless there
24 is created a duplication in numbering, reads as follows:

Article 131F. Noncompliance with procedural rules.

Any person subject to the Oklahoma Uniform Code of Military
Justice who:

1. Is responsible for unnecessary delay in the disposition of
any case of a person accused of an offense under the Code; or

2. Knowingly and intentionally fails to enforce or comply with
any provision of the Code regulating the proceedings before, during,
or after trial of an accused,
shall be punished as a court-martial may direct.

SECTION 187. NEW LAW A new section of law to be codified
in the Oklahoma Statutes as Section 931G of Title 44, unless there
is created a duplication in numbering, reads as follows:

ARTICLE 131G. Wrongful interference with adverse administrative
proceeding.

Any person subject to the Oklahoma Uniform Code of Military
Justice who, having reason to believe that an adverse administrative
proceeding is pending against any person subject to the Code,
wrongfully acts with the intent:

1. To influence, impede, or obstruct the conduct of the
proceeding; or

2. Otherwise to obstruct the due administration of justice,
shall be punished as a court-martial may direct.

1 SECTION 188. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 932 of Title 44, unless there is
3 created a duplication in numbering, reads as follows:

4 ARTICLE 132. Retaliation.

5 A. In general. Any person subject to the Oklahoma Uniform Code
6 of Military Justice who, with the intent to retaliate against any
7 person for reporting or planning to report a criminal offense, or
8 making or planning to make a protected communication, or with the
9 intent to discourage any person from reporting a criminal offense or
10 making or planning to make a protected communication:

11 1. Wrongfully takes or threatens to take an adverse personnel
12 action against any person; or

13 2. Wrongfully withholds or threatens to withhold a favorable
14 personnel action with respect to any person,
15 shall be punished as a court-martial may direct.

16 B. Definitions. In this section:

17 1. The term "protected communication" means the following:

18 a. a lawful communication to a Member of Congress or a
19 Member of the Oklahoma Legislature or an Inspector
20 General, and

21 b. a communication to a covered individual or
22 organization in which a member of the state military
23 forces complains of, or discloses information that the
24

1 member reasonably believes constitutes evidence of,
2 any of the following:

3 (1) a violation of law or regulation, including a law
4 or regulation prohibiting sexual harassment or
5 unlawful discrimination, or

6 (2) gross mismanagement, a gross waste of funds, an
7 abuse of authority, or a substantial and specific
8 danger to public health or safety;

9 2. The term "Inspector General" has the meaning given that term
10 in Section 1034(j) of Title 10 of the United States Code;

11 3. The term "covered individual or organization" means any
12 recipient of a communication specified in clauses (i) through (v) of
13 Section 1034(b)(1)(B) of Title 10 of the United States Code; and

14 4. The term "unlawful discrimination" means discrimination on
15 the basis of race, color, religion, sex, or national origin.

16 SECTION 189. NEW LAW A new section of law to be codified
17 in the Oklahoma Statutes as Section 933 of Title 44, unless there is
18 created a duplication in numbering, reads as follows:

19 ARTICLE 133. Conduct unbecoming an officer and a gentleman.

20 Any commissioned officer, cadet, or officer candidate who is
21 convicted of conduct unbecoming an officer and a gentleman shall be
22 punished as a court-martial may direct.

1 SECTION 190. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 934 of Title 44, unless there is
3 created a duplication in numbering, reads as follows:

4 ARTICLE 134. General article.

5 Though not specifically mentioned in the Oklahoma Uniform Code
6 of Military Justice, all disorders and neglects to the prejudice of
7 good order and discipline in the state military forces, all conduct
8 of a nature to bring discredit upon the state military forces, and
9 crimes and offenses not capital, of which persons subject to the
10 Code may be guilty, shall be taken cognizance of by a general,
11 special, or summary court-martial, according to the nature and
12 degree of the offense, and shall be punished at the discretion of
13 that court. However, where a crime constitutes an offense that
14 violates both the Code and the criminal laws of the State of
15 Oklahoma, jurisdiction over the offense shall be determined in
16 accordance with Section 802 of this title (Article 2).

17 PART XI.

18 MISCELLANEOUS PROVISIONS

19 SECTION 191. NEW LAW A new section of law to be codified
20 in the Oklahoma Statutes as Section 935 of Title 44, unless there is
21 created a duplication in numbering, reads as follows:

22 ARTICLE 135. Courts of inquiry.

23 A. Courts of inquiry to investigate any matter of concern to
24 the state military forces may be convened by any person authorized

1 to convene a general court-martial or by any other person designated
2 by the Adjutant General for that purpose, whether or not the persons
3 involved have requested such an inquiry.

4 B. A court of inquiry consists of three or more commissioned
5 officers. For each court of inquiry, the convening authority shall
6 also appoint counsel for the court.

7 C. 1. Any person subject to the Oklahoma Uniform Code of
8 Military Justice whose conduct is subject to inquiry shall be
9 designated as a party.

10 2. Any person subject to the Code and employed by the Oklahoma
11 Military Department, and who has a direct interest in the subject of
12 inquiry, has the right to be designated as a party upon request to
13 the court.

14 3. Any person designated as a party shall be given due notice
15 and has the right to be present, to be represented by counsel, to
16 cross-examine witnesses, and to introduce evidence.

17 D. Members of a court of inquiry may be challenged by a party,
18 but only for cause stated to the court.

19 E. The members, counsel, the reporter, and interpreters of
20 courts of inquiry shall take an oath to faithfully perform their
21 duties.

22 F. Witnesses may be summoned to appear and testify and be
23 examined before courts of inquiry, as provided for courts-martial.
24

1 G. Courts of inquiry shall make findings of fact but may not
2 express opinions or make recommendations unless required to do so by
3 the convening authority.

4 H. Each court of inquiry shall keep a record of its
5 proceedings, which shall be authenticated by the signatures of the
6 president and counsel for the court and forwarded to the convening
7 authority. If the record cannot be authenticated by the president,
8 it shall be signed by a member in lieu of the president. If the
9 record cannot be authenticated by the counsel for the court, it
10 shall be signed by a member in lieu of the counsel.

11 SECTION 192. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 936 of Title 44, unless there is
13 created a duplication in numbering, reads as follows:

14 ARTICLE 136. Authority to administer oaths.

15 A. The following persons may administer oaths for the purposes
16 of military administration, including military justice:

- 17 1. All judge advocates;
- 18 2. All summary courts-martial;
- 19 3. All adjutants, assistant adjutants, acting adjutants, and
20 personnel adjutants;
- 21 4. All commanding officers of the state military forces;
- 22 5. All staff judge advocates, and acting or assistant staff
23 judge advocates; or

1 6. All other persons designated by regulations of the armed
2 forces of the United States or by statute.

3 B. The following persons on active duty or performing inactive-
4 duty training may administer oaths necessary in the performance of
5 their duties:

6 1. The military judge, trial counsel, and assistant trial
7 counsel for all general and special courts-martial;

8 2. The president and the counsel for the court of any court of
9 inquiry;

10 3. All officers designated to take a deposition;

11 4. All persons detailed to conduct an investigation;

12 5. All recruiting officers;

13 6. All other persons designated by regulations of the armed
14 forces of the United States or by statute.

15 C. Each judge and the senior judge of the Military Court of
16 Appeals shall have the powers relating to oaths, affirmations, and
17 acknowledgments provided to justices and judges of the State of
18 Oklahoma.

19 D. The signature without seal of any such person, together with
20 the title of his or her office, is prima facie evidence of the
21 authority of that person.

22 SECTION 193. NEW LAW A new section of law to be codified
23 in the Oklahoma Statutes as Section 937 of Title 44, unless there is
24 created a duplication in numbering, reads as follows:

ARTICLE 137. Articles to be explained.

A. 1. The sections of the Oklahoma Uniform Code of Military Justice specified in paragraph 3 of this subsection shall be carefully explained to each enlisted member at the time of, or within thirty (30) days after, the member's initial entrance into a duty status with the state military forces.

2. Such articles shall be explained again:

a. after the member has completed basic or recruit training, and

b. at the time when the member reenlists.

3. This subsection applies with respect to Sections 802, 803, 807-815, 825, 827, 831, 837, 838, 855, 877-934, and 937-939 of this title (Articles 2, 3, 7-15, 25, 27, 31, 37, 38, 55, 77-134, and 137-139).

B. The text of the code and of the regulations prescribed under such code shall be made available to a member of the state military forces, upon request by the member, for the member's personal examination.

SECTION 194. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 938 of Title 44, unless there is created a duplication in numbering, reads as follows:

ARTICLE 138. Complaints of wrongs.

Any member of the state military forces who believes himself or herself wronged by a commanding officer, and who, upon due

1 application to that commanding officer, is refused redress, may
2 complain to any superior commissioned officer, who shall forward the
3 complaint to the officer exercising special court-martial
4 jurisdiction over the officer against whom it is made. The officer
5 exercising special court-martial jurisdiction shall examine into the
6 complaint and take proper measures for redressing the wrong
7 complained of; and shall, as soon as possible, send to the Adjutant
8 General a true statement of that complaint, with the proceedings had
9 thereon.

10 SECTION 195. NEW LAW A new section of law to be codified
11 in the Oklahoma Statutes as Section 939 of Title 44, unless there is
12 created a duplication in numbering, reads as follows:

13 ARTICLE 139. Redress of injuries to property.

14 A. Whenever a complaint is made to any commanding officer that
15 willful damage has been done to the property of any person or that
16 the person's property has been wrongfully taken by members of the
17 state military forces, the commanding officer, under such
18 regulations promulgated by the Adjutant General, shall convene a
19 board to investigate the complaint. The board shall consist of from
20 one to three commissioned officers and, for the purpose of that
21 investigation, it has power to summon witnesses and examine them
22 upon oath, to receive depositions or other documentary evidence, and
23 to assess the damages sustained against the responsible parties.
24 The assessment of damages made by the board is subject to the

1 approval of the commanding officer, and in the amount approved by
2 that officer shall be charged against the pay of the offenders. The
3 order of the commanding officer directing charges herein authorized
4 is conclusive on any disbursing officer for payment to the injured
5 parties of the damages so assessed and approved.

6 B. If the offenders cannot be ascertained, but the organization
7 or detachment to which they belong is known, charges totaling the
8 amount of damages assessed and approved may be made in such
9 proportion as may be considered just upon the individual members
10 thereof who are shown to have been present at the scene at the time
11 the damages complained of were inflicted, as determined by the
12 approved findings of the board.

13 SECTION 196. NEW LAW A new section of law to be codified
14 in the Oklahoma Statutes as Section 940 of Title 44, unless there is
15 created a duplication in numbering, reads as follows:

16 ARTICLE 140. Delegation by the Governor.

17 The Governor may delegate any authority vested in the Governor
18 under the Oklahoma Uniform Code of Military Justice, and provide for
19 the subdelegation of any such authority, except the powers given the
20 Governor by Section 822 and subsection K of Section 815 of this
21 title (Article 22 and Article 15, subsection K). Any delegations of
22 authority carried out pursuant to this section shall be published as
23 an executive order which the Adjutant General shall cause to be
24 published as a military publication.

2 in the Oklahoma Statutes as Section 940A of Title 44, unless there
3 is created a duplication in numbering, reads as follows:

4 ARTICLE 140A. Precedence of regulations.

5 When both the Governor and Adjutant General are authorized under
6 the Oklahoma Uniform Code of Military Justice to promulgate
7 regulations governing the same matter, if such regulations conflict,
8 the regulations promulgated by the Governor shall take precedence.

9 SECTION 198. NEW LAW A new section of law to be codified
10 in the Oklahoma Statutes as Section 940B of Title 44, unless there
11 is created a duplication in numbering, reads as follows:

12 ARTICLE 140B. Publication in administrative code.

13 Military publications promulgated or published by or under the
14 authority of the Adjutant General shall be provided to the Secretary
15 of State to be published and indexed as part of the "Oklahoma
16 Administrative Code". In the event state or federal law restricts
17 access to a military publication, the requirements of this
18 subsection shall not be applicable. Military publications
19 promulgated or published by a previous Adjutant General shall remain
20 in effect following appointment of the next Adjutant General by the
21 Governor until otherwise modified or rescinded in writing by the
22 newly appointed Adjutant General.

1 SECTION 199. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 942 of Title 44, unless there is
3 created a duplication in numbering, reads as follows:

4 ARTICLE 142. Payment and collection of fines.

5 A. Fines imposed by a military court or through imposition of
6 nonjudicial punishment shall be paid to the State of Oklahoma and
7 delivered to the convening authority or his or her designee or in
8 the case of nonjudicial punishment, the imposing officer. Fines may
9 be collected in the following manner:

10 1. By cash or money order;

11 2. By retention of any pay or allowances due or to become due
12 to the person fined from any state or the United States; or

13 3. By garnishment or levy, together with costs, on the wages,
14 goods, and chattels of a person delinquent in paying a fine, as

16 B. Any sum so received or retained shall be deposited in the
17 Military Justice Fund, except that the court may direct that the sum
18 so received or retained be provided to a victim or victims as
19 restitution.

20 SECTION 200. NEW LAW A new section of law to be codified
21 in the Oklahoma Statutes as Section 943 of Title 44, unless there is
22 created a duplication in numbering, reads as follows:

23 ARTICLE 143. Uniformity of interpretation.
24

1 The Oklahoma Uniform Code of Military Justice shall be so
2 construed as to effectuate its general purpose to make it uniform,
3 so far as practical, with the Uniform Code of Military Justice,
4 Chapter 47 of Title 10 of the United States Code.

5 SECTION 201. NEW LAW A new section of law to be codified
6 in the Oklahoma Statutes as Section 944 of Title 44, unless there is
7 created a duplication in numbering, reads as follows:

8 ARTICLE 144. Immunity for duties performed under Code.

9 Any person acting under the provisions of the Oklahoma Uniform
10 Code of Military Justice, whether as a member of the military or as
11 a civilian, shall be immune from personal liability for any of the
12 acts or omissions which he or she did or failed to do as part of his
13 or her duties under the Code.

14 SECTION 202. NEW LAW A new section of law to be codified
15 in the Oklahoma Statutes as Section 945 of Title 44, unless there is
16 created a duplication in numbering, reads as follows:

17 ARTICLE 145. Jurisdiction not extended to certain crimes.

18 Though not specifically mentioned in the Oklahoma Uniform Code
19 of Military Justice, all disorders and neglects to the prejudice of
20 good order and discipline in the state military forces, of which
21 persons subject to the Code may be guilty, shall be taken cognizance
22 of by a general, special, or summary court-martial according to the
23 nature and degree of the offense and shall be punished at the
24 discretion of that court. However, cognizance may not be taken of,

1 and jurisdiction shall not be extended to, the crimes of murder,
2 manslaughter, rape, rape and sexual assault of a child, child
3 endangerment, death or injury of an unborn child, kidnapping,
4 domestic violence, arson, robbery, maiming, arson, extortion,
5 burglary, parole violations or housebreaking, jurisdiction of which
6 is reserved to civil courts.

7 SECTION 203. NEW LAW A new section of law to be codified
8 in the Oklahoma Statutes as Section 946 of Title 44, unless there is
9 created a duplication in numbering, reads as follows:

10 ARTICLE 146. Continuances for military service.

11 A. It shall be the duty of any justice, judge, judicial
12 referee, corporation commissioner, administrative law judge or
13 hearing officer presiding over any civil, criminal or administrative
14 proceeding in this state to continue any trial, hearing or other
15 action pending before the court or an administrative forum when a
16 party to the pending action or the primary counsel representing a
17 party to the pending action is not present at the time the case or
18 matter in question is reached on the docket or schedule by reason of
19 participation in:

20 1. Active federal service, as defined in Title 10 of the United
21 States Code;

22 2. Title 32 active duty, as defined in Section 801 of this
23 title (Article 1);
24

1 3. Service in other reserve components of the Armed Forces of
2 the United States, as defined in Title 10 of the United States Code;
3 or

4 4. State active duty, as defined in Section 801 of this title
5 (Article 1).

6 B. The trial, hearing or other pending action may proceed if
7 the party, without the presence of his or her primary counsel, or
8 the primary counsel, without the presence of the party, declares
9 that the case or matter in question is nevertheless ready to proceed
10 at the scheduled time.

11 C. If the primary counsel of a party to the pending action is
12 not present due to military service pursuant to subsection A of this
13 section, the party so affected shall declare under oath that he or
14 she cannot properly proceed with the trial, hearing or other action
15 pending before the court or administrative forum without the
16 presence of the primary counsel.

17 D. If a party to the pending action is not present due to
18 military service pursuant to subsection A of this section, his or
19 her legal counsel shall appear and shall state in his or her place
20 that the case or matter in question cannot properly proceed without
21 the presence of the absent party.

22 E. Continuances granted pursuant to this section shall remain
23 in effect no longer than ninety (90) calendar days. The justice,
24 judge, judicial referee, corporation commissioner, administrative

1 law judge or hearing officer may, at his or her discretion, continue
2 the proceeding in question in order to carry out the administration
3 of justice. The protections provided to service members in this
4 section shall be available in addition to any protections afforded
5 to service members under Section 208.1 of this title.

6 SECTION 204. AMENDATORY 44 O.S. 2011, Section 208, is
7 amended to read as follows:

8 Section 208. No person shall discriminate against any officer
9 or enlisted member of the National Guard or Civil Air Patrol or a
10 judge carrying out his or her duties as a member of the Military
11 Court Of Appeals because of his or her membership therein. No
12 person shall prohibit or refuse entrance to any officer or enlisted
13 member of the United States Armed Forces, or of the military forces
14 of this state, into any public entertainment or place of amusement
15 because such officer or enlisted member is wearing a uniform of the
16 organization to which he or she belongs. No employer, officer or
17 agent of any corporation, company, firm or other person, shall
18 discharge any person from employment because of being an officer,
19 warrant officer or enlisted member of the military forces of the
20 state, or hinder or prevent him or her from performing any military
21 service he or she may be called upon to perform by proper authority,
22 in respect to his or her employment, trade or business. Any person
23 violating any of the provisions of this section, shall be punished
24 by a fine of not to exceed One Hundred Dollars (\$100.00), or by

1 imprisonment in the county jail for a period of not to exceed thirty
2 (30) days, or by both such fine and imprisonment.

3 SECTION 205. NEW LAW A new section of law to be codified
4 in the Oklahoma Statutes as Section 231b of Title 44, unless there
5 is created a duplication in numbering, reads as follows:

6 A. Subject to the conditions and limitations established in
7 regulations promulgated by the Governor, the state military forces
8 may use all appropriate means necessary to protect assets vital to
9 national security classified as such pursuant to the rules,
10 regulations or instructions promulgated by the United States
11 Department of Defense or the military departments of the United
12 States Department of Defense or as otherwise ordered by the
13 Governor.

14 B. Any regulations promulgated by the Governor pursuant to this
15 section shall be published by the Adjutant General as a military
16 publication as defined in Section 801 of this title.

17 SECTION 206. AMENDATORY 44 O.S. 2011, Section 241, is
18 amended to read as follows:

19 Section 241. The Governor, pursuant to the authority granted
20 the states by ~~the Act of Congress of October 21, 1940~~ Section 109 of
21 Title 32 of the United States Code or a successor provision, and
22 under such regulations as the Secretary of Defense may prescribe for
23 discipline in training, is hereby authorized to enlist, organize,
24 maintain, equip and discipline such military forces other than the

1 National Guard as he or she may deem necessary to defend the state.
2 Such forces shall be uniformed and subject to Sections 1 through
3 117, ~~192 through 195.8,~~ Sections 208 through 235.2 237, and ~~2101~~
4 ~~through 3113~~ Sections 800 through 946 of this title ~~unless in~~
5 ~~conflict with such sections,~~ insofar as such sections do not
6 conflict with Sections 241 through 250 of this title.

7 SECTION 207. AMENDATORY 44 O.S. 2011, Section 242, is
8 amended to read as follows:

9 Section 242. Such military forces shall be designated as the
10 "Oklahoma State Guard" and shall be composed of officers
11 commissioned or assigned, and such able-bodied male citizens of the
12 state as shall volunteer for service therein. They shall be
13 additional to and distinct from the National Guard ~~organized under~~
14 ~~existing law~~ of the State of Oklahoma, as defined in Title 32 of the
15 United States Code. They shall not be required to serve outside the
16 boundaries of ~~this state~~ the State of Oklahoma.

17 SECTION 208. AMENDATORY 44 O.S. 2011, Section 243, is

19 Section 243. A. The Governor is hereby authorized to prescribe
20 rules and regulations governing the enlistment, organization,
21 administration, equipment, discipline and discharge of the personnel
22 of such military forces; to requisition from the Secretary of
23 Defense such arms and equipment as may be in the possession of and
24 can be spared by the Department of Defense and to extend thereto the

1 facilities of state armories, Armed Forces Reserve Centers,

3 warehouses and their equipment and such other state premises and
4 property as may be available for the purpose of drill and
5 instruction. Insofar as applicable the procedure for the
6 enlistment, organization, pay, maintenance, equipment and

8 the rules and regulations governing and pertaining to the National
9 Guard; provided, that the officers and enlisted ~~men~~ personnel in the
10 Oklahoma State Guard shall not receive any compensation or monetary
11 allowances from the state except when ~~called into active service~~
12 activated for state active duty, as defined in Section 801 of this
13 title, by order of the Governor.

14 B. Members of the Oklahoma State Guard shall be considered part
15 of state military forces as defined in Section 801 of this title and
16 shall be subject to the Oklahoma Uniform Code of Military Justice.

17 C. When prescribing the rules and regulations governing
18 enlistment, organization, administration, equipment, discipline and
19 discharge of the personnel of the Oklahoma State Guard, the Governor
20 shall issue such rules and regulations in the form of an executive
21 order or in a series of such orders which shall be published in the
22 Oklahoma Administrative Code. For purposes of the Administrative
23 Procedures Act, the executive order prescribing the rules and
24 regulations governing enlistment, organization, administration,

1 equipment, discipline and discharge of the personnel of the Oklahoma
2 State Guard shall be considered a military publication and shall be
3 published and indexed as part of the Oklahoma Administrative Code.

4 SECTION 209. AMENDATORY 44 O.S. 2011, Section 244, is
5 amended to read as follows:

6 Section 244. Nothing in ~~this act~~ the Oklahoma State Guard Act
7 shall be construed as authorizing such forces, or any part thereof
8 to be called, ordered or in any manner drafted, as such into the
9 military service of the United States, but no person shall by reason
10 of his or her enlistment or commission in any such forces be
11 exempted from military service under any law of the United States.

12 SECTION 210. AMENDATORY 44 O.S. 2011, Section 247, is
13 amended to read as follows:

14 Section 247. No person shall be enlisted for more than one (1)
15 year, but such enlistment may be renewed. The oath to be taken upon
16 enlistment in such forces shall be substantially in the form
17 prescribed for enlisted ~~men~~ members of the National Guard,
18 substituting the words "Oklahoma State Guard" where necessary.

19 SECTION 211. AMENDATORY 44 O.S. 2011, Section 248, is
20 amended to read as follows:

21 Section 248. ~~(a) Whenever such forces or any part thereof~~
22 ~~shall be ordered out for active service the Articles of War of the~~
23 ~~United States applicable to members of the National Guard of this~~
24 ~~state in relation to courts-martial, their jurisdiction and the~~

1 ~~limits of punishment and the rules and regulations prescribed~~
2 ~~thereunder shall be in full force and effect with respect to "the~~
3 ~~Oklahoma State Guard."~~

4 ~~(b)~~ No officer or enlisted ~~man~~ person of ~~such forces~~ the
5 Oklahoma State Guard shall be arrested on any warrant, except for
6 treason or felony, while going to, remaining at, or returning from a
7 place where he or she is ordered to attend for military duty. Every
8 officer and enlisted ~~man~~ members of such forces shall, during his or
9 her service therein, be exempt from service upon any posse comitatus
10 and from jury duty.

11 SECTION 212. AMENDATORY 44 O.S. 2011, Section 250, is
12 amended to read as follows:

13 Section 250. This act may be cited as the Oklahoma State Guard
14 Act.

15 SECTION 213. AMENDATORY 21 O.S. 2011, Section 133, is
16 amended to read as follows:

17 Section 133. This chapter~~7~~ does not affect any power conferred
18 by law upon any court martial or other military authority or officer
19 to impose or inflict punishment upon offenders; nor any power
20 conferred by law upon any public body, tribunal, or officer, to
21 impose or inflict punishment for a contempt; nor any provisions of
22 the laws relating to apprentices, ~~bastards~~~~7~~, disorderly ~~persons~~~~7~~,
23 ~~Indians and vagrants~~ behavior or vagrancy.

1 SECTION 214. AMENDATORY 75 O.S. 2011, Section 250.4, as
2 last amended by Section 12, Chapter 430, O.S.L. 2014 (75 O.S. Supp.
3 2018, Section 250.4), is amended to read as follows:

4 Section 250.4 A. 1. Except as is otherwise specifically
5 provided in this subsection, each agency is required to comply with
6 Article I of the Administrative Procedures Act.

7 2. The Corporation Commission shall be required to comply with
8 the provisions of Article I of the Administrative Procedures Act
9 except for subsections A, B, C and E of Section 303 of this title
10 and Section 306 of this title. To the extent of any conflict or
11 inconsistency with Article I of the Administrative Procedures Act,
12 pursuant to Section 35 of Article IX of the Oklahoma Constitution,
13 it is expressly declared that Article I of the Administrative
14 Procedures Act is an amendment to and alteration of Sections 18
15 through 34 of Article IX of the Oklahoma Constitution.

16 3. The Oklahoma Military Department shall be exempt from the
17 provisions of Article I of the Administrative Procedures Act to the
18 extent it exercises its responsibility for military affairs.
19 Military publications, as defined in Section 801 of Title 44 of the
20 Oklahoma Statutes, shall be exempt from the provisions of Article I
21 and Article II of the Administrative Procedures Act, except as
22 provided in Section 251 of this title.

23 4. The Oklahoma Ordnance Works Authority, the Northeast
24 Oklahoma Public Facilities Authority, the Oklahoma Office of

1 Homeland Security and the Board of Trustees of the Oklahoma College
2 Savings Plan shall be exempt from Article I of the Administrative
3 Procedures Act.

4 5. The Transportation Commission and the Department of
5 Transportation shall be exempt from Article I of the Administrative
6 Procedures Act to the extent they exercise their authority in
7 adopting standard specifications, special provisions, plans, design
8 standards, testing procedures, federally imposed requirements and
9 generally recognized standards, project planning and programming,
10 and the operation and control of the State Highway System.

11 6. The Oklahoma State Regents for Higher Education shall be
12 exempt from Article I of the Administrative Procedures Act with
13 respect to:

- 14 a. prescribing standards of higher education,
- 15 b. prescribing functions and courses of study in each
- 16 institution to conform to the standards,
- 17 c. granting of degrees and other forms of academic
- 18 recognition for completion of the prescribed courses,
- 19 d. allocation of state-appropriated funds, and
- 20 e. fees within the limits prescribed by the Legislature.

21 7. Institutional governing boards within The Oklahoma State
22 System of Higher Education shall be exempt from Article I of the
23 Administrative Procedures Act.

- 1 8. a. The Commissioner of Public Safety shall be exempt from
2 Sections 303.1, 304, 307.1, 308 and 308.1 of this
3 title insofar as it is necessary to promulgate rules
4 pursuant to the Oklahoma Motor Carrier Safety and
5 Hazardous Materials Transportation Act, to maintain a
6 current incorporation of federal motor carrier safety
7 and hazardous material regulations, or pursuant to
8 Chapter 6 of Title 47 of the Oklahoma Statutes, to
9 maintain a current incorporation of federal commercial
10 driver license regulations, for which the Commissioner
11 has no discretion when the state is mandated to
12 promulgate rules identical to federal rules and
13 regulations.
- 14 b. Such rules may be adopted by the Commissioner and
15 shall be deemed promulgated twenty (20) days after
16 notice of adoption is published in "The Oklahoma
17 Register". Such publication need not set forth the
18 full text of the rule but may incorporate the federal
19 rules and regulations by reference.
- 20 c. Such copies of promulgated rules shall be filed with
21 the Secretary as required by Section 251 of this

24 discretion to allow variances, tolerances or

1 modifications from the federal rules and regulations,

10 of a rule made by the Council on Judicial Complaints may petition
11 the Court on the Judiciary to review the rules and issue opinions

14 county sheriffs and managers of city jails shall be exempt from
15 Article I of the Administrative Procedures Act with respect to:

19 of all incarcerated prisoners, and
- 20 b. prescribing internal management procedures for the
21 management of the probation and parole unit of the

2 of the Administrative Procedures Act with respect to prescribing
3 subject matter standards as provided for in Section 11-103.6a of

5 B. As specified, the following agencies or classes of agency
6 activities are not required to comply with the provisions of Article
7 II of the Administrative Procedures Act:

- 8 1. The Oklahoma Tax Commission;
- 9 2. The Commission for Human Services;
- 10 3. The Oklahoma Ordnance Works Authority;
- 11 4. The Corporation Commission;
- 12 5. The Pardon and Parole Board;
- 13 6. The Midwestern Oklahoma Development Authority;
- 14 7. The Grand River Dam Authority;
- 15 8. The Northeast Oklahoma Public Facilities Authority;
- 16 9. The Council on Judicial Complaints;
- 17 10. The Board of Trustees of the Oklahoma College Savings Plan;
- 18 11. The supervisory or administrative agency of any penal,
19 mental, medical or eleemosynary institution, only with respect to
20 the institutional supervision, custody, control, care or treatment
21 of inmates, prisoners or patients therein; provided, that the
22 provisions of Article II shall apply to and govern all
23 administrative actions of the Oklahoma Alcohol Prevention, Training,
24 Treatment and Rehabilitation Authority;

1 12. The Board of Regents or employees of any university,
2 college, or other institution of higher learning;

3 13. The Oklahoma Horse Racing Commission, its employees or
4 agents only with respect to hearing and notice requirements on the
5 following classes of violations which are an imminent peril to the
6 public health, safety and welfare:

- 7 a. any rule regarding the running of a race,
- 8 b. any violation of medication laws and rules,
- 9 c. any suspension or revocation of an occupation license
10 by any racing jurisdiction recognized by the
11 Commission,
- 12 d. any assault or other destructive acts within
13 Commission-licensed premises,
- 14 e. any violation of prohibited devices, laws and rules,
15 or
- 16 f. any filing of false information;

17 14. The Commissioner of Public Safety only with respect to
18 driver license hearings and hearings conducted pursuant to the
19 provisions of Section 2-115 of Title 47 of the Oklahoma Statutes;

20 15. The Administrator of the Department of Securities only with
21 respect to hearings conducted pursuant to provisions of the Oklahoma
22 Take-over Disclosure Act of 1985;

23 16. Hearings conducted by a public agency pursuant to Section
24 962 of Title 47 of the Oklahoma Statutes;

1 17. The Oklahoma Military Department;

2 18. The University Hospitals Authority, including all hospitals
3 or other institutions operated by the University Hospitals
4 Authority;

5 19. The Oklahoma Health Care Authority Board and the
6 Administrator of the Oklahoma Health Care Authority; and

7 20. The Oklahoma Office of Homeland Security.

8 SECTION 215. AMENDATORY 75 O.S. 2011, Section 251, as
9 amended by Section 1, Chapter 252, O.S.L. 2016 (75 O.S. Supp. 2018,
10 Section 251), is amended to read as follows:

11 Section 251. A. 1. Upon the request of the Secretary, each
12 agency shall furnish to the Office a complete set of its permanent
13 rules in such form as is required by the Secretary or as otherwise
14 provided by law.

15 2. The Secretary shall promulgate rules to ensure the effective
16 administration of the provisions of Article I of the Administrative
17 Procedures Act. The rules shall include, but are not limited to,
18 rules prescribing paper size, numbering system, and the format of
19 documents required to be filed pursuant to the provisions of the
20 Administrative Procedures Act or such other requirements as deemed
21 necessary by the Secretary to implement the provisions of the
22 Administrative Procedures Act.

23 B. 1. Each agency shall file the number of copies specified by
24 the Secretary of all new rules, and all amendments, revisions or

1 revocations of existing rules attested to by the agency, pursuant to
2 the provisions of Section 254 of this title, with the Office within
3 thirty (30) calendar days after they become finally adopted.

4 2. An agency filing rules pursuant to the provisions of this
5 subsection:

6 a. shall prepare the rules in plain language which can be
7 easily understood,

8 b. shall not unnecessarily repeat statutory language.

9 Whenever it is necessary to refer to statutory
10 language in order to effectively convey the meaning of
11 a rule interpreting that language, the reference shall
12 clearly indicate the portion of the language which is
13 statutory and the portion which is the agency's
14 amplification or interpretation of that language,

15 c. shall indicate whether a rule is new, amends an
16 existing permanent rule or repeals an existing
17 permanent rule. If a rule amends an existing rule,
18 the rule shall indicate the language to be deleted
19 typed with a line through the language and language to
20 be inserted typed with the new language underscored,

21 d. shall state if the rule supersedes an existing
22 emergency rule,

23 e. shall include a reference to any rule requiring a new
24 or revised form in a note to the rule. The Secretary

1 shall insert that reference in "The Oklahoma Register"
2 as a notation to the affected rule,

3 f. shall prepare, in plain language, a statement of the
4 gist of the rule and an analysis of new or amended
5 rules. The analysis shall include but not be limited
6 to a reference to any statute that the rule

7 interprets, any related statute or any related rule,

8 g. may include with its rules, brief notes,
9 illustrations, findings of facts, and references to
10 digests of Supreme Court cases, other court decisions,
11 or Attorney General's opinions, and other explanatory
12 material. Such material may be included if the
13 material is labeled or set forth in a manner which
14 clearly distinguishes it from the rules,

15 h. shall include other information, in such form and in
16 such manner as is required by the Secretary, and

17 i. may change the format of existing rules without any
18 rulemaking action by the agency in order to comply
19 with the standard provisions established by the
20 Secretary for "Code" and "The Oklahoma Register"
21 publication so long as there is no substantive change
22 to the rule.

23 C. The Secretary is authorized to determine a numbering system
24 and other standardized format for documents to be filed and may

1 refuse to accept for publication any document that does not
2 substantially conform to the promulgated rules of the Secretary.

3 D. In order to avoid unnecessary expense, an agency may use the
4 published standards established by organizations and technical
5 societies of recognized national standing, other state agencies, or
6 federal agencies by incorporating the standards or rules in its
7 rules or regulations by reference to the specific issue or issues of
8 publications in which the standards are published, without
9 reproducing the standards in full. The standards shall be readily
10 available to the public for examination at the administrative
11 offices of the agency. In addition, a copy of such standards shall
12 be kept and maintained by the agency pursuant to the provisions of
13 the Preservation of Essential Records Act.

14 E. The Secretary shall provide for the publication of all
15 Executive Orders received pursuant to the provisions of Section 664
16 of Title 74 of the Oklahoma Statutes.

17 F. The Secretary may authorize or require the filing of rules
18 or Executive Orders by or through electronic data or machine
19 readable equipment in such form and manner as is required by the
20 Secretary.

21 G. The Secretary shall provide for the publication of all
22 military publications received as defined in Section 801 of Title 44
23 of the Oklahoma Statutes. This subsection shall only apply to
24 military publications promulgated after November 1, 2019.

1 H. In consultation with the Adjutant General, the Secretary is
2 authorized to determine a numbering system and other standardized
3 format for military documents to be filed and may authorize or
4 require the filing of military publications by or through electronic
5 data or machine-readable equipment in such form and manner as is
6 required by the Secretary.

7 SECTION 216. AMENDATORY 75 O.S. 2011, Section 255, is
8 amended to read as follows:

9 Section 255. A. 1. The Secretary is hereby authorized,
10 directed, and empowered to publish "The Oklahoma Register" not less
11 than monthly for the publication of new rules, any amendment,
12 revision or revocation of an existing rule, emergency rules, any
13 notices of such rulemaking process, military publications and
14 Executive Orders as are required by law to be published in "The
15 Oklahoma Register". Said rules or amendments, revisions, or
16 revocations of existing rules shall be published in the first issue
17 of "The Oklahoma Register" published pursuant to Sections 251, 253,
18 256, 303, 303.1, 303.2 and 308 of this title after the date of
19 acceptance by the Secretary.

20 2. The Secretary shall cause a copy of each publication of "The
21 Oklahoma Register" to be sent to those county clerks who request it,
22 to members of the Legislature upon request, and to such other
23 agencies, libraries, and officials as the Secretary may select. The
24

1 Secretary may charge recipients of the publication a cost sufficient
2 to defray the cost of publication and mailing.

3 3. The Secretary shall cause a copy of all rules, all new
4 rules, and all amendments, revisions, or revocations of existing
5 rules to be on file and available for public examination in the
6 Office during normal office hours.

7 4. The Secretary shall promulgate rules to systematize the
8 designations of rules. To establish said system or to preserve
9 uniformity of designations, the Secretary may require the agency to
10 change the title or numbering of any rule or any amendment,
11 revision, or revocation thereof.

12 B. The Secretary is authorized to provide for the publication
13 of rules in summary form when the rules are of such length that
14 publication of the full text would be too costly. The summary shall
15 be prepared by the agency submitting the rules and shall state where
16 the full text of the rule may be obtained.

17 C. The notice required pursuant to the provisions of Section
18 303 of this title shall be published in "The Oklahoma Register"
19 prior to the adoption of a new rule, or amendment, revision or
20 revocation of any existing rule. The notice shall include the
21 information required by Section 303 of this title.

22 SECTION 217. AMENDATORY 75 O.S. 2011, Section 256, is
23 amended to read as follows:
24

1 Section 256. A. 1. The Secretary shall provide for the
2 codification, compilation, indexing and publication of agency rules,
3 military publications, as defined by Section 801 of Title 44 of the
4 Oklahoma Statutes and Executive Orders in a publication which shall
5 be known as the "Oklahoma Administrative Code" in the following
6 manner:

- 7 a. ~~On~~ on or before January 1, 1992, the Secretary shall
8 compile Executive Orders which are effective pursuant
9 to paragraph 3 of subsection B of this section, and
10 agency rules which have been submitted pursuant to the
11 agency schedule of compliance and have been accepted
12 as properly codified, as set forth in this section,
13 and rules promulgated by the Secretary. Such
14 compilation shall be maintained by the Office of
15 Administrative Rules and shall be updated by agencies,
16 in a manner prescribed by the Secretary, to reflect
17 subsequent permanent rulemaking. Prior to publication
18 of the first "Code", as set forth in subparagraph b of
19 this paragraph, the compilation shall constitute the
20 official permanent rules of the state. Effective
21 January 1, 1992, any permanent rule not included in
22 such compilation shall be void and of no effect.
23 b. ~~On~~ on or before December 1, 1992, the Secretary shall
24 have indexed and published the "Oklahoma

Administrative Code". To effectuate this provision, the Secretary may contract for the publishing and indexing, or both, of the "Oklahoma Administrative Code". Any permanent rule not published in the "Code" shall be void and of no effect. A finally adopted rule filed and published in "The Oklahoma Register" may be valid until publication of the next succeeding "Code" or "Code" supplement following the date of its final adoption. Provided, a permanent rule which is finally adopted after the closing date for publication in a "Code" or "Code" supplement as announced by the Secretary may be valid until publication of the next succeeding "Code" or "Code" supplement. A permanent rule which is published in "The Oklahoma Register" after the closing date for publication in the first "Code", as announced by the Secretary, shall be void and of no effect upon publication of the next succeeding "Code" or "Code" supplement, if not published in the "Code" or "Code" supplement, and

c. on or before January 1, 2021, the Secretary shall compile, index and publish in the Oklahoma Administrative Code the military publications provided by the Adjutant General pursuant to the Oklahoma

1 Uniform Code of Military Justice and the Oklahoma
2 State Guard Act.

3 2. Compilations or revisions of the "Code" or any part thereof
4 shall be supplemented or revised annually. The "Code" shall be
5 organized by state agency and shall be arranged, indexed and printed
6 in a manner to permit separate publications of portions thereof
7 relating to individual agencies.

8 3. Annual supplements to the "Code" shall be cumulative.
9 Emergency rules shall not be published in the "Code" or in any
10 supplements thereto.

11 4. The "Code" and the supplements shall include a general
12 subject index and an agency index of all rules and Executive Orders
13 contained therein. "The Oklahoma Register" shall also include a
14 sections-affected index of the "Code". The "Code" and supplements
15 shall contain such notes, cross references and explanatory materials
16 as required by the Secretary.

17 5. The Secretary in preparing such rules for publication in the
18 "Code" or supplements shall omit all material shown in canceled
19 type. The Secretary shall not prepare any rule for publication in
20 the "Code" which amends or revises a rule unless the rule so
21 amending or revising conforms to the provisions of the
22 Administrative Procedures Act.

23 6. The Secretary is authorized to determine a numbering system
24 and other standardized format for documents to be filed and may

1 refuse to accept for publication any document that does not
2 substantially conform to the promulgated rules of the Secretary.

3 B. 1. Rules submitted and accepted for publication in the
4 "Code" by August 15 of each year shall be published in the next
5 succeeding "Code" or supplement thereto.

6 2. As soon as possible after August 15 of each year, the
7 Secretary shall assemble all rules and Executive Orders, except
8 emergency rules, promulgated after the publication of the preceding
9 "Code" or "Code" supplement in accordance with the provisions of the
10 Administrative Procedures Act for publication in the "Oklahoma
11 Administrative Code". The "Code" or supplements thereto should be
12 published as soon as possible after August 30 of each year.

13 3. Executive Orders of previous gubernatorial administrations
14 shall terminate ninety (90) calendar days following the inauguration
15 of the next Governor unless otherwise terminated or continued during
16 that time by Executive Order. Copies of all Executive Orders shall
17 be published and indexed in the "Oklahoma Administrative Code". All
18 Executive Orders placing agencies or employees under the State Merit
19 System of Personnel Administration shall remain in effect unless
20 otherwise modified by action of the Legislature.

21 C. The Secretary is hereby authorized and empowered to publish
22 or to contract to publish the "Oklahoma Administrative Code", and to
23 publish or contract to publish such annual cumulative supplements so
24 as to keep the "Code" current. All such agreements shall provide

1 that the publisher shall make such publications in such form and
2 arrangement as shall be approved by the Secretary. The Secretary
3 may publish or authorize the publication of the "Code" in part.

4 D. The Secretary is authorized to correct spelling errors in
5 rules submitted for publication in the "Code" or any such
6 supplements or in "The Oklahoma Register". Any other errors in
7 rules submitted for publication in the "Code" may be noted in
8 editorial notes provided by the Secretary.

9 E. The Secretary shall make copies of the "Code" generally
10 available at a cost sufficient to defray the cost of publication and
11 mailing. Except as otherwise provided by Section 257.1 of this
12 title, the Secretary is authorized to sell or otherwise distribute
13 the "Code" and its supplements.

14 F. 1. The codification system, derivations, cross references,
15 notes of decisions, source notes, authority notes, numerical lists,
16 and codification guides, other than the actual text of rules,
17 indexes, tables and other aids relevant to the publication of the
18 "Oklahoma Administrative Code" and "The Oklahoma Register" shall be
19 the property of the state and may be reproduced only with the
20 written consent of the Secretary. The information which appears on
21 the same page with the text of a rule may be reproduced incidentally
22 with the reproduction of the rule, if the reproduction is for the
23 private use of the individual and not for resale. No person shall
24 attempt to copyright or publish the "Oklahoma Administrative Code"

1 or "The Oklahoma Register", in printed or electronic media, without
2 expressed written consent of the Secretary of State. The Secretary
3 shall notify the Speaker of the House of Representatives and the
4 President Pro Tempore of the Senate of any requests to copyright or
5 publish the "Oklahoma Administrative Code" or "The Oklahoma
6 Register", prior to consent by the Secretary.

7 2. The Secretary may provide for the electronic access to the
8 "Oklahoma Administrative Code" and "The Oklahoma Register" by:

9 a. subscription, or

10 b. an exclusive or a nonexclusive contract for public and
11 private access.

12 3. Publications of rules by agencies are not official
13 publications.

14 4. The sale or resale of the "Oklahoma Administrative Code" or
15 any part thereof by the Secretary of State shall be exempt from any
16 requirement mandating acquisition of a resale number and payment of
17 sales tax.

18 SECTION 218. RECODIFICATION 44 O.S. 2011, Section 3398,
19 shall be recodified as Section 941 of Title 44 of the Oklahoma
20 Statutes, unless there is created a duplication in numbering.
