7 PROPOSED COMMITTEE SUBSTITUTE

8 An Act relating to counties and county officers;  
9 authorizing boards of county commissioners to enter  
10 into contracts for security guard services upon  
11 sheriff request; directing sheriff to select and  
12 administer security plans; providing contract length;  
13 requiring certain licensing; providing for  
14 codification; and providing an effective date.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. NEW LAW A new section of law to be codified  
16 in the Oklahoma Statutes as Section 747 of Title 19, unless there is  
17 created a duplication in numbering, reads as follows:

18 A. At the request of the sheriff, the board of county  
19 commissioners of each county may enter into contracts with private  
20 security agencies or security guards for security guard services in  
21 buildings where the sheriff is required to provide security detail  
22 of prisoners in his or her custody where the prisoner is receiving  
23 medical care and treatment.

1       B. The sheriff has the responsibility and authority for  
2 selecting the security plans and administration of the plans for  
3 counties.

4       C. The contracts may be for a period not to exceed a time as  
5 determined by the commissioners subject to annual appropriations by  
6 the county excise board.

7       D. Security guard agencies or security guards providing  
8 security for buildings shall be licensed pursuant to the Oklahoma  
9 Security Guard and Private Investigator Act permitting the holder to  
10 perform the functions of a security guard, armed security guard or  
11 security agency.

12       SECTION 2. This act shall become effective November 1, 2020.
