  - 3. "Oklahoma beef retailer" means any person or entity located in Oklahoma engaged in the business of selling or offering for sale beef products to the public; and
  - 4. "Oklahoma beef supplier" means any person or entity located in Oklahoma that packages or supplies Oklahoma beef products for wholesale or retail sale.
  - SECTION 2. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 18-42.2 of Title 2, unless there is created a duplication in numbering, reads as follows:
  - A. An Oklahoma beef producer who sells or offers for sale beef products from cattle that are born, exclusively raised, fed, slaughtered and packaged in Oklahoma may promote and support the Oklahoma beef industry by use of an official Oklahoma beef label to designate or market these products to wholesale and retail buyers. Labels may be used in outdoor advertisements, print and online advertisements and inside advertisements such as restaurant menus.
  - B. Beef products sold or offered for sale by Oklahoma beef suppliers and Oklahoma beef retailers that do not meet the definition of "official Oklahoma beef" shall not bear or otherwise carry the official Oklahoma beef label.
