[transportation - requiring yearly selection of
certain pilot program - effective date]

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified
in the Oklahoma Statutes as Section 4020 of Title 69, unless there
is created a duplication in numbering, reads as follows:

A. As used in this section:

1. "Advanced transportation" means any new mode, form or type
of transportation as identified by the United States Secretary of
Transportation or the Administrator of the National Aeronautics and
Space Administration (NASA) including transportation based on both
manned and unmanned technologies. This definition shall also
include those types of transportation based on autonomous systems;

1 2. "Infrastructure" shall include traditional definitions of
2 infrastructure such as roads, highways, electrical transmission
3 facilities, as well as advanced communications systems, software
4 systems to manage advanced transportation systems and traffic, and
5 safety equipment to support the operation of advanced transportation
6 systems;

7 3. "Lead Oklahoma entity" means any city, town or county
8 government in the State of Oklahoma that is recognized as a
9 subdivision of the state, and that has been selected by the United
10 States Secretary of Transportation, by the NASA Administrator or by
11 both the United States Secretary of Transportation and the NASA
12 Administrator as the primary public entity in advanced
13 transportation pilot programs. The term shall also include any
14 federally recognized Native American tribal governments selected as
15 lead public entity for advanced transportation pilot programs, and
16 that have their primary headquarters within the State of Oklahoma;

17 4. "Lead entity investment" means a direct monetary investment
18 in advanced infrastructure to support the advanced transportation
19 projects;

20 5. "Pilot program" means any program created after January 1,
21 2017, by the United States Secretary of Transportation or
22 Administrator of NASA to demonstrate, test or evaluate advanced
23 transportation technologies within the State of Oklahoma. This
24 section shall only apply to those pilot programs that require and

1 include active local community stakeholder involvement as part of
2 national transportation policymaking. The stakeholder involvement
3 shall include efforts to address societal concerns such as privacy,
4 noise, safety and related concerns about the technology; and

5 6. "Qualifying lead entity investment" means any expenditure
6 either directly by the lead public entity or by other entities,
7 including industry partners, that make investments on behalf of the
8 lead public entity. Qualifying investments and expenditures shall
9 include those made no more than two (2) years prior to selection
10 under the provisions of this law.

11 B. No later than January 1 of each calendar year after November
12 1, 2019, and subject to availability of funding as appropriated by
13 the Oklahoma Legislature, the Oklahoma Department of Transportation
14 shall select one active eligible and active advanced transportation
15 pilot program within the State of Oklahoma to receive a direct one-
16 to-one match for qualified lead entity investments that are part of
17 an advanced transportation pilot program. The selected lead
18 Oklahoma entity shall use the matching funds to promote and advance
19 the goals of the pilot program.

20 SECTION 2. This act shall become effective November 1, 2019.
