An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; making appropriations to the State Board of Education, the Oklahoma Arts Council, the State Board of Career and Technology Education, the Office of Educational Quality and Accountability, the Oklahoma Educational Television Authority, the Oklahoma State Regents for Higher Education, the Commissioners of the Land Office, the Oklahoma Department of Libraries, the Physician Manpower Training Commission, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Center for the Advancement of Science and Technology, the Office of the State Auditor and Inspector, the State Election Board, the Oklahoma Department of Emergency Management, the Ethics Commission, the Office of the Governor, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Office of Management and Enterprise Services, the Oklahoma Merit Protection Commission, the Military Department of the State of Oklahoma, the Oklahoma State Senate, the Oklahoma Tax Commission, the Office of the State Treasurer, the Oklahoma Space Industry Development Authority, the Department of Transportation, the State Department of Health, the Oklahoma Health Care

12 Commerce, the Rural Economic Action Plan Fund, the  
13 Oklahoma Conservation Commission, the Corporation  
14 Commission, the Department of Environmental Quality,  
15 the Oklahoma Historical Society, the J.M. Davis  
16 Memorial Commission, the Department of Labor, the  
17 Department of Mines, the Oklahoma Tourism and  
18 Recreation Department, the Oklahoma Water Resources  
19 Board, the Alcoholic Beverage Laws Enforcement  
20 Commission, the Department of Corrections, the  
21 Oklahoma State Bureau of Investigation, the Council  
22 on Law Enforcement Education and Training, the Board  
23 of Medicolegal Investigations, the Oklahoma State  
24 Bureau of Narcotics and Dangerous Drugs Control, the  
Department of Public Safety, the Office of the  
Attorney General, the Court of Criminal Appeals,  
district attorneys and the District Attorneys  
Council, the Supreme Court, the Oklahoma Indigent  
Defense System, the Pardon and Parole Board, the  
Oklahoma Quick Action Closing Fund, The State  
Emergency Fund, the Rate Preservation Fund, the  
Maintenance of State Buildings Revolving Fund, the  
Digital Transformation Program Revolving Fund, and  
the Multiple Injury Trust Fund; stating amounts of  
the appropriations; stating purposes and  
restrictions; reappropriating certain funds;  
authorizing certain expenditures; and providing an  
effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

1       SECTION 1. There is hereby appropriated to the State Board of  
2 Education from any monies not otherwise appropriated from the  
3 General Revenue Fund of the State Treasury for the fiscal year  
4 ending June 30, 2021, the sum of Nine Hundred Fifty-three Million  
5 Three Hundred Thirty-eight Thousand Three Hundred Nineteen Dollars  
6 .(\$953,338,319.00) or so much thereof as may be necessary for the  
7 financial support of public schools.

8       SECTION 2. There is hereby appropriated to the State Board of  
9 Education from any monies not otherwise appropriated from the  
10 Education Reform Revolving Fund created in Section 34.89 of Title 62  
11 of the Oklahoma Statutes, the sum of One Billion Fifteen Million  
12 Seventy-four Thousand Four Hundred Nineteen Dollars  
13 (\$1,015,074,419.00) or so much thereof as may be necessary for the  
14 financial support of public schools.

15       SECTION 3. The State Board of Education is hereby authorized to  
16 expend during the fiscal year ending June 30, 2021, from the Common  
17 Education Technology Revolving Fund of the State Treasury, the sum  
18 of Forty-six Million Nine Hundred Thirty-eight Thousand Five Hundred  
19 Sixty-six Dollars (\$46,938,566.00) or so much thereof as may be  
20 necessary for the financial support of public schools.

21       SECTION 4. There is hereby appropriated to the State Board of  
22 Education from any monies not otherwise appropriated from the  
23 Mineral Leasing Fund of the State Treasury for the fiscal year  
24 ending June 30, 2021, the sum of Three Million Eight Hundred

1 Thousand Dollars (\$3,800,000.00) or so much thereof as may be  
2 necessary for the financial support of public schools.

3 SECTION 5. There is hereby appropriated to the State Board of  
4 Education from any monies not otherwise appropriated from the  
5 Mineral Leasing Fund of the State Treasury for the fiscal year  
6 ending June 30, 2019, the sum of Five Million Four Hundred Eleven  
7 Thousand Two Hundred Fifty-eight Dollars (\$5,411,258.00) or so much  
8 thereof as may be necessary for the financial support of public  
9 schools.

10 SECTION 6. There is hereby appropriated to the State Board of  
11 Education from any monies not otherwise appropriated from the  
12 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
13 fiscal year ending June 30, 2021, the sum of Twenty-three Million  
14 Seven Hundred Fifteen Thousand Dollars (\$23,715,000.00) or so much  
15 thereof as may be necessary for the financial support of public  
16 schools.

17 SECTION 7. There is hereby appropriated to the State Board of  
18 Education from any monies not otherwise appropriated from the  
19 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
20 fiscal year ending June 30, 2019, the sum of Nine Million Twenty-  
21 four Thousand Four Hundred Twenty-eight Dollars (\$9,024,428.00) or  
22 so much thereof as may be necessary for the financial support of  
23 public schools.

1       SECTION 8. There is hereby appropriated to the State Board of  
2 Education from any monies not otherwise appropriated from the  
3 General Revenue Fund of the State Treasury for the fiscal year  
4 ending June 30, 2021, the sum of One Hundred Million Nine Hundred  
5 Nineteen Thousand Twenty-six Dollars (\$100,919,026.00) or so much  
6 thereof as may be necessary for the support of public schools  
7 activities.

8       SECTION 9. There is hereby appropriated to the State Board of  
9 Education from any monies not otherwise appropriated from the  
10 Revenue Stabilization Fund (105 Fund) of the State Treasury, the sum  
11 of Thirty-three Million Dollars (\$33,000,000.00) or so much thereof  
12 as may be necessary for the purchase of textbooks and instructional  
13 materials.

14       SECTION 10. There is hereby appropriated to the State Board of  
15 Education from any monies not otherwise appropriated from the  
16 General Revenue Fund of the State Treasury for the fiscal year  
17 ending June 30, 2021, the sum of Three Hundred Forty-seven Million  
18 Eighty-one Thousand Six Hundred Forty-four Dollars (\$347,081,644.00)  
19 or so much thereof as may be necessary for the Certified Employee  
20 Health Benefit Allowance.

21       SECTION 11. There is hereby appropriated to the State Board of  
22 Education from any monies not otherwise appropriated from the  
23 General Revenue Fund of the State Treasury for the fiscal year  
24 ending June 30, 2021, the sum of One Hundred Eighty-eight Million

1 Four Hundred Fifty-five Thousand Three Hundred Seventy-seven Dollars  
2 (\$188,455,377.00) or so much thereof as may be necessary for the  
3 Support Personnel Health Benefit Allowance.

4 SECTION 12. There is hereby appropriated to the State Board of  
5 Education from any monies not otherwise appropriated from the  
6 General Revenue Fund of the State Treasury for the fiscal year  
7 ending June 30, 2019, the sum of Fifteen Million Twenty-seven  
8 Thousand Six Hundred Forty Dollars (\$15,027,640.00) or so much  
9 thereof as may be necessary for administrative and support functions  
10 of the State Department of Education.

11 SECTION 13. There is hereby appropriated to the State Board of  
12 Education from any monies not otherwise appropriated from the  
13 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
14 fiscal year ending June 30, 2021, the sum of Two Million Six Hundred  
15 Thirty-five Thousand Dollars (\$2,635,000.00) or so much thereof as  
16 may be necessary for transfer to the School Consolidation Assistance  
17 Fund.

18 SECTION 14. There is hereby appropriated to the State Board of  
19 Education from any monies not otherwise appropriated from the  
20 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
21 fiscal year ending June 30, 2019, the sum of One Million Two  
22 Thousand Seven Hundred Fourteen Dollars (\$1,002,714.00) or so much  
23 thereof as may be necessary for transfer to the School Consolidation  
24 Assistance Fund.

1       SECTION 15. There is hereby appropriated to the State Board of  
2 Education from any monies not otherwise appropriated from the  
3 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
4 fiscal year ending June 30, 2021, the sum of Two Million Six Hundred  
5 Thirty-five Thousand Dollars (\$2,635,000.00) or so much thereof as  
6 may be necessary for transfer to the Teachers' Retirement System  
7 Dedicated Revenue Revolving Fund.

8       SECTION 16. There is hereby appropriated to the State Board of  
9 Education from any monies not otherwise appropriated from the  
10 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
11 fiscal year ending June 30, 2019, the sum of One Million Two  
12 Thousand Seven Hundred Fourteen Dollars (\$1,002,714.00) or so much  
13 thereof as may be necessary for transfer to the Teachers' Retirement  
14 System Dedicated Revenue Revolving Fund.

15       SECTION 17. There is hereby appropriated to the Oklahoma Arts  
16 Council from any monies not otherwise appropriated from the General  
17 Revenue Fund of the State Treasury for the fiscal year ending June  
18 30, 2021, the sum of Two Million Seven Hundred Ninety-six Thousand  
19 Thirty Dollars (\$2,796,030.00) or so much thereof as may be  
20 necessary to perform the duties imposed upon the Oklahoma Arts  
21 Council by law.

22       SECTION 18. There is hereby appropriated to the State Board of  
23 Career and Technology Education from any monies not otherwise  
24 appropriated from the General Revenue Fund of the State Treasury for

1 the fiscal year ending June 30, 2021, the sum of One Hundred Thirty-  
2 three Million Four Hundred Seventy Thousand Three Hundred Eighty-  
3 five Dollars (\$133,470,385.00) or so much thereof as may be  
4 necessary to perform the duties imposed upon the State Board of  
5 Career and Technology Education by law.

6 SECTION 19. There is hereby appropriated to the State Board of  
7 Career and Technology Education from any monies not otherwise  
8 appropriated from the Oklahoma Education Lottery Trust Fund of the  
9 State Treasury for the fiscal year ending June 30, 2021, the sum of  
10 Two Million Eight Hundred Ninety-eight Thousand Five Hundred Dollars  
11 (\$2,898,500.00) pursuant to paragraph 2 of subsection F of Section  
12 713 of Title 3A of the Oklahoma Statutes for allocation by the State  
13 Board of Career and Technology Education for the education and  
14 general operating budgets of the institutions and for other  
15 programs, construction, renovations or repairs administered by the  
16 State Board of Career and Technology Education.

17 SECTION 20. There is hereby appropriated to the State Board of  
18 Career and Technology Education from any monies not otherwise  
19 appropriated from the Oklahoma Education Lottery Trust Fund of the  
20 State Treasury for the fiscal year ending June 30, 2019, the sum of  
21 One Million One Hundred Two Thousand Nine Hundred Eighty-six Dollars  
22 (\$1,102,986.00) pursuant to paragraph 2 of subsection F of Section  
23 713 of Title 3A of the Oklahoma Statutes for allocation by the State  
24 Board of Career and Technology Education for the education and



1 general operating budgets of the institutions and for other  
2 programs, construction, renovations or repairs administered by the  
3 State Board of Career and Technology Education.

4 SECTION 21. There is hereby appropriated to the Office of  
5 Educational Quality and Accountability from any monies not otherwise  
6 appropriated from the General Revenue Fund of the State Treasury for  
7 the fiscal year ending June 30, 2021, the sum of One Million Sixty-  
8 seven Thousand Two Hundred Nine Dollars (\$1,067,209.00) or so much  
9 thereof as may be necessary to perform the duties imposed upon the  
10 Office of Educational Quality and Accountability by law. Of those  
11 funds appropriated the sum of Sixty Thousand Dollars (\$60,000.00)  
12 shall be deposited in the Teacher Certification Scholarship  
13 Revolving Fund created pursuant to Section 6-187C of Title 70 of the  
14 Oklahoma Statutes. Of those funds appropriated the sum of One  
15 Hundred Eighty Thousand Dollars (\$180,000.00) shall be deposited in  
16 the Education Leadership Oklahoma Revolving Fund created pursuant to  
17 Section 6-204.3 of Title 70 of the Oklahoma Statutes.

18 SECTION 22. There is hereby appropriated to the Office of  
19 Educational Quality and Accountability from any monies not otherwise  
20 appropriated from the Special Cash Fund of the State Treasury the  
21 sum of Five Hundred Thousand Dollars (\$500,000.00) or so much  
22 thereof as may be necessary to perform the duties imposed upon the  
23 Office of Educational Quality and Accountability by law.

1       SECTION 23. There is hereby appropriated to the Oklahoma  
2 Educational Television Authority from any monies not otherwise  
3 appropriated from the General Revenue Fund of the State Treasury for  
4 the fiscal year ending June 30, 2021, the sum of Two Million Seven  
5 Hundred Twenty-nine Thousand Four Dollars (\$2,729,004.00) or so much  
6 thereof as may be necessary to perform the duties imposed upon the  
7 Oklahoma Educational Television Authority by law.

8       SECTION 24. There is hereby appropriated to the Oklahoma State  
9 Regents for Higher Education from any monies not otherwise  
10 appropriated from the General Revenue Fund of the State Treasury for  
11 the fiscal year ending June 30, 2021, the sum of Six Hundred Thirty-  
12 two Million Five Thousand Three Hundred Sixty Dollars  
13 (\$632,005,360.00) or so much thereof as may be necessary for  
14 allocation by the Oklahoma State Regents for Higher Education  
15 pursuant to the provisions of Article XIII-a of the Oklahoma  
16 Constitution for the education and general operating budgets of the  
17 institutions and for other programs, construction, renovations or  
18 repairs administered by the Oklahoma State Regents for Higher  
19 Education. Of those funds appropriated, the sum of Two Million Nine  
20 Hundred Ninety-eight Thousand Four Hundred Seventy-four Dollars  
21 (\$2,998,474.00) shall be transferred to the Oklahoma Tuition  
22 Equalization Grant Trust Fund to implement the provisions of the  
23 Oklahoma Tuition Equalization Grant Act.

1       SECTION 25. The Oklahoma State Regents for Higher Education are  
2 hereby authorized to expend during the fiscal year ending June 30,  
3 2021, the sum of Forty-six Million Nine Hundred Thirty-eight  
4 Thousand Five Hundred Sixty-six Dollars (\$46,938,566.00) from the  
5 Higher Education Capital Revolving Fund of the State Treasury for  
6 allocation by the Oklahoma State Regents for Higher Education  
7 pursuant to the provisions of Article XIII-a of the Oklahoma  
8 Constitution for the education and general operating budgets of the  
9 institutions and for other programs, construction, renovations or  
10 repairs administered by the Oklahoma State Regents for Higher  
11 Education.

12       SECTION 26. The Oklahoma State Regents for Higher Education are  
13 hereby authorized to expend during the fiscal year ending June 30,  
14 2021, the sum of Forty-six Million Nine Hundred Thirty-eight  
15 Thousand Five Hundred Sixty-six Dollars (\$46,938,566.00) from the  
16 Oklahoma Student Aid Revolving Fund of the State Treasury for  
17 allocation by the Oklahoma State Regents for Higher Education  
18 pursuant to the provisions of Article XIII-a of the Oklahoma  
19 Constitution for the education and general operating budgets of the  
20 institutions and for other programs, construction, renovations or  
21 repairs administered by the Oklahoma State Regents for Higher  
22 Education.

23       SECTION 27. There is hereby appropriated to the Oklahoma State  
24 Regents for Higher Education from any monies not otherwise

1 appropriated from the General Revenue Fund of the State Treasury for  
2 the fiscal year ending June 30, 2021, the sum of Eleven Million  
3 Seven Hundred Sixty-four Thousand Eight Hundred Twenty-three Dollars  
4 (\$11,764,823.00) or so much thereof as may be necessary for  
5 expenditures for concurrent enrollment pursuant to Section 628.13 of  
6 Title 70 of the Oklahoma Statutes.

7       SECTION 28. There is hereby appropriated to the Oklahoma State  
8 Regents for Higher Education from any monies not otherwise  
9 appropriated from the Oklahoma Education Lottery Trust Fund of the  
10 State Treasury for the fiscal year ending June 30, 2021, the sum of  
11 Twenty Million Eight Hundred Sixteen Thousand Five Hundred Dollars  
12 (\$20,816,500.00) pursuant to paragraph 2 of subsection F of Section  
13 713 of Title 3A of the Oklahoma Statutes for allocation by the  
14 Oklahoma State Regents for Higher Education pursuant to the  
15 provisions of Article XIII-a of the Oklahoma Constitution for  
16 construction, renovations or repairs administered by the Oklahoma  
17 State Regents for Higher Education or for any other purpose  
18 authorized by paragraph 2 of subsection F of Section 713 of Title 3A  
19 of the Oklahoma Statutes.

20       SECTION 29. There is hereby appropriated to the Oklahoma State  
21 Regents for Higher Education from any monies not otherwise  
22 appropriated from the Oklahoma Education Lottery Trust Fund of the  
23 State Treasury for the fiscal year ending June 30, 2019, the sum of  
24 Seven Million Nine Hundred Twenty-one Thousand Four Hundred Forty-

1 three Dollars (\$7,921,443.00) pursuant to paragraph 2 of subsection  
2 F of Section 713 of Title 3A of the Oklahoma Statutes for allocation  
3 by the Oklahoma State Regents for Higher Education pursuant to the  
4 provisions of Article XIII-a of the Oklahoma Constitution for  
5 construction, renovations or repairs administered by the Oklahoma  
6 State Regents for Higher Education or for any other purpose  
7 authorized by paragraph 2 of subsection F of Section 713 of Title 3A  
8 of the Oklahoma Statutes.

9 SECTION 30. There is hereby appropriated to the Oklahoma State  
10 Regents for Higher Education from any monies not otherwise  
11 appropriated from the General Revenue Fund of the State Treasury for  
12 the fiscal year ending June 30, 2021, the sum of Four Million  
13 Twenty-nine Thousand Four Hundred Eighty-four Dollars  
14 (\$4,029,484.00) or so much thereof as may be necessary for the  
15 general operating budget of the Administrative Offices of the  
16 Oklahoma State Regents for Higher Education.

17 SECTION 31. There is hereby appropriated to the Commissioners  
18 of the Land Office from any monies not otherwise appropriated from  
19 the Commissioners of the Land Office Fund of the State Treasury for  
20 the fiscal year ending June 30, 2021, the sum of Eight Million Three  
21 Hundred Seventy-nine Thousand Two Hundred Seventy-six Dollars  
22 (\$8,379,276.00) or so much thereof as may be necessary to perform  
23 the duties imposed upon the Commissioners of the Land Office by law.  
24

1       SECTION 32. There is hereby appropriated to the Oklahoma  
2 Department of Libraries from any monies not otherwise appropriated  
3 from the General Revenue Fund of the State Treasury for the fiscal  
4 year ending June 30, 2021, the sum of Four Million Three Hundred  
5 Forty-six Thousand Three Hundred Fifteen Dollars (\$4,346,315.00) or  
6 so much thereof as may be necessary to perform the duties imposed  
7 upon the Oklahoma Department of Libraries by law.

8       SECTION 33. There is hereby appropriated to the Physician  
9 Manpower Training Commission from any monies not otherwise  
10 appropriated from the General Revenue Fund of the State Treasury for  
11 the fiscal year ending June 30, 2021, the sum of Six Million Five  
12 Hundred Forty-six Thousand Eight Hundred Seventy-seven Dollars  
13 (\$6,546,877.00) or so much thereof as may be necessary to perform  
14 the duties imposed upon the Physician Manpower Training Commission  
15 by law.

16       SECTION 34. There is hereby appropriated to the Physician  
17 Manpower Training Commission from any monies not otherwise  
18 appropriated from the Special Cash Fund of the State Treasury the  
19 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much  
20 thereof as may be necessary to perform the duties imposed upon the  
21 Physician Manpower Training Commission by law.

22       SECTION 35. There is hereby appropriated to the Board of  
23 Trustees of the Oklahoma School of Science and Mathematics from any  
24 monies not otherwise appropriated from the General Revenue Fund of

1 the State Treasury for the fiscal year ending June 30, 2021, the sum  
2 of Six Million Thirty-three Thousand Three Hundred Seventy-three  
3 Dollars (\$6,033,373.00) or so much thereof as may be necessary to  
4 perform the duties imposed upon the Board of Trustees of the  
5 Oklahoma School of Science and Mathematics by law.

6 SECTION 36. There is hereby appropriated to the Oklahoma Center  
7 for the Advancement of Science and Technology from any monies not  
8 otherwise appropriated from the General Revenue Fund of the State  
9 Treasury for the fiscal year ending June 30, 2021, the sum of  
10 Thirteen Million Seven Hundred Ninety-six Thousand Five Hundred  
11 Forty-two Dollars (\$13,796,542.00) or so much thereof as may be  
12 necessary to perform the duties imposed upon the Oklahoma Center for  
13 the Advancement of Science and Technology by law. Of those funds  
14 appropriated, the sum of Five Million Five Hundred Eighteen Thousand  
15 Six Hundred Seventeen Dollars (\$5,518,617.00) shall be deposited in  
16 the Research Support Revolving Fund, created pursuant to Section  
17 5060.11 of Title 74 of the Oklahoma Statutes. Of those funds  
18 appropriated, the sum of Three Million Thirty-five Thousand Two  
19 Hundred Thirty-nine Dollars (\$3,035,239.00) shall be deposited in  
20 the Seed-Capital Revolving Fund, created pursuant to Section 5060.21  
21 of Title 74 of the Oklahoma Statutes.

22 GENERAL GOVERNMENT AND TRANSPORTATION

23 SECTION 37. There is hereby appropriated to the Office of the  
24 State Auditor and Inspector from any monies not otherwise

1 appropriated from the General Revenue Fund of the State Treasury for  
2 the fiscal year ending June 30, 2019, the sum of Four Million  
3 Eighty-six Thousand Sixteen Dollars (\$4,086,016.00) or so much  
4 thereof as may be necessary to perform the duties imposed upon the  
5 Office of the State Auditor and Inspector by law.

6 SECTION 38. There is hereby appropriated to the Office of the  
7 State Auditor and Inspector from any monies not otherwise  
8 appropriated from the General Revenue Fund of the State Treasury for  
9 the fiscal year ending June 30, 2021, the sum of Two Hundred  
10 Fourteen Thousand Two Hundred Ninety-nine Dollars (\$214,299.00) or  
11 so much thereof as may be necessary to perform the duties imposed  
12 upon the Commission on County Government Personnel Education and  
13 Training. The appropriation made in this section shall be expended  
14 exclusively for the purpose so stated and shall not be transferable.

15 SECTION 39. There is hereby appropriated to the State Election  
16 Board from any monies not otherwise appropriated from the General  
17 Revenue Fund of the State Treasury for the fiscal year ending June  
18 30, 2019, the sum of Nine Million Seven Hundred Thirty-seven  
19 Thousand Six Hundred Seventeen Dollars (\$9,737,617.00) or so much  
20 thereof as may be necessary to perform the duties imposed upon the  
21 State Election Board by law.

22 SECTION 40. There is hereby appropriated to the Oklahoma  
23 Department of Emergency Management from any monies not otherwise  
24 appropriated from the General Revenue Fund of the State Treasury for

20 SECTION 145. There is hereby appropriated to the Education  
21 Reform Revolving Fund created in Section 34.89 of Title 62 of the  
22 Oklahoma Statutes from the Oklahoma Medical Marijuana Authority  
23 Revolving Fund (Fund 248) of the State Treasury, the sum of Thirty  
24 Million Dollars (\$30,000,000.00) for availability of appropriation.

1       SECTION 146. There is hereby appropriated to the State Board of  
2 Education from any monies not otherwise appropriated from the  
3 General Revenue Fund of the State Treasury for the fiscal year  
4 ending June 30, 2019 the sum of One Hundred Twelve Million Dollars  
5 (\$112,000,000.00) to be transferred to the Ad Valorem Reimbursement  
6 Fund, created pursuant to Section 193 of Title 62 of the Oklahoma  
7 Statutes, for the purpose of reimbursing counties for school  
8 districts that claim a loss of revenue due to a tax exemption  
9 granted pursuant to the provisions of Section 6B of Article X of the  
10 Oklahoma Constitution.

11       SECTION 147. There is hereby appropriated to State Board of  
12 Education from any monies not otherwise appropriated from the  
13 General Revenue Fund of the State Treasury for the fiscal year  
14 ending June 30, 2019, the sum of Nine Million Eight Hundred Twenty-  
15 four Thousand Three Hundred Fifteen Dollars (\$9,824,315.00) for the  
16 purpose of funding the Teachers' Retirement Credit.

17       SECTION 148. There is hereby appropriated to the Oklahoma State  
18 Regents for Higher Education from any monies not otherwise  
19 appropriated from the General Revenue Fund of the State Treasury for  
20 the fiscal year ending June 30, 2019, the sum of Two Hundred Ten  
21 Thousand Dollars (\$210,000.00) for allocation by the Oklahoma State  
22 Regents for Higher Education pursuant to the provisions of Article  
23 XIII-a of the Oklahoma Constitution for the education and general  
24 operating budgets of the institutions and for other programs,

1 construction, renovations or repairs administered by the Oklahoma  
2 State Regents for Higher Education.

3 SECTION 149. There is hereby appropriated to the Office of  
4 Management and Enterprise Services from any monies not otherwise  
5 appropriated from the General Revenue Fund of the State Treasury for  
6 the fiscal year ending June 30, 2019, the sum of Two Million Four  
7 Hundred Seventy Thousand Dollars (\$2,470,000.00) or so much thereof  
8 as may be necessary for the relocation of the state agencies  
9 currently housed within the Robert S. Kerr and J. Howard Edmondson  
10 buildings.

11 SECTION 150. Sections 1 through 136 of this act shall become  
12 effective July 1, 2020.
