9 Section 3-104.4, as last amended by Section 27,  
10 Chapter 42, O.S.L. 2017 (70 O.S. Supp. 2018, Section  
11 3-104.4), which relates to standards for  
12 accreditation of schools; modifying circumstances  
13 under which accreditation cannot be withdrawn or  
14 denied for failure to meet certain media program  
15 standards; directing certain prohibition to cease  
16 once per-pupil expenditures are equal to or more than  
17 certain regional average expenditure as reported by  
18 the National Center for Education Statistics;  
19 directing the State Board of Education to report  
20 whether expenditures have reached certain level by  
21 certain date; modifying circumstances under which the  
22 State Board of Education cannot assess certain  
23 penalties; directing certain prohibition to cease  
24 once per-pupil expenditures are equal to or more than  
certain regional average expenditure as reported by  
the National Center for Education Statistics;  
directing the State Board of Education to report  
whether expenditures have reached certain level by  
certain date; amending 70 O.S. 2011, Section 3-167,  
as last amended by Section 2, Chapter 253, O.S.L.  
2016 (70 O.S. Supp. 2018, Section 3-167), which  
relates to advisory councils; modifying circumstances  
under which school districts are exempt from certain  
advisory council requirements; directing certain  
prohibition to cease once per-pupil expenditures are  
equal to or more than certain regional average  
expenditure as reported by the National Center for  
Education Statistics; directing the State Board of  
Education to report whether expenditures have reached  
certain level by certain date; amending 70 O.S. 2011,

1 Section 16-111, as last amended by Section 3, Chapter  
2 253, O.S.L. 2016 (70 O.S. Supp. 2018, Section 16-  
3 111), which relates to textbook adoption; modifying  
4 circumstances under which school districts are exempt  
5 from certain textbook adoption requirements;  
6 directing certain prohibition to cease once per-pupil  
7 expenditures are equal to or more than certain  
8 regional average expenditure as reported by the  
9 National Center for Education Statistics; directing  
10 the State Board of Education to report whether  
11 expenditures have reached certain level by certain  
12 date; providing an effective date; and declaring an  
13 emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 70 O.S. 2011, Section 3-104.4, as  
last amended by Section 27, Chapter 42, O.S.L. 2017 (70 O.S. Supp.  
2018, Section 3-104.4), is amended to read as follows:

Section 3-104.4. A. On or before February 1, 1991, the State  
Board of Education shall adopt standards for the accreditation of  
the public schools in this state according to the requirements of  
this act, to be effective as set forth in this act. The  
accreditation standards shall incorporate the curricular standards  
established pursuant to Section 11-103.6 of this title. The  
accreditation standards shall equal or exceed the accreditation  
standards for schools promulgated by the North Central Association  
of Colleges and Schools to the extent that the standards are  
consistent with an academic results oriented approach to  
accreditation, excluding those standards which deal with affective

1 behavior to the extent the adoption of the standards does not  
2 conflict with state statute. The accreditation adopted by the State  
3 Board shall encompass accreditation for elementary schools, middle  
4 schools, junior high schools, and high schools. The accreditation  
5 standards shall be made available for public inspection at the  
6 offices of the State Department of Education.

7 B. Standards for accreditation adopted by the State Board of  
8 Education shall include standards relating to the provision of  
9 school counselors to the public school children of this state. The  
10 State Board of Education shall require each local school district to  
11 provide information regarding the number of counselors serving each  
12 school site, the duties of all such counselors including all  
13 administrative duties, the number of students served by each  
14 counselor, and information regarding the number of counselors  
15 employed per elementary school, middle school, junior high school  
16 and high school.

17 C. Except as otherwise provided by subsection A of this section  
18 with regard to curricular standards, as a condition of receiving  
19 state accreditation pursuant to this act:

20 1. High schools shall meet the accreditation standards not  
21 later than June 30, 1995; and

22 2. Elementary, middle and junior high schools shall meet the  
23 accreditation standards not later than June 30, 1999.

1 Schools shall thereafter continue to meet the accreditation  
2 standards as a condition of continued accreditation. Nothing herein  
3 shall be construed as preventing changes to the adopted standards by  
4 the State Board of Education pursuant to the Administrative  
5 Procedures Act.

6 D. If one or more school sites fails to receive accreditation  
7 as required pursuant to this section by the dates set forth in  
8 subsection C of this section or subsequently loses accreditation,  
9 the State Board of Education shall close the school and reassign the  
10 students to accredited schools within the district or shall annex  
11 the district to one or more other districts in which the students  
12 can be educated in accredited schools.

13 E. Standards for accreditation adopted by the State Board of  
14 Education shall include standards relating to the provision of  
15 educational services provided in partial hospitalization programs,  
16 day treatment programs, day hospital programs, residential treatment  
17 programs and emergency shelter programs for persons between the ages  
18 of three (3) and twenty-one (21) years of age. The accreditation  
19 standards shall apply to onsite and offsite educational services  
20 provided by public school districts or state-accredited private  
21 schools. The accreditation standards shall provide for warnings,  
22 probation or nonaccredited status for schools that fail to meet the  
23 standards. Each school which is providing or is required to provide  
24 educational services for students placed in a program as described

1 in this subsection shall be actively monitored by the State  
2 Department of Education. The Department shall determine on an  
3 ongoing basis if the educational program and services are in  
4 compliance with the accreditation standards. The Department shall  
5 investigate a complaint of failure to provide educational services  
6 within ten (10) days of receiving the complaint. If the Department  
7 determines that a school has failed to comply with the accreditation  
8 standards the Department shall report the recommended warning,  
9 probation or nonaccredited accreditation status to the State Board  
10 of Education within sixty (60) days. If a school does not take  
11 action to comply with the accreditation standards within ninety (90)  
12 days after a report is filed by the Department, the Board shall  
13 withdraw accreditation for the school.

14 F. State Board accreditation regulations shall provide for  
15 warnings and for assistance to schools and school districts whenever  
16 there is reason to believe a school is in danger of losing its state  
17 accreditation.

18 G. The State Board shall provide assistance to districts in  
19 considering the possibility of meeting accreditation requirements  
20 through the use of nontraditional means of instruction. The State  
21 Board shall also assist districts in forming cooperatives and making  
22 arrangements for the use of satellite instruction or other  
23 instructional technologies to the extent that use of such  
24 instructional means meets accreditation standards.

1 H. 1. Accreditation shall not be withdrawn from or denied nor  
2 shall a penalty be assessed against a school or school district for  
3 failing to meet the media materials and equipment standards and  
4 media program expenditure standards as set forth in the  
5 accreditation standards adopted by the Board.

6 2. The provisions of paragraph 1 of this subsection shall cease  
7 to be effective ~~during a fiscal year immediately following a fiscal~~  
8 ~~year that the state financial support of public schools provides an~~  
9 ~~amount~~ once state per-pupil expenditures are equal to or more than  
10 ~~Three Thousand Two Hundred Ninety-one Dollars and sixty cents~~  
11 ~~(\$3,291.60) per weighted average daily membership as calculated~~  
12 ~~pursuant to Section 18-200.1 of this title and reported to school~~  
13 ~~districts by the State Department of Education on the initial~~

10 I. 1. The State Board shall not assess a financial penalty  
11 against any school district which is given a deficiency in  
12 accreditation status during any fiscal year as provided for in this  
13 subsection.

14 2. The provisions of paragraph 1 of this subsection shall cease  
15 to be effective ~~during a fiscal year immediately following a fiscal~~  
16 ~~year that the state financial support of public schools provides an~~  
17 ~~amount~~ once state per-pupil expenditures are equal to or more than

18 J. Accreditation shall not be withdrawn from or denied, nor  
19 shall a penalty be assessed against, a school district for complying  
20 with this section.

21 SECTION 2. AMENDATORY 70 O.S. 2011, Section 3-167, as  
22 last amended by Section 2, Chapter 253, O.S.L. 2016 (70 O.S. Supp.  
23 2018, Section 3-167), is amended to read as follows:  
24



1 Section 3-167. A. 1. The State Board of Education shall  
2 exempt all school districts from or waive any policy, rule or law  
3 which requires school districts to form, convene, or participate in  
4 any advisory council or committee, including but not limited to the  
5 requirement to convene an advisory council when preparing the school  
6 improvement plan as set forth in Section 5-117.4 of this title.

7 2. The provisions of paragraph 1 of this subsection shall cease  
8 to be effective ~~during a fiscal year immediately following a fiscal~~  
9 ~~year that the state financial support of public schools provides an~~  
10 ~~amount~~ once state per-pupil expenditures are equal to or more than  
11 ~~Three Thousand Two Hundred Ninety-one Dollars and sixty cents~~  
12 ~~(\$3,291.60) per weighted average daily membership as calculated~~  
13 ~~pursuant to Section 18-200.1 of this title and reported to school~~  
14 ~~districts by the State Department of Education on the initial~~  
15 ~~tentative State Aid allocation notice~~ the regional average per-pupil  
16 expenditure as defined by Section 1-124 of this title in public  
17 elementary and secondary schools for the most current year for which

11 B. School districts shall not be exempted from forming,  
12 convening or participating in an advisory council or committee if  
13 required by federal law or regulation.

14 SECTION 3. AMENDATORY 70 O.S. 2011, Section 16-111, as  
15 last amended by Section 3, Chapter 253, O.S.L. 2016 (70 O.S. Supp.  
16 2018, Section 16-111), is amended to read as follows:

17 Section 16-111. A. Except as otherwise provided for in  
18 subsection E of this section, the superintendent of schools of each  
19 school district in the state shall appoint a local textbook  
20 committee consisting of not fewer than three nor more than nine  
21 members. Each committee shall have one lay member, with the  
22 remainder of the members being teachers employed in the public  
23 schools of the district, a majority of whom shall be classroom  
24 teachers. The superintendent of schools or a designee who shall be

1 a principal or a curriculum specialist shall serve as chairperson of  
2 the local textbook committee.

3 B. Upon the written request of any duly appointed local  
4 textbook coordinator, the publisher of a textbook selected by the  
5 State Textbook Committee shall furnish at least one examination copy  
6 of the textbook and the teacher edition of the textbook, if one is  
7 published, and a copy of software for purposes of complete  
8 demonstration and review, if available, to the school district so  
9 that the local textbook committee may examine any or all new  
10 adoptions in the subjects taught or to be taught in schools in the  
11 district.

12 C. Except as otherwise provided for in subsection E of this  
13 section, on or before a date to be fixed by the State Board of  
14 Education, each local textbook committee shall adopt textbooks from  
15 the multiple list selected by the State Textbook Committee in a  
16 manner as shall be prescribed by the State Board of Education. Each  
17 local textbook committee shall serve without compensation and shall  
18 cease to exist when local adoptions have been completed and shall be  
19 replaced by another local textbook committee appointed in the same  
20 manner as provided for in this section.

21 D. Except as otherwise provided for in subsection E of this  
22 section, on or before a date to be fixed by the State Board of  
23 Education, the superintendent of each school district shall submit  
24 to the State Board of Education a textbook plan outlining the

1 estimated number of textbooks needed by the school district and the  
2 total amount of money to be expended by the district for textbooks  
3 including the allocated funds and any additional supplemental funds  
4 to be expended. The superintendent or textbook coordinator  
5 appointed by the superintendent, shall place orders from the proper  
6 depository or depositories for all of the textbooks needed as  
7 outlined in the textbook plan by the district for the ensuing year.  
8 The superintendent of a school district or textbook coordinator may  
9 order any textbooks placed on the official multiple textbook list.  
10 If the order exceeds the allocation for each school district as  
11 provided in Section 16-114a of this title any additional funds  
12 expended shall be reported on the statement of expenditures for the  
13 district.

14 E. 1. If a school district makes the election as provided for  
15 in subsection B of Section 16-114a of this title, the district shall  
16 not be required to appoint a local textbook committee, adopt  
17 textbooks, submit a textbook plan, or expend money on the purchase  
18 of textbooks during any fiscal year as provided for in this  
19 subsection.

20 2. The provisions of paragraph 1 of this subsection shall cease  
21 to be effective ~~during a fiscal year immediately following a fiscal~~  
22 ~~year that the state financial support of public schools provides an~~  
23 ~~amount~~ once state per-pupil expenditures are equal to or more than

24 SECTION 4. This act shall become effective July 1, 2019.

1       SECTION 5. It being immediately necessary for the preservation  
2 of the public peace, health or safety, an emergency is hereby  
3 declared to exist, by reason whereof this act shall take effect and  
4 be in full force from and after its passage and approval.
