21	school that serves any pupils in seventh grade to twelfth grade and

- B. It is the intent of the Legislature that, beginning July 1,

 2021, a public or private institution of higher education that

 issues student identification cards may have printed on either side

 of the student identification cards the telephone number described

 in paragraph 1 of this subsection and may have printed on either

 side of the student identification cards the telephone numbers

 described in paragraphs 2 and 3 of this subsection:
- 14 1. The telephone number for the National Suicide Prevention

- 2. The Crisis Text Line, which can be accessed by texting HOME to 741741; and
- 3. The campus police or security telephone number or, if the campus does not have a campus police or security telephone number, the local nonemergency telephone number.
- C. As of January 1, 2021, if a school subject to the requirements of subsection A of this section, or a public or private institution of higher education subject to the requirements of subsection B of this section, has a supply of unissued pupil or
