12	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:		
13	SECTION 1. AMENDATORY Section 44, Chapter 229, O.S.L.		
14	2013, as last amended by Section 1, Chapter 11, O.S.L. 2015 (63 O.S.		
15	Supp. 2019, Section 1-103a.1), is amended to read as follows:		
16	Section 1-103a.1. A. To assist and advise the State Board of		
17	Health State Commissioner of Health and the State Department of		
18	Health, there are hereby created:		
19	1. The Consumer Protection Licensing Advisory Council;		
20	2. The Trauma and Emergency Response Advisory Council;		
21	3. The Infant and Children's Health Advisory Council;		
22	4. The Advancement of Wellness Advisory Council; and		
23	5. The Home Care, Hospice and Palliative Care Advisory Council.

- B. 1. Except for the Home Care, Hospice and Palliative Care
 Advisory Council, each Public Health Advisory Council (Advisory
 Council) created pursuant to subsection A of this section shall
 consist of seven (7) members. Two members shall be appointed by the
 Governor, two members shall be appointed by the Speaker of the House
 of Representatives, two members shall be appointed by the President
 Pro Tempore of the Senate, and one member shall be appointed by the
 State Board of Health Commissioner. Appointments shall be for
 three-year terms. Members of the Advisory Councils shall serve at
 the pleasure of and may be removed from office by the appointing
 authority. Members shall continue to serve until their successors
 are appointed. Any vacancy shall be filled in the same manner as
 the original appointments. Four members shall constitute a quorum.
- 2. The Home Care, Hospice and Palliative Care Advisory Council shall consist of nine (9) members. Two members shall be appointed by the Governor, three members shall be appointed by the Speaker of the House of Representatives, three members shall be appointed by the President Pro Tempore of the Senate and one member shall be appointed by the State Board of Health Commissioner. Five members shall constitute a quorum.
- 3. Each Advisory Council shall meet at least twice a year, but no more than four times a year and shall elect a chair, a vice-chair and a secretary from among its members. Each Advisory Council shall only meet as required for election of officers, establishment of

1	meeting dates and times; rule development, review and
2	recommendation; and adoption of nonbinding resolutions to the State
3	Department of Health Department or the State Board of Health
4	<u>Commissioner</u> concerning matters brought before the Advisory Council.
5	Special meetings may be called by the chair or by the concurrence of
6	any three members.
7	C. 1. All members of the Consumer Protection Licensing
8	Advisory Council shall be knowledgeable of certain consumer issues
9	as specified below. The Consumer Protection Licensing Advisory
10	Council shall be composed as follows:
11	a. the Governor shall appoint:
12	(1) one member who is a licensed radiologist
13	assistant, and
14	(2) one member who is a licensed audiologist,
15	b. the President Pro Tempore of the Senate shall appoint:
16	(1) one member who is a licensed radiologist, and
17	(2) one member representing the hearing-aid-fitting
18	industry,
19	c. the Speaker of the House of Representatives shall
20	appoint:
21	(1) one member representing the medical
22	micropigmentation industry, and
23	(2) one member representing the hearing-impaired

public, and

- d. the State Board of Health Commissioner shall appoint one member representing a diagnostic x-ray facility.
 - 2. The jurisdiction areas of the Consumer Protection Licensing Advisory Council shall include the hearing-aid-fitting industry, the medical micropigmentation industry, the radiation industry and such other areas as designated by the State Board of Health Commissioner.
 - D. 1. All members of the Trauma and Emergency Response

 Advisory Council shall be knowledgeable of issues that arise in a

 hospital setting and issues that arise concerning emergency

 response. The Trauma and Emergency Response Advisory Council shall
 be composed as follows:
 - a. the Governor shall appoint:
 - (1) one member who is an administrative director of a licensed ambulance service, and
 - (2) one member who is a Board Certified Emergency

 Physician,
 - b. the President Pro Tempore of the Senate shall appoint:
 - (1) one member who is a representative from a hospital with trauma and emergency services, and
 - (2) one member who is a trauma surgeon with privileges at a hospital with trauma and emergency operative services,
 - c. the Speaker of the House of Representatives shall appoint:

1 (1)one member representing the trauma registrar of a licensed hospital that is classified as providing 2 3 trauma and emergency operative services, and (2) one member who is an Emergency Medical 4 5 Technician, and the State Board of Health Commissioner shall appoint 6 d. one member who is a critical care nurse. 7 The jurisdictional areas of the Trauma and Emergency 8 9 Response Advisory Council shall include emergency response systems 10 development, injury prevention, catastrophic health emergency, 11 trauma systems improvement and development and such other areas 12 designated by the State Board of Health Commissioner. 13 Ε. All members of the Infant and Children's Health Advisory Council shall be knowledgeable of issues that arise in the area of 14 infant and children's health care. The Infant and Children's Health 15 Advisory Council shall be composed as follows: 16 17 the Governor shall appoint: a. one member who works for the state or for a 18 political subdivision on child abuse issues, and 19 one member who is knowledgeable about childhood 20 (2) immunizations, 21 b. the President Pro Tempore of the Senate shall appoint: 22 one member who is knowledgeable about newborn 23 (1)

screening issues,

- 1 (2) one member licensed by the state as an
 2 optometrist who has knowledge of vision screening
 3 for children, and
 - (3) one member who is a licensed ophthalmologist in this state with the knowledge of treating visual deficiencies in children,
 - c. the Speaker of the House of Representatives shall appoint:
 - (1) one member who is licensed by the state as a physician and works as a pediatrician, and
 - (2) one member who is licensed by the state as a genetic counselor, and
 - d. the State Board of Health Commissioner shall appoint one member who is a physician licensed by the state who specializes in the diagnosis and treatment of childhood injuries in a trauma setting.
 - 2. The jurisdictional areas of the Infant and Children's Health Advisory Council shall include all issues that arise in the area of health care for infants and children and such other areas as designated by the State Board of Health Commissioner.
 - F. 1. All members of the Advancement of Wellness Advisory

 Council shall be knowledgeable of issues that arise in the area of

 advancing the health of all Oklahomans. The Advancement of Wellness

 Advisory Council shall be composed as follows:

1	a.	the Governor shall appoint:
2		(1) one member who is knowledgeable about breast and
3		cervical cancer issues, and
4		(2) one member who is knowledgeable about organ donor
5		issues,
6	b.	the President Pro Tempore of the Senate shall appoint:
7		(1) one member who is mayor of a city or town that
8		has been designated a certified healthy community
9		in an urban setting, and
10		(2) one member who is the president or chief
11		operating officer of a business that has been
12		designated a certified healthy business,
13	С.	the Speaker of the House of Representatives shall
14		appoint:
15		(1) one member who is the mayor of a city or town
16		that has been designated a certified healthy
17		community in a rural setting, and
18		(2) one member who is the president or chief
19		operating officer of a business that has been

22	d.	the State Board of Health Commissioner shall appoint
23		one member who is the Executive Director of the
24		Tobacco Settlement Endowment Trust.

- 1 2. The jurisdictional areas of the Advancement of Wellness Advisory Council shall include all issues that arise in the areas of tobacco usage and cessation, organ and tissue donation, the requirements for a city or town in the state to be designated as a certified healthy community, the requirements for a business to be designated as a certified healthy business and such other areas as designated by the State Board of Health Commissioner.
 - G. 1. All members of the Home Care, Hospice and Palliative Care Advisory Council shall be knowledgeable of issues that arise in the administration and practice of home care, hospice and palliative care services. The Home Care, Hospice and Palliative Care Advisory Council shall be composed as follows:
 - the Governor shall appoint: a.
 - one member who is the owner or administrator of (1)an entity licensed in accordance with the Oklahoma Hospice Licensing Act, and
 - (2) one member who is an owner or administrator of an entity licensed in accordance with the Oklahoma Home Care Act,
 - b. the President Pro Tempore of the Senate shall appoint:
 - (1)one member who is an owner or administrator of an entity licensed in accordance with the Oklahoma Hospice Licensing Act,

including, but not limited to:

- a. identifying methods that improve the quality and delivery of home care, hospice and palliative care,
 - b. reviewing best practices from home care, hospice and palliative care programs in the state,
 - c. developing information on home care, hospice and palliative care issues for the general public, and
 - d. such other areas as designated by the $\frac{\text{State Board of}}{\text{Health}}$ Commissioner.
- H. In addition to other powers and duties assigned to each Advisory Council pursuant to this section, each Advisory Council, within its jurisdictional area, shall:
- 1. Have authority to recommend to the State Board of Health

 Commissioner rules on behalf of the State Department of Health

 Department. The State Department of Health Department shall not have standing to recommend to the State Board of Health Commissioner permanent rules or changes to such rules within the jurisdiction of an Advisory Council which have not been submitted previously to the appropriate Advisory Council for action;
- 2. Before recommending any permanent rules to the State Board of Health Commissioner, give public notice, offer an opportunity for public comment and conduct a public rulemaking hearing when required by the Administrative Procedures Act;
- 3. Have the authority to make nonbinding written recommendations to the $\frac{\text{State Board of Health and/or}}{\text{Commissioner or}}$

- to the State Department of Health Department which have been concurred upon by at least a majority of the membership of the Advisory Council;
 - 4. Have the authority to provide a public forum for the discussion of issues it considers relevant to its area of jurisdiction, and to:
 - a. pass nonbinding resolutions expressing the sense of the Advisory Council, and
 - b. make recommendations to the State Board of Health

 Commissioner or the State Department of Health

 Department concerning the need and the desirability of conducting meetings, workshops and seminars; and
 - 5. Cooperate with each other Advisory Council, the public, the State Board of Health Commissioner and the Commissioner of Health in order to coordinate the rules within their respective jurisdictional areas and to achieve maximum efficiency and effectiveness in furthering the objectives of the State Department of Health Department.
 - I. The Advisory Councils shall not recommend rules for promulgation by the State Board of Health Commissioner unless all applicable requirements of the Administrative Procedures Act have been followed, including but not limited to notice, rule-impact statement and rulemaking hearings.

1	J. Members of the Advisory Councils shall serve without
2	compensation. The Advisory Councils are authorized to utilize the
3	conference rooms of the State Department of Health <u>Department</u> and
4	obtain administrative assistance from the State Department of Health
5	Department, as required.
6	SECTION 2. This act shall become effective November 1, 2020.
