7 average daily membership - withholding of State Aid -
8 calculation of State Aid - effective date]

10 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

11 SECTION 1. AMENDATORY 70 O.S. 2011, Section 5-155, is
12 amended to read as follows:

13 Section 5-155. A. The school district budget shall represent a
14 complete plan for the school district and shall present information
15 necessary and proper to disclose the financial position and
16 condition of the school district and the revenues and expenditures
17 thereof, both past and anticipated.

18 B. A school district budget shall contain a budget summary. It
19 shall also be accompanied by a budget message which shall explain
20 the budget and describe its important features. It shall contain at
21 least the following in tabular form for each fund:

22 1. Actual revenues and expenditures for the immediate prior
23 fiscal year;
24

1 2. Revenues and expenditures for the current fiscal year as
2 shown by the budget for the current year as adopted or amended; and

3 3. Estimates of revenues and expenditures for the budget year.

4 C. The school district governing body shall hold a public
5 hearing on the proposed budget within forty-five (45) days preceding
6 the beginning of the budget year. Notice of the date, time and
7 place of the hearing, together with the proposed budget summary,
8 shall be published in a newspaper of general circulation in the
9 school district not less than five (5) days before the date of the
10 hearing. The clerk of the board shall make available a sufficient
11 number of copies of the proposed budget as the governing body shall
12 determine and shall have them available for review or for
13 distribution at the office of the chief financial officer. At the
14 public hearing on the budget any person may present to the governing
15 body comments, recommendations or information on any part of the
16 proposed budget.

17 D. The adopted budget shall be in effect no later than the
18 first day of the fiscal year to which it applies. The budget as
19 adopted and filed with the State Auditor and Inspector shall
20 constitute an appropriation for each fund, and the appropriation
21 thus made shall not be used for any other purpose except as provided
22 by law.

23 E. Each school district shall amend the original budget after
24 June 30 of each year after the June financial activity has been

1 recorded, the annual Foundation ~~and Salary Incentive Aid~~ allocation
2 has been released, and the property tax valuations have been
3 certified for all affected counties within the school district. The
4 amended budget shall include all of the following information which
5 is applicable:

6 1. Valuation of the school district by county and
7 classification, excluding homestead exemptions;

8 2. Bonded debt and judgments outstanding, including interest
9 rates by maturity;

10 3. Matured debt and judgments;

11 4. Sinking fund balance, including cash and investments;

12 5. Sinking fund levy calculations, including surplus/deficit,
13 principal accrual, annual interest, judgment installment and
14 interest, total net levy and delinquency;

15 6. Levies in millage for general fund, building fund and
16 sinking fund;

17 7. Millage adjustment factor, if applicable;

18 8. Previous year sinking fund collections, including total
19 proceeds as certified, additions or deductions, reserve for
20 delinquent tax, reserve for protest pending, tax apportioned, net
21 balance in process of collection, and excess collections; and

22 9. Surplus analysis, including itemized sources of excess and
23 deductions.
24

1 F. At the time required by law, the county excise board shall
2 levy the taxes necessary for the school district general fund,
3 building fund and sinking fund for the budget year pursuant to
4 Sections 397 and 399 of Title 62 of the Oklahoma Statutes, and for
5 the school district general and building funds for the budget year
6 pursuant to Section 9 of Article X of the Oklahoma Constitution.

7 SECTION 2. AMENDATORY 70 O.S. 2011, Section 18-109.5, as
8 amended by Section 1, Chapter 228, O.S.L. 2018 (70 O.S. Supp. 2018,
9 Section 18-109.5), is amended to read as follows:

10 Section 18-109.5. A. As used in Section 18-201.1 of this
11 title:

12 1. "Visual impairment" means an impairment in vision that, even
13 with correction, adversely affects a child's educational
14 performance. This includes both partial sight and blindness;

15 2. "Specific learning disability" means a disorder in one or
16 more of the basic psychological processes involved in understanding
17 or in using language, spoken or written, that may manifest itself in
18 the imperfect ability to listen, think, speak, read, write, spell or
19 to do mathematical calculations, including conditions such as
20 perceptual disabilities, brain injury, minimal brain dysfunction,
21 dyslexia and developmental aphasia. The term does not include
22 learning problems that are primarily the result of visual, hearing
23 or motor disabilities, of intellectual disability, of emotional
24 disturbance or of environmental, cultural or economic disadvantage;

1 3. "Deafness" means a hearing impairment that is so severe that
2 the child is impaired in processing linguistic information through
3 hearing, with or without amplification, that adversely affects a
4 child's educational performance;

5 4. "Economically disadvantaged" means all children who qualify
6 for free or reduced lunches;

7 5. "Intellectual disability" means significantly subaverage
8 general intellectual functioning, existing concurrently with
9 deficits in adaptive behavior and manifested during the development
10 period, that adversely affects a child's educational performance;

11 6. "Emotional disturbance" means a condition exhibiting one or
12 more of the following characteristics over a long period of time and
13 to a marked degree that adversely affects a child's educational
14 performance:

15 a. an inability to learn which cannot be explained by
16 intellectual, sensory or health factors,

17 b. an inability to build or maintain satisfactory
18 interpersonal relationships with peers and teachers,

19 c. inappropriate types of behavior or feelings under
20 normal circumstances,

21 d. a general pervasive mood of unhappiness or depression,
22 or

23 e. a tendency to develop physical symptoms or fears
24 associated with personal or school problems.

1 The term includes children who are schizophrenic. The term does
2 not include children who are socially maladjusted, unless it is
3 determined that they are seriously emotionally disturbed;

4 7. "Gifted" means identified students as outlined in Section
5 1210.301 of this title;

6 8. "Hearing impairment" means an impairment in hearing, whether
7 permanent or fluctuating, that adversely affects a child's
8 educational performance but that is not included under the
9 definition of "deafness";

10 9. "Multiple disabilities" means concomitant impairments, such
11 as intellectual disability-blindness or intellectual disability-
12 orthopedic impairment, the combination of which causes such severe
13 educational needs that they cannot be accommodated in special
14 education programs solely for one of the impairments. The term does
15 not include deaf-blindness;

16 10. "Orthopedic impairment" means a severe orthopedic
17 impairment that adversely affects a child's educational performance.
18 The term includes impairments caused by a congenital anomaly,
19 impairments caused by disease such as poliomyelitis and bone
20 tuberculosis, and impairments from other causes such as cerebral
21 palsy, amputations and fractures or burns that cause contractures;

22 11. "Other health impairment" means having limited strength,
23 vitality or alertness, including a heightened alertness to
24 environmental stimuli, that results in limited alertness with

1 respect to the educational environment that adversely affects a
2 child's educational performance and is due to chronic or acute
3 health problems such as asthma, attention deficit disorder or
4 attention deficit hyperactivity disorder, diabetes, epilepsy, a
5 heart condition, hemophilia, lead poisoning, leukemia, nephritis,
6 rheumatic fever, sickle cell anemia and Tourette syndrome;

7 12. "Speech or language impairment" means a communication
8 disorder, such as stuttering, impaired articulation, a language
9 impairment, or a voice impairment, that adversely affects a child's
10 educational performance;

11 13. "Deaf-blindness" means concomitant hearing and visual
12 impairments, the combination of which causes such severe
13 communication and other developmental and educational problems that
14 they cannot be accommodated in special education programs solely for
15 children with deafness or children with blindness;

16 14. "Autism" means a developmental disability significantly
17 affecting verbal and nonverbal communication and social interaction,
18 generally evident before age three (3), that adversely affects a
19 child's educational performance. Other characteristics often
20 associated with autism are engagement in repetitive activities and
21 stereotyped movements, resistance to environmental change or change
22 in daily routines, and unusual responses to sensory experiences.
23 Autism does not apply if a child's educational performance is
24

1 adversely affected primarily because the child has an emotional
2 disturbance, as defined in this subsection;

3 15. "Traumatic brain injury" means an acquired injury to the
4 brain caused by an external physical force, resulting in total or
5 partial functional disability or psychosocial impairment, or both,
6 that adversely affects a child's educational performance. Traumatic
7 brain injury applies to open or closed head injuries resulting in
8 impairments in one or more areas such as cognition; language;
9 memory; attention; reasoning; abstract thinking; judgment; problem-
10 solving; sensory, perceptual, and motor abilities; psychosocial
11 behavior; physical functions; information processing; and speech.
12 Traumatic brain injury does not apply to brain injuries that are
13 congenital or degenerative or to brain injuries induced by birth
14 trauma;

15 16. ~~"Bilingual" "English learner" means those students a~~
16 ~~student who have limited English speaking abilities or who come from~~
17 ~~homes where English is not the dominant language as reported on the~~
18 ~~current year application for accreditation:~~

19 a. (1) was not born in the United States or whose native
20 language is a language other than English,

21 (2) is a Native American or Alaska Native or a native
22 resident of the outlying areas and who comes from
23 an environment where a language other than
24 English has had a significant impact on the

individual's level of English language
proficiency, or

(3) is migratory, whose native language is a language
other than English and who comes from an
environment where a language other than English
is dominant, and

b. whose difficulties in speaking, reading, writing or
understanding the English language may be sufficient
to deny the individual the ability to meet the subject
matter standards adopted pursuant to Section 11-103.6
of this title, the ability to successfully achieve in
classrooms where the language of instruction is
English, or the opportunity to participate fully in
society;

17. "Special Education Summer Program" means those summer
school programs which school districts may provide for children who
are severely or profoundly multiple-handicapped if their
individualized education program states the need for a continuing
educational experience to prevent loss of educational achievement or
basic life skills. Any school district receiving funds for such
special education summer programs shall provide services as provided
in Section 13-101 of this title; and

18. "Optional Extended School Year Program" means the program
defined in Section 1-109.1 of this title.

1 B. The State Board of Education is hereby authorized to modify
2 and redefine by rule the definitions set out in this section
3 whenever such modification is required to receive federal assistance
4 therefor.

5 SECTION 3. AMENDATORY 70 O.S. 2011, Section 18-112.2, is
6 amended to read as follows:

7 Section 18-112.2. A. ~~For the 1987-88 school year and for each~~
8 ~~school year thereafter, each school district which, pursuant to the~~
9 ~~provisions of Section 18-112 of Title 70 of the Oklahoma Statutes,~~
10 ~~received funding for the 1986-87 school year in excess of the sum of~~
11 ~~Foundation Aid, Salary Incentive Aid, and Transportation Supplement~~
12 ~~otherwise authorized pursuant to Section 18-109.2 of Title 70 of the~~
13 ~~Oklahoma Statutes shall receive a Supplement in State Aid: For the~~
14 ~~1987-88 school year, said Supplement shall be equal to sixty-seven~~
15 ~~percent (67%) of the amount of said excess funding, less the amount~~
16 ~~by which the sum of Foundation Aid, Salary Incentive Aid, and~~
17 ~~Transportation Supplement exceeds said sum for the preceding school~~
18 ~~year; for the 1988-89 2020-2021 school year and thereafter, the~~
19 Supplement in State Aid shall be an amount equal to the previous
20 year's Supplement less the amount by which the sum of Foundation
21 Aid, ~~Salary Incentive Aid,~~ and Transportation Supplement for the
22 school year being considered exceeds said sum for the preceding
23 school year. No school district shall receive for any school year
24 subsequent to the 1987-88 school year a Supplement in State Aid

1 larger than said Supplement received for the year preceding the
2 subsequent year. Districts ~~must~~ shall levy thirty-five (35) General
3 Fund mills to receive this Supplement.

4 B. Eligibility of a district for a Supplement in State Aid
5 shall not cause the district to be exempt from penalties required by
6 the provisions of Section 18-113.1 of ~~Title 70 of the Oklahoma~~
7 ~~Statutes~~ this title. Calculation of the Supplement in State Aid
8 shall be based on use of unreduced average daily ~~attendance~~
9 membership for determination of the sum of Foundation Aid, ~~Salary~~
10 ~~Incentive Aid~~, and Transportation Supplement. The actual amount of
11 Foundation Aid, ~~Salary Incentive Aid~~, and Transportation Supplement
12 to be paid, however, shall be subject to the provisions of Section
13 18-113.1 of ~~Title 70 of the Oklahoma Statutes~~ this title.

14 SECTION 4. AMENDATORY 70 O.S. 2011, Section 18-124, is
15 amended to read as follows:

16 Section 18-124. A. Any school district with an average daily
17 attendance (ADA) of more than one thousand five hundred (1,500)
18 students for the preceding year which expends for administrative
19 services in the 2005-06 school year or any school year thereafter,
20 less expenditures for legal services, more than five percent (5%) of
21 the amount it expends for total expenditures, less expenditures for
22 legal services, shall have the amount which exceeds the five percent
23 (5%) withheld the following year from the Foundation ~~and Salary~~
24 ~~Incentive~~ Aid for the school district.

1 B. Any school district with an average daily attendance (ADA)
2 of more than five hundred (500) students but not more than one
3 thousand five hundred (1,500) students for the preceding year which
4 expends for administrative services in the 2005-06 school year or
5 any school year thereafter, less expenditures for legal services,
6 more than seven percent (7%) of the amount it expends for total
7 expenditures, less expenditures for legal services, shall have the
8 amount which exceeds the seven percent (7%) withheld the following
9 year from the Foundation ~~and Salary Incentive~~ Aid for the school
10 district.

11 C. Any school district with an average daily attendance (ADA)
12 of five hundred (500) or fewer students for the preceding year which
13 expends for administrative services in the 2005-06 school year or
14 any school year thereafter, less expenditures for legal services,
15 more than eight percent (8%) of the amount it expends for total
16 expenditures, less expenditures for legal services, shall have the
17 amount which exceeds the eight percent (8%) withheld the following
18 year from the Foundation ~~and Salary Incentive~~ Aid for the school
19 district.

20 D. For purposes of this section, "administrative services"
21 means costs associated with:

- 22 1. Staff for the board of education;
- 23 2. The secretary/clerk for the board of education;
- 24 3. Staff relations;

1 4. Negotiations staff;

2 5. Immediate staff of the superintendent, any elementary
3 superintendent or any assistant superintendent;

4 6. Any superintendent, elementary superintendent, or assistant
5 superintendent;

6 7. Any employee of a school district employed as a director,
7 coordinator, supervisor, or who has responsibility for
8 administrative functions of a school district; and

9 8. Any consultant hired by the school district.

10 E. If an employee of a school district is employed in a
11 position where part of the employee's time is spent as an
12 administrator and part of the time is spent in nonadministrative
13 functions, the percentage of time spent as an administrator shall be
14 included as administrative services. A superintendent who spends
15 part of the time performing exempted nonadministrative services such
16 as teaching in the classroom, serving as a principal, counselor, or
17 library media specialist, can code up to forty percent (40%) of
18 their salary to other nonadministrative functions. The total amount
19 of time a superintendent of a school district spends performing
20 services for a school district shall be included as administrative
21 services even if part of the time the superintendent is performing
22 nonexempted nonadministrative service functions. The total amount
23 received by a superintendent from the school district as salary, for
24 the performance of administrative and nonexempted nonadministrative

1 services, shall be recorded under the code for superintendent salary
2 as provided for in the Oklahoma Cost Accounting System.

3 F. Each school site within a school district shall take steps
4 to ensure that the administrative costs for the school comply with
5 the expenditure limits established for school districts in this
6 section.

7 G. Funds withheld pursuant to the provisions of this section
8 shall be distributed through the State Aid formula to the districts
9 not so penalized.

10 H. For the 2003-04 and 2004-05 school year, school districts
11 shall report to the State Department of Education the costs
12 associated with administrative services for the school district as
13 defined in subsection D of this section.

14 SECTION 5. AMENDATORY 70 O.S. 2011, Section 18-200.1, is
15 amended to read as follows:

16 Section 18-200.1. A. Beginning with the ~~1997-98~~ 2020-2021
17 school year, and each school year thereafter, each school district
18 shall have its initial allocation of State Aid calculated based on
19 the state dedicated revenues actually collected during the preceding
20 fiscal year, the adjusted assessed valuation of the preceding year
21 and the highest weighted average daily membership for the school
22 district of the two (2) preceding school years; ~~however, the~~
23 ~~weighted membership of nonresident, transferred pupils enrolled in~~
24 ~~online courses shall be based on the weighted average daily~~

1 ~~membership of the preceding school year.~~ Each school district shall
2 submit the following data based on the first nine (9) weeks, to be
3 used in the calculation of the average daily membership of the
4 school district:

- 5 1. Student enrollment by grade level;
- 6 2. Pupil category counts; and
- 7 3. Transportation supplement data.

8 On or before December 30, the State Department of Education
9 shall determine each school district's current year allocation
10 pursuant to subsection D of this section. The State Department of
11 Education shall complete an audit, using procedures established by
12 the Department, of the student enrollment by grade level data, pupil
13 category counts and transportation supplement data to be used in the
14 State Aid Formula pursuant to subsection D of this section by
15 December 1 and by January 15 shall notify each school district of
16 the district's final State Aid allocation for the current school
17 year. The January payment of State Aid and each subsequent payment
18 for the remainder of the school year shall be based on the final
19 State Aid allocation as calculated in subsection D of this section.
20 Except for reductions made due to the assessment of penalties by the
21 State Department of Education according to law, the January payment
22 of State Aid and each subsequent payment for the remainder of the
23 school year shall not decrease by an amount more than the amount
24 that the current chargeable revenue increases for that district.

1 B. The State Department of Education shall retain not less than
2 one and one-half percent (1 1/2%) of the total funds appropriated
3 for financial support of schools, to be used to make midyear
4 adjustments in State Aid and which shall be reflected in the final
5 allocations. If the amount of appropriated funds, including the one
6 and one-half percent (1 1/2%) retained, remaining after January 1 of
7 each year is not sufficient to fully fund the final allocations, the
8 Department shall recalculate each school district's remaining
9 allocation pursuant to subsection D of this section using the
10 reduced amount of appropriated funds.

11 C. On and after ~~July 1, 1997~~ July 1, 2020, the amount of State
12 Aid each district shall receive shall be the sum of the Foundation
13 Aid, ~~the Salary Incentive Aid~~ and the Transportation Supplement, as
14 adjusted pursuant to the provisions of subsection G of this section
15 and Section 18-112.2 of this title; provided, no district having per
16 pupil revenue in excess of three hundred percent (300%) of the
17 average per pupil revenue of all districts shall receive any State
18 Aid or Supplement in State Aid.

19 The July calculation of per pupil revenue shall be determined by
20 dividing the district's second preceding year's total weighted
21 average daily membership (ADM) into the district's second preceding
22 year's total revenues excluding federal revenue, insurance loss
23 payments, reimbursements, recovery of overpayments and refunds,

24

1 unused reserves, prior expenditures recovered, prior year surpluses,
2 and less the amount of any transfer fees paid in that year.

3 The December calculation of per pupil revenue shall be
4 determined by dividing the district's preceding year's total
5 weighted average daily membership (ADM) into the district's
6 preceding year's total revenues excluding federal revenue, insurance
7 loss payments, reimbursements, recovery of overpayments and refunds,
8 unused reserves, prior expenditures recovered, prior year surpluses,
9 and less the amount of any transfer fees paid in that year.

10 D. For the ~~1997-98~~ 2020-2021 school year, and each school year
11 thereafter, Foundation Aid, and the Transportation Supplement ~~and~~
12 ~~Salary Incentive Aid~~ shall be calculated as follows:

13 1. Foundation Aid shall be determined by subtracting the amount
14 of the Foundation Program Income from the cost of the Foundation
15 Program and adding to this difference the Transportation Supplement.

16 a. The Foundation Program shall be a district's highest
17 weighted average daily membership based on the first
18 nine (9) weeks of the current school year, the
19 preceding school year or the second preceding school
20 year of a school district, as determined by the
21 provisions of subsection A of Section 18-201.1 of this
22 title and paragraphs 1, 2, 3 and 4 of subsection B of
23 Section 18-201.1 of this title, multiplied by the Base
24 Foundation Support Level. ~~However, for the portion of~~

~~weighted membership derived from nonresident,
transferred pupils enrolled in online courses, the
Foundation Program shall be a district's weighted
average daily membership of the preceding school year
or the first nine (9) weeks of the current school
year, whichever is greater, as determined by the
provisions of subsection A of Section 18-201.1 of this
title and paragraphs 1, 2, 3 and 4 of subsection B of
Section 18-201.1 of this title, multiplied by the Base
Foundation Support Level.~~

b. The Foundation Program Income shall be the sum of the
following:

(1) The adjusted assessed valuation of the current
school year of the school district, minus the
previous year protested ad valorem tax revenues
held as prescribed in Section 2884 of Title 68 of
the Oklahoma Statutes, multiplied by the general
fund mills levied pursuant to subsection (c) of
Section 9 of Article X of the Oklahoma
Constitution, if applicable, as adjusted in
subsection (c) of Section 8A of Article X of the
Oklahoma Constitution. For purposes of this
subsection, the "adjusted assessed valuation of
the current school year" shall be the adjusted

1 assessed valuation on which tax revenues are
2 collected during the current school year, and
3 (2) Seventy-five percent (75%) of the amount received
4 by the school district from the proceeds of the
5 county levy during the preceding fiscal year, as
6 levied pursuant to subsection (b) of Section 9 of
7 Article X of the Oklahoma Constitution, and
8 (3) Motor Vehicle Collections, and
9 (4) Gross Production Tax, and
10 (5) State Apportionment, and
11 (6) R.E.A. Tax.

12 The items listed in divisions (3), (4), (5), and (6)
13 of this subparagraph shall consist of the amounts
14 actually collected from such sources during the
15 preceding fiscal year calculated on a per capita basis
16 on the unit provided for by law for the distribution
17 of each such revenue-; and

18 2. The Transportation Supplement shall be equal to the average
19 daily haul times the per capita allowance times the appropriate
20 transportation factor.

21 a. The average daily haul shall be the number of children
22 in a district who are legally transported and who live
23 one and one-half (1 1/2) miles or more from school.

b. The per capita allowance shall be determined using the following chart:

22 weighted pupil category calculation provided in subparagraph m of
