13	SECTION 1. AMENDATORY 74 O.S. 2011, Section 840-5.5, as
14	last amended by Section 2, Chapter 222, O.S.L. 2018 (74 O.S. Supp.
15	2018, Section 840-5.5), is amended to read as follows:
16	Section 840-5.5. A. The following offices, positions, and
17	personnel shall be in the unclassified service and shall not be
18	placed under the classified service:
19	1. Persons chosen by popular vote or appointment to fill an
20	elective office, and their employees, except the employees of the
21	Corporation Commission, the State Department of Education and the
22	Department of Labor;
23	
24	

- 2. Members of boards and commissions, and heads of agencies; also one principal assistant or deputy and one executive secretary for each state agency;
 - 3. All judges, elected or appointed, and their employees;
- 4. Persons employed with one-time, limited duration, federal or other grant funding that is not continuing or indefinitely renewable. The length of the unclassified employment shall not exceed the period of time for which that specific federal funding is provided;
- 5. All officers and employees of The Oklahoma State System of Higher Education, State Board of Education and Oklahoma Department of Career and Technology Education;
- 6. Persons employed in a professional or scientific capacity to make or conduct a temporary and special inquiry, investigation, or examination on behalf of the Legislature or a committee thereof or by authority of the Governor. These appointments and authorizations shall terminate on the first day of the regular legislative session immediately following the appointment, if not terminated earlier. However, nothing in this paragraph shall prevent the reauthorization and reappointment of any such person. Any such appointment shall be funded from the budget of the appointing authority;
 - 7. Election officials and employees;
- 8. Temporary employees employed to work less than one thousand (1,000) hours in any twelve-month period, and seasonal employees

Effective July 1, 1996, authorization for unclassified offices, positions, or personnel contained in a bill or joint resolution shall terminate June 30 of the ensuing fiscal year after the authorization unless the authorization is codified in the Oklahoma Statutes or the termination is otherwise provided in the legislation.
- D. The appointing authority of agencies participating in the statewide information systems project may establish unclassified positions and appoint unclassified employees to the project as needed. Additional unclassified positions may be established, if required, to appoint an unclassified employee to perform the duties of a permanent classified employee who is temporarily absent from a classified position as a result of assignment to this project. All unclassified appointments under this authority shall expire no later than December 31, 2007, and all unclassified positions established

1 to support the project shall be abolished. Both the positions and 2 appointments resulting from this authority shall be exempt from any 3 agency FTE limitations and any limits imposed on the number of unclassified positions authorized. Permanent classified employees 4 may request a leave of absence from classified status and accept an 5 unclassified appointment and compensation with the same agency under 6 the provisions of this subsection; provided, the leave shall expire 7 no later than December 31, 2007. Employees accepting the 9 appointment and compensation shall be entitled to participate 10 without interruption in any benefit programs available to classified 11 employees, including retirement and insurance programs. Immediately 12 upon termination of an unclassified appointment pursuant to this 13 subsection, an employee on assignment from the classified service shall have a right to be restored to the classified service and 14 15 reinstated to the former job family level and compensation plus any adjustments and increases in salary or benefits which the employee 16 17 would have received but for the leave of absence.

SECTION 2. This act shall become effective November 1, 2019.
