  - 3. One member who represents a comprehensive university, appointed by the Speaker of the House of Representatives;
    - 4. The Chancellor of Higher Education or a designee; and
    - 5. The Secretary of Education or a designee.
  - The chair of the task force shall be the Secretary of Education or his or her designee.
- C. Appointments to the task force shall be made within thirty
  (30) days after the effective date of this act. The task force
  shall conduct an organizational meeting not later than August 31,
  2019.
  - D. A quorum of the task force shall be required to approve any final action of the task force. For purposes of this section, three members shall constitute a quorum.
  - E. The task force may meet as often as may be required in order to perform the duties imposed upon it.
  - F. The meetings of the task force shall be subject to the Oklahoma Open Meeting Act.
- G. Members of the task force shall receive no compensation or travel reimbursement.
