To manufacture, bottle, package and store beer or cider

3 2. To sell beer <u>or cider</u> in this state to holders of beer
4 distributor licenses and retail licenses or to sell beer <u>or cider</u>

3. To serve free samples of beer <u>or cider</u> produced by the
7 licensee to visitors twenty-one (21) years of age or older;

8 4. To sell beer <u>or cider</u> produced by the licensee for either
9 on-premises or off-premises consumption to consumers on the brewery
10 premises, or on premises located contiguous thereto;

11 5. To sell beer <u>or cider</u> at public events such as trade shows 12 or festivals;

13 6. To purchase wine in retail containers from the holder of a14 wholesaler license or as specifically provided by law; and

15 7. To sell, offer for sale and possess wine for on-premises16 consumption.

C. Nothing in this act the Oklahoma Alcoholic Beverage Control
<u>Act</u> shall prohibit the holder of a small brewer license from also
holding or owning an interest in the holder of a brewpub license.
D. For purposes of this section, no visitor may sample more
than a total of twelve (12) fluid ounces of beer or cider per day.

The brewer must restrict the distribution and consumption of beer samples or cider to an the serving area within the licensed premises designated by the brewer as defined in this subsection. A current

1 floor plan that includes the designated sampling serving area must be on file with the ABLE Commission. No visitor under twenty-one 2 3 (21) years of age shall be permitted to enter this designated sampling serving area when samples are being distributed or 4 5 consumed. Accompanied visitors under twenty-one (21) years of age shall be allowed anywhere on the premises except for a serving area. 6 Samples of beer or cider served by a brewery under this section 7 shall not be considered a sale of beer or cider within the meaning 8 9 of Article XXVIIIA of the Oklahoma Constitution or Section 1-103 of 10 this title; however, such samples of beer or cider shall be 11 considered beer or cider removed or withdrawn from the brewery for 12 use or consumption within the meaning of Section 5-110 of this title for excise tax determination and reporting requirements. Sales and 13 sampling may only occur between the hours of 10:00 a.m. and 2:00 14 a.m. For purposes of this subsection, "serving area" means the area 15 16 of the bar where drinks are sold, prepared and served to paying customers and shall not include other areas of the brewery where 17 customers consume purchased products. 18

E. A small brewer self-distribution license shall authorize
holders of a small brewer license to distribute beer <u>or cider</u>
produced only by such licensee to a holder of a retail beer license,
retail spirits license, mixed beverage license, beer and wine
license, caterer's license, special event license, public event
license, winemaker license charitable auction license or brewpub
