To purchase spirits and wines from licensed distillers, 7 rectifiers and winemakers in this state; To purchase spirits and wines from licensed wholesalers, to 8 3. 9 the extent set forth in subsections B and C of this section; 10 To sell in retail containers in this state to retailers, 4. 11 mixed beverage, caterer, special event, public event, hotel beverage 12 or airline/railroad beverage licensees, spirits and wines which have 13 been received and unloaded at the bonded warehouse facilities of the 14 wholesaler before such sale; provided, it shall be unlawful for any 15 wholesaler to sell any alcoholic beverages if the alcoholic 16 beverages have not been purchased by the wholesaler from the primary 17 American source of supply; 18 5. 20 been received and unloaded at the bonded warehouse facilities of the
21 wholesaler before such sale; and

Provided, however, sales of spirits and wine in containers with a capacity of less than one-twentieth (1/20) gallon by a holder of a wholesaler license shall be in full case lots and in the original unbroken case. Wholesalers shall be authorized to place such signs outside their place of business as are required by Acts of Congress and by such laws and regulations promulgated under such Acts.

B. A wholesaler may sell spirits and wine to other wholesalers
or purchase spirits and wines from other wholesalers without
complying with subsection A of this section in the case of the sale,
purchase or other transfer or acquisition of <u>a particular brand of</u>
<u>wine or spirits or</u> the entire business of a wholesaler, including
the inventory of spirits and wine.

15 C. A wholesaler license shall authorize the holder thereof to: 16 1. Maintain not more than three (3) self-owned or leased and 17 self-operated bonded warehouses within this state. All invoices 18 shall be stored at the principal place of business for which the 19 wholesaler license was granted; and

1 SECTION 3. AMENDATORY Section 47, Chapter 366, O.S.L.
2 2016 (37A O.S. Supp. 2018, Section 2-135), is amended to read as
3 follows:

4 Section 2-135. A. All out-of-state distillers, winemakers, 5 brewers, importers, brokers and others who sell alcoholic beverages to wine and spirits wholesalers and beer distributors in Oklahoma, 6 7 regardless of whether such sales are consummated within or without the state, must either obtain a manufacturer's license or contract 8 9 with a person that maintains a nonresident seller license in order 10 to sell alcoholic beverages intended for consumption within the 11 State of Oklahoma.

A manufacturer's license or nonresident seller license shall authorize the holder thereof to solicit and take orders for alcoholic beverages from the holders of licenses authorized to import the same into this state, and to ship or deliver, or cause to be shipped or delivered, alcoholic beverages into Oklahoma pursuant to such sales.

B. A brewer not licensed in this state selling beer to a
nonresident seller shall have a written distribution sales agreement
with the nonresident seller. Such agreement shall be subject to
inspection by the ABLE Commission.

C. The ABLE Commission may, subject to the provisions of the Oklahoma Alcoholic Beverage Control Act requiring notice and hearing in the case of sanctions against holders of licenses, suspend or

1 revoke a manufacturer's license or nonresident seller license for 2 any violation of the Oklahoma Alcoholic Beverage Control Act by the 3 holder thereof.

No licensee in this state authorized to import alcoholic 4 D. 5 beverages into this state shall purchase or receive any alcoholic beverages from without this state from any person not holding a 6 7 valid and existing manufacturer's license or nonresident seller license. Every manufacturer's license or nonresident seller license 8 9 shall expire on the June 30 following its issuance or renewal, and 10 shall be eligible for subsequent renewal terms of one (1) year beginning on the July 1 following each expiration. License fees for 11 12 a new or initial manufacturer's license or nonresident seller 13 license applied for after July 1 may be prorated through the 14 following June 30 on a quarterly basis.

E. The holder of a manufacturer's license or nonresident seller license shall, promptly upon consignment of any alcoholic beverages to an importer in Oklahoma, forward to the ABLE Commission a true copy of the invoice, bill of lading or other document as the ABLE Commission may by rule prescribe, showing the details of such shipment.

F. Any person, not otherwise a dealer in alcoholic beverages, coming into possession of any alcoholic beverages as security for or in payment of a debt, or as an insurer or its transferee or assignee for the salvage or liquidation of an insured casualty or damage or

1 loss, or as an executor, administrator, trustee or other fiduciary, 2 may sell the beverages in one lot or parcel to a duly licensed 3 wholesaler or beer distributor at an agreed-upon price without 4 regard to current posted prices. However, immediately after taking 5 possession of the alcoholic beverages, the person shall register with the Director and furnish a detailed list of the alcoholic 6 7 beverages and post with the Director a bond in such amount as the 8 Director deems sufficient to protect the state from any taxes due on 9 the alcoholic beverages. The person shall pay to the Director a 10 registration fee of Fifty Dollars (\$50.00), which fee shall permit 11 the sale of only the alcoholic beverages detailed in the registration request. A wholesaler or beer distributor receiving a 12 13 lot or parcel of alcoholic beverages pursuant to this subsection may 14 sell it in one lot or parcel or more than one lot or parcel to a 15 licensed package store or mixed beverage licensee or more than one 16 licensed package store or mixed beverage licensee at an agreed-upon 17 price without regard to current posted prices; provided, the total 18 of the lots sold by the wholesaler or beer distributor shall not 19 exceed four (4) lots. 20 G. In the event a winery, distiller, importer or broker obtains

21 <u>a manufacturer's license, the manufacturer shall elect to be either</u> 22 <u>a designating manufacturer or nondesignating manufacturer. For</u> 23 <u>purposes of this title:</u>

1	1. "Designating manufacturer" shall be any manufacturer,
