7 An Act relating to State Department of Health
8 funding; amending Section 63, Chapter 146, O.S.L.
9 2018, which relates to the appropriation to the State
10 Department of Health for Fiscal Year 2019; reducing
11 amount of the appropriation; making appropriations to
the Special Cash Fund of the State Treasury;
identifying sources; stating amounts of the
appropriations; stating purposes; and declaring an
emergency.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. AMENDATORY Section 63, Chapter 146, O.S.L.
16 2018, is amended to read as follows:

17 Section 63. There is hereby appropriated to the State
18 Department of Health from any monies not otherwise appropriated from
19 the General Revenue Fund of the State Treasury for the fiscal year
20 ending June 30, 2019, the sum of ~~Fifty-four Million Eight Hundred~~
21 ~~Seventy-four Thousand Seven Hundred Dollars (\$54,874,700.00)~~ Fifty-
22 one Million One Hundred Seventy-four Thousand Seven Hundred Dollars
23 (\$51,174,700.00) or so much thereof as may be necessary to perform
24 the duties imposed upon the State Department of Health by law.

1 SECTION 2. An amount of Nine Million Three Hundred Fifty-seven
2 Thousand Two Hundred Fifty-five Dollars (\$9,357,255.00) from the
3 amount of Thirty Million Dollars (\$30,000,000.00) originally
4 appropriated to the State Department of Health from the General
5 Revenue Fund of the State Treasury for the fiscal year ending June
6 30, 2017, by Section 169, Chapter 2, 1st Extraordinary Session,
7 O.S.L. 2017, is hereby appropriated to the Special Cash Fund of the
8 State Treasury for availability of appropriation.

9 SECTION 3. An amount of Thirteen Million Nine Hundred Twenty-
10 one Thousand Six Hundred Forty-four Dollars (\$13,921,644.00) from
11 the amount of Fifty-two Million Seven Hundred Thirty-five Thousand
12 Eight Hundred Sixty-six Dollars (\$52,735,866.00) originally
13 appropriated to the State Department of Health from the General
14 Revenue Fund of the State Treasury for the fiscal year ending June
15 30, 2018, by Section 73, Chapter 3, 2nd Extraordinary Session,
16 O.S.L. 2018, is hereby appropriated to the Special Cash Fund of the
17 State Treasury for availability of appropriation.

18 SECTION 4. There is hereby appropriated to the Special Cash
19 Fund of the State Treasury from any monies not otherwise
20 appropriated from the Public Health Special Fund (210) of the State
21 Department of Health the sum of Three Million Twenty-one Thousand
22 One Hundred One Dollars (\$3,021,101.00) for availability of
23 appropriation.

SECTION 5. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
