7 An Act relating to schools; requiring certain schools  
8 to include certain information on pupil  
9 identification cards; stating intent of the  
10 Legislature to require institutions of higher  
11 education to include certain information on student  
12 identification cards; allowing schools and  
13 institutions of higher education to issue unused  
14 pupil and student identification cards; providing  
15 applicability; providing for codification; and  
16 providing an effective date.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. NEW LAW A new section of law to be codified  
19 in the Oklahoma Statutes as Section 1210.200A of Title 70, unless  
20 there is created a duplication in numbering, reads as follows:

21 A. Beginning July 1, 2021, a public school, including a charter  
22 school, that serves any pupils in seventh grade to twelfth grade and  
23 issues pupil identification cards, shall have printed on either side  
24 of the pupil identification cards the telephone number described in  
paragraph 1 of this subsection and may have printed on either side

1 of the pupil identification cards the telephone number described in  
2 paragraph 2 of this subsection:

3 1. The telephone number for the National Suicide Prevention  
4 Lifeline; and

5 2. The Crisis Text Line, which can be accessed by texting HOME  
6 to 741741.

7 B. It is the intent of the Legislature that, beginning July 1,  
8 2021, a public or private institution of higher education that  
9 issues student identification cards may have printed on either side  
10 of the student identification cards the telephone number described  
11 in paragraph 1 of this subsection and may have printed on either  
12 side of the student identification cards the telephone numbers  
13 described in paragraphs 2 and 3 of this subsection:

14 1. The telephone number for the National Suicide Prevention  
15 Lifeline;

16 2. The Crisis Text Line, which can be accessed by texting HOME  
17 to 741741; and

18 3. The campus police or security telephone number or, if the  
19 campus does not have a campus police or security telephone number,  
20 the local nonemergency telephone number.

21 C. As of January 1, 2021, if a school subject to the  
22 requirements of subsection A of this section, or a public or private  
23 institution of higher education subject to the requirements of  
24 subsection B of this section, has a supply of unissued pupil or

1 student identification cards that do not comply with the  
2 requirements of subsections A and B of this section, as applicable,  
3 the school or the public or private institution of higher education  
4 shall issue those pupil or student identification cards until that  
5 supply is depleted.

6 D. Subsections A and B of this section shall apply to a pupil  
7 or student identification card issued for the first time to a pupil  
8 or student, and to a pupil or student identification card issued to  
9 replace a damaged or lost pupil or student identification card.

10 SECTION 2. This act shall become effective November 1, 2020.
