7 An Act relating to schools; authorizing dropout
8 prevention and credit recovery education programs;
9 allowing programs to be offered jointly by school
10 districts and technology centers; listing program
11 requirements; requiring memorandums of understanding
12 regarding program funding; requiring the Oklahoma
13 Department of Career and Technology Education to make
14 monies available, subject to availability of funds;
15 requiring certain funding and expenditure reports;
16 establishing certification requirements for program
17 teachers; providing for codification; providing an
18 effective date; and declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. NEW LAW A new section of law to be codified
17 in the Oklahoma Statutes as Section 35e-1 of Title 70, unless there
18 is created a duplication in numbering, reads as follows:

19 A. Pursuant to the availability of funds, beginning with the
20 first semester of the 2020-2021 school year, the Oklahoma Department
21 of Career and Technology Education shall authorize a statewide
22 system of dropout prevention and credit recovery education programs.

23 B. Beginning with the first semester of the 2020-2021 school
24 year, dropout prevention and credit recovery education programs may

1 be offered jointly between an Oklahoma public school and an Oklahoma
2 technology center. A program shall:

3 1. Allow class sizes and student/teacher ratios which are
4 conducive to effective learning for at-risk students;

5 2. Incorporate appropriate structure, curriculum, and
6 interaction and reinforcement strategies designed to provide
7 effective instruction;

8 3. Include an intake and screening process to determine
9 eligibility of students;

10 4. Demonstrate that teaching faculty are appropriately
11 certified teachers;

12 5. Demonstrate that teaching faculty have been selected on the
13 basis of a record of successful work with at-risk students or
14 personal and educational factors that qualify them for work with at-
15 risk students;

16 6. Reflect appropriate collaborative efforts with state
17 agencies and local agencies serving youth in the program;

18 7. Provide courses that meet the academic curricula standards
19 adopted by the State Board of Education and additional remedial
20 courses;

21 8. Offer individualized instruction;

22 9. State clear and measurable program goals and objectives;

1 10. Include counseling and social services components with the
2 provision that providers of services are not required to be
3 certified as school counselors;

4 11. Require a plan leading to graduation be developed for each
5 student in the program which will allow the student to participate
6 in graduation exercises for the school district after meeting the
7 requirements of the school district as specified in the individual
8 graduation plan for that student. The plan shall specifically
9 address whether the student is required to meet the graduation
10 requirements established in Section 11-103.6 of Title 70 of the
11 Oklahoma Statutes;

12 12. Provide a proposed annual budget;

13 13. Include an evaluation component including an annual written
14 self-evaluation;

15 14. Be appropriately designed to serve secondary school
16 students in grades ten through twelve who are most at risk of not
17 completing a high school education; and

18 15. Allow students in the dropout prevention and credit
19 recovery program, who otherwise meet all of the participation
20 requirements, to participate in vocational programs and
21 extracurricular activities, including but not limited to athletics,
22 band, and clubs.

23 C. For each dropout prevention and credit recovery program, a
24 memorandum of understanding shall be established between the

1 participating public school and technology center specifying a
2 dedicated percentage of state funding received on a per pupil basis
3 that will be attributed to the operation of the program. In
4 addition, and subject to the availability of funds, the Oklahoma
5 Department of Career and Technology Education shall make monies
6 available to approved dropout prevention and credit recovery
7 programs.

8 D. By September 15 of each school year, all statewide
9 alternative education funds received and expended for students
10 participating in a dropout prevention and credit recovery program
11 shall be reported to the Oklahoma Department of Career and
12 Technology Education by major object codes and by program
13 classifications pursuant to the Oklahoma Cost Accounting System as
14 adopted by the State Department of Education pursuant to Section 5-
15 135 of Title 70 of the Oklahoma Statutes.

16 E. A district board of education of a public school or
17 technology center shall hire only certified teachers to teach in
18 dropout prevention and credit recovery programs. The teacher's
19 certification in subjects in which the teacher does not otherwise
20 hold certification pursuant to the provisions of this section shall
21 be valid only for purposes of teaching in the dropout prevention and
22 credit recovery program.

23 SECTION 2. This act shall become effective July 1, 2020.

SECTION 3. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
