By deleting the years "2019-2020" and inserting in lieu thereof the years "2021-2022"; and

On Page 2, Line 2 by deleting the words "four through eight" and inserting in lieu thereof the words "three through twelve"; and

On Page 2, Lines 2-3, by deleing all the language beginning with the word "only" on Line 2 and through the word "enrolled" on Line 3 and interesting in lieu thereof the following language:

"in a course that satisfies the physical education program required pursuant Section 11-103.9 of this title or during the school year where the assessment can be administered by trained personnel"; and

On Page 2, Line 7, by inserting after the period the following language: "A local school district shall not be required to conduct the annual fitness assessment for students with a disability or other condition that requires an exemption as determined by the State Department of Education."; and

On Page 2, Line 8, by inserting after the subsection letter "B." and before the first "The" the following language: "The State Department of Education shall adopt an assessment instrument that includes standards accessible to districts which adequately express the most current and widely accepted best practices and benchmarks in the areas of student health and physical education to be used by all local school districts in assessing student physical fitness."

On Page 3, Line 2, by inserting after the period the following language:

"The performance results provided to the Board pursuant to this subsection may be used for assessing the effectiveness of health programs and developing recommendations for modifications to physical education and health and wellness programs or related curriculum."; and

On Page 3, Line 3-6, by deleting all of the language beginning with the word "The" on Line 3 and through the period on 6 and inserting in lieu thereof a new subsection D and E to read as follows:

"D. Not later than the last day of the school year, a school district shall provide a parent or guardian with a copy of the results of the physical fitness assessment of the parent's or guardian's child. The results provided to a parent or guardian under this subsection shall be clear, precise, and easy to understand.

E. 1. The Department shall analyze the performance results provided to the Board pursuant to subsection C of this section and identify, for each school district, any correlation between the results and the following:

- a. student obesity,
- b. student attendance levels,
- c. student academic achievement levels,
- d. student disciplinary problems, and
- e. school meal programs.

2. The Department may contract with a public or private entity for that entity to conduct all or part of the analysis required in paragraph 1 of this subsection.

3. Beginning September 1, 2021, and for each year thereafter, the Department shall report, for the proceeding school year, the findings of the analysis required under this subsection to the State Superintendent of Public Instruction and to the Oklahoma State Department of Health."; and

By renumbering the subsequent subsections; and

On Page 3, Line 10, by deleting the numeral year "2020" and inserting in lieu thereof the numeral year "2022"; and

On Page 3-4, by deleting Sections 2 and 3 in their entirety.
