1 "SECTION 2. AMENDATORY 47 O.S. 2011, Section 1135.5, as
2 last amended by Section 3, Chapter 434, O.S.L. 2019 (47 O.S. Supp.
3 2019, Section 1135.5), is amended to read as follows:

4 Section 1135.5 A. The Oklahoma Tax Commission is hereby
5 authorized to design and issue appropriate official special license
6 plates to persons wishing to demonstrate support and provide
7 financial assistance as provided by this section.

8 Special license plates shall not be transferred to any other
9 person but shall be removed from the vehicle upon transfer of
10 ownership and retained. The special license plate may then be used
11 on another vehicle but only after such other vehicle has been
12 registered for the current year with a motor license agent.

13 Special license plates shall be renewed each year by the Tax
14 Commission or a motor license agent, unless authorized by the Tax
15 Commission to be renewed for a period greater than one (1) year.
16 The Tax Commission shall notify by mail all persons issued special
17 license plates. The notice shall contain all necessary information
18 and shall contain instructions for the renewal procedure upon
19 presentation to a motor license agent or the Tax Commission. The
20 license plates shall be issued on a staggered system.

21 The Tax Commission is hereby directed to develop and implement a
22 system whereby motor license agents are permitted to accept
23 applications for special license plates authorized under this
24 section. The motor license agent shall confirm the applicant's

1 eligibility, if applicable, collect and deposit any amount
2 specifically authorized by law, accept and process the necessary
3 information directly into such system and generate a receipt
4 accordingly. For performance of these duties, motor license agents
5 shall retain the fee provided in Section 1141.1 of this title for
6 registration of a motor vehicle. The motor license agent fees for
7 acceptance of applications and renewals shall be paid out of the
8 Oklahoma Tax Commission Reimbursement Fund.

9 If fewer than one hundred of any type of special license plates
10 authorized prior to January 1, 2004, are issued prior to January 1,
11 2006, the Tax Commission shall discontinue issuance and renewal of
12 that type of special license plate. Any such authorized special
13 license plate registrant shall be allowed to display the license
14 plate upon the designated vehicle until the registration expiration
15 date. After such time the expired special license plate shall be
16 removed from the vehicle.

17 For special license plates authorized on or after July 1, 2004,
18 no special license plates shall be developed or issued by the Tax
19 Commission until the Commission receives one hundred prepaid
20 applications therefor. The prepaid applications must be received by
21 the Tax Commission within one hundred eighty (180) days of the
22 effective date of the authorization or the authority to issue shall
23 be null and void. In the event one hundred prepaid applications are
24

1 not received by the Tax Commission within such prescribed time
2 period any payment so received shall be refunded accordingly.

3 B. The special license plates provided by this section are as
4 follows:

5 1. University or College Supporter License Plate - such plates
6 shall be designed and issued to any person wishing to demonstrate
7 support to any state-supported or private university or college. As
8 provided in this section, an amount of the fee collected shall be
9 apportioned as provided in Section 1104.1 of this title;

10 2. Environmental Awareness License Plate - such plates shall be
11 designed, subject to the criteria to be presented to the Tax
12 Commission by the Department of Environmental Quality in
13 consultation with the Oklahoma Arts Council, and issued to any
14 person wishing to demonstrate support to implement the statewide
15 general public environmental education program created pursuant to
16 the provisions of the Oklahoma Environmental Quality Code. Such
17 plates shall be designed and issued to any person in any combination
18 of numbers and letters from one to a maximum of seven, as for
19 personalized license plates. A dealer's license plate issued
20 pursuant to Section 1116.1 or 1128 of this title may be designated
21 an Environmental Awareness License Plate upon payment of the fee
22 imposed by this section and any other registration fees required by
23 the Oklahoma Vehicle License and Registration Act. As provided in
24

1 this section, an amount of the fee collected shall be apportioned
2 pursuant to Section 1104.2 of this title;

3 3. Firefighter License Plate - such plates shall be designed
4 for any career or retired firefighter, volunteer or paid.

5 Firefighters may apply for firefighter plates for up to four
6 vehicles with a rated capacity of one (1) ton or less or for a
7 motorcycle upon proof of a fire department membership by either an
8 identification card or letter from the chief of the fire department.
9 Retirees who are eligible for such plates shall provide proof of
10 eligibility upon initial application, but shall not be required to
11 provide proof of eligibility annually. The surviving spouse of any
12 deceased firefighter, if the spouse has not since remarried, may
13 apply for a firefighter license plate for one vehicle with a rated
14 carrying capacity of one (1) ton or less or for a motorcycle upon
15 proof that the deceased firefighter was a member of a fire
16 department by either an identification card or letter from the chief
17 of the fire department. The license plate shall be designed in
18 consultation with the Oklahoma Firefighters Association.

19 As provided in this section, an amount of the fee collected
20 shall be deposited to the Oklahoma State Firemen's Museum Building &
21 Memorial Fund for support of the Oklahoma Firefighters Museum and
22 the Oklahoma Fallen and Living Firefighters Memorial;

23 4. Wildlife Conservation License Plate - such plates shall be
24 designed, subject to the criteria to be presented to the Tax

1 Commission by the Oklahoma Department of Wildlife Conservation in
2 consultation with the Oklahoma Arts Council, and issued to any
3 person wishing to demonstrate support for wildlife conservation in
4 this state through the Wildlife Diversity Fund, provided for in
5 Section 3-310 of Title 29 of the Oklahoma Statutes. Such plates may
6 be designed and issued to any person as for personalized license
7 plates.

8 As provided in this section, an amount of the fee collected
9 shall be apportioned pursuant to subsection D of Section 3-310 of
10 Title 29 of the Oklahoma Statutes;

11 5. Child Abuse Prevention License Plate - such plates shall be
12 designed, subject to the criteria to be presented to the Tax
13 Commission by the Office of Child Abuse Prevention in the State
14 Department of Health and the Oklahoma Committee to Prevent Child
15 Abuse, and issued to any person wishing to demonstrate support for
16 the prevention of child abuse.

17 As provided in this section, an amount of the fee collected
18 shall be deposited in the Child Abuse Prevention Fund;

19 6. United States Olympic Committee Supporter License Plate -
20 such plates shall be designed and issued to any person wishing to
21 demonstrate support for the United States Olympic Committee. The
22 plates shall be issued to any person in any combination of numbers
23 and letters from one to a maximum of seven, as for personalized
24 license plates. The plate shall contain the official United States

1 Olympic Committee logo. The Tax Commission shall be authorized, if
2 necessary, to enter into a licensing agreement with the United
3 States Olympic Committee for any licensing fees which may be
4 required in order to use the United States Olympic Committee logo or
5 design. The licensing agreement shall provide for a payment of not
6 more than Twenty-five Dollars (\$25.00) for each license plate
7 issued;

8 7. Oklahoma History License Plate - such plates shall be
9 designed and issued to any person wishing to demonstrate interest in
10 Oklahoma history. As provided in this section, an amount of the fee
11 collected shall be deposited to the Oklahoma Historical Society
12 Revolving Fund to be used for educational purposes;

13 8. Historic Route 66 License Plate - such:

14 a. vehicle plates shall be designed to honor historic
15 Route 66, also known as the "Mother Road". As
16 provided in this section, an amount of the fee
17 collected for each vehicle license plate shall be
18 apportioned to the Oklahoma Historical Society
19 Revolving Fund to be distributed to the Route 66
20 Museum located in Clinton, Oklahoma, and

21 b. motorcycle plates shall be designed in consultation
22 with the Oklahoma Route 66 Association, Inc. The
23 Oklahoma Tax Commission shall be authorized to enter
24 into a licensing agreement with the Oklahoma Route 66

1 Association, Inc., for any licensing fees which may be
2 required in order to use the Oklahoma Route 66
3 Association, Inc., logo or design. The licensing
4 agreement shall provide for a payment to the Oklahoma
5 Route 66 Association, Inc., of not more than Twenty
6 Dollars (\$20.00) for each motorcycle license plate
7 issued;

8 9. Heart of the Heartland License Plate - such plates shall be
9 designed and issued to any person wishing to honor the victims of
10 the terrorist bombing attack on the Alfred P. Murrah Federal
11 Building in downtown Oklahoma City on April 19, 1995. As provided
12 in this section, an amount of the fee collected shall be deposited
13 in the Heart of the Heartland Scholarship Fund, as established in
14 Section 2282 of Title 70 of the Oklahoma Statutes;

15 10. Emergency Medical Technician License Plate - such plates
16 shall be designed and issued to any person who is an emergency
17 medical technician. Such persons may apply for an emergency medical
18 technician license plate for each vehicle with a rated carrying
19 capacity of one (1) ton or less upon proof of an emergency medical
20 technician's license. The license plate shall be designed in
21 consultation with the state association of emergency medical
22 technicians. As provided in this section, an amount of the fee
23 collected shall be apportioned to the Emergency Medical Personnel
24

1 Death Benefit Revolving Fund created in Section 1-2505.2 of Title 63
2 of the Oklahoma Statutes;

3 11. Fight Breast Cancer License Plate - such plates shall be
4 designed to demonstrate support for the prevention and treatment of
5 breast cancer in this state. As provided in this section, an amount
6 of the fee collected shall be apportioned to the Breast Cancer Act
7 Revolving Fund;

8 12. Crime Victims Awareness License Plate - such plates shall
9 be designed and issued to any person wishing to demonstrate
10 awareness of and support for victims of crimes. The license plates
11 shall be designed in consultation with the Oklahoma Crime Victims
12 Centre. As provided in this section, an amount of the fee collected
13 shall be apportioned to the Attorney General's Revolving Fund for
14 the Office of the Attorney General, which is hereby directed to use
15 such funds to contract with a statewide nonprofit organization to
16 provide services to crime victims;

17 13. Oklahoma Safe Kids Association License Plate - such plates
18 shall be designed and issued to any person wishing to demonstrate
19 support and awareness of the Oklahoma Safe Kids Association. The
20 license plate shall be designed in consultation with the Oklahoma
21 Safe Kids Association. As provided in this section, an amount of
22 the fee collected shall be deposited in the Children's Hospital -
23 Oklahoma Safe Kids Association Revolving Fund to be distributed to
24 the Oklahoma Safe Kids Association program;

1 14. Four-H Club License Plate - such plates shall be designed,
2 subject to criteria to be presented to the Tax Commission by the
3 Four-H Foundation, and issued to any person wishing to demonstrate
4 support of the Four-H Club. Such plates may be designed and issued
5 to any person as for personalized license plates. As provided in
6 this section, an amount of the fee collected shall be apportioned to
7 the OSU Extension Service License Plate Revolving Fund created in
8 Section 1104.4 of this title;

9 15. Agricultural Awareness License Plate - such plates shall be
10 designed, subject to criteria to be presented to the Tax Commission,
11 by the Oklahoma Department of Agriculture, Food, and Forestry in
12 consultation with the Oklahoma Arts Council, and issued to any
13 person wishing to demonstrate support of the Department's Ag in the
14 Classroom Education Program. As provided in this section, an amount
15 of the fee collected shall be apportioned as provided in Section
16 1104.3 of this title;

17 16. Oklahoma Statehood Centennial License Plate - such plates
18 shall be designed and issued to any person wishing to commemorate
19 the centennial of Oklahoma's admission to statehood in 1907. The
20 license plates shall be designed in consultation with the Oklahoma
21 Capitol Complex and Centennial Commemoration Commission. As
22 provided in this section, an amount of the fee collected shall be
23 deposited in the Oklahoma Capitol Complex and Centennial
24

1 Commemoration Commission Revolving Fund created in Section 98.5 of
2 Title 73 of the Oklahoma Statutes;

3 17. Support Education License Plate - such plates shall be
4 designed, subject to criteria to be presented to the Tax Commission
5 by the State Department of Education in consultation with the
6 Oklahoma Arts Council, and issued to any person wishing to
7 demonstrate support for education in this state. All motor license
8 agents shall display a sample of the Support Education License plate
9 in the area of the business accessed by the public. Twenty-three
10 Dollars (\$23.00) of the fee collected shall be apportioned as
11 follows:

- 12 a. five percent (5%) shall be deposited to the Education
13 Reform Revolving Fund,
- 14 b. five percent (5%) shall be deposited to the Higher
15 Education Revolving Fund,
- 16 c. five percent (5%) shall be deposited to the State
17 Career Technology Fund, and
- 18 d. eighty-five percent (85%) of the fee shall be
19 deposited to the Teachers' Retirement Benefit Fund as
20 set forth in Section 17-108 of Title 70 of the
21 Oklahoma Statutes.

22 However, when the Teachers' Retirement Benefit Fund attains a
23 seventy percent (70%) funded ratio based on an annual actuarial
24 valuation as required by law, the amount of the fee shall be

1 apporportioned equally pursuant to subparagraphs a, b and c of this
2 paragraph;

3 18. Retired Oklahoma Highway Patrol Officers License Plate -
4 such plates shall be designed and issued to any retired officer of
5 the Oklahoma Highway Patrol. The license plate shall have the
6 legend "Oklahoma" and shall contain, in the center of the plate, the
7 Highway Patrol Officers patch using the same colors and pattern as
8 used in the patch. Centered on the bottom of the license plate
9 shall be the word "Retired". The letters "TRP" shall be used in
10 combination with three numbers on either side of the insignia or
11 emblem. The color of the letters and numbers shall be brown.
12 Retirees who are eligible for such plates shall provide proof of
13 eligibility upon initial application, but shall not be required to
14 provide proof of eligibility annually. The surviving spouse of any
15 deceased retired officer of the Oklahoma Highway Patrol, if the
16 spouse has not since remarried, or if remarried, the remarriage is
17 terminated by death, divorce, or annulment, may apply for a Retired
18 Oklahoma Highway Patrol Officers license plate. As provided in this
19 section, an amount of the fee collected shall be deposited into the
20 Law Enforcement Retirement Fund;

21 19. Boy Scouts of America Supporter License Plate - such plates
22 shall be designed and issued to any person wishing to demonstrate
23 support for the Boy Scouts of America. The plates shall be issued
24 to any person in any combination of numbers and letters from one to

1 a maximum of seven, as for personalized license plates. The plate
2 shall contain the official Boy Scouts of America logo. The Tax
3 Commission shall be authorized, if necessary, to enter into a
4 licensing agreement with the Boy Scouts of America for any licensing
5 fees which may be required in order to use the Boy Scouts of America
6 logo or design. The licensing agreement shall provide for a payment
7 to the Boy Scouts of America of not more than Twenty Dollars
8 (\$20.00) for each license plate issued;

9 20. Urban Forestry and Beautification License Plate - such
10 plates shall be designed, subject to criteria to be presented to the
11 Tax Commission, by the Oklahoma Department of Agriculture, Food, and
12 Forestry in consultation with nonprofit organizations in this state
13 that develop and operate programs to encourage urban forestry and
14 beautification, and issued to any person wishing to demonstrate
15 support of such programs. As provided in this section, an amount of
16 the fee collected shall be apportioned as provided in Section 1104.5
17 of this title;

18 21. Oklahoma State Parks Supporter License Plate - such plates
19 shall be designed, subject to criteria to be presented to the Tax
20 Commission by the Oklahoma Tourism and Recreation Department, and
21 issued to any person wishing to demonstrate support for the Oklahoma
22 state parks system. Twenty-three Dollars (\$23.00) of the fee
23 collected shall be deposited in the Oklahoma Tourism and Recreation
24

1 Department Revolving Fund. Such money shall be designated for and
2 may only be expended for the support of Oklahoma state parks;

3 22. Adoption Creates Families License Plate - such plates shall
4 be issued to any person wishing to demonstrate support of pregnant
5 women who are committed to placing their children for adoption and
6 wishing to provide assistance to guardians, adoptive parents and
7 other created families to assist in the adoption and placement of
8 children in permanent, safe homes. The license plates shall be
9 designed and final terminology delivered in consultation with the
10 Oklahoma Adoption Coalition and the Department of Human Services.
11 Twenty-five Dollars (\$25.00) of the fee collected shall be deposited
12 in a revolving fund established in the State Treasury for and to be
13 used by the Department of Human Services for the implementation of
14 the Investing in Stronger Oklahoma Families Act specifically for
15 created families;

16 23. Choose Life License Plate - such plates shall be designed,
17 subject to criteria presented to the Tax Commission, by Choose Life,
18 Inc., and issued to any person who wishes to demonstrate support of
19 organizations that encourage adoption as a positive choice for women
20 with unplanned pregnancies. As provided in this section, an amount
21 of the fee collected shall be deposited in the Choose Life
22 Assistance Program Revolving Fund established in Section 1104.6 of
23 this title;

24

1 24. Future Farmers of America License Plate - such plates shall
2 be designed and issued to persons wishing to demonstrate support for
3 the Oklahoma FFA (formerly known as Future Farmers of America). The
4 license plates shall be designed in consultation with the Oklahoma
5 FFA Foundation Board of Directors. As provided in this section, an
6 amount of the fee collected shall be apportioned as provided in
7 Section 1104.7 of this title;

8 25. Lions Club License Plate - such plates shall be designed
9 and issued to persons wishing to demonstrate support for the Lions
10 Club of Oklahoma. The plates shall be issued to any person in any
11 combination of numbers and letters from one to a maximum of seven,
12 as for personalized license plates. The license plates shall be
13 designed in consultation with the Oklahoma Lions Service Foundation
14 and shall contain the official logo of the International Association
15 of Lions Clubs. The Tax Commission shall be authorized to enter
16 into a licensing agreement with the Oklahoma Lions Service
17 Foundation. The licensing agreement shall provide for a payment to
18 the Oklahoma Lions Service Foundation of not more than Ten Dollars
19 (\$10.00) for each license plate issued;

20 26. Color Oklahoma License Plate - such plates shall be
21 designed, subject to criteria to be presented to the Tax Commission
22 by the Oklahoma Native Plant Society, and issued to any person
23 wishing to demonstrate support for preserving and planting
24 wildflowers and native plants in Oklahoma and to promote Oklahoma's

1 wildflower heritage through education. As provided in this section,
2 an amount of the fee collected shall be apportioned as provided in
3 Section 1104.8 of this title;

4 27. Girl Scouts of the United States of America Supporter
5 License Plate - such plates shall be designed and issued to any
6 person wishing to demonstrate support for the Girl Scouts of the
7 United States of America. The plates shall be issued to any person
8 in any combination of numbers and letters from one to a maximum of
9 seven, as for personalized license plates. The plate shall contain
10 the official Girl Scouts of the United States of America logo. The
11 Tax Commission shall be authorized, if necessary, to enter into a
12 licensing agreement with the Girl Scouts of the United States of
13 America for any licensing fees which may be required in order to use
14 the Girl Scouts of the United States of America logo or design. The
15 licensing agreement shall provide for a payment to the Girl Scouts
16 of Magic Empire Council, acting on behalf of all Oklahoma Girl Scout
17 councils, of not more than Twenty Dollars (\$20.00) for each license
18 plate issued;

19 28. Oklahoma City Memorial Marathon License Plate - such plates
20 shall be designed and issued to any person wishing to demonstrate
21 support for the Oklahoma City Memorial Marathon. The plate shall be
22 designed in consultation with the Oklahoma City Memorial Marathon.
23 The Tax Commission shall be authorized to enter into a licensing
24 agreement with the Oklahoma City Memorial Marathon for any licensing

1 fees which may be required in order to use the Oklahoma City
2 Memorial Marathon logo or design. The licensing agreement shall
3 provide for a payment to the Oklahoma City Memorial Marathon of not
4 more than Twenty Dollars (\$20.00) for each license plate issued;

5 29. Oklahoma Scenic Rivers License Plate - such plates shall be
6 designed to demonstrate support for the Oklahoma Scenic Rivers. The
7 plates shall be designed in consultation with the Oklahoma Scenic
8 Rivers Commission. Twenty-five Dollars (\$25.00) of the fee shall be
9 apportioned to the Oklahoma Scenic Rivers Commission;

10 30. Fight Cancer License Plate - such plates shall be designed
11 to demonstrate support for the Oklahoma Central Cancer Registry.
12 The plate shall contain the American Cancer Society logo. The
13 American Cancer Society logo shall be used in accordance with the
14 American Cancer Society's branding guidelines and shall only be
15 utilized to support the Oklahoma Central Cancer Registry. Twenty
16 Dollars (\$20.00) of the fee shall be apportioned to the Oklahoma
17 Central Cancer Registry Revolving Fund;

18 31. Animal Friendly License Plate - such plates shall be
19 designed and issued to any person wishing to demonstrate support for
20 controlling the overpopulation of dogs and cats through educational
21 and sterilization efforts. The plates shall be designed in
22 consultation with the Veterinary Medical Association. Twenty
23 Dollars (\$20.00) of the fee collected shall be designated by the
24 purchaser of the plate to be deposited in the Oklahoma Pet

1 Overpopulation Fund created in Section 2368.13 of Title 68 of the
2 Oklahoma Statutes or the Animal Friendly Revolving Fund created in
3 Section 1104.10 of this title;

4 32. Patriot License Plate - such plates shall be designed in
5 consultation with the Military Department of Oklahoma and issued to
6 any person wishing to demonstrate support for Oklahoma residents who
7 are members of the Oklahoma National Guard and deployed on active
8 duty. The plates shall be issued to any person in any combination
9 of numbers and letters from one to a maximum of seven, as for
10 personalized license plates. As provided in this section, a portion
11 of the fee collected shall be deposited in the Patriot License Plate
12 Revolving Fund created in Section 1104.11 of this title;

13 33. Global War on Terrorism License Plate - such plate shall be
14 designed in consultation with the Military Department of Oklahoma
15 and issued to any person wishing to demonstrate support for Oklahoma
16 residents who are members of the Armed Forces of the United States
17 or Oklahoma National Guard that have served in the Global War on
18 Terrorism. The plate shall be issued to any person in any
19 combination of numbers and letters from one to a maximum of six. As
20 provided in this section, a portion of the fee collected shall be
21 deposited in the 45th Infantry Division Museum Fund created in
22 Section 235.1 of Title 44 of the Oklahoma Statutes;

23 34. Boys and Girls Clubs of America Supporter License Plate -
24 such plates shall be designed and issued to any person wishing to

1 demonstrate support for the Boys and Girls Clubs of America. The
2 plates shall be issued to any person in any combination of numbers
3 and letters from one to a maximum of seven, as for personalized
4 license plates. The plate shall contain the official Boys and Girls
5 Clubs of America logo. The Tax Commission, if necessary, may enter
6 into a licensing agreement with the Boys and Girls Clubs of America
7 for any licensing fees which may be required in order to use the
8 Boys and Girls Clubs of America logo or design. The licensing
9 agreement shall provide for a payment to the Boys and Girls Clubs of
10 America of not more than Twenty Dollars (\$20.00) for each license
11 plate issued;

12 35. Oklahoma Quarter Horse License Plate - such plates shall be
13 designed and issued to any person wishing to demonstrate support for
14 the American Quarter Horse in Oklahoma. The plate shall be designed
15 in consultation with the Oklahoma Quarter Horse Association. As
16 provided in this section, a portion of the fee collected shall be
17 deposited in the Oklahoma Quarter Horse Revolving Fund created in
18 Section 1104.12 of this title;

19 36. Oklahoma Association for the Deaf License Plate - such
20 plates shall be designed in consultation with the Oklahoma
21 Association for the Deaf and issued to any person wishing to
22 demonstrate support for Oklahoma residents who are deaf. The plates
23 shall be issued to any person in any combination of numbers and
24 letters from one to a maximum of seven, as for personalized license

1 plates. As provided in this section, a portion of the fee collected
2 shall be deposited in the Oklahoma Association for the Deaf License
3 Plate Revolving Fund created in Section 1104.15 of this title;

4 37. Oklahoma City Zoo License Plate - such plates shall be
5 issued to any person wishing to demonstrate support for the Oklahoma
6 City Zoo. The license plates shall be designed in consultation with
7 the Oklahoma Zoological Society, Inc. As provided in this section,
8 an amount of the fee collected shall be deposited in the Oklahoma
9 Zoological Society Revolving Fund created in Section 1104.13 of this
10 title;

11 38. March of Dimes License Plate - such plates shall be issued
12 to persons wishing to demonstrate support for the March of Dimes
13 mission to improve the health of babies by preventing birth defects,
14 premature birth and infant mortality. The license plates shall be
15 designed in consultation with the Oklahoma Chapter March of Dimes.

4 81. Oklahoma Music Hall of Fame Inc. License Plate - such
5 plates shall be designed in consultation with the Oklahoma Music
6 Hall of Fame Inc. and issued to any member of the organization
7 wishing to demonstrate support. The Tax Commission shall be
8 authorized to enter into a licensing agreement with the Oklahoma
9 Music Hall of Fame Inc. for any licensing fees which may be required
10 in order to use the organization's logo or design. The licensing
11 agreement shall provide for a payment to the Oklahoma Music Hall of
12 Fame Inc. of not more than Twenty Dollars (\$20.00) for each license
13 plate issued. The plates shall incorporate a numbering system
14 agreed upon by the Oklahoma Music Hall of Fame Inc. and the Tax
15 Commission. Subject to the provisions of subsection A of this
16 section, the Oklahoma Music Hall of Fame Inc. License Plate is
17 hereby reauthorized effective November 1, 2019;

18 82. Techlahoma Foundation License Plate - such plates shall be
19 issued to any person wishing to provide financial support for the
20 Techlahoma Foundation. The license plate shall be designed in
21 consultation with the Techlahoma Foundation. The plate shall be
22 issued to any person in any combination of numbers and letters from
23 one to a maximum of seven, as for personalized plates. The Tax
24 Commission shall be authorized to enter into a licensing agreement

1 with the Techlahoma Foundation for any licensing fees, which may be
2 required in order to use the association's logo or design. The
3 licensing agreement shall provide for a payment to the Techlahoma
4 Foundation of not more than Twenty Dollars (\$20.00) for each license
5 plate issued;

6 83. Bethany Public Schools Foundation License Plate - such
7 plates shall be issued to any person wishing to demonstrate support
8 for the Bethany Public Schools Foundation. The license plates shall
9 be designed in consultation with the administration of the Bethany
10 Public Schools Foundation. The Oklahoma Tax Commission shall be
11 authorized to enter into a licensing agreement with the Bethany
12 Public Schools Foundation for any licensing fees which may be
13 required in order to use the Foundation's logo or design. The
14 licensing agreement shall provide for a payment to the Bethany
15 Public Schools Foundation of not more than Twenty Dollars (\$20.00)
16 for each license plate issued;

17 84. Cystic Fibrosis Foundation License Plate - such plates
18 shall be issued to any person wishing to demonstrate support for the
19 Cystic Fibrosis Foundation. The license plates shall be designed in
20 consultation with the administration of the Cystic Fibrosis
21 Foundation. The Oklahoma Tax Commission shall be authorized to
22 enter into a licensing agreement with the Cystic Fibrosis Foundation
23 for any licensing fees which may be required in order to use the
24 Foundation's logo or design. The licensing agreement shall provide

1 for a payment to the Cystic Fibrosis Foundation of not more than
2 Twenty Dollars (\$20.00) for each license plate issued;

3 85. Down Syndrome Association of Central Oklahoma License Plate
4 - such plates shall be designed and issued to any person wishing to
5 demonstrate support for the Down Syndrome Association of Central
6 Oklahoma. Such plates shall be designed in consultation with the
7 Association. As provided in this section, an amount of the fee
8 collected shall be deposited in the Down Syndrome Association of
9 Central Oklahoma License Plate Revolving Fund created in Section
10 1104.30 of this title;

11 86. Elk City Education Foundation License Plate - such plates
12 shall be designed and issued to any person wishing to demonstrate
13 support for the Elk City Education Foundation. Such plates shall be
14 designed in consultation with the Foundation. As provided in this
15 section, an amount of the fee collected shall be deposited in the
16 Elk City Education Foundation License Plate Revolving Fund created
17 in Section 1104.31 of this title;

18 87. A Brotherhood Aiming Toward Education of Oklahoma (ABATE)
19 License Plate - such plates shall be designed and issued to any
20 person wishing to provide financial support for ABATE of Oklahoma.
21 Such plates shall be designed in consultation with ABATE of
22 Oklahoma. The plates shall be issued to any person in any
23 combination of numbers and letters from one to a maximum of seven,
24 as for personalized plates. The license plate for a motorcycle may

1 be of similar design as space permits or a new design in order to
2 meet the space requirements of a motorcycle license plate. The
3 Oklahoma Tax Commission shall be authorized to enter into a
4 licensing agreement with ABATE of Oklahoma for any licensing fees
5 which may be required in order to use the ABATE of Oklahoma logo or
6 design. The licensing agreement shall provide for a payment to
7 ABATE of Oklahoma of not more than Twenty Dollars (\$20.00) for each
8 license plate issued;

9 88. Downed Bikers Association License Plate - such plates shall
10 be designed for a vehicle or motorcycle in any combination of
11 numbers and letters from one to a maximum of seven, as for
12 personalized plates, and issued to any person wishing to demonstrate
13 support for the Downed Bikers Association, a nonprofit charitable
14 organization exempt from taxation pursuant to the provisions of the
15 Internal Revenue Code, 26 U.S.C., Section 501(c)(3), which provides
16 emotional and financial support for downed bikers. The license
17 plate shall be designed in consultation with the Central Oklahoma
18 Chapter of the Downed Bikers Association and shall contain any
19 official logo or design of the organization. The license plate for
20 a motorcycle may be of similar design as space permits or a new
21 design in order to meet the space requirements of a motorcycle
22 license plate. The Tax Commission, if necessary, may enter into a
23 licensing agreement with the Downed Bikers Association for any
24 licensing fees which may be required in order to use the

1 organization's logo or design. The licensing agreement shall
2 provide for a payment to the Downed Bikers Association of not more
3 than Twenty Dollars (\$20.00) for each license plate;

4 89. Eagle Scout License Plate - Such plates shall be designed
5 to demonstrate support for Eagle Scouts and shall include the Eagle
6 Scout logo. Plates may be issued to any person who can show proof
7 of having obtained the rank of Eagle Scout. The Oklahoma Tax
8 Commission shall be authorized to enter into a licensing agreement
9 with the various Oklahoma local councils for any licensing fees
10 which may be required in order to use the applicable logo or design.
11 The licensing agreement shall provide for a payment of not more than
12 Twenty Dollars (\$20.00) for each license plate issued to the
13 specific Oklahoma local area Council designated by the applicant;

14 90. Extraordinary Educators License Plate - such plates shall
15 be designed and issued to any person wishing to provide financial
16 support for common education in Oklahoma. Such plates shall be
17 designed in consultation with the State Department of Education.
18 The plates shall be issued to any person in any combination of
19 numbers and letters from one to a maximum of seven, as for
20 personalized plates. As provided in this section, an amount of the
21 fee collected shall be deposited in the Extraordinary Educators
22 License Plate Revolving Fund created in Section 1104.32 of this
23 title;

1 91. Former Oklahoma Legislator License Plate - such plates
2 shall be designed and issued to any person who previously served as
3 a member of the Oklahoma House of Representatives or Oklahoma State
4 Senate. The license plates shall be designed in consultation with
5 the Oklahoma Historical Society. As provided in this section, an
6 amount of the fee collected shall be deposited in the Oklahoma
7 Historical Society Capital Improvement and Operations Revolving Fund
8 created in Section 1.10a of Title 53 of the Oklahoma Statutes. The
9 Tax Commission shall create and maintain a list of former members of
10 the Oklahoma House of Representatives and Oklahoma State Senate
11 eligible to be issued such plates; provided, that no former member
12 of the Oklahoma House of Representatives and Oklahoma State Senate
13 shall be eligible to possess more than two of such plates at any one
14 time. The Tax Commission shall confer as needed with the Chief
15 Clerk of the Oklahoma House of Representatives and the Secretary of
16 the Oklahoma State Senate to confirm that such list is complete and
17 accurate;

18 92. Monarch Butterfly License Plate - such plates shall be
19 designed and issued to any person wishing to demonstrate support for
20 the operations of the Nature Conservancy of Oklahoma. Such plates
21 shall be designed in consultation with the Oklahoma Chapter of the
22 Nature Conservancy. The Tax Commission shall be authorized to enter
23 into a licensing agreement with the Nature Conservancy of Oklahoma
24 for any licensing fees which may be required in order to use the

1 foundation's logo or design. The licensing agreement shall provide
2 for a payment to the Nature Conservancy of Oklahoma of not more than
3 Twenty Dollars (\$20.00) for each license plate issued;

4 93. Oklahoma Tennis Foundation License Plate - such plates
5 shall be designed and issued to any person wishing to demonstrate
6 support for the Oklahoma Tennis Foundation. The license plates
7 shall be designed in consultation with the Oklahoma Tennis
8 Foundation. The Tax Commission shall be authorized to enter into a
9 licensing agreement with the Oklahoma Tennis Foundation for any
10 licensing fees which may be required in order to use the
11 foundation's logo or design. The licensing agreement shall provide
12 for a payment to the Oklahoma Tennis Foundation of not more than
13 Twenty Dollars (\$20.00) for each license plate issued;

14 94. Veterans of Foreign Wars License Plate - such plates shall
15 be designed and issued to any person wishing to demonstrate support
16 for the Veterans of Foreign Wars Foundation. The license plates
17 shall be designed in consultation with the Veterans of Foreign Wars
18 Foundation. The Tax Commission shall be authorized to enter into a
19 licensing agreement with the Veterans of Foreign Wars Foundation for
20 any licensing fees which may be required in order to use the
21 foundation's logo or design. The licensing agreement shall provide
22 for a payment to the Veterans of Foreign Wars Foundation of not more
23 than Twenty Dollars (\$20.00) for each license plate issued;

1 95. Oklahoma Women Veterans Organization License Plate - such
2 plates shall be designed and issued to any female veteran of any
3 branch of the United States Armed Forces wishing to demonstrate
4 support for the Oklahoma Women Veterans Organization. The license
5 plates shall be designed in consultation with the Oklahoma Women
6 Veterans Organization. The Tax Commission shall be authorized to
7 enter into a licensing agreement with the Oklahoma Women Veterans
8 Organization for any licensing fees which may be required in order
9 to use the organization's logo or design. The licensing agreement
10 shall provide for a payment to the Oklahoma Women Veterans
11 Organization of not more than Twenty Dollars (\$20.00) for each
12 license plate issued;

13 96. FIRST (For Inspiration and Recognition of Science and
14 Technology) License Plate - such plates shall be issued to any
15 person wishing to demonstrate support for FIRST Robotics Programs.
16 The license plates shall be designed in consultation with the
17 administration of FIRST. The Oklahoma Tax Commission shall be
18 authorized to enter into a licensing agreement with FIRST for any
19 licensing fees which may be required in order to use the FIRST logo
20 or design. The licensing agreement shall provide for a payment to
21 FIRST of not more than Twenty Dollars (\$20.00) for each license
22 plate issued;

23 97. Pittsburg State University License Plate - such plates
24 shall be designed and issued to any person wishing to demonstrate

1 support for the Pittsburg State University. The license plates
2 shall be designed in consultation with Pittsburg State University.
3 The Tax Commission shall be authorized to enter into a licensing
4 agreement with Pittsburg State University for any licensing fees
5 which may be required in order to use the school foundation's logo
6 or design. The licensing agreement shall provide for a payment to
7 the Pittsburg State University of not more than Twenty Dollars
8 (\$20.00) for each license plate issued; ~~and~~

9 98. Historic Greenwood District License Plate - such plates
10 shall be issued to persons wishing to demonstrate support for the
11 Historic Greenwood District Juneteenth Festival held in the Historic
12 Greenwood District in Tulsa, Oklahoma. The plates shall be issued
13 to any person in any combination of numbers and letters from one to
14 a maximum of seven, as for personalized license plates. The license
15 plates shall be designed in consultation with the Black Wall Street
16 Chamber of Commerce. Twenty-five Dollars (\$25.00) of the fee
17 collected shall be deposited in the Historic Greenwood
18 District/Juneteenth Festival Revolving Fund established in Section ~~5~~
19 2368.32 of ~~this act~~ Title 68 of the Oklahoma Statutes. Two Dollars
20 (\$2.00) of the fee collected shall be deposited in the Public School
21 Classroom Support Revolving Fund, for expenditure as provided in

23 99. Paramedic License Plate - such plates shall be designed and
24 issued to any person who is a paramedic. Such persons may apply for

3 paramedic license. The license plate shall be designed in
4 consultation with the Oklahoma State University Oklahoma City
5 Paramedicine Program and the state association of emergency medical
6 technicians. As provided in this section, an amount of the fee
7 collected shall be apportioned to the Emergency Medical Personnel
8 Death Benefit Revolving Fund created in Section 1-2505.2 of Title 63
9 of the Oklahoma Statutes.

10 C. The fee for such plates shall be Thirty-five Dollars
11 (\$35.00) per year of renewal and shall be in addition to all other
12 registration fees provided by the Oklahoma Vehicle License and
13 Registration Act. The fee shall be apportioned as follows:

14 1. Twenty Dollars (\$20.00) per year of renewal or any other
15 amount as provided in this title of the fee shall be apportioned as
16 provided or deposited in a fund as specified within the paragraph
17 authorizing the special license plate;

18 2. Eight Dollars (\$8.00) per year of renewal of the fee shall
19 be deposited in the Oklahoma Tax Commission Reimbursement Fund to be
20 used for the administration of the Oklahoma Vehicle License and
21 Registration Act; and
