FLOOR SUBSTITUTE

An Act relating to memorial bridge designations;
designating the Gold Star Families Memorial Highway;
designating the Randy Peterson Memorial Highway;
designating the Sgt. Michael A. Crawford Memorial
Highway; designating the Sgt. Jason McCluskey
Memorial Bridge; requiring certain markers; providing
for codification; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified
in the Oklahoma Statutes as Section 1698.287 of Title 69, unless
there is created a duplication in numbering, reads as follows:

The section of U.S. Highway 277 beginning on the west side of
the H.E. Bailey Turnpike and extending west to the intersection of
U.S. Highway 62 in Comanche County shall be designated as the "Gold
Star Families Memorial Highway". The Department of Transportation

1 shall cause suitable permanent markers bearing that name to be
2 placed on the highway.

3 SECTION 2. NEW LAW A new section of law to be codified
4 in the Oklahoma Statutes as Section 1698.288 of Title 69, unless
5 there is created a duplication in numbering, reads as follows:

6 The section of U.S. Highway 69B beginning at the intersection of
7 Foley Avenue and extending north to the intersection of Selmon Road
8 within the municipal limits of Eufaula shall be designated as the
9 "Randy Peterson Memorial Highway". The Department of Transportation
10 shall cause suitable permanent markers bearing that name to be
11 placed on the highway.

12 SECTION 3. NEW LAW A new section of law to be codified
13 in the Oklahoma Statutes as Section 1698.289 of Title 69, unless
14 there is created a duplication in numbering, reads as follows:

15 The section of U.S. Highway 266 beginning at the intersection
16 with U.S. Highway 75 and extending east to the eastern municipal
17 limit of Dewar within Okmulgee County shall be designated as the
18 "Sgt. Michael A. Crawford Memorial Highway". The Department of
19 Transportation shall cause suitable permanent markers bearing that
20 name to be placed on the highway.

21 SECTION 4. NEW LAW A new section of law to be codified
22 in the Oklahoma Statutes as Section 1698.290 of Title 69, unless
23 there is created a duplication in numbering, reads as follows:

1 The bridge over U.S. Highway 69 on U.S. Highway 270 within the
2 municipal limits of McAlester shall be designated as the "Sgt. Jason
3 McCluskey Memorial Bridge". The Department of Transportation shall
4 cause suitable permanent markers bearing that name to be placed on
5 the highway.

6 SECTION 5. This act shall become effective November 1, 2019.
