10 An Act relating to the State Historic Preservation
11 Office; providing for transfer of duties to the
12 Oklahoma Department of Commerce; providing for
13 transfer of books, records, equipment and personnel;
14 providing for transferred employees to be in the
15 unclassified service; providing for transfer of
16 funds; making exception for encumbered funds;
17 providing for modification of existing website
18 information; providing for modification of webpage
19 information by the Oklahoma Department of Commerce;
20 amending 74 O.S. 2011, Section 840-5.5, as last
21 amended by Section 1, Chapter 365, O.S.L. 2019 (74
22 O.S. Supp. 2019, Section 840-5.5), which relates to
23 the Oklahoma Personnel Act; providing for
24 unclassified service of employees of the State
 Historic Preservation Office; providing for
 codification; providing an effective date; and
 declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW

A new section of law to be codified in the Oklahoma Statutes as Section 5019.1 of Title 74, unless there is created a duplication in numbering, reads as follows:

A. Effective July 1, 2020, the State Historic Preservation Office shall no longer be under the jurisdiction of the Oklahoma Historical Society and its duties and functions shall be transferred to the Oklahoma Department of Commerce.

B. All books, records, papers, equipment and tangible personal property used by the State Historic Preservation Office shall be transferred to the Oklahoma Department of Commerce.

C. Personnel assigned to the State Historic Preservation Office shall be transferred to and become employees of the Oklahoma Department of Commerce. All personnel transferred pursuant to the provisions of this subsection shall be in the unclassified service for purposes of the Oklahoma Personnel Act.

D. Any funds under the control of the State Historic Preservation Office, with the exception of funds encumbered prior to the effective date of this act, shall be transferred to the Oklahoma Department of Commerce.

E. Any website information which identifies the State Historic Preservation Office as an administrative unit of the Oklahoma Historical Society shall be modified to reflect the transfer of functions required by this act and, if necessary, the Oklahoma Department of Commerce shall create a website or modify an existing

1 agency website so that the information contained in the existing
2 webpages for the State Historic Preservation Office will be
3 preserved to the extent possible and so that the Office is correctly
4 identified as an administrative unit or program of the Oklahoma
5 Department of Commerce.

6 SECTION 2. AMENDATORY 74 O.S. 2011, Section 840-5.5, as
7 last amended by Section 1, Chapter 365, O.S.L. 2019 (74 O.S. Supp.
8 2019, Section 840-5.5), is amended to read as follows:

9 Section 840-5.5 A. The following offices, positions, and
10 personnel shall be in the unclassified service and shall not be
11 placed under the classified service:

12 1. Persons chosen by popular vote or appointment to fill an
13 elective office, and their employees, except the employees of the
14 Corporation Commission, the State Department of Education and the
15 Department of Labor;

16 2. Members of boards and commissions, and heads of agencies;
17 also one principal assistant or deputy and one executive secretary
18 for each state agency;

19 3. All judges, elected or appointed, and their employees;

20 4. Persons employed with one-time, limited duration, federal or
21 other grant funding that is not continuing or indefinitely
22 renewable. The length of the unclassified employment shall not
23 exceed the period of time for which that specific federal funding is
24 provided;

1 5. All officers and employees of The Oklahoma State System of
2 Higher Education, State Board of Education and Oklahoma Department
3 of Career and Technology Education;

4 6. Persons employed in a professional or scientific capacity to
5 make or conduct a temporary and special inquiry, investigation, or
6 examination on behalf of the Legislature or a committee thereof or
7 by authority of the Governor. These appointments and authorizations
8 shall terminate on the first day of the regular legislative session
9 immediately following the appointment, if not terminated earlier.
10 However, nothing in this paragraph shall prevent the reauthorization
11 and reappointment of any such person. Any such appointment shall be
12 funded from the budget of the appointing authority;

13 7. Election officials and employees;

14 8. Temporary employees employed to work less than one thousand
15 (1,000) hours in any twelve-month period, and seasonal employees
16 employed by the Oklahoma Tourism and Recreation Department pursuant
17 to Section 2241 of this title who work less than one thousand six
18 hundred (1,600) hours in any twelve-month period;

19 9. Department of Public Safety employees occupying the
20 following offices or positions:

- 21 a. administrative aides to the Commissioner,
- 22 b. executive secretaries to the Commissioner,
- 23 c. the Governor's representative of the Oklahoma Highway
24 Safety Office who shall be appointed by the Governor,

d. Highway Patrol Colonel,
e. Highway Patrol Lieutenant Colonel,
f. Highway Patrol Major,
g. Director of Finance,
h. noncommissioned pilots,
i. Information Systems Administrator,
j. Law Enforcement Telecommunications System Specialist,
k. Director of Driver Compliance,
l. Director of Transportation Division,
m. Director of the Oklahoma Highway Safety Office,
n. Civil Rights Administrator,
o. Budget Analyst,
p. Comptroller,
q. Chaplain,
r. Helicopter Mechanic,
s. Director of Safety Compliance,
t. Human Resources Director,
u. Administrator of Department Services, and
v. a maximum of seven positions for the purpose of
administering programs in the Oklahoma Highway Safety
Office, within full-time employee limitations of the
Department, employed with federal funding that is
continuing or indefinitely renewable. The

1 authorization for such positions shall be terminated
2 if the federal funding for positions is discontinued;
3 provided, any person appointed to a position prescribed in
4 subparagraph d, e or f of this paragraph shall have a right of
5 return to the classified commissioned position without any loss of
6 rights, privileges or benefits immediately upon completion of the
7 duties in the unclassified commissioned position;

8 10. Professional trainees only during the prescribed length of
9 their course of training or extension study;

10 11. Students who are employed on a part-time basis, which shall
11 be seventy-five percent (75%) of a normal forty-hour work week or
12 thirty (30) hours per week, or less, or on a full-time basis if the
13 employment is pursuant to a cooperative education program such as
14 that provided for under Title I IV-D of the Higher Education Act of
15 1965 (20 U.S.C. 1087a-1087c), as amended, and who are regularly
16 enrolled in:

17 a. an institution of higher learning within The Oklahoma
18 State System of Higher Education,

19 b. an institution of higher learning qualified to become
20 coordinated with The Oklahoma State System of Higher
21 Education. For purposes of this section, a student
22 shall be considered a regularly enrolled student if
23 the student is enrolled in a minimum of five (5) hours
24 of accredited graduate courses or a minimum of ten

1 (10) hours of accredited undergraduate courses;
2 provided, however, the student shall only be required
3 to be enrolled in a minimum of six (6) hours of
4 accredited undergraduate courses during the summer, or
5 c. high school students regularly enrolled in a high
6 school in Oklahoma and regularly attending classes
7 during such time of enrollment;

8 12. The spouses of personnel who are employed on a part-time
9 basis to assist or work as a relief for their spouses in the
10 Oklahoma Tourism and Recreation Department;

11 13. Service substitute attendants who are needed to replace
12 museum and site attendants who are unavoidably absent. Service
13 substitutes may work as part-time or full-time relief for absentees
14 for a period of not more than four (4) weeks per year in the
15 Oklahoma Historical Society sites and museums; such substitutes will
16 not count towards the agency's full-time-equivalent (FTE) employee
17 limit;

18 14. Employees of the Oklahoma House of Representatives, the
19 State Senate, or the Legislative Service Bureau;

20 15. Corporation Commission personnel occupying the following
21 offices and positions:

22 a. Administrative aides, and executive secretaries to the

19 interruption in any benefit programs available to classified
20 employees, including retirement and insurance programs. Immediately
21 upon termination of an unclassified appointment pursuant to this
22 paragraph, an employee on assignment from the classified service
23 shall have a right to be restored to the classified service and
24 reinstated to the former job family level and compensation plus any

1 adjustments and increases in salary or benefits which the employee
2 would have received but for the leave of absence;

24 Juvenile Center in Manitou after June 1, 2020, as

provided in subsection C of Section 2-7-202 of Title
10A of the Oklahoma Statutes; and

55. Heads of agencies, principal assistants or deputies and
executive secretaries of an agency that is consolidated into another
agency.

B. If an agency has the authority to employ personnel in the
following offices and positions, the appointing authority shall have
the discretion to appoint personnel to the unclassified service:

1. Licensed medical doctors, osteopathic physicians, dentists,
psychologists, and nurses;

2. Certified public accountants;

3. Licensed attorneys;

4. Licensed veterinarians; and

5. Licensed pharmacists.

C. Effective July 1, 1996, authorization for unclassified
offices, positions, or personnel contained in a bill or joint
resolution shall terminate June 30 of the ensuing fiscal year after
the authorization unless the authorization is codified in the
Oklahoma Statutes or the termination is otherwise provided in the
legislation.

D. The appointing authority of agencies participating in the
statewide information systems project may establish unclassified
positions and appoint unclassified employees to the project as
needed. Additional unclassified positions may be established, if

1 required, to appoint an unclassified employee to perform the duties
2 of a permanent classified employee who is temporarily absent from a
3 classified position as a result of assignment to this project. All
4 unclassified appointments under this authority shall expire no later
5 than December 31, 2007, and all unclassified positions established
6 to support the project shall be abolished. Both the positions and
7 appointments resulting from this authority shall be exempt from any
8 agency FTE limitations and any limits imposed on the number of
9 unclassified positions authorized. Permanent classified employees
10 may request a leave of absence from classified status and accept an
11 unclassified appointment and compensation with the same agency under
12 the provisions of this subsection; provided, the leave shall expire
13 no later than December 31, 2007. Employees accepting the
14 appointment and compensation shall be entitled to participate
15 without interruption in any benefit programs available to classified
16 employees, including retirement and insurance programs. Immediately
17 upon termination of an unclassified appointment pursuant to this
18 subsection, an employee on assignment from the classified service
19 shall have a right to be restored to the classified service and
20 reinstated to the former job family level and compensation plus any
21 adjustments and increases in salary or benefits which the employee
22 would have received but for the leave of absence.

23 SECTION 3. This act shall become effective July 1, 2020.

SECTION 4. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
