An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; making appropriations to the State Board of Education, the Oklahoma Arts Council, the State Board of Career and Technology Education, the Office of Educational Quality and Accountability, the Oklahoma Educational Television Authority, the Oklahoma State Regents for Higher Education, the Commissioners of the Land Office, the Oklahoma Department of Libraries, the Physician Manpower Training Commission, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Center for the Advancement of Science and Technology, the Office of the State Auditor and Inspector, the State Election Board, the Oklahoma Department of Emergency Management, the Ethics Commission, the Office of the Governor, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Office of Management and Enterprise Services, the Oklahoma Merit Protection Commission, the Military Department of the State of Oklahoma, the Oklahoma State Senate, the Oklahoma Tax Commission, the Office of the State Treasurer, the Oklahoma Space Industry Development Authority, the Department of Transportation, the State Department of Health, the Oklahoma Health Care Authority, the J.D. McCarty Center for Children with Developmental Disabilities, the Department of Mental

1 Health and Substance Abuse Services, the Oklahoma
2 State University Medical Authority, the University
3 Hospitals Authority, the Oklahoma Department of
4 Veterans Affairs, the Oklahoma Commission on Children
5 and Youth, the Office of Disability Concerns, the
6 Department of Human Services, the Office of Juvenile
7 Affairs, the State Department of Rehabilitation
8 Services, the Oklahoma Department of Agriculture,
9 Food, and Forestry, the Oklahoma Department of
10 Commerce, the Rural Economic Action Plan Fund, the
11 Oklahoma Conservation Commission, the Corporation
12 Commission, the Department of Environmental Quality,
13 the Oklahoma Historical Society, the J.M. Davis
14 Memorial Commission, the Department of Labor, the
15 Department of Mines, the Oklahoma Tourism and
16 Recreation Department, the Oklahoma Water Resources
17 Board, the Alcoholic Beverage Laws Enforcement
18 Commission, the Department of Corrections, the
19 Oklahoma State Bureau of Investigation, the Council
20 on Law Enforcement Education and Training, the Board
21 of Medicolegal Investigations, the Oklahoma State
22 Bureau of Narcotics and Dangerous Drugs Control, the
23 Department of Public Safety, the Office of the
24 Attorney General, the Court of Criminal Appeals,
district attorneys and the District Attorneys
Council, the Supreme Court, the Oklahoma Indigent
Defense System, the Pardon and Parole Board, the
Oklahoma Quick Action Closing Fund, The State
Emergency Fund, the Rate Preservation Fund, the
Maintenance of State Buildings Revolving Fund, the
Digital Transformation Program Revolving Fund, and
the Multiple Injury Trust Fund; stating amounts of
the appropriations; stating purposes and
restrictions; reappropriating certain funds;
authorizing certain expenditures; and providing an
effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

SECTION 1. There is hereby appropriated to the State Board of
Education from any monies not otherwise appropriated from the

1 General Revenue Fund of the State Treasury for the fiscal year
2 ending June 30, 2021, the sum of Nine Hundred Fifty-three Million
3 Three Hundred Thirty-eight Thousand Three Hundred Nineteen Dollars
4 .(\$953,338,319.00) or so much thereof as may be necessary for the
5 financial support of public schools.

6 SECTION 2. There is hereby appropriated to the State Board of
7 Education from any monies not otherwise appropriated from the
8 Education Reform Revolving Fund created in Section 34.89 of Title 62
9 of the Oklahoma Statutes, the sum of One Billion Fifteen Million
10 Seventy-four Thousand Four Hundred Nineteen Dollars
11 (\$1,015,074,419.00) or so much thereof as may be necessary for the
12 financial support of public schools.

13 SECTION 3. The State Board of Education is hereby authorized to
14 expend during the fiscal year ending June 30, 2021, from the Common
15 Education Technology Revolving Fund of the State Treasury, the sum
16 of Forty-six Million Nine Hundred Thirty-eight Thousand Five Hundred
17 Sixty-six Dollars (\$46,938,566.00) or so much thereof as may be
18 necessary for the financial support of public schools.

19 SECTION 4. There is hereby appropriated to the State Board of
20 Education from any monies not otherwise appropriated from the
21 Mineral Leasing Fund of the State Treasury for the fiscal year
22 ending June 30, 2021, the sum of Three Million Eight Hundred
23 Thousand Dollars (\$3,800,000.00) or so much thereof as may be
24 necessary for the financial support of public schools.

1 SECTION 5. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 Mineral Leasing Fund of the State Treasury for the fiscal year
4 ending June 30, 2019, the sum of Five Million Four Hundred Eleven
5 Thousand Two Hundred Fifty-eight Dollars (\$5,411,258.00) or so much
6 thereof as may be necessary for the financial support of public
7 schools.

8 SECTION 6. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 Oklahoma Education Lottery Trust Fund of the State Treasury for the
11 fiscal year ending June 30, 2021, the sum of Twenty-three Million
12 Seven Hundred Fifteen Thousand Dollars (\$23,715,000.00) or so much
13 thereof as may be necessary for the financial support of public
14 schools.

15 SECTION 7. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 Oklahoma Education Lottery Trust Fund of the State Treasury for the
18 fiscal year ending June 30, 2019, the sum of Nine Million Twenty-
19 four Thousand Four Hundred Twenty-eight Dollars (\$9,024,428.00) or
20 so much thereof as may be necessary for the financial support of
21 public schools.

22 SECTION 8. There is hereby appropriated to the State Board of
23 Education from any monies not otherwise appropriated from the
24 General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2021, the sum of One Hundred Million Nine Hundred
2 Nineteen Thousand Twenty-six Dollars (\$100,919,026.00) or so much
3 thereof as may be necessary for the support of public schools
4 activities.

5 SECTION 9. There is hereby appropriated to the State Board of
6 Education from any monies not otherwise appropriated from the
7 Revenue Stabilization Fund (105 Fund) of the State Treasury, the sum
8 of Thirty-three Million Dollars (\$33,000,000.00) or so much thereof
9 as may be necessary for the purchase of textbooks and instructional
10 materials.

11 SECTION 10. There is hereby appropriated to the State Board of
12 Education from any monies not otherwise appropriated from the
13 General Revenue Fund of the State Treasury for the fiscal year
14 ending June 30, 2021, the sum of Three Hundred Forty-seven Million
15 Eighty-one Thousand Six Hundred Forty-four Dollars (\$347,081,644.00)
16 or so much thereof as may be necessary for the Certified Employee
17 Health Benefit Allowance.

18 SECTION 11. There is hereby appropriated to the State Board of
19 Education from any monies not otherwise appropriated from the
20 General Revenue Fund of the State Treasury for the fiscal year
21 ending June 30, 2021, the sum of One Hundred Eighty-eight Million
22 Four Hundred Fifty-five Thousand Three Hundred Seventy-seven Dollars
23 (\$188,455,377.00) or so much thereof as may be necessary for the
24 Support Personnel Health Benefit Allowance.

1 SECTION 12. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 General Revenue Fund of the State Treasury for the fiscal year
4 ending June 30, 2019, the sum of Fifteen Million Twenty-seven
5 Thousand Six Hundred Forty Dollars (\$15,027,640.00) or so much
6 thereof as may be necessary for administrative and support functions
7 of the State Department of Education.

8 SECTION 13. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 Oklahoma Education Lottery Trust Fund of the State Treasury for the
11 fiscal year ending June 30, 2021, the sum of Two Million Six Hundred
12 Thirty-five Thousand Dollars (\$2,635,000.00) or so much thereof as
13 may be necessary for transfer to the School Consolidation Assistance
14 Fund.

15 SECTION 14. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 Oklahoma Education Lottery Trust Fund of the State Treasury for the
18 fiscal year ending June 30, 2019, the sum of One Million Two
19 Thousand Seven Hundred Fourteen Dollars (\$1,002,714.00) or so much
20 thereof as may be necessary for transfer to the School Consolidation
21 Assistance Fund.

22 SECTION 15. There is hereby appropriated to the State Board of
23 Education from any monies not otherwise appropriated from the
24 Oklahoma Education Lottery Trust Fund of the State Treasury for the

1 fiscal year ending June 30, 2021, the sum of Two Million Six Hundred
2 Thirty-five Thousand Dollars (\$2,635,000.00) or so much thereof as
3 may be necessary for transfer to the Teachers' Retirement System
4 Dedicated Revenue Revolving Fund.

5 SECTION 16. There is hereby appropriated to the State Board of
6 Education from any monies not otherwise appropriated from the
7 Oklahoma Education Lottery Trust Fund of the State Treasury for the
8 fiscal year ending June 30, 2019, the sum of One Million Two
9 Thousand Seven Hundred Fourteen Dollars (\$1,002,714.00) or so much
10 thereof as may be necessary for transfer to the Teachers' Retirement
11 System Dedicated Revenue Revolving Fund.

12 SECTION 17. There is hereby appropriated to the Oklahoma Arts
13 Council from any monies not otherwise appropriated from the General
14 Revenue Fund of the State Treasury for the fiscal year ending June
15 30, 2021, the sum of Two Million Seven Hundred Ninety-six Thousand
16 Thirty Dollars (\$2,796,030.00) or so much thereof as may be
17 necessary to perform the duties imposed upon the Oklahoma Arts
18 Council by law.

19 SECTION 18. There is hereby appropriated to the State Board of
20 Career and Technology Education from any monies not otherwise
21 appropriated from the General Revenue Fund of the State Treasury for
22 the fiscal year ending June 30, 2021, the sum of One Hundred Thirty-
23 three Million Four Hundred Seventy Thousand Three Hundred Eighty-
24 five Dollars (\$133,470,385.00) or so much thereof as may be

1 necessary to perform the duties imposed upon the State Board of
2 Career and Technology Education by law.

3 SECTION 19. There is hereby appropriated to the State Board of
4 Career and Technology Education from any monies not otherwise
5 appropriated from the Oklahoma Education Lottery Trust Fund of the
6 State Treasury for the fiscal year ending June 30, 2021, the sum of
7 Two Million Eight Hundred Ninety-eight Thousand Five Hundred Dollars
8 (\$2,898,500.00) pursuant to paragraph 2 of subsection F of Section
9 713 of Title 3A of the Oklahoma Statutes for allocation by the State
10 Board of Career and Technology Education for the education and
11 general operating budgets of the institutions and for other
12 programs, construction, renovations or repairs administered by the
13 State Board of Career and Technology Education.

14 SECTION 20. There is hereby appropriated to the State Board of
15 Career and Technology Education from any monies not otherwise
16 appropriated from the Oklahoma Education Lottery Trust Fund of the
17 State Treasury for the fiscal year ending June 30, 2019, the sum of
18 One Million One Hundred Two Thousand Nine Hundred Eighty-six Dollars
19 (\$1,102,986.00) pursuant to paragraph 2 of subsection F of Section
20 713 of Title 3A of the Oklahoma Statutes for allocation by the State
21 Board of Career and Technology Education for the education and
22 general operating budgets of the institutions and for other
23 programs, construction, renovations or repairs administered by the
24 State Board of Career and Technology Education.

1 SECTION 21. There is hereby appropriated to the Office of
2 Educational Quality and Accountability from any monies not otherwise
3 appropriated from the General Revenue Fund of the State Treasury for
4 the fiscal year ending June 30, 2021, the sum of One Million Sixty-
5 seven Thousand Two Hundred Nine Dollars (\$1,067,209.00) or so much
6 thereof as may be necessary to perform the duties imposed upon the
7 Office of Educational Quality and Accountability by law. Of those
8 funds appropriated the sum of Sixty Thousand Dollars (\$60,000.00)
9 shall be deposited in the Teacher Certification Scholarship
10 Revolving Fund created pursuant to Section 6-187C of Title 70 of the
11 Oklahoma Statutes. Of those funds appropriated the sum of One
12 Hundred Eighty Thousand Dollars (\$180,000.00) shall be deposited in
13 the Education Leadership Oklahoma Revolving Fund created pursuant to
14 Section 6-204.3 of Title 70 of the Oklahoma Statutes.

15 SECTION 22. There is hereby appropriated to the Office of
16 Educational Quality and Accountability from any monies not otherwise
17 appropriated from the Special Cash Fund of the State Treasury the
18 sum of Five Hundred Thousand Dollars (\$500,000.00) or so much
19 thereof as may be necessary to perform the duties imposed upon the
20 Office of Educational Quality and Accountability by law.

21 SECTION 23. There is hereby appropriated to the Oklahoma
22 Educational Television Authority from any monies not otherwise
23 appropriated from the General Revenue Fund of the State Treasury for
24 the fiscal year ending June 30, 2021, the sum of Two Million Seven

1 Hundred Twenty-nine Thousand Four Dollars (\$2,729,004.00) or so much
2 thereof as may be necessary to perform the duties imposed upon the
3 Oklahoma Educational Television Authority by law.

4 SECTION 24. There is hereby appropriated to the Oklahoma State
5 Regents for Higher Education from any monies not otherwise
6 appropriated from the General Revenue Fund of the State Treasury for
7 the fiscal year ending June 30, 2021, the sum of Six Hundred Thirty-
8 two Million Five Thousand Three Hundred Sixty Dollars
9 (\$632,005,360.00) or so much thereof as may be necessary for
10 allocation by the Oklahoma State Regents for Higher Education
11 pursuant to the provisions of Article XIII-a of the Oklahoma
12 Constitution for the education and general operating budgets of the
13 institutions and for other programs, construction, renovations or
14 repairs administered by the Oklahoma State Regents for Higher
15 Education. Of those funds appropriated, the sum of Two Million Nine
16 Hundred Ninety-eight Thousand Four Hundred Seventy-four Dollars
17 (\$2,998,474.00) shall be transferred to the Oklahoma Tuition
18 Equalization Grant Trust Fund to implement the provisions of the
19 Oklahoma Tuition Equalization Grant Act.

20 SECTION 25. The Oklahoma State Regents for Higher Education are
21 hereby authorized to expend during the fiscal year ending June 30,
22 2021, the sum of Forty-six Million Nine Hundred Thirty-eight
23 Thousand Five Hundred Sixty-six Dollars (\$46,938,566.00) from the
24 Higher Education Capital Revolving Fund of the State Treasury for

1 allocation by the Oklahoma State Regents for Higher Education
2 pursuant to the provisions of Article XIII-a of the Oklahoma
3 Constitution for the education and general operating budgets of the
4 institutions and for other programs, construction, renovations or
5 repairs administered by the Oklahoma State Regents for Higher
6 Education.

7 SECTION 26. The Oklahoma State Regents for Higher Education are
8 hereby authorized to expend during the fiscal year ending June 30,
9 2021, the sum of Forty-six Million Nine Hundred Thirty-eight
10 Thousand Five Hundred Sixty-six Dollars (\$46,938,566.00) from the
11 Oklahoma Student Aid Revolving Fund of the State Treasury for
12 allocation by the Oklahoma State Regents for Higher Education
13 pursuant to the provisions of Article XIII-a of the Oklahoma
14 Constitution for the education and general operating budgets of the
15 institutions and for other programs, construction, renovations or
16 repairs administered by the Oklahoma State Regents for Higher
17 Education.

18 SECTION 27. There is hereby appropriated to the Oklahoma State
19 Regents for Higher Education from any monies not otherwise
20 appropriated from the General Revenue Fund of the State Treasury for
21 the fiscal year ending June 30, 2021, the sum of Eleven Million
22 Seven Hundred Sixty-four Thousand Eight Hundred Twenty-three Dollars
23 (\$11,764,823.00) or so much thereof as may be necessary for
24

1 expenditures for concurrent enrollment pursuant to Section 628.13 of
2 Title 70 of the Oklahoma Statutes.

3 SECTION 28. There is hereby appropriated to the Oklahoma State
4 Regents for Higher Education from any monies not otherwise
5 appropriated from the Oklahoma Education Lottery Trust Fund of the
6 State Treasury for the fiscal year ending June 30, 2021, the sum of
7 Twenty Million Eight Hundred Sixteen Thousand Five Hundred Dollars
8 (\$20,816,500.00) pursuant to paragraph 2 of subsection F of Section
9 713 of Title 3A of the Oklahoma Statutes for allocation by the
10 Oklahoma State Regents for Higher Education pursuant to the
11 provisions of Article XIII-a of the Oklahoma Constitution for
12 construction, renovations or repairs administered by the Oklahoma
13 State Regents for Higher Education or for any other purpose
14 authorized by paragraph 2 of subsection F of Section 713 of Title 3A
15 of the Oklahoma Statutes.

16 SECTION 29. There is hereby appropriated to the Oklahoma State
17 Regents for Higher Education from any monies not otherwise
18 appropriated from the Oklahoma Education Lottery Trust Fund of the
19 State Treasury for the fiscal year ending June 30, 2019, the sum of
20 Seven Million Nine Hundred Twenty-one Thousand Four Hundred Forty-
21 three Dollars (\$7,921,443.00) pursuant to paragraph 2 of subsection
22 F of Section 713 of Title 3A of the Oklahoma Statutes for allocation
23 by the Oklahoma State Regents for Higher Education pursuant to the
24 provisions of Article XIII-a of the Oklahoma Constitution for

1 construction, renovations or repairs administered by the Oklahoma
2 State Regents for Higher Education or for any other purpose
3 authorized by paragraph 2 of subsection F of Section 713 of Title 3A
4 of the Oklahoma Statutes.

5 SECTION 30. There is hereby appropriated to the Oklahoma State
6 Regents for Higher Education from any monies not otherwise
7 appropriated from the General Revenue Fund of the State Treasury for
8 the fiscal year ending June 30, 2021, the sum of Four Million
9 Twenty-nine Thousand Four Hundred Eighty-four Dollars
10 (\$4,029,484.00) or so much thereof as may be necessary for the
11 general operating budget of the Administrative Offices of the
12 Oklahoma State Regents for Higher Education.

13 SECTION 31. There is hereby appropriated to the Commissioners
14 of the Land Office from any monies not otherwise appropriated from
15 the Commissioners of the Land Office Fund of the State Treasury for
16 the fiscal year ending June 30, 2021, the sum of Eight Million Three
17 Hundred Seventy-nine Thousand Two Hundred Seventy-six Dollars
18 (\$8,379,276.00) or so much thereof as may be necessary to perform
19 the duties imposed upon the Commissioners of the Land Office by law.

20 SECTION 32. There is hereby appropriated to the Oklahoma
21 Department of Libraries from any monies not otherwise appropriated
22 from the General Revenue Fund of the State Treasury for the fiscal
23 year ending June 30, 2021, the sum of Four Million Three Hundred
24 Forty-six Thousand Three Hundred Fifteen Dollars (\$4,346,315.00) or

1 so much thereof as may be necessary to perform the duties imposed
2 upon the Oklahoma Department of Libraries by law.

3 SECTION 33. There is hereby appropriated to the Physician
4 Manpower Training Commission from any monies not otherwise
5 appropriated from the General Revenue Fund of the State Treasury for
6 the fiscal year ending June 30, 2021, the sum of Six Million Five
7 Hundred Forty-six Thousand Eight Hundred Seventy-seven Dollars
8 (\$6,546,877.00) or so much thereof as may be necessary to perform
9 the duties imposed upon the Physician Manpower Training Commission
10 by law.

11 SECTION 34. There is hereby appropriated to the Physician
12 Manpower Training Commission from any monies not otherwise
13 appropriated from the Special Cash Fund of the State Treasury the
14 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much
15 thereof as may be necessary to perform the duties imposed upon the
16 Physician Manpower Training Commission by law.

17 SECTION 35. There is hereby appropriated to the Board of
18 Trustees of the Oklahoma School of Science and Mathematics from any
19 monies not otherwise appropriated from the General Revenue Fund of
20 the State Treasury for the fiscal year ending June 30, 2021, the sum
21 of Six Million Thirty-three Thousand Three Hundred Seventy-three
22 Dollars (\$6,033,373.00) or so much thereof as may be necessary to
23 perform the duties imposed upon the Board of Trustees of the
24 Oklahoma School of Science and Mathematics by law.

1 SECTION 36. There is hereby appropriated to the Oklahoma Center
2 for the Advancement of Science and Technology from any monies not
3 otherwise appropriated from the General Revenue Fund of the State
4 Treasury for the fiscal year ending June 30, 2021, the sum of
5 Thirteen Million Seven Hundred Ninety-six Thousand Five Hundred
6 Forty-two Dollars (\$13,796,542.00) or so much thereof as may be
7 necessary to perform the duties imposed upon the Oklahoma Center for
8 the Advancement of Science and Technology by law. Of those funds
9 appropriated, the sum of Five Million Five Hundred Eighteen Thousand
10 Six Hundred Seventeen Dollars (\$5,518,617.00) shall be deposited in
11 the Research Support Revolving Fund, created pursuant to Section
12 5060.11 of Title 74 of the Oklahoma Statutes. Of those funds
13 appropriated, the sum of Three Million Thirty-five Thousand Two
14 Hundred Thirty-nine Dollars (\$3,035,239.00) shall be deposited in
15 the Seed-Capital Revolving Fund, created pursuant to Section 5060.21
16 of Title 74 of the Oklahoma Statutes.

17 GENERAL GOVERNMENT AND TRANSPORTATION

18 SECTION 37. There is hereby appropriated to the Office of the
19 State Auditor and Inspector from any monies not otherwise
20 appropriated from the General Revenue Fund of the State Treasury for
21 the fiscal year ending June 30, 2019, the sum of Four Million
22 Eighty-six Thousand Sixteen Dollars (\$4,086,016.00) or so much
23 thereof as may be necessary to perform the duties imposed upon the
24 Office of the State Auditor and Inspector by law.

1 SECTION 38. There is hereby appropriated to the Office of the
2 State Auditor and Inspector from any monies not otherwise
3 appropriated from the General Revenue Fund of the State Treasury for
4 the fiscal year ending June 30, 2021, the sum of Two Hundred
5 Fourteen Thousand Two Hundred Ninety-nine Dollars (\$214,299.00) or
6 so much thereof as may be necessary to perform the duties imposed
7 upon the Commission on County Government Personnel Education and
8 Training. The appropriation made in this section shall be expended
9 exclusively for the purpose so stated and shall not be transferable.

10 SECTION 39. There is hereby appropriated to the State Election
11 Board from any monies not otherwise appropriated from the General
12 Revenue Fund of the State Treasury for the fiscal year ending June
13 30, 2019, the sum of Nine Million Seven Hundred Thirty-seven
14 Thousand Six Hundred Seventeen Dollars (\$9,737,617.00) or so much
15 thereof as may be necessary to perform the duties imposed upon the
16 State Election Board by law.

17 SECTION 40. There is hereby appropriated to the Oklahoma
18 Department of Emergency Management from any monies not otherwise
19 appropriated from the General Revenue Fund of the State Treasury for
20 the fiscal year ending June 30, 2021, the sum of Five Hundred Five
21 Thousand Eight Hundred Fifty-nine Dollars (\$505,859.00) or so much
22 thereof as may be necessary to perform the duties imposed upon the
23 Oklahoma Department of Emergency Management by law.

1 SECTION 41. There is hereby appropriated to the Ethics
2 Commission from any monies not otherwise appropriated from the
3 General Revenue Fund of the State Treasury for the fiscal year
4 ending June 30, 2021, the sum of Six Hundred Eighty-seven Thousand
5 Nine Hundred Fifty-seven Dollars (\$687,957.00) or so much thereof as
6 may be necessary to perform the duties imposed upon the Ethics
7 Commission by law.

8 SECTION 42. There is hereby appropriated to the Office of the
9 Governor from any monies not otherwise appropriated from the General
10 Revenue Fund of the State Treasury for the fiscal year ending June
