23 SECTION 1. There is hereby appropriated to the State Board of

24 Education from any monies not otherwise appropriated from the

General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Nine Hundred Fifty-three Million Three Hundred Thirty-eight Thousand Three Hundred Nineteen Dollars (\$953,338,319.00) or so much thereof as may be necessary for the financial support of public schools.

6 SECTION 2. There is hereby appropriated to the State Board of 7 Education from any monies not otherwise appropriated from the 8 Education Reform Revolving Fund created in Section 34.89 of Title 62 9 of the Oklahoma Statutes, the sum of One Billion Fifteen Million 10 Seventy-four Thousand Four Hundred Nineteen Dollars 11 (\$1,015,074,419.00) or so much thereof as may be necessary for the

12 | financial support of public schools.

SECTION 3. The State Board of Education is hereby authorized to expend during the fiscal year ending June 30, 2021, from the Common Education Technology Revolving Fund of the State Treasury, the sum of Forty-six Million Nine Hundred Thirty-eight Thousand Five Hundred Sixty-six Dollars (\$46,938,566.00) or so much thereof as may be necessary for the financial support of public schools.

19 SECTION 4. There is hereby appropriated to the State Board of 20 Education from any monies not otherwise appropriated from the 21 Mineral Leasing Fund of the State Treasury for the fiscal year 22 ending June 30, 2021, the sum of Three Million Eight Hundred 23 Thousand Dollars (\$3,800,000.00) or so much thereof as may be 24 necessary for the financial support of public schools.

SECTION 5. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Five Million Four Hundred Eleven Thousand Two Hundred Fifty-eight Dollars (\$5,411,258.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 12. SECTION 20. There is hereby appropriated to the State Board of 14 Career and Technology Education from any monies not otherwise 15 16 appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of 17 One Million One Hundred Two Thousand Nine Hundred Eighty-six Dollars 18 (\$1,102,986.00) pursuant to paragraph 2 of subsection F of Section 19 713 of Title 3A of the Oklahoma Statutes for allocation by the State 20 Board of Career and Technology Education for the education and 21 general operating budgets of the institutions and for other 22 programs, construction, renovations or repairs administered by the 23 State Board of Career and Technology Education. 24

1 SECTION 21. There is hereby appropriated to the Office of 2 Educational Quality and Accountability from any monies not otherwise 3 appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of One Million Sixty-4 5 seven Thousand Two Hundred Nine Dollars (\$1,067,209.00) or so much thereof as may be necessary to perform the duties imposed upon the 6 7 Office of Educational Quality and Accountability by law. Of those funds appropriated the sum of Sixty Thousand Dollars (\$60,000.00) 8 9 shall be deposited in the Teacher Certification Scholarship 10 Revolving Fund created pursuant to Section 6-187C of Title 70 of the 11 Oklahoma Statutes. Of those funds appropriated the sum of One Hundred Eighty Thousand Dollars (\$180,000.00) shall be deposited in 12 13 the Education Leadership Oklahoma Revolving Fund created pursuant to Section 6-204.3 of Title 70 of the Oklahoma Statutes. 14

15 SECTION 22. There is hereby appropriated to the Oklahoma State 4 5 Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for 6 the fiscal year ending June 30, 2021, the sum of Six Hundred Thirty-7 two Million Five Thousand Three Hundred Sixty Dollars 8 9 (\$632,005,360.00) or so much thereof as may be necessary for 10 allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-a of the Oklahoma 11 12 Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or 13 repairs administered by the Oklahoma State Regents for Higher 14 Education. Of those funds appropriated, the sum of Two Million Nine 15 Hundred Ninety-eight Thousand Four Hundred Seventy-four Dollars 16 17 (\$2,998,474.00) shall be transferred to the Oklahoma Tuition Equalization Grant Trust Fund to implement the provisions of the 18 Oklahoma Tuition Equalization Grant Act. 19

20 SECTION 25. The Oklahoma State Regents for Higher Education are 21 hereby authorized to expend during the fiscal year ending June 30, 22 2021, the sum of Forty-six Million Nine Hundred Thirty-eight 23 Thousand Five Hundred Sixty-six Dollars (\$46,938,566.00) from the 24 Higher Education Capital Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education
 pursuant to the provisions of Article XIII-a of the Oklahoma
 Constitution for the education and general operating budgets of the
 institutions and for other programs, construction, renovations or
 repairs administered by the Oklahoma State Regents for Higher
 Education.
