9 An Act relating to the Department of Public Safety;
10 amending 74 O.S. 2011, Section 840-5.5, as last
11 amended by Section 2, Chapter 222, O.S.L. 2018 (74
12 O.S. Supp. 2018, Section 840-5.5), which relates to
13 unclassified service positions and personnel;
14 modifying included positions; and providing an
15 effective date.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. AMENDATORY 74 O.S. 2011, Section 840-5.5, as
18 last amended by Section 2, Chapter 222, O.S.L. 2018 (74 O.S. Supp.
19 2018, Section 840-5.5), is amended to read as follows:

20 Section 840-5.5. A. The following offices, positions, and
21 personnel shall be in the unclassified service and shall not be
22 placed under the classified service:

23 1. Persons chosen by popular vote or appointment to fill an
24 elective office, and their employees, except the employees of the

1 Corporation Commission, the State Department of Education and the
2 Department of Labor;

3 2. Members of boards and commissions, and heads of agencies;
4 also one principal assistant or deputy and one executive secretary
5 for each state agency;

6 3. All judges, elected or appointed, and their employees;

7 4. Persons employed with one-time, limited duration, federal or
8 other grant funding that is not continuing or indefinitely
9 renewable. The length of the unclassified employment shall not
10 exceed the period of time for which that specific federal funding is
11 provided;

12 5. All officers and employees of The Oklahoma State System of
13 Higher Education, State Board of Education and Oklahoma Department
14 of Career and Technology Education;

15 6. Persons employed in a professional or scientific capacity to
16 make or conduct a temporary and special inquiry, investigation, or
17 examination on behalf of the Legislature or a committee thereof or
18 by authority of the Governor. These appointments and authorizations
19 shall terminate on the first day of the regular legislative session
20 immediately following the appointment, if not terminated earlier.
21 However, nothing in this paragraph shall prevent the reauthorization
22 and reappointment of any such person. Any such appointment shall be
23 funded from the budget of the appointing authority;

24 7. Election officials and employees;

1 8. Temporary employees employed to work less than one thousand
2 (1,000) hours in any twelve-month period, and seasonal employees
3 employed by the Oklahoma Tourism and Recreation Department pursuant
4 to Section 2241 of this title who work less than one thousand six
5 hundred (1,600) hours in any twelve-month period;

6 9. Department of Public Safety employees occupying the
7 following offices or positions:

- 8 a. administrative aides to the Commissioner,
- 9 b. executive secretaries to the Commissioner,
- 10 c. the Governor's representative of the Oklahoma Highway
11 Safety Office who shall be appointed by the Governor,
- 12 d. Highway Patrol Colonel,
- 13 e. Highway Patrol Lieutenant Colonel,
- 14 f. Highway Patrol Major,
- 15 g. Director of Finance,
- 16 ~~g.~~
- 17 h. noncommissioned pilots,
- 18 ~~h.~~
- 19 i. Information Systems Administrator,
- 20 ~~i.~~
- 21 j. Law Enforcement Telecommunications System Specialist,

2 authorization for such positions shall be terminated
3 if the federal funding for positions is discontinued;
4 provided, any person appointed to a position prescribed in
5 subparagraph ~~d or~~, e or f of this paragraph shall have a right of
6 return to the classified commissioned position without any loss of
7 rights, privileges or benefits immediately upon completion of the
8 duties in the unclassified commissioned position;

9 10. Professional trainees only during the prescribed length of
10 their course of training or extension study;

11 11. Students who are employed on a part-time basis, which shall
12 be seventy-five percent (75%) of a normal forty-hour work week or
13 thirty (30) hours per week, or less, or on a full-time basis if the
14 employment is pursuant to a cooperative education program such as
15 that provided for under Title I IV-D of the Higher Education Act of
16 1965 (20 U.S.C. 1087a-1087c), as amended, and who are regularly
17 enrolled in:

18 a. an institution of higher learning within The Oklahoma
19 State System of Higher Education,

20 b. an institution of higher learning qualified to become
21 coordinated with The Oklahoma State System of Higher
22 Education. For purposes of this section, a student
23 shall be considered a regularly enrolled student if
24 the student is enrolled in a minimum of five (5) hours

1 of accredited graduate courses or a minimum of ten
2 (10) hours of accredited undergraduate courses;
3 provided, however, the student shall only be required
4 to be enrolled in a minimum of six (6) hours of
5 accredited undergraduate courses during the summer, or
6 c. high school students regularly enrolled in a high
7 school in Oklahoma and regularly attending classes
8 during such time of enrollment;

9 12. The spouses of personnel who are employed on a part-time
10 basis to assist or work as a relief for their spouses in the
11 Oklahoma Tourism and Recreation Department;

12 13. Service substitute attendants who are needed to replace
13 museum and site attendants who are unavoidably absent. Service
14 substitutes may work as part-time or full-time relief for absentees
15 for a period of not more than four (4) weeks per year in the
16 Oklahoma Historical Society sites and museums; such substitutes will
17 not count towards the agency's full-time-equivalent (FTE) employee
18 limit;

19 14. Employees of the Oklahoma House of Representatives, the
20 State Senate, or the Legislative Service Bureau;

21 15. Corporation Commission personnel occupying the following
22 offices and positions:

23 a. Administrative aides, and executive secretaries to the
24 Commissioners,

- b. Directors of all the divisions, personnel managers and comptrollers,
- c. General Counsel,
- d. Public Utility Division Chief Engineer,
- e. Public Utility Division Chief Accountant,

24 law on an agency. Permanent classified employees may request a

1 leave of absence from classified status and accept an unclassified
2 appointment and compensation as an acting incumbent with the same
3 agency; provided, the leave shall expire no later than two (2) years
4 from the date of the acting incumbent appointment. An appointing
5 authority may establish unclassified positions and appoint
6 unclassified employees to perform the duties of a permanent
7 classified employee who is on leave of absence from a classified
8 position to serve as an acting incumbent. All unclassified
9 appointments created pursuant to this paragraph shall expire no
10 later than two (2) years from the date of appointment. Classified
11 employees accepting unclassified appointments and compensation
12 pursuant to this paragraph shall be entitled to participate without
13 interruption in any benefit programs available to classified
14 employees, including retirement and insurance programs. Immediately
15 upon termination of an unclassified appointment pursuant to this
16 paragraph, an employee on assignment from the classified service
17 shall have a right to be restored to the classified service and
18 reinstated to the former job family level and compensation plus any
19 adjustments and increases in salary or benefits which the employee
20 would have received but for the leave of absence;

21 50. The Oklahoma Homeland Security Director and all other
22 positions assigned the responsibilities of working in the Oklahoma
23 Office of Homeland Security;

1 51. The following eighteen positions in the State Department of
2 Health:

- 3 a. one surveillance supervisor,

1 B. If an agency has the authority to employ personnel in the
2 following offices and positions, the appointing authority shall have
3 the discretion to appoint personnel to the unclassified service:

4 1. Licensed medical doctors, osteopathic physicians, dentists,
5 psychologists, and nurses;

6 2. Certified public accountants;

7 3. Licensed attorneys;

8 4. Licensed veterinarians; and

9 5. Licensed pharmacists.

10 C. Effective July 1, 1996, authorization for unclassified
11 offices, positions, or personnel contained in a bill or joint
12 resolution shall terminate June 30 of the ensuing fiscal year after
13 the authorization unless the authorization is codified in the
14 Oklahoma Statutes or the termination is otherwise provided in the
15 legislation.

16 D. The appointing authority of agencies participating in the
17 statewide information systems project may establish unclassified
18 positions and appoint unclassified employees to the project as
19 needed. Additional unclassified positions may be established, if
20 required, to appoint an unclassified employee to perform the duties
21 of a permanent classified employee who is temporarily absent from a
22 classified position as a result of assignment to this project. All
23 unclassified appointments under this authority shall expire no later
24 than December 31, 2007, and all unclassified positions established

1 to support the project shall be abolished. Both the positions and
2 appointments resulting from this authority shall be exempt from any
3 agency FTE limitations and any limits imposed on the number of
4 unclassified positions authorized. Permanent classified employees
5 may request a leave of absence from classified status and accept an
6 unclassified appointment and compensation with the same agency under
7 the provisions of this subsection; provided, the leave shall expire
8 no later than December 31, 2007. Employees accepting the
9 appointment and compensation shall be entitled to participate
10 without interruption in any benefit programs available to classified
11 employees, including retirement and insurance programs. Immediately
12 upon termination of an unclassified appointment pursuant to this
13 subsection, an employee on assignment from the classified service
14 shall have a right to be restored to the classified service and
15 reinstated to the former job family level and compensation plus any
16 adjustments and increases in salary or benefits which the employee
17 would have received but for the leave of absence.

18 SECTION 2. This act shall become effective November 1, 2019.
