10 COMMITTEE SUBSTITUTE

11 An Act relating to law enforcement protective
12 services; amending 43A O.S. 2011, Section 1-110, as
13 last amended by Section 1, Chapter 374, O.S.L. 2016
14 (43A O.S. Supp. 2018, Section 1-110), which relates
15 to law enforcement responsibilities for transporting
16 persons for mental health services; clarifying
17 responsibilities of counties and municipalities;
18 providing definition; and providing an effective
19 date.

20 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

21 SECTION 1. AMENDATORY 43A O.S. 2011, Section 1-110, as
22 last amended by Section 1, Chapter 374, O.S.L. 2016 (43A O.S. Supp.
23 2018, Section 1-110), is amended to read as follows:

24 Section 1-110. A. Sheriffs and peace officers shall be
 responsible for transporting individuals to and from designated

1 sites or facilities for the purpose of examination, emergency
2 detention, protective custody and inpatient services.

3 B. A municipal law enforcement agency shall be responsible for
4 transportation of any individual ~~found~~ initially contacted by the
5 municipal law enforcement agency within such municipality's

6 jurisdiction. The county sheriff shall be responsible for
7 transportation of any individual ~~found~~ initially contacted by the
8 county law enforcement agency outside of a municipality's

9 jurisdiction, but within the county. For purposes of this section,
10 "initially contacted" shall include, but not be limited to, contact
11 made by a law enforcement officer, either in person or by electronic
12 or telephone communication.

13 C. The law enforcement agency transporting an individual to and
14 from designated sites or facilities pursuant to the provisions of
15 this section shall maintain responsibility for the transportation of
16 such individual pending completion of the examination, emergency
17 detention, protective custody and inpatient services.

18 D. Sheriffs and peace officers shall be entitled to
19 reimbursement from the Department of Mental Health and Substance
20 Abuse Services for transportation services associated with minors or
21 adults requiring examination, emergency detention, protective
22 custody and inpatient services.

23 E. Any transportation provided by a sheriff or deputy sheriff
24 or a peace officer on behalf of any county, city, town or

1 municipality of this state, to or from any facility for the purpose
2 of examination, admission, interfacility transfer, medical treatment
3 or court appearance shall be reimbursed in accordance with the
4 provisions of the State Travel Reimbursement Act.

5 F. Nothing in this section shall prohibit a law enforcement
6 agency from entering into a lawful agreement with any other law
7 enforcement agency to fulfill the requirements established by this
8 section or from contracting with a third party to provide the
9 services established by this section provided the third party meets
10 minimum standards as determined by the Department. Standards
11 determined by the Department shall not exceed the standards required
12 by law enforcement.

13 G. A law enforcement agency shall not be liable for the actions
14 of a peace officer commissioned by the agency when such officer is
15 providing services as a third party pursuant to subsection F of this
16 section outside his or her primary employment as a peace officer.

17 SECTION 2. This act shall become effective November 1, 2019.
