11 An Act relating to the Oklahoma Department of
12 Corrections; amending 57 O.S. 2011, Section 509, as
13 last amended by Section 2, Chapter 259, O.S.L. 2016
14 (57 O.S. Supp. 2018, Section 509), which relates to
15 penal institutions; modifying name of facility; and
16 providing an effective date.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. AMENDATORY 57 O.S. 2011, Section 509, as last
18 amended by Section 2, Chapter 259, O.S.L. 2016 (57 O.S. Supp. 2018,
19 Section 509), is amended to read as follows:

20 Section 509. The Oklahoma State Penitentiary shall be located
21 at McAlester in Pittsburg County, State of Oklahoma; and the
22 Oklahoma State Reformatory shall be located at Granite in Greer
23 County, State of Oklahoma; and the Lexington Assessment and
24 Reception Center shall be located at Lexington in Cleveland County,

1 State of Oklahoma; and the Jackie Brannon Correctional Center shall
2 be located at McAlester in Pittsburg County, State of Oklahoma; and
3 the Joseph Harp Correctional Center shall be located at Lexington in
4 Cleveland County, State of Oklahoma; and the Howard C. McLeod
5 Correctional Center shall be located at Farris in Atoka County,
6 State of Oklahoma; and the Mack H. Alford Correctional Center shall
7 be located at Stringtown in Atoka County, State of Oklahoma; and the
8 Jim E. Hamilton Correctional Center shall be located at Hodgen in
9 LeFlore County, State of Oklahoma; and the Mabel Bassett
10 Correctional Center shall be located at McLoud, in Pottawatomie
11 County, State of Oklahoma; and the R.B. "Dick" Conner Correctional
12 Center shall be located at Hominy in Osage County, State of
13 Oklahoma; and the James Crabtree Correctional Center shall be
14 located at Helena in Alfalfa County, State of Oklahoma; and the Jess
15 Dunn Correctional Center shall be located at Taft in Muskogee
16 County, State of Oklahoma; and the Northeast Oklahoma Correctional
17 Center shall be located at Vinita in Craig County, State of
18 Oklahoma; and the John Lilley Correctional Center shall be located
19 at Boley in Okfuskee County, State of Oklahoma; and the William S.
20 Key Correctional Center shall be located at Fort Supply in Woodward
21 County, State of Oklahoma; and the Dr. Eddie Walter Warrior
22 Correctional Center shall be located at Taft in Muskogee County,
23 State of Oklahoma; and the Clara Waters and Kate Barnard Community
24 Corrections Centers shall be located at Oklahoma City in Oklahoma

1 County, State of Oklahoma; and the Lawton Community Corrections
2 Center shall be located at Lawton in Comanche County, State of
3 Oklahoma; and the Enid Community Corrections Center shall be located
4 at Enid in Garfield County, State of Oklahoma; and the Union City
5 Community Corrections Center shall be located at Union City in
6 Canadian County, State of Oklahoma; and the Charles E. "Bill"
7 Johnson Correctional Center shall be located east of Alva in Woods
8 County, State of Oklahoma; and the ~~Southern Oklahoma Resource Center~~
9 Washita Valley Correctional Center shall be located at Pauls Valley
10 in Garvin County, State of Oklahoma; and said institutions and
11 community corrections centers are hereby established within the
12 Department. Said Department shall be the legal successor of and,
13 except as otherwise provided in the Oklahoma Corrections Act of
14 1967, shall have the powers and duties vested by law in the Office
15 of Management and Enterprise Services in all matters relating to
16 penal institutions, heretofore or hereafter established by the
17 Department, which institutions and community corrections centers
18 shall be under the administrative direction and control of the
19 Department.

20 SECTION 2. This act shall become effective November 1, 2019.
