BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 68 O.S. 2011, Section 227, as last amended by Section 1, Chapter 358, O.S.L. 2016 (68 O.S. Supp. 2019, Section 227), is amended to read as follows:

Section 227. ~~(a) Any~~ A. Except as provided in subsection B of Section 1361.2 of this title, any taxpayer who has paid to the State of Oklahoma, through error of fact, or computation, or misinterpretation of law, any tax collected by the Tax Commission may, as hereinafter provided, be refunded the amount of such tax so erroneously paid, without interest.

~~(b) — (1)~~ B. 1. Except as otherwise provided by ~~division (2)~~
paragraph 2 of this subsection, any taxpayer who has so paid any
such tax may, within three (3) years from the date of payment
thereof file with the Tax Commission a verified claim for refund of

1 such tax so erroneously paid. The Tax Commission may accept an
2 amended withholding tax or other report or return as a verified
3 claim for refund if the amended report or return establishes a
4 liability less than the original report or return previously filed.

5 ~~(2)~~ 2. Upon ~~the effective date of this act~~ August 26, 2016,
6 with respect to the sales tax imposed by Section 1354 of this title
7 and with respect to the use tax imposed by Section 1402 of this
8 title, any taxpayer who has so paid such sales or use tax may,
9 within two (2) years from the date of payment thereof file with the
10 Tax Commission a verified claim for refund of such tax so
11 erroneously paid. The Tax Commission may accept an amended sales or
12 use tax report or return as a verified claim for refund if the
13 amended report or return establishes a liability less than the
14 original report or return previously filed.

15 ~~(c)~~ Said C. The claim so filed with the Tax Commission, except
16 for an amended report or return, shall specify the name of the
17 taxpayer, the time when and period for which ~~said~~ the tax was paid,
18 the nature and kind of tax so paid, the amount of the tax which ~~said~~
19 the taxpayer claimed was erroneously paid, the grounds upon which a
20 refund is sought, and such other information or data relative to
21 such payment as may be necessary to an adjustment thereof by the Tax
22 Commission. It shall be the duty of the Commission to determine
23 what amount of refund, if any, is due as soon as practicable after
24 such claim has been filed and advise the taxpayer about the

1 correctness of his claim and the claim for refund shall be approved
2 or denied by written notice to the taxpayer.

3 ~~(d)~~ D. If the claim for refund is denied, the taxpayer may file
4 a demand for hearing with the Commission. The demand for hearing
5 must be filed on or before the sixtieth day after the date the
6 notice of denial was mailed. If the taxpayer fails to file a demand
7 for hearing, the claim for refund shall be barred.

8 ~~(e)~~ E. Upon the taxpayer's timely filing of a demand for
9 hearing, the Commission shall set a date for hearing upon the claim
10 for refund which date shall not be later than sixty (60) days from
11 the date the demand for hearing was mailed. The taxpayer shall be
12 notified of the time and place of the hearing. The hearing may be
13 held after the sixty-day period provided by this subsection upon
14 agreement of the taxpayer.

15 ~~(f)~~ F. The provisions of this section shall not apply: ~~(1) to~~

16 1. To refunds of income tax erroneously paid, refunds of which
17 tax shall be payable out of the income tax adjustment fund as
18 provided by law; ~~(2) to~~

19 2. To estate tax because the payment of such tax is covered by
20 an order of the Tax Commission and the estate and interested parties
21 are given notice that Commission's position and computation of the
22 tax will become final unless they protest and resist the payment
23 thereof as provided by statute; nor, ~~(3) in~~

1 3. In any case where the tax was paid after an assessment
2 thereof was made by the Tax Commission which assessment became final
3 under the law.

4 SECTION 2. AMENDATORY 68 O.S. 2011, Section 1361.2, is
5 amended to read as follows:

6 Section 1361.2. A. In order to claim the exemption authorized
7 by paragraph 34 of Section 1357 of ~~Title 68 of the Oklahoma Statutes~~
8 this title, the person to whom the sale is made shall be required to
9 furnish the vendor proof of eligibility for the exemption as issued
10 by the Oklahoma Tax Commission. All vendors shall honor the proof
11 of eligibility for sales tax exemption and sales for the benefit of
12 the disabled veteran to a person providing such proof shall be
13 exempt from the tax levied pursuant to the Oklahoma Sales Tax Code.

14 B. A claim for refund of sales taxes erroneously paid may only
15 be made if a vendor refuses to honor the proof of eligibility issued
16 by the Tax Commission for the exemption authorized pursuant to
17 paragraph 34 of Section 1357 of this title and the person eligible
18 for the exemption submits to the Tax Commission a signed
19 notification of the vendor's denial of exemption on a form
20 prescribed by the Commission.

21 SECTION 3. This act shall become effective November 1, 2020.
