SENATE BILL NO. 403

[ Department of Public Safety - unclassified service  
positions and personnel - positions - effective date ]

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 74 O.S. 2011, Section 840-5.5, as last amended by Section 2, Chapter 222, O.S.L. 2018 (74 O.S. Supp. 2018, Section 840-5.5), is amended to read as follows:

Section 840-5.5. A. The following offices, positions, and personnel shall be in the unclassified service and shall not be placed under the classified service:

1. Persons chosen by popular vote or appointment to fill an elective office, and their employees, except the employees of the Corporation Commission, the State Department of Education and the Department of Labor;

2. Members of boards and commissions, and heads of agencies;  
also one principal assistant or deputy and one executive secretary  
for each state agency;

3. All judges, elected or appointed, and their employees;

1       4. Persons employed with one-time, limited duration, federal or  
2 other grant funding that is not continuing or indefinitely  
3 renewable. The length of the unclassified employment shall not  
4 exceed the period of time for which that specific federal funding is  
5 provided;

6       5. All officers and employees of The Oklahoma State System of  
7 Higher Education, State Board of Education and Oklahoma Department  
8 of Career and Technology Education;

9       6. Persons employed in a professional or scientific capacity to  
10 make or conduct a temporary and special inquiry, investigation, or  
11 examination on behalf of the Legislature or a committee thereof or  
12 by authority of the Governor. These appointments and authorizations  
13 shall terminate on the first day of the regular legislative session  
14 immediately following the appointment, if not terminated earlier.  
15 However, nothing in this paragraph shall prevent the reauthorization  
16 and reappointment of any such person. Any such appointment shall be  
17 funded from the budget of the appointing authority;

18       7. Election officials and employees;

19       8. Temporary employees employed to work less than one thousand  
20 (1,000) hours in any twelve-month period, and seasonal employees  
21 employed by the Oklahoma Tourism and Recreation Department pursuant  
22 to Section 2241 of this title who work less than one thousand six  
23 hundred (1,600) hours in any twelve-month period;

2 rights, privileges or benefits immediately upon completion of the  
3 duties in the unclassified commissioned position;

4 10. Professional trainees only during the prescribed length of  
5 their course of training or extension study;

6 11. Students who are employed on a part-time basis, which shall  
7 be seventy-five percent (75%) of a normal forty-hour work week or  
8 thirty (30) hours per week, or less, or on a full-time basis if the  
9 employment is pursuant to a cooperative education program such as  
10 that provided for under Title I IV-D of the Higher Education Act of  
11 1965 (20 U.S.C. 1087a-1087c), as amended, and who are regularly  
12 enrolled in:

13 a. an institution of higher learning within The Oklahoma  
14 State System of Higher Education,

15 b. an institution of higher learning qualified to become  
16 coordinated with The Oklahoma State System of Higher  
17 Education. For purposes of this section, a student  
18 shall be considered a regularly enrolled student if  
19 the student is enrolled in a minimum of five (5) hours  
20 of accredited graduate courses or a minimum of ten  
21 (10) hours of accredited undergraduate courses;  
22 provided, however, the student shall only be required  
23 to be enrolled in a minimum of six (6) hours of  
24 accredited undergraduate courses during the summer, or

1           c.    high school students regularly enrolled in a high  
2                school in Oklahoma and regularly attending classes  
3                during such time of enrollment;

4       12.   The spouses of personnel who are employed on a part-time  
5 basis to assist or work as a relief for their spouses in the  
6 Oklahoma Tourism and Recreation Department;

7       13.   Service substitute attendants who are needed to replace  
8 museum and site attendants who are unavoidably absent. Service  
9 substitutes may work as part-time or full-time relief for absentees  
10 for a period of not more than four (4) weeks per year in the  
11 Oklahoma Historical Society sites and museums; such substitutes will  
12 not count towards the agency's full-time-equivalent (FTE) employee  
13 limit;

2 position to serve as an acting incumbent. All unclassified  
3 appointments created pursuant to this paragraph shall expire no  
4 later than two (2) years from the date of appointment. Classified  
5 employees accepting unclassified appointments and compensation  
6 pursuant to this paragraph shall be entitled to participate without  
7 interruption in any benefit programs available to classified  
8 employees, including retirement and insurance programs. Immediately  
9 upon termination of an unclassified appointment pursuant to this  
10 paragraph, an employee on assignment from the classified service  
11 shall have a right to be restored to the classified service and  
12 reinstated to the former job family level and compensation plus any  
13 adjustments and increases in salary or benefits which the employee  
14 would have received but for the leave of absence;

18        B. If an agency has the authority to employ personnel in the

22 psychologists, and nurses;
- 23           2. Certified public accountants;
- 24           3. Licensed attorneys;

1       4. Licensed veterinarians; and

2       5. Licensed pharmacists.

3       C. Effective July 1, 1996, authorization for unclassified  
4 offices, positions, or personnel contained in a bill or joint  
5 resolution shall terminate June 30 of the ensuing fiscal year after  
6 the authorization unless the authorization is codified in the  
7 Oklahoma Statutes or the termination is otherwise provided in the  
8 legislation.

9       D. The appointing authority of agencies participating in the  
10 statewide information systems project may establish unclassified  
11 positions and appoint unclassified employees to the project as  
12 needed. Additional unclassified positions may be established, if  
13 required, to appoint an unclassified employee to perform the duties  
14 of a permanent classified employee who is temporarily absent from a  
15 classified position as a result of assignment to this project. All  
16 unclassified appointments under this authority shall expire no later  
17 than December 31, 2007, and all unclassified positions established  
18 to support the project shall be abolished. Both the positions and  
19 appointments resulting from this authority shall be exempt from any  
20 agency FTE limitations and any limits imposed on the number of  
21 unclassified positions authorized. Permanent classified employees  
22 may request a leave of absence from classified status and accept an  
23 unclassified appointment and compensation with the same agency under  
24 the provisions of this subsection; provided, the leave shall expire

1 no later than December 31, 2007. Employees accepting the  
2 appointment and compensation shall be entitled to participate  
3 without interruption in any benefit programs available to classified  
4 employees, including retirement and insurance programs. Immediately  
5 upon termination of an unclassified appointment pursuant to this  
6 subsection, an employee on assignment from the classified service  
7 shall have a right to be restored to the classified service and  
8 reinstated to the former job family level and compensation plus any  
9 adjustments and increases in salary or benefits which the employee  
10 would have received but for the leave of absence.

11 SECTION 2. This act shall become effective November 1, 2019.
