15	SECTION 1. AMENDATORY 74 O.S. 2011, Section 85.3A, as
16	last amended by Section 9, Chapter 269, O.S.L. 2016 (74 O.S. Supp.
17	2018, Section 85.3A), is amended to read as follows:
18	Section 85.3A. A. Compliance with the provisions of The
19	Oklahoma Central Purchasing Act shall not be required of:

22	institutions, centers, or other constituent agencies of The Oklahoma

reasonable cost and explore flexibility, administrative relief, and transformation changes through utilization of procurement technology.

C. At the invitation of the State Purchasing Director entities
exempted from the provisions of The Oklahoma Central Purchasing Act
shall participate in the advisory committee referenced in subsection
B of this section.

B. The State Purchasing Director may invite representatives of
 9 local government and local common education entities to participate
 10 as members of the advisory committee.

SECTION 2. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 63.22 of Title 74, unless there is created a duplication in numbering, reads as follows:

A. The Oklahoma Department of Veterans Affairs may grant a preference for purposes of the expenditure of funds for tangible or intangible personal property or services to be acquired by the agency to an honorably discharged veteran or to a lawfully recognized business entity the majority ownership of which fifty-one percent (51%) or more is held by an honorably discharged veteran at the time the contract is awarded.

B. No individual veteran or veteran-owned business entity, as defined in paragraph A of this section, shall be eligible for consideration as a vendor pursuant to this section unless the individual veteran or veteran-owned business entity has registered

1	with the federal System for Award Management (SAM.gov) in the same
2	manner as required to do business with the federal government.
3	C. As used in this section, the term "veteran" shall be defined
4	in accordance with Section 2 of Title 72 of the Oklahoma Statutes.
5	SECTION 3. This act shall become effective July 1, 2019.
6	SECTION 4. It being immediately necessary for the preservation
7	of the public peace, health or safety, an emergency is hereby
8	declared to exist, by reason whereof this act shall take effect and
9	be in full force from and after its passage and approval.
