SENATE BILL 1801

AS INTRODUCED

An Act relating to the Oklahoma Open Meeting Act; amending 25 O.S. 2011, Sections 304, as amended by Section 3, Chapter 81, O.S.L. 2019 and 307, as last amended by Section 57, Chapter 476, O.S.L. 2019 (25 O.S. Supp. 2019, Sections 304 and 307), which relate to definitions and executive sessions; adding Judicial Nominating Commission to definition of public body; establishing purposes for permissible executive sessions; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 25 O.S. 2011, Section 304, as amended by Section 3, Chapter 81, O.S.L. 2019 (25 O.S. Supp. 2019, Section 304), is amended to read as follows:

Section 304. As used in the Oklahoma Open Meeting Act:

1. "Public body" means the governing bodies of all municipalities located within this state, boards of county commissioners of the counties in this state, boards of public and higher education in this state and all boards, bureaus, commissions, agencies, trusteeships, authorities, councils, committees, public trusts or any entity created by a public trust, including any

1 committee or subcommittee composed of any of the members of a public
2 trust or other legal entity receiving funds from the Rural Economic
3 Action Plan Fund as authorized by Section 2007 of Title 62 of the
4 Oklahoma Statutes, task forces or study groups in this state
5 supported in whole or in part by public funds or entrusted with the
6 expending of public funds, or administering public property, and
7 shall include all committees or subcommittees of any public body.
8 Public body shall include the Judicial Nominating Commission.

9 Public body shall not include the state judiciary, the Council on
10 Judicial Complaints when conducting, discussing, or deliberating any
11 matter relating to a complaint received or filed with the Council,
12 the Legislature, or administrative staffs of public bodies,
13 including, but not limited to, faculty meetings and athletic staff
14 meetings of institutions of higher education when those staffs are
15 not meeting with the public body, or entry-year assistance
16 committees. Furthermore, public body shall not include the
17 multidisciplinary teams provided for in Section 1-9-102 of Title 10A
18 of the Oklahoma Statutes and subsection C of Section 1-502.2 of
19 Title 63 of the Oklahoma Statutes or any school board meeting for
20 the sole purpose of considering recommendations of a
21 multidisciplinary team and deciding the placement of any child who
22 is the subject of the recommendations. Furthermore, public body
23 shall not include meetings conducted by stewards designated by the
24 Oklahoma Horse Racing Commission pursuant to Section 203.4 of Title

1 3A of the Oklahoma Statutes when the stewards are officiating at
2 races or otherwise enforcing rules of the Commission;

3 2. "Meeting" means the conduct of business of a public body by
4 a majority of its members being personally together or, as
5 authorized by Section 307.1 of this title, together pursuant to a
6 videoconference. Meeting shall not include informal gatherings of a
7 majority of the members of the public body when no business of the
8 public body is discussed;

9 3. "Regularly scheduled meeting" means a meeting at which the
10 regular business of the public body is conducted;

11 4. "Special meeting" means any meeting of a public body other
12 than a regularly scheduled meeting or emergency meeting;

13 5. "Emergency meeting" means any meeting called for the purpose
14 of dealing with an emergency. For purposes of the Oklahoma Open
15 Meeting Act, an emergency is defined as a situation involving injury
16 to persons or injury and damage to public or personal property or
17 immediate financial loss when the time requirements for public
18 notice of a special meeting would make such procedure impractical
19 and increase the likelihood of injury or damage or immediate
20 financial loss;

21 6. "Continued or reconvened meeting" means a meeting which is
22 assembled for the purpose of finishing business appearing on an
23 agenda of a previous meeting. For the purposes of the Oklahoma Open
24 Meeting Act, only matters on the agenda of the previous meeting at
25

1 which the announcement of the continuance is made may be discussed
2 at a continued or reconvened meeting; and

3 7. "Videoconference" means a conference among members of a
4 public body remote from one another who are linked by interactive
5 telecommunication devices permitting both visual and auditory
6 communication between and among members of the public body and
7 members of the public. During any videoconference, both the visual
8 and auditory communications functions of the device shall be
9 utilized. Whenever the term "teleconference" appears in any law in
10 relation to a meeting of a public body, it shall be deemed to mean a
11 videoconference as defined in this paragraph.

12 SECTION 2. AMENDATORY 25 O.S. 2011, Section 307, as last
13 amended by Section 57, Chapter 476, O.S.L. 2019 (25 O.S. Supp. 2019,
14 Section 307), is amended to read as follows:

15 Section 307. A. No public body shall hold executive sessions
16 unless otherwise specifically provided in this section.

17 B. Executive sessions of public bodies will be permitted only
18 for the purpose of:

19 1. Discussing the employment, hiring, appointment, promotion,
20 demotion, disciplining or resignation of any individual salaried
21 public officer or employee;

22 2. Discussing negotiations concerning employees and
23 representatives of employee groups;

24 3. Discussing the purchase or appraisal of real property;

1 4. Confidential communications between a public body and its
2 attorney concerning a pending investigation, claim, or action if the
3 public body, with the advice of its attorney, determines that
4 disclosure will seriously impair the ability of the public body to
5 process the claim or conduct a pending investigation, litigation, or
6 proceeding in the public interest;

7 5. Permitting district boards of education to hear evidence and
8 discuss the expulsion or suspension of a student when requested by
9 the student involved or the student's parent, attorney or legal
10 guardian;

11 6. Discussing matters involving a specific handicapped child;

12 7. Discussing any matter where disclosure of information would
13 violate confidentiality requirements of state or federal law;

14 8. Engaging in deliberations or rendering a final or
15 intermediate decision in an individual proceeding pursuant to
16 Article II of the Administrative Procedures Act;

17 9. Discussing matters involving safety and security at state
18 penal institutions or correctional facilities used to house state
19 inmates;

20 10. Discussing contract negotiations involving contracts
21 requiring approval of the Board of Corrections, which shall be
22 limited to members of the public body, the attorney for the public
23 body, and the immediate staff of the public body. No person who may
24 profit directly or indirectly by a proposed transaction which is

1 under consideration may be present or participate in the executive
2 session; or

3 11. Discussing the following:

- 4 a. the investigation of a plan or scheme to commit an act
5 of terrorism,
- 6 b. assessments of the vulnerability of government
7 facilities or public improvements to an act of
8 terrorism,
- 9 c. plans for deterrence or prevention of or protection
10 from an act of terrorism,
- 11 d. plans for response or remediation after an act of
12 terrorism,
- 13 e. information technology of the public body but only if
14 the discussion specifically identifies:
 - 15 (1) design or functional schematics that demonstrate
16 the relationship or connections between devices
17 or systems,
 - 18 (2) system configuration information,
 - 19 (3) security monitoring and response equipment
20 placement and configuration,
 - 21 (4) specific location or placement of systems,
22 components or devices,
 - 23 (5) system identification numbers, names, or
24 connecting circuits,

- (6) business continuity and disaster planning, or
response plans, or
- (7) investigation information directly related to
security penetrations or denial of services, or
- f. the investigation of an act of terrorism that has
already been committed.

For the purposes of this subsection, the term "terrorism" means any act encompassed by the definitions set forth in Section 1268.1 of Title 21 of the Oklahoma Statutes.

C. Notwithstanding the provisions of subsection B of this section, the following public bodies may hold executive sessions:

1. The State Banking Board, as provided for under Section 306.1 of Title 6 of the Oklahoma Statutes;

2. The Oklahoma Industrial Finance Authority, as provided for in Section 854 of Title 74 of the Oklahoma Statutes;

3. The Oklahoma Development Finance Authority, as provided for in Section 5062.6 of Title 74 of the Oklahoma Statutes;

4. The Oklahoma Center for the Advancement of Science and Technology, as provided for in Section 5060.7 of Title 74 of the Oklahoma Statutes;

5. The Oklahoma Health Research Committee for purposes of conferring on matters pertaining to research and development of products, if public disclosure of the matter discussed would

1 interfere with the development of patents, copyrights, products, or
2 services;

3 6. The Workers' Compensation Commission for the purposes
4 provided for in Section 20 of Title 85A of the Oklahoma Statutes;

5 7. A review committee, as provided for in Section 855 of Title
6 62 of the Oklahoma Statutes;

7 8. The Child Death Review Board for purposes of receiving and
8 conferring on matters pertaining to materials declared confidential
9 by law;

10 9. The Domestic Violence Fatality Review Board as provided in
11 Section 1601 of Title 22 of the Oklahoma Statutes;

12 10. The Opioid Overdose Fatality Review Board, as provided in
13 Section 2-1001 of Title 63 of the Oklahoma Statutes;

14 11. All nonprofit foundations, boards, bureaus, commissions,
15 agencies, trusteeships, authorities, councils, committees, public
16 trusts, task forces or study groups supported in whole or part by
17 public funds or entrusted with the expenditure of public funds for
18 purposes of conferring on matters pertaining to economic
19 development, including the transfer of property, financing, or the
20 creation of a proposal to entice a business to remain or to locate
21 within their jurisdiction if public disclosure of the matter
22 discussed would interfere with the development of products or
23 services or if public disclosure would violate the confidentiality
24 of the business;

1 12. The Oklahoma Indigent Defense System Board for purposes of
2 discussing negotiating strategies in connection with making possible
3 counteroffers to offers to contract to provide legal representation
4 to indigent criminal defendants and indigent juveniles in cases for
5 which the System must provide representation pursuant to the
6 provisions of the Indigent Defense System Act; ~~and~~

7 13. The Quality Investment Committee for purposes of discussing
8 applications and confidential materials pursuant to the terms of the
9 Oklahoma Quality Investment Act; and

10 14. The Judicial Nominating Commission for the purposes of
11 discussing the merits and qualifications of candidates for judicial
12 office if a majority of the Commission votes that public discussion
13 of the matter would violate the reasonable expectation of
14 confidentiality of the candidates and would prevent candid
15 discussion among Commissioners. Commissioners shall not vote or
16 indicate how they intend to vote in executive session, nor shall
17 candidate interviews be conducted in executive session.

18 D. Except as otherwise specified in this subsection, an
19 executive session for the purpose of discussing the purchase or
20 appraisal of real property shall be limited to members of the public
21 body, the attorney for the public body and the immediate staff of
22 the public body. No landowner, real estate salesperson, broker,
23 developer or any other person who may profit directly or indirectly
24 by a proposed transaction concerning real property which is under

1 consideration may be present or participate in the executive
2 session, unless they are operating under an existing agreement to
3 represent the public body.

4 E. No public body may go into an executive session unless the
5 following procedures are strictly complied with:

6 1. The proposed executive session is noted on the agenda as
7 provided in Section 311 of this title;

8 2. The executive session is authorized by a majority vote of a
9 quorum of the members present and the vote is a recorded vote; and

10 3. Except for matters considered in executive sessions of the
11 State Banking Board and the Oklahoma Savings and Loan Board, and
12 which are required by state or federal law to be confidential, any
13 vote or action on any item of business considered in an executive
14 session shall be taken in public meeting with the vote of each
15 member publicly cast and recorded.

16 F. A willful violation of the provisions of this section shall:

17 1. Subject each member of the public body to criminal sanctions
18 as provided in Section 314 of this title; and

19 2. Cause the minutes and all other records of the executive
20 session, including tape recordings, to be immediately made public.

21 SECTION 3. It being immediately necessary for the preservation
22 of the public peace, health or safety, an emergency is hereby
