7	An Act relating to the Department of Environmental Quality; amending 59 O.S. 2011, Section 1158, which

13	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
14	SECTION 1. AMENDATORY 59 O.S. 2011, Section 1158, is
15	amended to read as follows:
16	Section 1158. A. On and after July 1, 2002, any person, before
17	engaging in the installation of individual sewage disposal systems,
18	shall first obtain certification from the Department of
19	Environmental Quality under such rules as may be promulgated by the
20	Environmental Quality Board. The provisions of this subsection
21	shall only apply to persons who install more than ten individual
22	sewage disposal systems per calendar year. As used in this section,
23	"individual sewage disposal systems" means a sewage disposal system

3 в. Environmental Specialists employed by the Department of 4 Environmental Quality may perform soil profile descriptions to 5 design individual and other subsurface sewage disposal systems. Any 6 other individual choosing to perform soil profile descriptions to 7 design individual and other subsurface sewage disposal systems shall 8 first be certified by the Department of Environmental Quality under 9 such rules as may be promulgated by the Environmental Quality Board. 10 On or after the effective date of this act, the Department shall 11 promulgate rules requiring the use of data from the Oklahoma Mesonet 12 in performing soil profile descriptions to determine the number of 13 sprinklers required for an aerobic subsurface sewage disposal 14 system. Variables to be considered include, but are not limited to, 15 rainfall, soil moisture, rainfall runoff and evaporation rate in the 16 area in which the system shall be installed.

C. The Environmental Quality Board shall promulgate rules that shall include, but not be limited to, the following:

19 1. Establishment of minimum requirements for each type of 20 certification;

21 2. Establishment of a procedure and schedule for the assessment 22 of penalties for failure to comply with this section or rules 23 promulgated pursuant thereto;

1 3. Establishment of procedures for suspension, revocation and 2 nonrenewal of a certification; and

3 4. A requirement that an annual fee, as set by the 4 Environmental Quality Board pursuant to Section 2-3-402 of Title 27A 5 of the Oklahoma Statutes, shall be paid to the Department of 6 Environmental Quality for each certification. 7 D. The Water Quality Management Advisory Council shall 8 recommend proposed rules to the Environmental Quality Board pursuant 9 to Section 2-2-201 of Title 27A of the Oklahoma Statutes. 10 The Department of Environmental Quality may, after notice Ε.

and opportunity for a hearing pursuant to the Administrative Procedures Act, assess administrative penalties and may revoke, suspend or deny renewal of a certification pursuant to Section 2-3for Title 27A of the Oklahoma Statutes for any violation of this section or rules promulgated pursuant thereto. Such administrative penalties shall be deposited as provided in Section 2-3-401 of Title 27A of the Oklahoma Statutes.
