6 AS INTRODUCED

7 An Act relating to the Oklahoma Department of
8 Corrections; amending 57 O.S. 2011, Section 509, as
9 last amended by Section 2, Chapter 259, O.S.L. 2016
10 (57 O.S. Supp. 2018, Section 509), which relates to
11 penal institutions; clarifying language; and
12 providing an effective date.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. AMENDATORY 57 O.S. 2011, Section 509, as last
14 amended by Section 2, Chapter 259, O.S.L. 2016 (57 O.S. Supp. 2018,
15 Section 509), is amended to read as follows:

16 Section 509. The Oklahoma State Penitentiary shall be located
17 at McAlester in Pittsburg County, State of Oklahoma; and the
18 Oklahoma State Reformatory shall be located at Granite in Greer
19 County, State of Oklahoma; and the Lexington Assessment and
20 Reception Center shall be located at Lexington in Cleveland County,
21 State of Oklahoma; and the Jackie Brannon Correctional Center shall
22 be located at McAlester in Pittsburg County, State of Oklahoma; and
23 the Joseph Harp Correctional Center shall be located at Lexington in
24 Cleveland County, State of Oklahoma; and the Howard C. McLeod

1 Correctional Center shall be located at Farris in Atoka County,
2 State of Oklahoma; and the Mack H. Alford Correctional Center shall
3 be located at Stringtown in Atoka County, State of Oklahoma; and the
4 Jim E. Hamilton Correctional Center shall be located at Hodgen in
5 LeFlore County, State of Oklahoma; and the Mabel Bassett
6 Correctional Center shall be located at McLoud, in Pottawatomie
7 County, State of Oklahoma; and the R.B. "Dick" Conner Correctional
8 Center shall be located at Hominy in Osage County, State of
9 Oklahoma; and the James Crabtree Correctional Center shall be
10 located at Helena in Alfalfa County, State of Oklahoma; and the Jess
11 Dunn Correctional Center shall be located at Taft in Muskogee
12 County, State of Oklahoma; and the Northeast Oklahoma Correctional
13 Center shall be located at Vinita in Craig County, State of
14 Oklahoma; and the John Lilley Correctional Center shall be located
15 at Boley in Okfuskee County, State of Oklahoma; and the William S.
16 Key Correctional Center shall be located at Fort Supply in Woodward
17 County, State of Oklahoma; and the Dr. Eddie Walter Warrior
18 Correctional Center shall be located at Taft in Muskogee County,
19 State of Oklahoma; and the Clara Waters and Kate Barnard Community
20 Corrections Centers shall be located at Oklahoma City in Oklahoma
21 County, State of Oklahoma; and the Lawton Community Corrections
22 Center shall be located at Lawton in Comanche County, State of
23 Oklahoma; and the Enid Community Corrections Center shall be located
24 at Enid in Garfield County, State of Oklahoma; and the Union City

1 Community Corrections Center shall be located at Union City in
2 Canadian County, State of Oklahoma; and the Charles E. "Bill"
3 Johnson Correctional Center shall be located east of Alva in Woods
4 County, State of Oklahoma; and the ~~Southern Oklahoma Resource Center~~
5 Washita Valley Complex shall be located at Pauls Valley in Garvin
6 County, State of Oklahoma; and said institutions and community
7 corrections centers are hereby established within the Department.
8 Said Department shall be the legal successor of and, except as
9 otherwise provided in the Oklahoma Corrections Act of 1967, shall
10 have the powers and duties vested by law in the Office of Management
11 and Enterprise Services in all matters relating to penal
12 institutions, heretofore or hereafter established by the Department,
13 which institutions and community corrections centers shall be under
14 the administrative direction and control of the Department.

15 SECTION 2. This act shall become effective November 1, 2019.
