7 An Act relating to soldiers and sailors; amending 72
8 O.S. 2011, Section 229, as amended by Section 3,
9 Chapter 100, O.S.L. 2018 (72 O.S. Supp. 2018, Section
10 229), which relates to the veterans center at
11 Talihina; eliminating authorization to transfer
12 veterans center location; repealing Section 2,
13 Chapter 100, O.S.L. 2018 (72 O.S. Supp. 2018, Section
14 229.1), which relates to transfer of Talihina
15 veterans center; and providing an effective date.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. AMENDATORY 72 O.S. 2011, Section 229, as
18 amended by Section 3, Chapter 100, O.S.L. 2018 (72 O.S. Supp. 2018,
19 Section 229), is amended to read as follows:

20 Section 229. ~~A. Until operations are transferred pursuant to~~
21 ~~subsection B of this section, there~~ There is hereby established, in
22 addition to the Oklahoma Veterans Centers established by Sections
23 221 and 226 of this title, the Oklahoma Veterans Center at Talihina,
24 Oklahoma, on the site of the Oklahoma State Sanatorium, Talihina,
Oklahoma. All persons serving as employees of the Oklahoma State
Sanatorium under the provisions of the State Merit System of

1 Personnel Administration shall continue to serve as employees of the
2 Oklahoma Veterans Center at Talihina, provided that such employees
3 remain in the classified service. All employees hired by the
4 Oklahoma Veterans Center at Talihina on or after the effective date
5 of this act shall be under the Oklahoma Merit System of Personnel
6 Administration, except one manager, one principal assistant or
7 deputy, one private secretary, part-time physicians and other
8 professional personnel engaged in clinical and consultant services.
9 The average number of full-time-equivalent employees utilized in the
10 total operation of the Oklahoma Veterans Center, Talihina, shall not
11 exceed one hundred fifty-three (153) during the fiscal year ending
12 June 30, 1976. The buildings, equipment and land under the
13 jurisdiction of the Oklahoma State Sanatorium, Talihina, are hereby
14 transferred to the Oklahoma Veterans Center, Talihina.

15 ~~B. Operations of the Oklahoma Veterans Center established~~
16 ~~pursuant to this section shall continue until such time as~~
17 ~~operations are transferred to the location identified pursuant to~~
18 ~~the authority conferred upon the Oklahoma Veterans Commission under~~
19 ~~Section 2 of this act.~~

20 SECTION 2. REPEALER Section 2, Chapter 100, O.S.L. 2018
21 (72 O.S. Supp. 2018, Section 229.1), is hereby repealed.
