6 AS INTRODUCED

7 An Act relating to schools; defining term;  
8 designating school as a Purple Star Campus; providing  
9 qualifications for Purple Star Campus; directing the  
10 State Department of Education to promulgate rules;  
11 providing for codification; and providing an  
12 effective date.

13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. NEW LAW A new section of law to be codified  
15 in the Oklahoma Statutes as Section 510.3 of Title 70, unless there  
16 is created a duplication in numbering, reads as follows:

17 A. In this section, "military-connected student" shall mean a  
18 student enrolled in a public school who is a dependent of a current  
19 or former member of:

- 20 1. The United States military;  
21 2. The Oklahoma National Guard; or  
22 3. A reserve force of the United States military.

1 B. The State Department of Education shall designate a school  
2 district campus as a Purple Star Campus if the campus applies and  
3 qualifies for the designation under this section.

4 C. To qualify as a Purple Star Campus, a campus shall:

5 1. Designate a staff member as a military liaison, whose duties  
6 include:

- 7 a. identifying military-connected students enrolled at  
8 the campus,
- 9 b. serving as the point of contact between the campus and  
10 military-connected students and their families,
- 11 c. determining appropriate campus services available to  
12 military-connected students, and
- 13 d. assisting in coordinating campus programs relevant to  
14 military-connected students;

15 2. Maintain on the campus Internet website an easily accessible  
16 web page that includes resources for military-connected students and  
17 their families, including information regarding:

- 18 a. relocation to, enrollment at, registration at, and  
19 transferring records to the campus,
- 20 b. academic planning, course sequences, and advanced  
21 classes available at the campus,
- 22 c. counseling and other support services available for  
23 military-connected students enrolled at the campus,  
24 and

1           d.    the military liaison designated under paragraph 1 of  
2                    this subsection;

3           3.    Maintain a transition program led by students, where  
4 appropriate, that assists military-connected students in  
5 transitioning into the campus;

6           4.    Offer professional development for staff members on issues  
7 related to military-connected students; and

8           5.    Offer at least one of the following initiatives:

9           a.    a resolution showing support for military-connected  
10 students and their families,

11           b.    recognition of the Month of the Military Child or  
12 Military Family Month with relevant events hosted by  
13 the campus, or

14           c.    a partnership with a local military installation that  
15 provides opportunities for active duty military  
16 members to volunteer at the campus, speak at an  
17 assembly, or host a field trip.

18           D.    The State Department of Education shall promulgate rules as  
19 necessary for the implementation and administration of this section.

20           SECTION 2.   This act shall become effective November 1, 2020.
