It is the intent of the Legislature that, beginning July 1, 2021, a public or private institution of higher education that issues student identification cards may have printed on either side of the student identification cards the telephone number described in paragraph 1 of this subsection and may have printed on either side of the student identification cards the telephone numbers described in paragraphs 2, 3 and 4 of this subsection:
- 15 1. The telephone number for the National Suicide Prevention Lifeline, 1-800-273-8255;
 - 2. The Crisis Text Line, which can be accessed by texting HOME to 741741;
 - 3. The campus police or security telephone number or, if the campus does not have a campus police or security telephone number, the local nonemergency telephone number; and
