11 An Act relating to the University Hospitals
12 Authority; requiring that portions of certain
13 appropriated funds be used for certain purposes;
14 requiring certain transition payments be used for
15 stated purposes; requiring certain calculation;
16 requiring certain remaining funds be budgeted for
17 stated purposes; authorizing requests for early
18 transfers of certain funds for specific purposes;
19 providing for lapse of funds under certain
20 conditions; requiring certain budget procedures;
21 prohibiting certain budget procedures; providing an
22 effective date; and declaring an emergency.

23 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

24 SECTION 1. From the funds appropriated to the University
Hospitals Authority in Enrolled House Bill No. 2765 of the 1st
Session of the 57th Oklahoma Legislature, Five Million Dollars
(\$5,000,000.00) shall be used for support of the Oklahoma Health
Care Authority's Diagnostic Related Grouping (DRG) maintenance of

1 effort, Six Hundred Twenty-nine Thousand Forty Dollars (\$629,040.00)
2 shall be used for support of the Oklahoma Health Care Authority's
3 medical flight transportation maintenance of effort, One Million
4 Five Hundred Eighty-six Thousand Two Hundred Fourteen Dollars
5 (\$1,586,214.00) shall be used to support the Oklahoma Health Care
6 Authority's Level I Trauma maintenance of effort and Two Million One
7 Hundred Twenty-six Thousand Four Hundred Fifteen Dollars
8 (\$2,126,415.00) shall be used to support the Oklahoma Health Care
9 Authority's Hospital Graduate Medical Education program maintenance
10 of effort.

11 SECTION 2. From the funds appropriated to the University
12 Hospitals Authority in Enrolled House Bill No. 2765 of the 1st
13 Session of the 57th Oklahoma Legislature, Five Million Dollars
14 (\$5,000,000.00) shall be used to modernize research facilities and
15 equipment at the OU Health Sciences Center Biomedical Sciences
16 Building.

17 SECTION 3. From the funds appropriated to the University
18 Hospitals Authority in Enrolled House Bill No. 2765 of the 1st
19 Session of the 57th Oklahoma Legislature, Forty Million Six Hundred
20 Six Thousand Seventy-eight Dollars (\$40,606,078.00) shall be used
21 for duties including the University of Oklahoma Dean's GME Program.

22 SECTION 4. OUHSC shall ensure that in addition to funding the
23 Dean's GME Program for the fiscal year ending June 30, 2020, funds
24 received pursuant to Section 3 of this act in combination with funds

1 received from the Dean's GME transition payments for the fiscal year
2 ending June 30, 2019, are used to:

3 1. Reimburse the Oklahoma Health Care Authority an amount equal
4 to the proportionate share of OUHSC's Dean's GME program
5 disallowance for each of the four quarters of the state fiscal year
6 ending June 30, 2020; and

7 2. Budget an additional Eight Million Three Hundred Thousand
8 Dollars (\$8,300,000.00) in one-time funds on research programs.

9 OUHSC shall calculate the net collection from the Dean's GME
10 transition payments for the fiscal year ending June 30, 2019, less
11 the provisions of paragraphs 1 and 2 of this section. OUHSC shall
12 ensure the remaining balance from this calculation shall be budgeted
13 equally between an electronic health record conversion and support
14 of one-time research initiatives.

15 SECTION 5. From the funds appropriated to the University
16 Hospitals Authority in Enrolled House Bill No. 2765 of the 1st
17 Session of the 57th Oklahoma Legislature, Two Million Five Hundred
18 Ninety-five Thousand Eight Hundred Sixty-seven Dollars
19 (\$2,595,867.00) shall be used for providing audiologist- and speech
20 pathologist-related services for children.

21 SECTION 6. From the funds appropriated to the University
22 Hospitals Authority in Enrolled House Bill No. 2765 of the 1st
23 Session of the 57th Oklahoma Legislature, Five Hundred Ten Thousand
24

1 Dollars (\$510,000.00) shall be used to support the Oklahoma Center
2 for Poison and Drug Information.

3 SECTION 7. The CEO of the University Hospitals Authority may
4 request through the Director of the Office of Management and
5 Enterprise Services the early transfer by the Oklahoma Tax
6 Commission of tax collections to the General Revenue Fund for the
7 purpose of early allocation to the Authority's disbursing funds to
8 alleviate cash-flow problems.

9 SECTION 8. Appropriations made by Enrolled House Bill No. 2765
10 of the 1st Session of the 57th Oklahoma Legislature, not including
11 appropriations made for capital outlay purposes, may be budgeted for
12 the fiscal year ending June 30, 2020 (hereafter FY-20), or may be
13 budgeted for the fiscal year ending June 30, 2021 (hereafter FY-21).
14 Funds budgeted for FY-20 may be encumbered only through June 30,
15 2020, and must be expended by November 15, 2020. Any funds
16 remaining after November 15, 2020, and not budgeted for FY-21, shall
17 lapse to the credit of the proper fund for the then-current fiscal
18 year. Funds budgeted for FY-21 may be encumbered only through June
19 30, 2021. Any funds remaining after November 15, 2021, shall lapse
20 to the credit of the proper fund for the then-current fiscal year.
21 These appropriations shall not be budgeted in both fiscal years
22 simultaneously. Funds budgeted in FY-20, and not required to pay
23 obligations for that fiscal year, may be budgeted for FY-21, after
24 the agency to which the funds have been appropriated has prepared

1 and submitted a budget work program revision removing these funds
2 from the FY-20 budget work program and after such revision has been
3 approved by the Office of Management and Enterprise Services.

4 SECTION 9. This act shall become effective July 1, 2019.

5 SECTION 10. It being immediately necessary for the preservation
6 of the public peace, health or safety, an emergency is hereby
7 declared to exist, by reason whereof this act shall take effect and
8 be in full force from and after its passage and approval.
