There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Nine Hundred Fifty-three Million Three Hundred Thirty-eight Thousand Three Hundred Nineteen Dollars (\$953,338,319.00) or so much thereof as may be necessary for the financial support of public schools.

8 SECTION 2. There is hereby appropriated to the State Board of 9 Education from any monies not otherwise appropriated from the 10 Education Reform Revolving Fund created in Section 34.89 of Title 62 11 of the Oklahoma Statutes, the sum of One Billion Fifteen Million 12 Seventy-four Thousand Four Hundred Nineteen Dollars 13 (\$1,015,074,419.00) or so much thereof as may be necessary for the 14 financial support of public schools.

15 SECTION 3. The State Board of Education is hereby authorized to 16 expend during the fiscal year ending June 30, 2021, from the Common 17 Education Technology Revolving Fund of the State Treasury, the sum 18 of Forty-six Million Nine Hundred Thirty-eight Thousand Five Hundred 19 Sixty-six Dollars (\$46,938,566.00) or so much thereof as may be 20 necessary for the financial support of public schools.

21 SECTION 4. There is hereby appropriated to the State Board of 22 Education from any monies not otherwise appropriated from the 23 Mineral Leasing Fund of the State Treasury for the fiscal year 24 ending June 30, 2021, the sum of Three Million Eight Hundred

Thousand Dollars (\$3,800,000.00) or so much thereof as may be
 necessary for the financial support of public schools.

3 SECTION 5. There is hereby appropriated to the State Board of 4 Education from any monies not otherwise appropriated from the 5 Mineral Leasing Fund of the State Treasury for the fiscal year 6 ending June 30, 2019, the sum of Five Million Four Hundred Eleven 7 Thousand Two Hundred Fifty-eight Dollars (\$5,411,258.00) or so much 8 thereof as may be necessary for the financial support of public 9 schools.

SECTION 6. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Twenty-three Million Seven Hundred Fifteen Thousand Dollars (\$23,715,000.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 7. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Nine Million Twentyfour Thousand Four Hundred Twenty-eight Dollars (\$9,024,428.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 8. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of One Hundred Million Nine Hundred Nineteen Thousand Twenty-six Dollars (\$100,919,026.00) or so much thereof as may be necessary for the support of public schools activities.

8 SECTION 9. 21 SECTION 11. There is hereby appropriated to the State Board of 22 Education from any monies not otherwise appropriated from the 23 General Revenue Fund of the State Treasury for the fiscal year 24 ending June 30, 2021, the sum of One Hundred Eighty-eight Million

4 SECTION 12. There is hereby appropriated to the State Board of 5 Education from any monies not otherwise appropriated from the 6 General Revenue Fund of the State Treasury for the fiscal year 7 ending June 30, 2019, the sum of Fifteen Million Twenty-seven 8 Thousand Six Hundred Forty Dollars (\$15,027,640.00) or so much 9 thereof as may be necessary for administrative and support functions 10 of the State Department of Education.

SECTION 13. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Two Million Six Hundred Thirty-five Thousand Dollars (\$2,635,000.00) or so much thereof as may be necessary for transfer to the School Consolidation Assistance Fund.

Of those funds appropriated, the sum of Two Million Nine 19 Hundred Ninety-eight Thousand Four Hundred Seventy-four Dollars 20 (\$2,998,474.00) shall be transferred to the Oklahoma Tuition 21 Equalization Grant Trust Fund to implement the provisions of the 22 Oklahoma Tuition Equalization Grant Act. 23
