17	SECTION 1. AMENDATORY Section 1, Chapter 447, O.S.L.
18	2019 (63 O.S. Supp. 2019, Section 5020A), is amended to read as
19	follows:
20	Section 5020A. There is hereby created in the State Treasury a
21	fund for the Oklahoma Health Care Authority to be designated the
22	"Rate Preservation Fund". The fund shall be a continuing fund, not
23	subject to fiscal year limitations, and shall consist of monies
24	designated to the fund by law. All monies accruing to the credit of

    the fund are hereby appropriated and may be budgeted and expended by

    the Authority for the sole purpose of maintaining reimbursement

    rates to providers when decreases in the state's Federal Medical

    Expenditures from the fund shall be made upon warrants issued by the
