Research Analysis

HB 3336 modifies the fee assessed for failure to yield causing a fatality or serious bodily injury from discretionary fee to a mandatory fee and lowers the fee from \$1,000 to \$500. The fee is deposited in the Motorcycle Safety and Education Revolving Fund.

Fiscal Analysis

HB 3336 reduces the fee for failure to yield from \$1,000 to \$500 and requires it to be mandatory fee rather than discretionary. Based off of prior year actual revenue (see graphic below) from the fee being discretionary, the Department of Public Safety (DPS) expects the reduction in fee revenue to be ~\$186,000.

Making this a mandatory rather than discretionary fee will increase the amount of individuals required to pay the fee. This could lessen the estimated revenue loss, however, this number is unknown and is therefore unquantifiable. The actual revenue loss could range from \$0 to \$186,000.

The fund to which this revenue is deposited is the DPS Motorcycle Safety and Education Program Revolving (240) Fund and is used for the purposes of awarding matched federal grants in order to improve motorcycle safety in the state. The revenue is also utilized to fund the operations of the Motorcycle Safety and Education Program.
