Bill Analysis

SB 62 requires employees of agency contractors with access to Federal Tax Information and data to supply all necessary information required by the Oklahoma State Bureau of Investigations to conduct a criminal history search. Additionally, the measure requires contractors to provide fingerprints to the OSBI so that it may conduct a national criminal history check. Current law only requires employees of the Oklahoma Tax Commission, Oklahoma Department of Human Services, and Oklahoma Employment Security Commission to provide the information needed for a criminal history search.
