**PROPOSAL:** Amendatory

The measure proposes to amend 47 O.S. § 1135.5 by creating the Oklahoma American Legion Boys State special license plate to be designed and issued to any person wishing to demonstrate support for the Oklahoma American Legion Boys State Program. The special plate shall be designed in consultation with the Oklahoma American Legion Boys State Program. It authorizes the Tax Commission to enter into a licensing agreement with the Oklahoma chapter of the American Legion for any licensing fees required to use the organization's logo or design. The licensing agreement shall provide for a payment to the Oklahoma chapter of the American Legion of not more than \$20.00 for each license plate issued.

**ATTACHMENT TO REVENUE IMPACT- SB 1482 - [Introduced] - Prepared 02/03/2020**

The measure proposes to amend 47 O.S. § 1135.5 by creating the Oklahoma American Legion Boys State special license plate to be designed and issued to any person wishing to demonstrate support for the Oklahoma American Legion Boys State Program. The special plate shall be designed in consultation with the Oklahoma American Legion Boys State Program. It authorizes the Tax Commission to enter into a licensing agreement with the Oklahoma chapter of the American Legion to use the organization's logo or design. The licensing agreement shall provide for a payment to the Oklahoma chapter of the American Legion of not more than \$20.00 for each license plate issued.

The annual fee for special license plates issued pursuant to Section 1135.5 of Title 47 is \$35 and is in addition to all other annual vehicle registration fees. Of this amount, \$20 shall be paid to the Oklahoma chapter of the American Legion pursuant to a licensing agreement with \$8 deposited in the OTC Reimbursement Fund to be used for administrative purposes associated with issuance of the special license plates and any remaining amounts of the \$35 fee apportioned as motor vehicle collections pursuant to the provisions of 47 O.S. § 1104.

The estimated revenue impact associated with this measure is a minimal increase in motor vehicle collections.
