An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; making appropriations to the State Board of Education, the Oklahoma Arts Council, the State Board of Career and Technology Education, the Office of Educational Quality and Accountability, the Oklahoma Educational Television Authority, the Oklahoma State Regents for Higher Education, the Commissioners of the Land Office, the Oklahoma Department of Libraries, the Physician Manpower Training Commission, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Center for the Advancement of Science and Technology, the Office of the State Auditor and Inspector, the State Election Board, the Oklahoma Department of Emergency Management, the Ethics Commission, the Office of the Governor, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Office of Management and Enterprise Services, the Oklahoma Merit Protection Commission, the Military Department of the State of Oklahoma, the Oklahoma State Senate, the Oklahoma Tax Commission, the Office of the State Treasurer, the Oklahoma Space Industry Development Authority, the Department of Transportation, the State Department of Health, the Oklahoma Health Care Authority, the J.D. McCarty Center for Children with Developmental Disabilities, the Department of Mental Health and Substance Abuse Services, the Oklahoma

State University Medical Authority, the University Hospitals Authority, the Oklahoma Department of Veterans Affairs, the Oklahoma Commission on Children and Youth, the Office of Disability Concerns, the Department of Human Services, the Office of Juvenile Affairs, the State Department of Rehabilitation Services, the Oklahoma Department of Agriculture, Food, and Forestry, the Oklahoma Department of Commerce, the Rural Economic Action Plan Fund, the Oklahoma Conservation Commission, the Corporation Commission, the Department of Environmental Quality, the Oklahoma Historical Society, the J.M. Davis Memorial Commission, the Department of Labor, the Department of Mines, the Oklahoma Tourism and Recreation Department, the Oklahoma Water Resources Board, the Alcoholic Beverage Laws Enforcement Commission, the Department of Corrections, the Oklahoma State Bureau of Investigation, the Council on Law Enforcement Education and Training, the Board of Medicolegal Investigations, the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control, the Department of Public Safety, the Office of the Attorney General, the Court of Criminal Appeals, district attorneys and the District Attorneys Council, the Supreme Court, the Oklahoma Indigent Defense System, the Pardon and Parole Board, the Oklahoma Quick Action Closing Fund, The State Emergency Fund, the Rate Preservation Fund, the Maintenance of State Buildings Revolving Fund, the Digital Transformation Program Revolving Fund, and the Multiple Injury Trust Fund; stating amounts of the appropriations; stating purposes and restrictions; reappropriating certain funds; authorizing certain expenditures; and providing an effective date.

SUBJECT: General appropriations

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

SECTION 1. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Nine Hundred Fifty-three Million Three Hundred Thirty-eight Thousand Three Hundred Nineteen Dollars (\$953,338,319.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Education Reform Revolving Fund created in Section 34.89 of Title 62 of the Oklahoma Statutes, the sum of One Billion Fifteen Million Seventy-four Thousand Four Hundred Nineteen Dollars (\$1,015,074,419.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 3. The State Board of Education is hereby authorized to expend during the fiscal year ending June 30, 2021, from the Common Education Technology Revolving Fund of the State Treasury, the sum of Forty-six Million Nine Hundred Thirty-eight Thousand Five Hundred Sixty-six Dollars (\$46,938,566.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 4. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Three Million Eight Hundred Thousand Dollars (\$3,800,000.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 5. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Five Million Four Hundred Eleven Thousand Two Hundred Fifty-eight Dollars (\$5,411,258.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 6. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Twenty-three Million Seven Hundred Fifteen Thousand Dollars (\$23,715,000.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 7. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Nine Million Twenty-four Thousand Four Hundred Twenty-eight Dollars (\$9,024,428.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 8. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of One Hundred Million Nine Hundred Nineteen Thousand Twenty-six Dollars (\$100,919,026.00) or so much thereof as may be necessary for the support of public schools activities.

SECTION 9. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Revenue Stabilization Fund (105 Fund) of the State Treasury, the sum of Thirty-three Million Dollars (\$33,000,000.00) or so much thereof as may be necessary for the purchase of textbooks and instructional materials.

SECTION 10. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Three Hundred Forty-seven Million Eighty-one Thousand Six Hundred Forty-four Dollars (\$347,081,644.00) or so much thereof as may be necessary for the Certified Employee Health Benefit Allowance.

SECTION 11. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year

ending June 30, 2021, the sum of One Hundred Eighty-eight Million Four Hundred Fifty-five Thousand Three Hundred Seventy-seven Dollars (\$188,455,377.00) or so much thereof as may be necessary for the Support Personnel Health Benefit Allowance.

SECTION 12. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Fifteen Million Twenty-seven Thousand Six Hundred Forty Dollars (\$15,027,640.00) or so much thereof as may be necessary for administrative and support functions of the State Department of Education.

SECTION 13. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Two Million Six Hundred Thirty-five Thousand Dollars (\$2,635,000.00) or so much thereof as may be necessary for transfer to the School Consolidation Assistance Fund.

SECTION 14. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of One Million Two Thousand Seven Hundred Fourteen Dollars (\$1,002,714.00) or so much thereof as may be necessary for transfer to the School Consolidation Assistance Fund.

SECTION 15. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Two Million Six Hundred Thirty-five Thousand Dollars (\$2,635,000.00) or so much thereof as may be necessary for transfer to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

SECTION 16. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of One Million Two Thousand Seven Hundred Fourteen Dollars (\$1,002,714.00) or so much

thereof as may be necessary for transfer to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

SECTION 17. There is hereby appropriated to the Oklahoma Arts Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Two Million Seven Hundred Ninety-six Thousand Thirty Dollars (\$2,796,030.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Arts Council by law.

SECTION 18. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of One Hundred Thirty-three Million Four Hundred Seventy Thousand Three Hundred Eighty-five Dollars (\$133,470,385.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Career and Technology Education by law.

SECTION 19. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Two Million Eight Hundred Ninety-eight Thousand Five Hundred Dollars (\$2,898,500.00) pursuant to paragraph 2 of subsection F of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the State Board of Career and Technology Education for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the State Board of Career and Technology Education.

SECTION 20. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of One Million One Hundred Two Thousand Nine Hundred Eighty-six Dollars (\$1,102,986.00) pursuant to paragraph 2 of subsection F of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the State Board of Career and Technology Education for the education and general operating budgets of the institutions and for other

programs, construction, renovations or repairs administered by the State Board of Career and Technology Education.

SECTION 21. There is hereby appropriated to the Office of Educational Quality and Accountability from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of One Million Sixty-seven Thousand Two Hundred Nine Dollars (\$1,067,209.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Educational Quality and Accountability by law. Of those funds appropriated the sum of Sixty Thousand Dollars (\$60,000.00) shall be deposited in the Teacher Certification Scholarship Revolving Fund created pursuant to Section 6-187C of Title 70 of the Oklahoma Statutes. Of those funds appropriated the sum of One Hundred Eighty Thousand Dollars (\$180,000.00) shall be deposited in the Education Leadership Oklahoma Revolving Fund created pursuant to Section 6-204.3 of Title 70 of the Oklahoma Statutes.

SECTION 22. There is hereby appropriated to the Office of Educational Quality and Accountability from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of Five Hundred Thousand Dollars (\$500,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Educational Quality and Accountability by law.

SECTION 23. There is hereby appropriated to the Oklahoma Educational Television Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Two Million Seven Hundred Twenty-nine Thousand Four Dollars (\$2,729,004.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Educational Television Authority by law.

SECTION 24. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Six Hundred Thirty-two Million Five Thousand Three Hundred Sixty Dollars (\$632,005,360.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-a of the Oklahoma Constitution for the education and general operating budgets of the

institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education. Of those funds appropriated, the sum of Two Million Nine Hundred Ninety-eight Thousand Four Hundred Seventy-four Dollars (\$2,998,474.00) shall be transferred to the Oklahoma Tuition Equalization Grant Trust Fund to implement the provisions of the Oklahoma Tuition Equalization Grant Act.

SECTION 25. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2021, the sum of Forty-six Million Nine Hundred Thirty-eight Thousand Five Hundred Sixty-six Dollars (\$46,938,566.00) from the Higher Education Capital Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-a of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 26. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2021, the sum of Forty-six Million Nine Hundred Thirty-eight Thousand Five Hundred Sixty-six Dollars (\$46,938,566.00) from the Oklahoma Student Aid Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-a of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 27. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Eleven Million Seven Hundred Sixty-four Thousand Eight Hundred Twenty-three Dollars (\$11,764,823.00) or so much thereof as may be necessary for expenditures for concurrent enrollment pursuant to Section 628.13 of Title 70 of the Oklahoma Statutes.

SECTION 28. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Twenty Million Eight Hundred Sixteen Thousand Five Hundred Dollars (\$20,816,500.00) pursuant to paragraph 2 of subsection F of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-a of the Oklahoma Constitution for construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education or for any other purpose authorized by paragraph 2 of subsection F of Section 713 of Title 3A of the Oklahoma Statutes.

SECTION 29. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Seven Million Nine Hundred Twenty-one Thousand Four Hundred Forty-three Dollars (\$7,921,443.00) pursuant to paragraph 2 of subsection F of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-a of the Oklahoma Constitution for construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education or for any other purpose authorized by paragraph 2 of subsection F of Section 713 of Title 3A of the Oklahoma Statutes.

SECTION 30. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Four Million Twenty-nine Thousand Four Hundred Eighty-four Dollars (\$4,029,484.00) or so much thereof as may be necessary for the general operating budget of the Administrative Offices of the Oklahoma State Regents for Higher Education.

SECTION 31. There is hereby appropriated to the Commissioners of the Land Office from any monies not otherwise appropriated from the Commissioners of the Land Office Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Eight Million Three Hundred Seventy-nine Thousand Two Hundred Seventy-six Dollars

(\$8,379,276.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 32. There is hereby appropriated to the Oklahoma Department of Libraries from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Four Million Three Hundred Forty-six Thousand Three Hundred Fifteen Dollars (\$4,346,315.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Libraries by law.

SECTION 33. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Six Million Five Hundred Forty-six Thousand Eight Hundred Seventy-seven Dollars (\$6,546,877.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 34. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of Four Hundred Thousand Dollars (\$400,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 35. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Six Million Thirty-three Thousand Three Hundred Seventy-three Dollars (\$6,033,373.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 36. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Thirteen Million Seven Hundred Ninety-six Thousand Five Hundred Forty-two Dollars (\$13,796,542.00) or so much thereof as may be

necessary to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law. Of those funds appropriated, the sum of Five Million Five Hundred Eighteen Thousand Six Hundred Seventeen Dollars (\$5,518,617.00) shall be deposited in the Research Support Revolving Fund, created pursuant to Section 5060.11 of Title 74 of the Oklahoma Statutes. Of those funds appropriated, the sum of Three Million Thirty-five Thousand Two Hundred Thirty-nine Dollars (\$3,035,239.00) shall be deposited in the Seed-Capital Revolving Fund, created pursuant to Section 5060.21 of Title 74 of the Oklahoma Statutes.

GENERAL GOVERNMENT AND TRANSPORTATION

SECTION 37. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Four Million Eighty-six Thousand Sixteen Dollars (\$4,086,016.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Auditor and Inspector by law.

SECTION 38. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Two Hundred Fourteen Thousand Two Hundred Ninety-nine Dollars (\$214,299.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission on County Government Personnel Education and Training. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 39. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Nine Million Seven Hundred Thirty-seven Thousand Six Hundred Seventeen Dollars (\$9,737,617.00) or so much thereof as may be necessary to perform the duties imposed upon the State Election Board by law.

SECTION 40. There is hereby appropriated to the Oklahoma Department of Emergency Management from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for

the fiscal year ending June 30, 2021, the sum of Five Hundred Five Thousand Eight Hundred Fifty-nine Dollars (\$505,859.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Emergency Management by law.

SECTION 41. There is hereby appropriated to the Ethics Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Six Hundred Eighty-seven Thousand Nine Hundred Fifty-seven Dollars (\$687,957.00) or so much thereof as may be necessary to perform the duties imposed upon the Ethics Commission by law.

SECTION 42. There is hereby appropriated to the Office of the Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Three Million Five Hundred Fifty-seven Thousand Nine Hundred Forty Dollars (\$3,557,940.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Governor by law.

SECTION 43. There is hereby appropriated to the Oklahoma House of Representatives from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Nineteen Million Seventy-eight Thousand Three Hundred Twenty-seven Dollars (\$19,078,327.00) or so much thereof as may be necessary to pay the salaries, per diem and expenses of the members of the Oklahoma House of Representatives, the salaries of the employees of the Oklahoma House of Representatives and other necessary expenses. Claims and payrolls filed against the appropriation made to the Oklahoma House of Representatives for the fiscal year ending June 30, 2021, shall be approved by the Speaker of the Oklahoma House of Representatives.

SECTION 44. There is hereby appropriated to the Legislative Service Bureau from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Sixteen Million Seven Hundred Twenty-three Thousand Three Hundred Ninety-one Dollars (\$16,723,391.00) or so much thereof as may be necessary to perform the duties imposed upon the Legislative Service Bureau by law.

SECTION 45. There is hereby appropriated to the Office of the Lieutenant Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Four Hundred Sixty-four Thousand Six Hundred Sixty-five Dollars (\$464,665.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Lieutenant Governor by law.

SECTION 46. There is hereby appropriated to the Office of Management and Enterprise Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Fifty-two Million Nine Hundred Eighty-two Thousand Forty-three Dollars (\$52,982,043.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Management and Enterprise Services by law.

SECTION 47. There is hereby appropriated to the Office of Management and Enterprise Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of One Million Seven Hundred Ninety-three Thousand One Hundred Forty-four Dollars (\$1,793,144.00) to be transferred to the Building and Facility Revolving Fund, created in Section 63.1 of Title 74 of the Oklahoma Statutes, for the purpose of maintaining state buildings operated by the Office of Management and Enterprise Services.

SECTION 48. There is hereby appropriated to the Oklahoma State Bureau of Investigation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Fifteen Million Nine Hundred Twenty-six Thousand Eight Hundred Forty Dollars (\$15,926,840.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma State Bureau of Investigation by law. Of the funds appropriated herein, a maximum of One Hundred Thousand Dollars (\$100,000.00) may be transferred to an agency special account for the purpose of purchasing evidence items, paying fees to informers or special employees, paying expenses incurred in the prosecution and defense of civil actions, and paying other expenses as incurred under the Evidence Fund activity in trying to apprehend and convict violators of the laws of the state. The Oklahoma State Bureau of Investigation shall report income to the Evidence Fund annually pursuant to the provisions of Sections 34.36 and 34.42 of Title 62 of the Oklahoma Statutes.

SECTION 107. There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Two Million Six Hundred Thirty-seven Thousand Sixteen Dollars (\$2,637,016.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 108. There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from the C.L.E.E.T. Fund for the fiscal year ending June 30, 2021, the sum of Seven Hundred Thirty-three Thousand Eight Hundred Seventeen Dollars (\$733,817.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 109. There is hereby appropriated to the Board of Medicolegal Investigations from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Seventeen Million Two Hundred Seventy-one Thousand Seven Hundred Three Dollars

(\$17,271,703.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Medicolegal Investigations by law.

SECTION 110. There is hereby appropriated to the Board of Medicolegal Investigations from the Opioid Lawsuit Settlement Fund (Fund 383) of the State Treasury, the sum of Five Hundred Thousand Dollars (\$500,000.00) or so much thereof as may be necessary to address the impact of opioids on the state and its residents.

SECTION 111. There is hereby appropriated to the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Seven Hundred Forty-five Thousand Three Hundred Thirty Dollars (\$745,330.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control by law.

SECTION 112. There is hereby appropriated to the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control from the Opioid Lawsuit Settlement Fund (Fund 383) of the State Treasury, the sum of Two Million Four Hundred Thousand Dollars (\$2,400,000.00) or so much thereof as may be necessary to address the impact of opioids on the state and its residents.

SECTION 113. There is hereby appropriated to the Department of Public Safety from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Fifty-one Million Nine Hundred Twenty Thousand Eighty-six Dollars (\$51,920,086.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Public Safety by law.

SECTION 114. There is hereby appropriated to the Department of Public Safety from any monies not otherwise appropriated from the State Public Safety Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Twenty-four Million Three Hundred Sixty-seven Thousand Four Hundred Forty-three Dollars (\$24,367,443.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Public Safety by law.

SECTION 115. There is hereby appropriated to the Department of Public Safety from any monies not otherwise appropriated from the State Public Safety Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of One Million Seven Hundred Twelve Thousand Nine Hundred Nine Dollars (\$1,712,909.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Public Safety by law.

SECTION 116. There is hereby appropriated to the Department of Public Safety from any monies not otherwise appropriated from the C.L.E.E.T. Fund for the fiscal year ending June 30, 2021, the sum of Two Million Two Hundred One Thousand Four Hundred Fifty Dollars (\$2,201,450.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Public Safety by law.

SECTION 117. There is hereby appropriated to the Department of Public Safety from any monies not otherwise appropriated from the Revenue Stabilization Fund (105 Fund) of the State Treasury, the sum of Fifteen Million Dollars (\$15,000,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Department of Public Safety by law.

JUDICIARY

SECTION 118. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Eight Million Five Hundred Ninety-nine Thousand Three Hundred Sixty-eight Dollars (\$8,599,368.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Attorney General by law.

SECTION 119. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Nine Hundred Fifty-nine Thousand Three Hundred Seventy-eight Dollars (\$959,378.00) to transfer to the Legal Services Revolving Fund, created pursuant to subsection G of Section 921.1 of Title 12 of the Oklahoma Statutes.

SECTION 120. There is hereby appropriated to the Office of the Attorney General from the Opioid Lawsuit Settlement Fund (Fund 383)

of the State Treasury, the sum of One Million Five Hundred Thousand Dollars (\$1,500,000.00) or so much thereof as may be necessary to address the impact of opioids on the state and its residents.

SECTION 121. For the fiscal year ending June 30, 2021, the Office of the Attorney General is authorized to transfer an amount not to exceed Three Hundred Twenty Thousand Four Hundred Thirty Dollars (\$320,430.00) from the Office of the Attorney General's Evidence Fund (700 Fund), created by Section 19 of Title 74 of the Oklahoma Statutes, to the Office of the Attorney General's Revolving Fund (200 Fund), created by Section 20 of Title 74 of the Oklahoma Statutes.

SECTION 122. There is hereby appropriated to the Court of Criminal Appeals from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Four Million Twenty-two Thousand Seven Hundred Seven Dollars (\$4,022,707.00) or so much thereof as may be necessary to perform the duties imposed upon the Court of Criminal Appeals by law.

SECTION 123. There is hereby appropriated to the District Attorneys Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Forty-six Million Six Hundred Forty-two Thousand One Hundred Forty-nine Dollars (\$46,642,149.00) or so much thereof as may be necessary to perform the duties imposed upon the district attorneys and the District Attorneys Council by law. Of the funds appropriated herein, the District Attorneys Council shall transfer up to the sum of Four Hundred Ninety-one Thousand Fourteen Dollars (\$491,014.00) or so much thereof as may be required by the district attorneys and District Attorneys Council to the District Attorneys Evidence Fund for necessary expenses relative to any case within the official responsibility of the offices of the district attorneys as provided by Section 215.40 of Title 19 of the Oklahoma Statutes.

SECTION 124. There is hereby appropriated to the District Attorneys Council from any monies not otherwise appropriated from the Revenue Stabilization Fund (105 Fund) of the State Treasury, the sum of Ten Million Dollars (\$10,000,000.00) or so much thereof as

may be necessary to perform the duties imposed upon the district attorneys and the District Attorneys Council by law.

SECTION 125. For the fiscal year ending June 30, 2021, the District Attorneys Council is authorized to transfer an amount not to exceed One Million Dollars (\$1,000,000.00), on an as-needed basis, from the Crime Victims Compensation Revolving Fund created by Section 142.17 of Title 21 of the Oklahoma Statutes to the Sexual Assault Examination Fund, created by Section 142.20 of Title 21 of the Oklahoma Statutes.

SECTION 126. For the fiscal year ending June 30, 2021, up to Eight Hundred Sixty Thousand Dollars (\$860,000.00) is authorized to be transferred from the Crime Victims Compensation Revolving Fund, created by Section 142.17 of Title 21 of the Oklahoma Statutes, to the District Attorneys Council to support the Crime Victims Compensation Board.

SECTION 127. For the fiscal year ending June 30, 2021, up to One Million Five Hundred One Thousand Three Hundred Seventy-five Dollars (\$1,501,375.00) is authorized to be transferred from the Crime Victims Compensation Revolving Fund, created by Section 142.17 of Title 21 of the Oklahoma Statutes, to the District Attorneys Council for duties to support victim-witness services.

SECTION 128. The Supreme Court is hereby authorized to expend during the fiscal year ending June 30, 2021, from the State Judicial Revolving Fund of the State Treasury, the sum of Thirty-seven Million Dollars (\$37,000,000.00) or so much thereof as may be necessary for the financial support of the District Courts.

SECTION 129. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Twenty-seven Million Nine Hundred Eighty Thousand Three Hundred Sixty-one Dollars (\$27,980,361.00) or so much thereof as may be necessary to perform the duties imposed upon the District Courts by law.

SECTION 130. There is hereby appropriated to the Supreme Court from the Opioid Lawsuit Settlement Fund (Fund 383) of the State Treasury, the sum of Three Million Dollars (\$3,000,000.00) or so

much thereof as may be necessary to address the impact of opioids on the state and its residents.

SECTION 131. There is hereby appropriated to the Oklahoma Indigent Defense System from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Seventeen Million Five Hundred Eight Thousand Three Hundred Sixty-three Dollars (\$17,508,363.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Indigent Defense System by law.

SECTION 132. There is hereby appropriated to the Pardon and Parole Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Two Million Two Hundred Seventy-three Thousand Four Hundred Dollars (\$2,273,400.00) or so much thereof as may be necessary to perform the duties imposed upon the Pardon and Parole Board by law.

SECTION 133. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Eleven Million Two Hundred Twelve Thousand Seventy-eight Dollars (\$11,212,078.00) or so much thereof as may be necessary to perform the duties imposed upon the Supreme Court or Court of Civil Appeals by law.

SECTION 134. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the Revenue Stabilization Fund (105 Fund) of the State Treasury, the sum of Five Million Dollars (\$5,000,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Supreme Court by law.

SECTION 135. There is hereby appropriated to the Rate Preservation Fund created pursuant to Section 5020A of Title 63 of the Oklahoma Statutes from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Four Million Ninety-two Thousand Four Hundred Seventy Dollars (\$4,092,470.00) to be budgeted and expended in accordance with law.

SECTION 136. There is hereby appropriated to the Multiple Injury Trust Fund from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of One Million Dollars (\$1,000,000.00) or so much thereof as may be necessary to pay obligations of the Fund.

SECTION 137. There is hereby appropriated to the Special Cash Fund of the State Treasury from any monies not otherwise appropriated from the State Transportation Fund the sum of Forty-six Million One Hundred Ninety-one Thousand Four Hundred Eighty-nine Dollars (\$46,191,489.00) for availability of appropriation.

SECTION 138. There is hereby appropriated to the Special Cash Fund of the State Treasury from any monies not otherwise appropriated from the Oklahoma Tourism Capital Improvement Revolving Fund (267 Fund) the sum of Eight Million Dollars (\$8,000,000.00) for availability of appropriation.

SECTION 139. There is hereby appropriated to the Special Cash Fund of the State Treasury from any monies not otherwise appropriated from the Unclaimed Property Fund (711 Fund) the sum of Twenty-five Million Dollars (\$25,000,000.00) for availability of appropriation.

SECTION 140. There is hereby appropriated to the Special Cash Fund of the State Treasury from any monies not otherwise appropriated from the State Insurance Commissioner Revolving Fund (200 Fund) the sum of Six Million Five Hundred Thousand Dollars (\$6,500,000.00) for availability of appropriation.

SECTION 141. There is hereby appropriated to the Special Cash Fund of the State Treasury from any monies not otherwise appropriated from the Revolving Fund for the Office of the Secretary of State (200 Fund) the sum of Six Million Five Hundred Thousand Dollars (\$6,500,000.00) for availability of appropriation.

SECTION 142. There is hereby appropriated to the Special Cash Fund of the State Treasury from any monies not otherwise appropriated from the Weigh Station Improvement Revolving Fund (265 Fund) the sum of Twenty Million Dollars (\$20,000,000.00) for availability of appropriation.

SECTION 143. There is hereby appropriated to the Special Cash Fund of the State Treasury from any monies not otherwise appropriated from the Drug Money Laundering and Wire Transmitter Revolving Fund (Fund 220) the sum of Two Million Five Hundred Thousand Dollars (\$2,500,000.00) for availability of appropriation.

SECTION 144. There is hereby appropriated to the Special Cash Fund of the State Treasury from any monies not otherwise appropriated from the Digital Transformation Program Revolving Fund created pursuant to Section 36 of Title 62 of the Oklahoma Statutes the sum of Six Million Five Hundred Thousand Dollars (\$6,500,000.00) for availability of appropriation.

SECTION 145. There is hereby appropriated to the Education Reform Revolving Fund created in Section 34.89 of Title 62 of the Oklahoma Statutes from the Oklahoma Medical Marijuana Authority Revolving Fund (Fund 248) of the State Treasury, the sum of Thirty Million Dollars (\$30,000,000.00) for availability of appropriation.

SECTION 146. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019 the sum of One Hundred Twelve Million Dollars (\$112,000,000.00) to be transferred to the Ad Valorem Reimbursement Fund, created pursuant to Section 193 of Title 62 of the Oklahoma Statutes, for the purpose of reimbursing counties for school districts that claim a loss of revenue due to a tax exemption granted pursuant to the provisions of Section 6B of Article X of the Oklahoma Constitution.

SECTION 148. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Two Hundred Ten

Thousand Dollars (\$210,000.00) for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-a of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 149. There is hereby appropriated to the Office of Management and Enterprise Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Two Million Four Hundred Seventy Thousand Dollars (\$2,470,000.00) or so much thereof as may be necessary for the relocation of the state agencies currently housed within the Robert S. Kerr and J. Howard Edmondson buildings.

SECTION 150. Sections 1 through 136 of this act shall become effective July 1, 2020.
