11 An Act relating to the Revenue Stabilization Fund;  
12 making appropriations to the Revenue Stabilization  
13 Fund; stating purpose; and providing an effective  
14 date.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. There is hereby appropriated to the Revenue  
17 Stabilization Fund created pursuant to Section 34.102 of Title 62 of  
18 the Oklahoma Statutes from any monies not otherwise appropriated  
19 from the General Revenue Fund of the State Treasury for the fiscal  
20 year ending June 30, 2020, the sum of One Hundred Eighty-six Million  
21 Eighty-four Thousand Seven Hundred Eighty-two Dollars  
22 (\$186,084,782.00), to be utilized as provided by law.

23 SECTION 2. There is hereby appropriated to the Revenue  
24 Stabilization Fund created pursuant to Section 34.102 of Title 62 of

1 the Oklahoma Statutes from any monies not otherwise appropriated  
2 from the Alcoholic Beverage Control Fund, the sum of Thirteen  
3 Million Nine Hundred Fifteen Thousand Two Hundred Eighteen Dollars  
4 (\$13,915,218.00), to be utilized as provided by law.

5 SECTION 3. This act shall become effective September 1, 2019.
